**RE: HB 4072 – FIRE and ICE; SEASONAL FIREFIGHTING PERSONNEL**

Dear Chair Dingfelder and Members of the Committee:

The Department of Forestry appreciates the opportunity to provide testimony in support of House Bill 4072.

House Bill 4072 is an effort to clarify, or correct the possible lack of, specific authority for a beneficial practice that has occurred for several years among the Oregon Department of Transportation (ODOT), Forest Protective Associations (associations) and the Department of Forestry (ODF). This practice, known as "Fire and Ice" involves seasonal firefighting employees of the associations and ODF being rehired for a winter season, and then loaned to ODOT on a reimbursable basis to conduct winter highway maintenance programs such as plowing and de-icing.

This practice has long been acknowledged as a good example of efficiency in state government in agency budgeting and discussions with various Ways and Means Sub-Committees, with ODOT having the expenditure authority and ODF having position authority to "get the job done." Further, ODF and ODOT have had cooperative agreements that describe the practice, methods of payment, conditions of employment, etc. It has been assumed that the forest protective associations, through ORS 477.406, fit the same mold, and they have provided employees in the same fashion.

"Fire and Ice" fills an important need for skilled equipment operators with ODOT. It is even more important to the firefighting organizations, because it allows seasonal employees the financial capability to return to seasonal firefighting work year after year, gaining valuable experience and higher levels of training to fill critical firefighting roles, not only in their normal daily responsibilities, but also often as participants with incident management teams fighting our larger forest fires statewide. The agencies gain additional savings through this program by reducing the amount of unemployment claims paid out.

Current law clearly provides the opportunity and mechanism for this type of cooperation between the two state agencies. HB 4072 would establish that the associations and ODOT may similarly enter into cooperative agreements to accomplish mutually beneficial work.
