Removes requirement but still permits excess moneys collected by corporation from insurers and state programs to be held and invested to offset future net losses. Prescribes investments to be made with excess charges that are held and invested. Authorizes corporation to borrow money and give guarantees under specified conditions. Specifies applicable provisions of public contracting code.

Authorizes board of directors or executive director of corporation to contract with carriers to develop innovative health benefit plans for employees of corporation if plans are approved by Director of Department of Consumer and Business Services. Exempts such plans from Insurance Code requirements for small employer health benefit plans. Provides legislative approval of corporation business plan for health insurance exchange by repealing provisions of law enacted to require legislative approval. Makes technical corrections. Declares emergency, effective on passage.

ISSUES DISCUSSED:

EFFECT OF COMMITTEE AMENDMENT: Permits school districts and eligible employees of school districts to participate in health benefit plans offered through the Health Insurance Exchange beginning October 1, 2015. Directs ORHIX to consult with education stakeholder regarding the plans that may be offered, as well as to apply for any necessary federal waivers to allow districts and eligible employees of districts to obtain health benefit plans through the Exchange.

BACKGROUND: In 2011, the Oregon Legislature enacted Senate Bill 99, which established the public corporation to administer the Oregon Health Insurance Exchange (ORHIX). Senate Bill 99 requires the corporation to submit a formal business plan to the Legislature for approval. The business plan was presented to the House Interim Health Care Committee during the January Legislative Days.

HB 4164 acknowledges approval of the ORHIX business plan, and includes technical and conforming changes to provide the corporation with the financial infrastructure to operate as an independent entity.
