

HOUSE AMENDMENTS TO HOUSE BILL 4063

1 On page 1 of the printed bill, line 3, after “181.875,” insert “342.195.”

2 In line 4, delete “681.260, 681.264, 681.360.”

3 After line 25, insert:

4 “**SECTION 1a.** ORS 342.195 is amended to read:

5 “342.195. [*Upon payment of the required fees, an otherwise qualified applicant for an initial or*
6 *basic teaching license shall be granted the license upon showing by proof satisfactory to the Teacher*
7 *Standards and Practices Commission that the applicant has completed under an Armed Forces of the*
8 *United States or Peace Corps program, or as a volunteer under section 603 of the Economic Opportu-*
9 *nity Act of 1964 (Public Law 88-452), two years of satisfactory service which emphasized teaching in*
10 *any preprimary program or in any grades 1 through 12 in subjects regularly taught in public schools*
11 *if the applicant either:]*

12 “[*(1) Has completed an approved teacher education program; or]*

13 “[*(2) Has at least the baccalaureate degree from an accredited institution of higher education and*
14 *has completed a teacher training program provided under the auspices of the federal program.]* **An**
15 **otherwise qualified applicant for an initial or basic teaching license shall be granted the li-**
16 **cence upon payment of the required fees and the showing by proof satisfactory to the**
17 **Teacher Standards and Practices Commission that:**

18 “**(1) While the applicant was in the Peace Corps program or was a volunteer under sec-**
19 **tion 603 of the Economic Opportunity Act of 1964 (Public Law 88-452), the applicant:**

20 “**(a) Completed two years of satisfactory service that emphasized teaching in any pre-**
21 **primary program or in any grade 1 through 12 in subjects regularly taught in public schools;**
22 **and**

23 “**(b)(A) Has completed an approved teacher education program; or**

24 “**(B) Has earned at least a baccalaureate degree from an accredited institution of higher**
25 **education and has completed a teacher training program provided under the auspices of the**
26 **federal program.**

27 “**(2) The applicant was a certified instructor for the Armed Forces of the United**
28 **States.”.**

29 On page 3, delete lines 41 through 45.

30 On page 4, delete lines 1 through 18 and insert:

31 “**SECTION 7.** ORS 677.512 is amended to read:

32 “677.512. (1) A person seeking licensure as a physician assistant shall complete an application
33 form provided by the Oregon Medical Board and submit the form to the board, accompanied by
34 nonrefundable fees for the application and for the license in amounts determined by rule of the
35 board.

1 “(2) The board may issue a license to a physician assistant who:
2 “(a) Submits an application as required by the board by rule;
3 “(b) Pays the application fee established by the board by rule;
4 “(c) Has completed an educational program accredited by a nationally recognized accreditation
5 organization for physician assistant educational programs;
6 “(d) Has passed the initial national examination required of physician assistants to become na-
7 tionally certified;
8 “(e) Is mentally and physically able to engage safely in practice as a physician assistant;
9 “(f) Has not been disciplined by a physician assistant licensing board in another state, unless
10 the board considers the discipline and determines that the person is competent to practice as a
11 physician assistant; and
12 “(g) Is of good moral character as determined by the board.

13 “(3) The board may issue a license by reciprocity to a person who is licensed as a physician
14 assistant in another state and meets the requirements of subsection (2)(c) and (d) of this section.

15 “(4)(a) The board shall adopt necessary and proper rules to govern the renewal of licenses is-
16 sued under this section.

17 “(b) **If the board requires a licensee to complete continuing education in order to renew
18 a license issued under this section, the board shall allow a licensee to meet those require-
19 ments by providing the board with documentation of military training or experience that is
20 substantially equivalent to the continuing education required by the board.”.**

21 On page 6, delete lines 2 through 45.

22 On page 7, delete lines 1 through 20 and insert:

23 “**NOTE:** Sections 11 through 13 were deleted by amendment. Subsequent sections were not re-
24 numbered.”.

25 On page 16, line 8, delete “department” and insert “Department of Public Safety Standards and
26 Training”.

27 In line 9, delete “board” and insert “department”.

28 On page 17, delete lines 30 through 34 and insert:

29 “**SECTION 31. (1) The amendments to ORS 181.875, 342.195, 672.105, 672.118, 675.030,
30 675.240, 675.250, 678.442, 680.515, 680.520, 684.040, 688.050, 688.455, 688.650, 688.720, 688.815,
31 688.819, 689.255, 689.490, 690.047, 692.045, 692.105, 703.080, 703.090, 703.415 and 807.040 by
32 sections 1 to 6 and 8 to 30 of this 2012 Act apply to applications for licenses, certificates and
33 registrations submitted on or after the effective date of this 2012 Act.**

34 “(2) **The amendments to ORS 677.512 by section 7 of this 2012 Act apply to applications
35 for renewal of a license submitted on or after the effective date of this 2012 Act.”.**
