by the Emergency Board prior to December 1, 2012, the moneys remaining on that date become available for any purpose for which the Emergency Board lawfully may allocate funds.
<u>SECTION 13.</u> Sections 1, 4 and 7 of this 2012 Act are repealed July 1, 2013. Any moneys
remaining in the Oregon Senior and Disabled Emergency Fund, the Oregon Education
Emergency Fund and the Oregon Public Safety Emergency Fund on July 1, 2013, shall be
transferred to the Oregon Rainy Day Fund established under ORS 293.144.

34 <u>SECTION 14.</u> This 2012 Act being necessary for the immediate preservation of the public 35 peace, health and safety, an emergency is declared to exist, and this 2012 Act takes effect 36 on its passage.
