Senate Bill 1501

Sponsored by Senators ATKINSON, JOHNSON (Presession filed.)

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced.**

Authorizes holder of off-premises sales license, under certain conditions, to store wine at licensed premises for transport to other licensed premises for sale at retail. Authorizes sale of wine transported to receiving premises on behalf of transporting holder.

transported to receiving premises on behalf of transporting holder. Creates central warehouse license. Authorizes central warehouse licensee, under certain circumstances, to store wine at central warehouse for transport to premises in which licensee holds qualifying interest. Authorizes member of cooperative that is central warehouse licensee, under certain circumstances, to store wine at central warehouse for transport to premises in which member holds qualifying interest.

Declares emergency, effective on passage.

| 7 | SECTION 2. (1) The holder of an off-premises sales license may store wine at the licensed |
| 8 | premises and cause the wine to be transported to another premises that is licensed for off- |
| 9 | premises sales if the holder: |
| 10 | (a) Takes title to the wine no later than when the wine is delivered to the licensed |
| 11 | premises at which the holder will store the wine before transportation; |
| 12 | (b) Retains title to the wine until the wine is sold at retail; |
| 13 | (c) Owns, leases or subleases the premises receiving wine transported from the licensed |
| 14 | premises of the holder; and |
| 15 | (d) Ensures that wine transported from the licensed premises of the holder to another |
| 16 | premises licensed for off-premises sales is transported to the receiving premises: |
| 17 | (A) On a vehicle owned or operated by the holder; |
| 18 | (B) On a vehicle owned by a licensed wholesaler; or |

1 (b) Retains title to the wine until the wine is sold at retail; and

2 (c) Causes the wine to be transported from the central warehouse only to a licensed 3 premises in which the member has an interest described in subsection (3) of this section.

4 (3) A premises licensed for off-premises sales in this state may receive wine from a 5 central warehouse that is owned by a cooperative described in this section if a member of 6 the cooperative is named on the off-premises sales license and the premises is:

(a) Wholly owned by the member;

8 (b) Owned in part by the member and sells wine at retail under a trade name of the 9 member; or

(c) Operated under a contract with the member and sells wine at retail under a trade
 name of the member.

12 **SECTION 6.** ORS 471.186 is amended to read:

471.186. (1) The holder of an off-premises sales license may sell factory-sealed containers of wine,
malt beverages and cider. Containers of malt beverages sold under the license may not hold more
than two and one-quarter gallons.

(2) The holder of an off-premises sales license may provide sample tasting of alcoholic beverages
on the licensed premises if the licensee makes written application to the Oregon Liquor Control
Commission and receives approval from the commission to conduct tastings on the premises.
Tastings must be limited to the alcoholic beverages that may be sold under the privileges of the license.

(3) An off-premises sales license may not be issued for use at a premises that is mobile.

(4) Except as provided in ORS 471.402, a manufacturer or wholesaler may not provide or pay for
 sample tastings of alcoholic beverages for the public on premises licensed under an off-premises
 sales license.

(5) The holder of an off-premises sales license may deliver wine or cider that is sold under the privileges of the license to retail customers in this state without a direct shipper permit issued under ORS 471.282. Any deliveries by the holder of an off-premises sales license are subject to any rules adopted by the commission relating to deliveries made under this subsection. Deliveries under this subsection:

30 (a) May be made only to a person who is at least 21 years of age;

31 (b) May be made only for personal use and not for the purpose of resale; and

(c) Must be made in containers that are conspicuously labeled with the words: "CONTAINS
 ALCOHOL: SIGNATURE OF PERSON AGE 21 YEARS OR OLDER REQUIRED FOR
 DELIVERY."

(6) The holder of an off-premises sales license that makes deliveries of wine or cider under
subsection (5) of this section must take all actions necessary to ensure that a carrier used by the
licensee does not deliver any wine or cider unless the carrier:

(a) Obtains the signature of the recipient of the wine or cider upon delivery;

39 (b) Verifies by inspecting government-issued photo identification that the recipient is at least
40 21 years of age; and

41 (c) Determines that the recipient is not visibly intoxicated at the time of delivery.

42 (7) Any person who knowingly or negligently delivers wine or cider under the provisions of this
43 section to a person under 21 years of age, or who knowingly or negligently delivers wine or cider
44 under the provisions of this section to a visibly intoxicated person, violates ORS 471.410.

45 (8) If a court determines that deliveries of wine or cider under subsection (5) of this section

cannot be restricted to holders of off-premises sales licenses, and the decision is a final judgment 1

2 that is no longer subject to appeal, the holder of an off-premises sales license may not make deliv-

eries of wine or cider under the provisions of subsection (5) of this section after entry of the final 3

4 judgment.

(9) The holder of an off-premises sales license may cause wine to be transported from the 5 licensed premises to another premises that is licensed for off-premises sales if the holder 6 complies with section 2 of this 2012 Act. The holder of an off-premises sales license may 7 cause wine to be transported from a central warehouse to a premises licensed for off-8 9 premises sales if the holder complies with section 4 or 5 of this 2012 Act.

SECTION 7. ORS 471.311 is amended to read:

471.311. (1) Any person desiring a license or renewal of a license under this chapter shall make 11 12 application to the Oregon Liquor Control Commission upon forms to be furnished by the commission 13 showing the name and address of the applicant, location of the place of business that is to be operated under the license, and such other pertinent information as the commission may require. 14 15 [No] A license [shall] may not be granted or renewed until the applicant has complied with the 16 provisions of this chapter and the rules of the commission.

(2) The commission may reject any application that is not submitted in the form required by 17 rule. The commission shall give applicants an opportunity to be heard if an application is rejected. 18 A hearing under this subsection is not subject to the requirements for contested case proceedings 19 20under ORS chapter 183.

(3) Subject to subsection (4) of this section, the commission shall assess a nonrefundable fee for 2122processing a renewal application for any license authorized by this chapter only if the renewal ap-23plication is received by the commission less than 20 days before expiration of the license. If the renewal application is received prior to expiration of the license but less than 20 days prior to ex-24 piration, [this] the fee shall be 25 percent of the annual license fee. If a renewal application is re-25ceived by the commission after expiration of the license but no more than 30 days after expiration, 2627[this] the fee shall be 40 percent of the annual license fee. This subsection does not apply to a certificate of approval, a brewery-public house license or any license that is issued for a period of less 28than 30 days. 29

30 (4) The commission may waive the fee imposed under subsection (3) of this section if [it] the 31 commission finds that failure to submit a timely application was due to unforeseen circumstances or to a delay in processing the application by the local governing authority that is no fault of the 32licensee. 33

34 (5) The license fee is nonrefundable and [shall] must be paid by each applicant upon the granting or committing of a license. Subject to ORS 471.155 and 473.065, the annual or daily license 35fee and the minimum bond required of each class of license under this chapter are as follows: 36

25(6) The fee for a certificate of approval or special certificate of approval granted under ORS 471.244 is nonrefundable and must be paid by each applicant upon the granting or committing of a 2627certificate of approval or special certificate of approval. No bond is required for the granting of a certificate of approval or special certificate of approval. Certificates of approval are valid for a pe-28riod commencing on the date of issuance and ending on December 31 of the fifth calendar year fol-2930 lowing the calendar year of issuance. The fee for a certificate of approval is \$175. Special 31 certificates of approval are valid for a period of 30 days. The fee for a special certificate of approval is \$10. 32

(7) Except as provided in subsection (8) of this section, the annual license fee for a full on premises sales license is \$400. No bond is required for any full on-premises sales license.

(8) The annual license fee for a full on-premises sales license held by a nonprofit private club
as described in ORS 471.175 (8), or held by a nonprofit or charitable organization that is registered
with the state, is \$200.

(9) The annual fee for a wine self-distribution permit is \$100, and the minimum bond is \$1,000.

39 <u>SECTION 8.</u> Section 2 of this 2012 Act applies to the transportation, storage and sale of
 40 wine occurring before, on or after the effective date of this 2012 Act.

41 <u>SECTION 9.</u> This 2012 Act being necessary for the immediate preservation of the public 42 peace, health and safety, an emergency is declared to exist, and this 2012 Act takes effect 43 on its passage.
