SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Updates connection date to federal Internal Revenue Code and other provisions of federal tax law. Provides that, for specified agricultural or horticultural cooperatives, disconnection from federal law treatment of qualified production activities income does not affect calculation of patronage dividends.

Takes effect on 91st day following adjournment sine die.

 professional wildland firefighter and whose primary duties include the abatement of uncontrolled

(A) An hour for which an eligible employee is directly or indirectly paid or entitled to payment

(b) "Hour of service" does not include any hour for which payment is made or due under a plan maintained solely for the purpose of complying with applicable workers' compensation laws or unemployment compensation laws.

is not a retired member and who is not employed in a qualifying position.

(9) "Individual account program" means the defined contribution individual account program of
 the Oregon Public Service Retirement Plan established under ORS 238A.025.

(10) "Institution of higher education" means a public university listed in ORS 352.002, the
 Oregon Health and Science University or a community college, as defined in ORS 341.005.

(11) "Member" means an eligible employee who has established membership in the pension pro gram or the individual account program of the Oregon Public Service Retirement Plan and whose
 membership has not been terminated under ORS 238A.110 or 238A.310.

(12) "Participating public employer" means a public employer as defined in ORS 238.005 that
 provides retirement benefits for employees of the public employer under the system.

(13) "Pension program" means the defined benefit pension program of the Oregon Public Service

34 (c) "Salary" does not include the following amounts:

(A) Travel or any other expenses incidental to employer's business which is reimbursed by the
 employer.

(C) Any lump sum payment for accumulated unused sick leave, vacation leave or other paidleave.

40 (D) Any severance payment, accelerated payment of an employment contract for a future period 41 or advance against future wages.

42 (E) Any retirement incentive, retirement bonus or retirement gratuitous payment.

(F) Payment for a leave of absence after the date the employer and employee have agreed thatno future services in a qualifying position will be performed.

by the number of years of retirement credit attributable to service as a police officer or firefighter.
(b) For service as other than a police officer or firefighter, 1.5 percent of final average salary
multiplied by the number of years of retirement credit attributable to service as other than a police

238A.150. (6) "Educational institution," including an institution of higher education as defined in sub-2122section (9) of this section, means an institution: 23(a) In which participants, trainees or students are offered an organized course of study or training designed to transfer to them knowledge, skills, information, doctrines, attitudes or abilities 2425from, by or under the guidance of an instructor or teacher; (b) That is accredited, registered, approved, licensed or issued a permit to operate as a school 2627by the Department of Education or other government agency, or that offers courses for credit that are transferable to an approved, registered or accredited school; 28(c) In which the course or courses of study or training that it offers may be academic, technical, 2930 trade or preparation for gainful employment in a recognized occupation; and 31 (d) In which the course or courses of study or training are offered on a regular and continuing 32basis. (11) "Nonprofit employing unit" means an organization, or group of organizations, described in 3 section 501(c)(3) of the Internal Revenue Code that is exempt from income tax under section 501(a) 4 of the Internal Revenue Code. 5

(12) "State" includes, in addition to the states of the United States of America, the District of 6 Columbia and Puerto Rico. 317.398. Except as otherwise provided in this section, a taxpayer that is allowed a deduction 11 12for qualified production activities income under section 199 of the Internal Revenue Code for federal 13 tax purposes shall add the amount deducted to federal taxable income for purposes of the tax imposed by this chapter.
