SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Extends certain rights and benefits to members of commissioned corps of National Oceanic and Atmospheric Administration and members of Public Health Service of the United States Department of Health and Human Services.

[Requires community colleges to waive tuition for certain courses for child, spouse or unremarried surviving spouse of service member.]

Declares emergency, effective on passage.

4 claring an emergency.

5 **Be It Enacted by the People of the State of Oregon:**

6 **SECTION 1.** ORS 90.475 is amended to read:

7 90.475. (1) A tenant may terminate a rental agreement upon written notice if the tenant provides
8 the landlord with proof of official orders showing that the tenant is:

9 (a) Enlisting for active service in the Armed Forces of the United States;

10 (b) Serving as a member of a National Guard or other reserve component or an active service
11 component of the Armed Forces of the United States and ordered to active service outside the area
12 for a period that will exceed 90 days;

13 (c) Terminating active service in the Armed Forces of the United States; *[or]*

14 (d) A member of the Public Health Service of the United States Department of Health and Hu-
15 man Services detailed by proper authority for duty with the Army or Navy of the United States and:

16 (A) Ordered to active service outside the area for a period that will exceed 90 days; or

17 (B) Terminating the duty and moving outside the area within the period that the member is
18 entitled by federal law to the storage or shipment of household goods; **or**

19 **(e) A member of the commissioned corps of the National Oceanic and Atmospheric Ad-**
20 **ministration ordered to active service outside the area for a period that will exceed 90 days.**

21 (2) As used in subsection (1) of this section, "Armed Forces of the United States" means the
22 Air Force, Army, Coast Guard, Marine Corps or Navy of the United States.

23 (3) A termination of a rental agreement under this section is effective on the earlier of:

1 (a) A date determined under the provisions of any applicable federal law; or

2 (b) The later of:

3 (A) 30 days after delivery of the notice;

4 (B) 30 days before the earliest reporting date on orders for active service;

5 (C) A date specified in the notice; or

6 (D) 90 days before the effective date of the orders if terminating duty described under subsection
7 (1)(d)(B) of this section or terminating any active service described in this section.

8 (4) Notwithstanding ORS 90.300 (7)(a)(A) and 90.430, a tenant who terminates a lease under
9 subsection (1) of this section is not:

10 (a) Subject to a penalty, fee, charge or loss of deposit because of the termination; or

11 (b) Liable for any rent beyond the effective date of the termination as determined under sub-
12 section (3) of this section.

13 **SECTION 2.** ORS 109.056 is amended to read:

14 109.056. (1) Except as provided in subsection (2) or (3) of this section, a parent or guardian of
15 a minor or incapacitated person, by a properly executed power of attorney, may delegate to another
16 person, for a period not exceeding six months, any of the powers of the parent or guardian regarding
17 care, custody or property of the minor child or ward, except the power to consent to marriage or
18 adoption of a minor ward.

19 (2) A parent or guardian of a minor child may delegate the powers designated in subsection (1)
20 of this section to a school administrator for a period not exceeding 12 months.

21 (3)(a) As used in this subsection, "servicemember-parent" means a parent or guardian:

22 (A) Who is:

23 (i) A member of the organized militia of this state [or];

24 (ii) A member of the Reserves of the Army, Navy, Air Force, Marine Corps or Coast Guard of
25 the United States; [and]

26 (iii) **A member of the commissioned corps of the National Oceanic and Atmospheric Ad-
27 ministration; or**

41 parent or another individual, and the servicemember-parent is married to an individual other than

44 active duty service plus 30 days, unless a court finds that the delegation would not be in the best

1 **SECTION 3.** ORS 166.260 is amended to read:

2 166.260. (1) ORS 166.250 does not apply to or affect:

3 (a) Sheriffs, constables, marshals, parole and probation officers, police officers, whether active
4 or honorably retired, or other duly appointed peace officers.

5 (b) Any person summoned by any such officer to assist in making arrests or preserving the
6 peace, while said person so summoned is actually engaged in assisting the officer.

7 (c) The possession or transportation by any merchant of unloaded firearms as merchandise.

8 (d) Active or reserve members of:

9 **(A)** The Army, Navy, Air Force, Coast Guard or Marine Corps of the United States, or of the
10 National Guard, when on duty[.];

11 **(B) The commissioned corps of the National Oceanic and Atmospheric Administration;**
12 **or**

13 **(C) The Public Health Service of the United States Department of Health and Human**
14 **Services, when detailed by proper authority for duty with the Army or Navy of the United**

16 (e) Organizations which are by law authorized to purchase or receive weapons described in ORS

18 (f) Duly authorized military or civil organizations while parading, or the members thereof when
19 going to and from the places of meeting of their organization.

20 (g) A corrections officer while transporting or accompanying an individual convicted of or ar-
21 rested for an offense and confined in a place of incarceration or detention while outside the confines
22 of the place of incarceration or detention.

23 (h) A person who is licensed under ORS 166.291 and 166.292 to carry a concealed handgun.

24 (2) It is an affirmative defense to a charge of violating ORS 166.250 (1)(c)(C) that the person has
25 been granted relief from the disability under ORS 166.274.

26 (3) Except for persons who are otherwise prohibited from possessing a firearm under ORS
27 166.250 (1)(c) or 166.270, ORS 166.250 does not apply to or affect:

28 (a) Members of any club or organization, for the purpose of practicing shooting at targets upon
29 the established target ranges, whether public or private, while such members are using any of the
30 firearms referred to in ORS 166.250 upon such target ranges, or while going to and from such

39 Guard, **National Oceanic and Atmospheric Administration or Public Health Service of the**
40 **United States Department of Health and Human Services** exchanges and commissaries and Navy
41 or Coast Guard ships' stores, the United States Department of Veterans Affairs, ships' stores main-
42 tained under federal bond, or to any person that by virtue of the Constitution or statutes of the
43 United States cannot be made the subject of taxation by this state.

44 (2) The sale or gift of federally tax-free cigarettes when the cigarettes are delivered directly
45 from the manufacturer under Internal Revenue bond to a veterans' home or a hospital or domiciliary

1 facility of the United States Department of Veterans Affairs for gratuitous issue to veterans re-

37 (C) Reside in another state or a foreign country and establish Oregon residency by filing Oregon
38 state income taxes no later than 12 months before leaving active duty.

35 dent annual angling license issued to the person under ORS 497.121 if the person:

36 (a) Is an [*active member of the Armed Forces of the United States*] officer or enlisted person in
37 the Armed Forces of the United States who:

38 (A) Resides in this state while assigned to duty at any base, station, shore establishment
39 or other facility in this state;

40 (B) Resides in this state while serving as a member of the crew of a ship that has an
41 Oregon port or shore establishment as its home port or permanent station; or

42 (C) Resides in another state or a foreign country and establishes Oregon residency by
43 filing Oregon state income taxes no later than 12 months before leaving active duty; or

44 (b) Has retired from the Armed Forces of the United States within 12 months of the date of
45 making the application for a license.

1 (3) The department shall reimburse a person described in subsection (2) of this section for the
2 cost of a resident annual hunting license to hunt wildlife and a resident annual angling license upon
3 receipt of the person's application.

4 (4) The department shall adopt regulations implementing subsection (3) of this section.

5 **SECTION 12. The amendments to ORS 341.529, 341.531, 351.642, 351.643 and 353.200 by**
6 **sections 5 to 9 of this 2012 Act first apply to the 2012-2013 school year.**

7 **SECTION 13. This 2012 Act being necessary for the immediate preservation of the public**
8 **peace, health and safety, an emergency is declared to exist, and this 2012 Act takes effect**
9 **on its passage.**
