SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure

Directs Department of Corrections to establish risk assessment tool applicable to sex offenders. Establishes general rules regarding community notification based on results of risk assessment.

Authorizes State Board of Parole and Post-Prison Supervision and Psychiatric Security Review Board to conduct hearings to reclassify certain sex offenders and to relieve certain sex offenders of obligation to report. Specifies factors boards must consider and standards boards must apply when reclassifying sex offenders or relieving sex offenders of obligation to report.

Adds reclassification hearings to list of proceedings of which victims must be notified. Applies to recent offenders on January 1, 2014, and remaining offenders on January 1, 2017.

Specifies that certain sex offenders must be on active supervision after serving prison sentences.

Appropriates moneys to State Board of Parole and Post-Prison Supervision for assessment of offenders.

Declares emergency, effective on passage.

RECLASSIFICATION AND RELIEF HEARINGS

<u>SECTION 5.</u> (1)(a) A person who is required to report as a sex offender under ORS 181.595, 181.596 or 181.597 due to a conviction for a sex crime and is classified as a level one sex offender under section 1 (1) of this 2013 Act may petition the State Board of Parole and Post-Prison Supervision to relieve the person from the obligation to report as a sex offender under ORS 181.595, 181.596 or 181.597.
