House Bill 2549

Introduced and printed pursuant to House Rule 12.00. Presession filed (at the request of House Interim Committee on Judiciary)

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Directs Department of Corrections to establish risk assessment tool applicable to sex offenders. Establishes general rules regarding community notification based on results of risk assessment. Authorizes State Board of Parole and Post-Prison Supervision to conduct hearings to reclassify certain sex offenders and to relieve certain sex offenders of obligation to report. Applies to recent offenders on January 1, 2014, and remaining offenders on January 1, 2017.

Declares emergency, effective on passage.

10 <u>SECTION 1.</u> The Department of Corrections shall adopt by rule a sex offender risk as-11 sessment tool for use in classifying sex offenders based on the statistical likelihood that an 12 individual sex offender will commit another sex crime. Application of the risk assessment 13 tool to a sex offender must result in placing the sex offender in one of the following levels:

(1) A level one sex offender who presents the lowest risk of reoffending and requires a
 limited range of notification.

(2) A level two sex offender who presents a moderate risk of reoffending and requires a
 moderate range of notification.

(3) A level three sex offender who presents the highest risk of reoffending and requires
 the widest range of notification.

<u>SECTION 2.</u> (1) When a person convicted of a sex crime is sentenced to a term of imprisonment in a Department of Corrections institution, the department shall conduct a risk assessment of the person utilizing the risk assessment tool described in section 1 of this 2013 Act before the person is released from custody.

(2) When a person convicted of a sex crime is sentenced to a term of incarceration in a
jail, or is discharged, released or placed on probation by the court, the supervisory authority
as defined in ORS 144.087 shall conduct a risk assessment of the person utilizing the risk
assessment tool described in section 1 of this 2013 Act no later than 60 days after the person
is released from jail or discharged, released or placed on probation by the court.

1 (3) When a person is found guilty except for insanity of a sex crime, the Psychiatric Se-2 curity Review Board shall conduct a risk assessment of the person utilizing the risk assess-3 ment tool described in section 1 of this 2013 Act:

(a) Before the person is placed on conditional release by the board or the Oregon Health
Authority or is discharged from the jurisdiction of the board or the authority, if the person
is confined in a correctional facility by the court under ORS 161.327 after being found guilty
except for insanity.

(b) No later than 60 days after the person is placed on conditional release by the court
 under ORS 161.327 or discharged by the court under ORS 161.329.

(4) At the request of a person required to report as a sex offender under ORS 181.595,
181.596 or 181.597 who has not been subjected to a risk assessment utilizing the risk assessment tool described in section 1 of this 2013 Act, the State Board of Parole and Post-Prison
Supervision shall conduct a risk assessment of the person utilizing the risk assessment tool
described in section 1 of this 2013 Act if the person:

(a) Has been convicted in another United States court of a crime that would constitute
 a sex crime if committed in this state; or

(b) Is required to register in another state for having committed a sex offense in the
 other state, regardless of whether the crime would constitute a sex crime in this state.

(5) When the Department of Corrections, the State Board of Parole and Post-Prison Supervision, a supervisory authority or the Psychiatric Security Review Board conducts a risk assessment under this section, the agency shall notify the Department of State Police of the results of the risk assessment. Upon receipt, the Department of State Police shall enter the results of the risk assessment into the Law Enforcement Data System.

(6) A risk assessment conducted under this section is not subject to appeal.
