#### Work Session

SB 225 A

Modifies requirements for alternative education programs, including applicable laws, funding provisions, notice requirements, reporting requirements, oversight requirements and requirements related to special education and 504 Plans.

SB 776

Permits individual who is 16 or 17 years of age and registered to vote to cast ballot in school district elections.

SB 418 A

Creates rebuttable presumption that statement made by person under 18 years of age, during custodial interview in connection with investigation into certain acts, is involuntary if peace officer intentionally used false information to elicit statement.

SB 859

Increases amount that State Marine Board may deposit and retain in Salvaged Vessel Subaccount each biennium.

SB 863

Authorizes rural fire protection district to acquire real property or easement for purpose of establishing fire evacuation route, to construct or maintain fire evacuation route or to participate in agreement related to fire evacuation route.
