Measure: HB3501

In 1981 the classic film, "Escape From New York" starring Kurt Russel was released. It featured the New York City as a husk of itself that had been turned into a prison of sorts where criminals were sentenced to spend their lives in a quasi post-apocalyptic wasteland. Famed director John Carpenter directed both the original film and a 1996 sequel, "Escape from LA." in which the undesirables of the country were confined to Los Angeles, which had been reduced to an island by an earthquake and flood. Both films are underrated classics.

For too long we have waited for a second sequel to supplement the original two films. This is primarily for a lack of a decent place to film them that doesn't cost a huge amount to construct. And while CGI is much better than it used to be, nothing compares to honest to goodness locations rather than computer generated fantasy backdrops. But now, with the proven success of Measure 110 we're half-way to having the set that can be used to film the third installment of the "Escape from..." films. By passing HB 3501 the legislature would double down on Measure 110's success and get us over that finish line, virtually guaranteeing Oregon's suitability as an appropriate place to film "Escape from Oregon" with a minimal amount of additional cost to Hollywood producers. This would undoubtedly give Oregon a really good shot at being the shooting gallery of choice (for shooting movies and tv shows, obviously) and we could attract many people to Oregon from all over the country to serve as extras for not only the Escape from Oregon sequel, but also for a whole host of additional films that would require apocalyptic scenery and hordes of mindless zombies/addicts.

In addition, I have no doubt that we would receive multiple accolades from virtually every other state in the Union as they would finally have a place to refer their homeless, drug addicted and mentally ill individuals, as well as any illegal immigrants that a state wanted to send our direction. This would take a tremendous amount of pressure off of places like Chicago, New York City and the policy makers of the federal government as Texas, Florida, and California, among others, could send people to Oregon with the absolute comfort of knowing that there's a place for these folks in our medians, on/off ramps, city streets, parks, campuses, and parking lots.
