**GOVERNOR'S BUDGET:** This bill is anticipated by the Governor's recommended budget.

**LOCAL GOVERNMENT MANDATE:** This bill does not affect local governments' service levels or shared revenues sufficient to trigger Section 15, Article XI of the Oregon Constitution.

**COMMENTS:** This bill approves certain new or increased fees adopted by the Oregon Department of Transportation (ODOT) administratively in 2006. The Department of Administrative Services reviewed and approved the fee increases and additions in December 5, 2005. The public comment period closed on December 21, 2005 with no comments received. The Oregon Transportation Commission approved the fee increases and additions on January 18, 2006 and the amended rule was filed and became effective on January 24, 2006. The fees for public records requests were last updated in January 1995.
