Summary of Subcommittee Action

House Bill 3054 appropriates \$275,000 General Fund to the Department of Administrative Services to disburse funds to the Independent Development Enterprise Alliance to develop a statewide plan to support community-based programs that assist underserved individuals in removing legal impediments to employment. This bill directs the plan to give preference to individual programs that promote community service and establish monitoring programs that measure results. The bill also directs the Independent Development Enterprise Alliance to report periodically on the plan and its implementation to the appropriate interim or other committee of the Legislative Assembly.
