SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure

[Prohibits Secretary of State from disclosing Social Security numbers, federal employer identification numbers and taxpayer identification numbers provided in certain documents filed with Secretary of State.]

Authorizes Secretary of State to refuse to file certain documents if documents contain Social Security number, state identification number, driver license number, credit card or debit card number or account number that has not been redacted.

Deletes requirement that certain documents filed with Secretary of State contain Social Security numbers, federal employer identification numbers and taxpayer identification numbers.

Modifies provisions relating to authentication of financing statements required to register security interest in farm product. Directs Secretary of State to devise system for establishing unique identifiers for persons filing

statements under central filing system for farm products. Directs Secretary of State to seek approval of system from Secretary of United States Department of Agriculture.
