1 "(2) Failure to comply with the applicable provisions of this chapter.

"(3) Violation of any rule of the Environmental Quality Commission regarding sewage disposal
services.

"(4) The licensee was licensed by the Construction Contractors Board at the time of licensing
under ORS 454.695 and the license issued by the board was revoked or suspended as provided under
ORS [701.100 or] 701.102 or section 14 of this 2007 Act and rules adopted by the board.
