SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Modifies definition of actual address of program participant that may not be disclosed to include county of residence and precinct in which participant is registered to vote.

Specifies that substitute address designated by Attorney General for program participant may be used for purposes of laws requiring use of residence address.

Directs public bodies that receive request from program participant to develop procedure to prevent disclosure of program participant's actual address within the public body.

Restricts circumstances under which Attorney General may disclose actual address or telephone number of program participant. Requires that court order be justified by finding of good cause.

Exempts program participants from requirement that residence address be listed on driver license, [or] identification card **or vehicle registration application** issued by Department of Transportation.

Provides that jury source lists may not contain and State Court Administrator or justice of peace is not required to obtain information about program participants.

Provides that county clerk list of electors may not contain information about program participants.

Declares emergency, effective on passage.

5 **Be It Enacted by the People of the State of Oregon:**

6 **SECTION 1.** ORS 192.820 is amended to read:

7 192.820. As used in ORS 192.820 to 192.868:

8 (1) "Actual address" means:

9 (a) A residential, work or school street address of an individual specified on the application of
10 the individual to be a program participant; **or**

11 (b) **The name of the county in which the program participant resides or the name or**
12 **number of the election precinct in which the program participant is registered to vote.**

13 (2) "Address Confidentiality Program" means the program established under ORS 192.822.

14 (3) "Application assistant" means an employee of or a volunteer serving a public or private en-
15 tity designated by the Attorney General under ORS 192.854 to assist individuals with applications
16 to participate in the Address Confidentiality Program.

17 (4) "Program participant" means an individual accepted into the Address Confidentiality Pro-
18 gram under ORS 192.820 to 192.868.

19 (5) "Public body" has the meaning given that term in ORS 174.109.

NOTE: Matter in **boldfaced** type in an amended section is new; matter [*italic and bracketed*] is existing law to be omitted. New sections are in **boldfaced** type.

1 (6) "Public record" has the meaning given that term in ORS 192.410.

2 (7) "Substitute address" means an address designated by the Attorney General under the Ad-
3 dress Confidentiality Program.

4 (8) "Victim of domestic violence" means:

5 (a) An individual against whom domestic violence has been committed, as defined in ORS
6 135.230, 181.610, 411.117 or 657.176;

7 (b) An individual who has been a victim of abuse, as defined in ORS 107.705; or

8 (c) Any other individual designated a victim of domestic violence by the Attorney General by
9 rule.

10 (9) "Victim of a sexual offense" means:

11 (a) An individual against whom a sexual offense has been committed, as described in ORS
12 163.305 to 163.467, 163.427, 163.466 or 163.525; or

13 (b) Any other individual designated by the Attorney General by rule.

14 (10) "Victim of stalking" means:

15 (a) An individual against whom stalking has been committed, as described in ORS 163.732; or

16 (b) Any other individual designated by the Attorney General by rule.

17 **SECTION 1a. The amendments to ORS 192.820 by section 1 of this 2007 Act become op-
18 erative June 1, 2008.**

19 **SECTION 2.** ORS 192.836 is amended to read:

20 192.836. (1)(a) A program participant may request that public bodies use the substitute address
21 designated by the Attorney General as the address of the program participant in any ongoing
22 actions or proceedings or when creating a new public record.

23 (b) A public body is not responsible for requesting that departments, divisions, affiliates or other
24 organizational units of the public body or other public bodies use the substitute address [*designated*
25 *by the Attorney General*] as the address of the program participant.

26 (c) Unless requested by the program participant, when the actual address of a program partic-
27 ipant is contained in a public record that is filed with the public body, the public body is not re-
28 sponsible for modifying the public record to contain the substitute address designated by the
29 Attorney General.

30 (d) The Attorney General is not responsible for making requests under this subsection.

31 (2) Except as provided in this section **and ORS 192.842**, when a program participant submits a
32 current and valid Address Confidentiality Program authorization card to a public body, the public
33 body shall accept the substitute address on the authorization card as the address of the program
34 participant when creating a new public record. Upon the request of the program participant, the
35 public body shall use the substitute address on the authorization card in any ongoing actions or
36 proceedings.

37 (3) A public body may request a waiver from the requirements of the Address Confidentiality
38 Program by submitting a waiver request to the Attorney General. The waiver request shall be in
39 writing and include:

40 (a) An explanation of why the public body cannot meet its statutory or administrative obli-
41 gations by possessing or using the substitute address; and

42 (b) An affirmation that if the Attorney General accepts the waiver, the public body will only
43 use the actual address of the program participant for those statutory or administrative purposes
44 included in the waiver request.

45 (4) The Attorney General shall accept or deny a waiver request from a public body in writing

1 and include a statement of specific reasons for acceptance or denial. An acceptance or denial made
2 under this subsection is not considered an order as defined in ORS 183.310 and is not subject to
3 judicial review under ORS 183.480.

4 **(5) Except as provided in ORS 192.820 to 192.868, if a law or rule requires the use of a**
5 **residence address, the substitute address may be used instead.**

6 **SECTION 3.** ORS 192.844 is amended to read:

7 192.844. (1) Except as provided in ORS 192.820 to 192.868, a public body that *[has received]* **re-**
8 **ceives** a request from a program participant under ORS 192.836 may not disclose the actual address
9 or telephone number of the program participant.

10 **(2) Each public body that receives a request from a program participant under ORS**
11 **192.836 shall adopt a procedure to prevent unnecessary disclosure of actual addresses or**
12 **telephone numbers of program participants to employees of that public body or other persons**
13 **in that public body.**

14 **SECTION 4.** ORS 192.848 is amended to read:

15 192.848. (1) The Attorney General may not disclose the actual address or telephone number of
16 a program participant, except under **either of** the following circumstances:

17 *[(a) Upon request by a federal, state or local law enforcement agency or district attorney for official*
18 *use only;]*

19 *[(b)]* **(a) [Pursuant to a court order;] Upon receipt of a court order signed by a judge pursu-**
20 **ant to a finding of good cause. Good cause exists when disclosure is sought for a lawful**
21 **purpose that outweighs the risk of the disclosure and, in the case of a request for disclosure**
22 **received from a federal, state or local law enforcement agency, district attorney or other**
23 **public body, when information is provided to the court that describes the official purpose for**
24 **which the actual address or telephone number of the program participant will be used. If a**
25 **judge finds that good cause exists, the terms of the court order shall address, as much as**
26 **practicable, the safety and protection of the program participant. In cases where the Attor-**
27 **ney General has not received prior notice of a court order, not later than three business days**
28 **after receiving the order, the Attorney General may object to the order and request a hear-**
29 **ing before the judge who signed the order.**

30 *[(c) Upon request by a public body for a statutory or administrative purpose described in ORS*
31 *192.836; or]*

32 *[(d)]* **(b) Where the program participant is required to disclose the actual address of the program**
33 **participant as part of a registration for sex offenders as required under ORS 181.598 and 181.599.**

34 **(2) A person to whom an actual address or telephone number of a program participant has been**
35 **disclosed pursuant to a court order may not disclose the actual address or telephone number to any**
36 **other person unless permitted to do so by order of the court.**

37 **(3) The Attorney General shall notify a program participant within one business day after the**
38 **Attorney General discloses an actual address under subsection [(1)(b) or (c)] (1)(a) of this section.**

39 **(4) Upon request by a public body, the Attorney General may verify whether or not a person is**
40 **a program participant when the verification is for official use only.**

41 **SECTION 5.** ORS 807.110 is amended to read:

42 807.110. A license issued by the Department of Transportation shall comply with all of the fol-
43 lowing:

44 **(1) A license shall bear the distinguishing number assigned to the person issued the license by**
45 **the department.**

1 (2) A license shall contain, for the purpose of identification, a brief description of the person to
2 whom the license is issued.

3 (3) A license shall contain the name, **the** date of birth and, except as provided for corrections
4 officers in ORS 802.253, [or] eligible employees in ORS 802.250 **or Address Confidentiality Pro-**
5 **gram participants in section 11 of this 2007 Act, the** residence address of the person to whom
6 the license is issued and a space for the person's signature.

7 (4) Upon request of the person to whom the license is issued, a license shall indicate on the li-
8 cense the fact that the person is an anatomical donor.

9 (5) Upon order of the juvenile court, a license shall indicate on the license the fact that the
10 person to whom the license is issued is an emancipated minor.

11 (6) Except as otherwise provided in this subsection, a license shall bear a photograph described
12 in this subsection. The Director of Transportation, by rule, may provide for issuance of a valid li-
13 cense without a photograph if the applicant shows good cause. The director shall include religious
14 preferences as good cause for issuance of a license without a photograph but shall not limit good
15 cause to religious grounds. A photograph required under this subsection shall:

16 (a) Be a full-faced, color photograph of the person to whom the license is issued;

29 ment.

30 **SECTION 6.** ORS 807.110, as amended by section 7, chapter 775, Oregon Laws 2005, is amended
31 to read:

32 807.110. (1) A license issued by the Department of Transportation shall contain all of the fol-
33 lowing:

34 (a) The distinguishing number assigned to the person issued the license by the department.

35 (b) For the purpose of identification, a brief description of the person to whom the license is
36 issued.

37 (c) The name, **the** date of birth and, except as provided for corrections officers in ORS
38 802.253, [or] eligible employees in ORS 802.250 **or Address Confidentiality Program participants**
39 **in section 11 of this 2007 Act, the** residence address of the person to whom the license is issued
40 and a space for the person's signature.

41 (d) Upon request of the person to whom the license is issued, the fact that the person is an
42 anatomical donor.

43 (e) Upon order of the juvenile court, the fact that the person to whom the license is issued is
44 an emancipated minor.

45 (f) Except as otherwise provided in this paragraph, a photograph described in this paragraph.

1 The Director of Transportation, by rule, may provide for issuance of a valid license without a photo-
2 tograph if the applicant shows good cause. The director shall include religious preferences as good
3 cause for issuance of a license without a photograph but shall not limit good cause to religious
4 grounds. A photograph required under this paragraph shall:

5 (A) Be a full-faced, color photograph of the person to whom the license is issued;

6 (B) Be of a size approved by the department; and

7 (C) Be taken at the time of application for issuance of the license whether the application is for
8 an original license, replacement of a license under ORS 807.160 or for renewal of a license under
9 ORS 807.150.

10 (g) The class of license issued and any endorsements granted. If the license is a commercial
11 driver license, the words "commercial driver license" or the letters "CDL" shall appear on the li-
12 cense.

13 (2) A license is not valid until signed by the person to whom it is issued.

14 (3) The department shall use security procedures, processes and materials in the preparation,
15 manufacture and issuance of any license that prohibit as nearly as possible anyone's ability to alter,
16 counterfeit, duplicate or modify the license without ready detection. The security features used in
17 the production of the licenses shall provide for:

18 (a) The authentication of a genuine document in a reasonable time; and

19 (b) The production of the license only by equipment that requires verification of the identity of
20 the operator of the equipment before a license may be produced.

21 **SECTION 7.** ORS 807.050 is amended to read:

22 807.050. An application for a license shall be in a form approved by the Oregon Department of
23 Transportation. An application must contain all the following:

24 (1) The applicant's true name, age, sex, residence address, except as otherwise provided for
25 corrections officers in ORS 802.253, [or] eligible employees in ORS 802.250 **or Address**
26 **Confidentiality Program participants in section 11 of this 2007 Act**, and post-office address other
27 than general delivery. The department may provide by rule for acceptance of something other than
28 an actual residence or post-office address if the department determines that the applicant does not
29 have an actual address. The department shall require proof to verify the address in addition to
30 anything else the department may require of the applicant.

31 (2) Whether or not the applicant has ever been issued any driver license or driver permit. If the
32 applicant has been issued any license or driver permit:

33 (a) When the license or driver permit was granted;

34 (b) What jurisdiction granted the license or driver permit;

35 (c) Whether or not the driving privileges under the license or driver permit are currently sus-
36 pended or revoked; and

40 (4) The Social Security number of the applicant or other number or identifying information de-

44 (5) Any other information the department deems necessary to assist the department in deter-
45 mining whether the applicant is qualified or eligible to be licensed.

1 **SECTION 8.** ORS 807.400 is amended to read:

2 807.400. (1) The Department of Transportation shall issue an identification card to any person
3 who:

- 4 (a) Is domiciled in or resident of this state, as described in ORS 807.062;
- 5 (b) Does not have a current, valid driver license; and
- 6 (c) Furnishes such evidence of the person's age and identity as the department may require.

7 (2) The department shall work with other agencies and organizations to attempt to improve the
8 issuance system for identification cards.

9 (3) Every original application for an identification card must be signed by the applicant. The
10 department shall require at least one document to verify the address of an applicant for issuance
11 of an identification card in addition to other documents the department may require of the applicant.
12 If the address of an applicant has changed since the last time an identification card was issued to
13 or renewed for the applicant, the department shall require proof to verify the address of an applicant
14 for renewal of an identification card, in addition to anything else the department may require.

32 from that shown on the identification card and does not provide the department with notice of the

34 (10) If a person to whom an identification card was issued and who changes residence address
35 appears in person at a department office that issues identification cards, the department may do any

37 (a) Issue a replacement identification card containing the new address upon receipt of the old
38 identification card and payment of the fee established for issuing a replacement identification card
39 with a changed address under ORS 807.410. Except as otherwise provided in subsection (12) of this
40 section, the replacement identification card shall bear the same distinguishing number as the card
41 being replaced.

42 (b) Note the new address on the old identification card in a manner to be determined by the

14 ileges or a license may be canceled under ORS 809.310. The department may reissue an identifica-
15 tion card canceled under this subsection when the applicant has satisfied all requirements for the
16 identification card.

17 (15) Notwithstanding any other provision of this section, the department may issue an identifi-
18 cation card to a person under this subsection without charge when the person surrenders a license
19 or driver permit to the department for reasons described in this subsection. If the department issues
20 an identification card under this subsection, the identification card shall expire at the same time

22 under this subsection is subject to the same requirements and fees for renewal or upon expiration

34 807.400. (1) The Department of Transportation shall issue an identification card to any person
35 who:

36 (a) Is domiciled in or resident of this state, as described in ORS 807.062;

37 (b) Does not have a current, valid driver license;

38 (c) Furnishes such evidence of the person's age and identity as the department may require; and

39 (d) Submits to collection of biometric data by the department that establish the identity of the
40 person as provided in ORS 807.024.

41 (2) The department shall work with other agencies and organizations to attempt to improve the
42 issuance system for identification cards.

43 (3) Every original application for an identification card must be signed by the applicant. The
44 department shall require at least one document to verify the address of an applicant for issuance
45 of an identification card in addition to other documents the department may require of the applicant.

1 If the address of an applicant has changed since the last time an identification card was issued to
2 or renewed for the applicant, the department shall require proof to verify the address of an applicant

20 **SECTION 10. Section 11 of this 2007 Act is added to and made a part of ORS 192.820 to**
21 **192.868.**

22 **SECTION 11. (1) A program participant may request that any driver or vehicle record**
23 **kept by the Department of Transportation that contains or is required to contain the pro-**
24 **gram participant's actual address contain instead the substitute address designated by the**
25 **Attorney General. A request under this subsection must:**

26 (a) **Be in a form specified by the department; and**

27 (b) **Contain verification that the individual is a program participant.**

28 (2) **Upon receipt of a request and verification under this section, the department shall**
29 **remove the program participant's actual address from its records and instead use the sub-**
30 **stitute address designated by the Attorney General. The department shall note on the re-**
31 **records that the address shown is a substitute address under ORS 192.820 to 192.868. While the**
32 **request is in effect, the program participant may enter the substitute address on any driver**
33 **or vehicle form issued by the department that requires an address.**

34 (3) **If an individual ceases to be certified as a program participant, the individual shall**
35 **notify the department of a change of address as provided in ORS 803.220, 807.420 or 807.560.**

36 **SECTION 12. ORS 192.842 is amended to read:**

37 192.842. (1) A county clerk **or other elections official** shall use the actual address of a program
38 participant for voter registration purposes. Except as provided in ORS 192.820 to 192.868, [the] a
39 county clerk **or other elections official** may not disclose the actual address.

40 (2) A county clerk **or other elections official** shall use the substitute address of the program
41 participant for purposes of mailing a ballot to an elector under ORS 254.470.

42 (3) A school district shall use the actual address of a program participant for any purpose re-
43 lated to admission or assignment. The school district shall take such measures as necessary to pro-
44 tect the confidentiality of the actual address of the program participant. Student records created

1 (4) A county clerk shall accept the substitute address of the program participant as the address
2 of the applicant for the purpose of issuing a marriage license under ORS 106.041.

3 **SECTION 13.** ORS 247.967 is amended to read:

4 247.967. Notwithstanding any provision of ORS 192.410 to 192.505:

5 (1) **Except as provided in subsection (3) of this section,** the county clerk may disclose the
6 residence address of an elector exempt from public disclosure under ORS 247.965 if the county clerk
7 receives a court order or a request from any law enforcement agency to disclose the address.

8 (2) A petition may be filed with the circuit court of the county in which the administrative of-
9 fices of the county clerk are located requesting disclosure of the residence address of any elector
10 exempt from disclosure under ORS 247.965. The petitioner shall have the burden of showing the
11 disclosure would not constitute an unreasonable invasion of privacy.

12 **(3) The county clerk may not disclose the actual address, as defined in ORS 192.820, of**

16 master jury list containing names selected at random from the source lists. The source lists are the
17 most recent list of electors of the county, the records furnished by the Department of Transportation
18 as provided in ORS 802.260 (2) and any other sources approved by the Chief Justice of the Supreme
19 Court that will furnish a fair cross section of the citizens of the county. The State Court Adminis-
20 trator and circuit courts may use source lists obtained from any person or public body, and jury lists
21 containing names selected from a source list, only for purposes consistent with administering the
22 selection and summoning of persons for service as jurors, the drawing of names of jurors, and other
23 tasks necessary to accomplish those functions. **Source lists may not contain and the State Court**
24 **Administrator is not required to obtain information about individuals who are participants**
25 **in the Address Confidentiality Program under ORS 192.820 to 192.868.** Except as specifically
26 provided by law, the State Court Administrator and circuit courts may not disclose source lists ob-
27 tained from any person or public body, and jury lists containing names selected from a source list,
28 to any other person or public body.

29 (2) A public body having custody, possession or control of any list that may be used as a source
30 list for preparation of a master jury list, upon written request by the State Court Administrator,
31 shall make its list available at any reasonable time and, except as otherwise provided in ORS
32 802.260, without charge to the State Court Administrator for inspection or copying. The public
33 body, upon written request by the State Court Administrator, shall provide a copy of its list for the
34 date and in the form requested to the State Court Administrator. Except as otherwise provided in
35 ORS 802.260, the copy shall be provided without charge.

19 from the latest jury list sources. The jury list sources are the elector registration list for the dis-

34 list of active electors, as described in ORS 247.013, of the county. **Except as provided in this**
35 **section**, the list shall contain the name, party affiliation, residence or mailing address and precinct
36 name or number of each active elector and shall be arranged in groups by election precinct. **The**
37 **list may not contain any information about participants in the Address Confidentiality Pro-**
38 **gram established under ORS 192.820 to 192.868.** A major political party or its affiliate within the
39 county or a minor political party may make no more than two separate requests under this sub-

26 (3) An odometer disclosure in a form determined by the department by rule pursuant to ORS

30 eral heavy vehicle use tax, proof that the federal use tax has been paid. The department shall adopt

33 (a) That the applicant is domiciled in this state as described in ORS 803.355 if the applicant is
34 required by ORS 803.360 to be domiciled in this state in order to register a vehicle in the state; and

35 (b) That so long as the vehicle remains registered to the applicant in this state, the applicant
36 will remain domiciled in this state if required to do so in order to register the vehicle.

38 (a) That the vehicle qualifies under ORS 803.360 (2) for registration in this state, if the owner

4 805.320. Application for registration described under ORS 805.300 shall be made in a form pre-
5 scribed by the Department of Transportation and certified to by the applicant and shall include all
6 of the following:

7 (1) The name and residence or business address of the applicant, **except as provided for Ad-
8 dress Confidentiality Program participants in section 11 of this 2007 Act.**

9 (2) The township and number of acres as shown on the latest county real property tax state-
10 ments of one or more of the farms, orchards or ranches upon which the motor vehicle sought to be
11 registered is to be used.

12 (3) The type and amount of agricultural commodities, agricultural products or livestock
13 produced annually on one or more of the farms, orchards or ranches upon which the motor vehicle
14 sought to be registered is to be used.

15 (4) The number of trucks used on the one or more farms, orchards or ranches upon which the
16 motor vehicle sought to be registered is to be used and the combined weight of the motor vehicle
17 sought to be registered.

18 (5) A statement that any motor vehicle registered under ORS 805.300:

19 (a) Will be used for one or more of the purposes specified under ORS 805.390.

20 (b) Will not be used, at any time while registered under ORS 805.300, for any other purpose or
21 for the transportation of any other commodities or products for hire except as provided under ORS
22 825.024.

23 (c) Is needed in the operation of the one or more farms, orchards or ranches upon which the
24 motor vehicle sought to be registered is to be used.

25 (6) Any other information required by the department.

26 (7) Additional information required by law or by the department in making an application for
27 regular registration for the motor vehicle.

28 (8) The application shall contain a declaration that it is made under penalties for false certif-
29 ication. Violation of this subsection is subject to penalties under ORS 805.370.

30 **SECTION 20. This 2007 Act being necessary for the immediate preservation of the public
31 peace, health and safety, an emergency is declared to exist, and this 2007 Act takes effect
32 on its passage.**
