**SUMMARY**

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Makes technical changes to Public Contracting Code.  
**Modifies provisions governing prevailing wage rates.**  
**Declares emergency, effective July 1, 2007.**

2 Relating to the Public Contracting Code; creating new provisions; amending ORS 279A.010,

8 **Be It Enacted by the People of the State of Oregon:**

9 **SECTION 1.** ORS 279A.010 is amended to read:

10 279A.010. (1) As used in the Public Contracting Code, unless the context or a specifically ap-  
11 plicable definition requires otherwise:

12 (a) "Bidder" means a person that submits a bid in response to an invitation to bid.

13 (b) "Contracting agency" means a public body authorized by law to conduct a procurement.  
14 "Contracting agency" includes, but is not limited to, the Director of the Oregon Department of Ad-  
15 ministrative Services and any person authorized by a contracting agency to conduct a procurement  
16 on the contracting agency's behalf. "Contracting agency" does not include the judicial department  
17 or the legislative department.

18 (c) "Days" means calendar days.

19 (d) "Department" means the Oregon Department of Administrative Services.

20 (e) "Director" means the Director of the Oregon Department of Administrative Services or a  
21 person designated by the director to carry out the authority of the director under the Public Con-  
22 tracting Code.

23 (f) "Emergency" means circumstances that:

24 (A) Could not have been reasonably foreseen;

25 (B) Create a substantial risk of loss, damage or interruption of services or a substantial threat  
26 to property, public health, welfare or safety; and

**NOTE:** Matter in **boldfaced** type in an amended section is new; matter [*italic and bracketed*] is existing law to be omitted.  
New sections are in **boldfaced** type.

1 (C) Require prompt execution of a contract to remedy the condition.

2 (g) "Energy savings performance contract" means a public contract between a contracting  
3 agency and a qualified energy service company for the identification, evaluation, recommendation,  
4 design and construction of energy conservation measures, including a design-build contract, that  
5 guarantee energy savings or performance.

6 (h) "Executive department" has the meaning given that term in ORS 174.112.

7 (i) **"Goods" includes supplies, equipment, materials, personal property, including any**  
8 **tangible, intangible and intellectual property and rights and licenses in relation thereto, and**  
9 **combinations of any of the items identified in this paragraph.**

10 (j) **"Goods and services" or "goods or services" includes combinations of any of the items**  
11 **identified in the definitions of "goods" and "services."**

12 [(i)(A)] (k)(A) "Grant" means:

13 (i) An agreement under which a contracting agency receives moneys, property or other assist-  
14 ance, including but not limited to federal assistance that is characterized as a grant by federal law  
15 or regulations, loans, loan guarantees, credit enhancements, gifts, bequests, commodities or other  
16 assets, from a grantor for the purpose of supporting or stimulating a program or activity of the  
17 contracting agency and in which no substantial involvement by the grantor is anticipated in the  
18 program or activity other than involvement associated with monitoring compliance with the grant  
19 conditions; or

20 (ii) An agreement under which a contracting agency provides moneys, property or other assist-  
21 ance, including but not limited to federal assistance that is characterized as a grant by federal law  
22 or regulations, loans, loan guarantees, credit enhancements, gifts, bequests, commodities or other  
23 assets, to a recipient for the purpose of supporting or stimulating a program or activity of the re-  
24 cipient and in which no substantial involvement by the contracting agency is anticipated in the  
25 program or activity other than involvement associated with monitoring compliance with the grant  
26 conditions.

27 (B) "Grant" does not include a public contract for a public improvement, for public works, as  
28 defined in ORS 279C.800, or for emergency work, minor alterations or ordinary repair or mainte-  
29 nance necessary to preserve a public improvement, when under the public contract a contracting  
30 agency pays, in consideration for contract performance intended to realize or to support the real-  
31 ization of the purposes for which grant funds were provided to the contracting agency, moneys that  
32 the contracting agency has received under a grant.

33 [(j)] (L) "Industrial oil" means any compressor, turbine or bearing oil, hydraulic oil, metal-  
34 working oil or refrigeration oil.

35 [(k)] (m) "Judicial department" has the meaning given that term in ORS 174.113.

36 [(L)] (n) "Legislative department" has the meaning given that term in ORS 174.114.

37 [(m)] (o) "Local contract review board" means a local contract review board described in ORS  
38 279A.060.

39 [(n)] (p) "Local contracting agency" means a local government or special government body au-  
40 thorized by law to conduct a procurement. "Local contracting agency" includes any person author-  
41 ized by a local contracting agency to conduct a procurement on behalf of the local contracting  
42 agency.

43 [(o)] (q) "Local government" has the meaning given that term in ORS 174.116.

44 [(p)] (r) "Lowest responsible bidder" means the lowest bidder who:

45 (A) Has substantially complied with all prescribed public contracting procedures and require-

1 ments;

2 (B) Has met the standards of responsibility set forth in ORS 279B.110 or 279C.375;

3 (C) Has not been debarred or disqualified by the contracting agency under ORS 279B.130 or  
4 279C.440; and

5 (D) If the advertised contract is a public improvement contract, is not on the list created by the  
6 Construction Contractors Board under ORS 701.227.

7 [(q)] (s) “Lubricating oil” means any oil intended for use in an internal combustion crankcase,  
8 transmission, gearbox or differential or an automobile, bus, truck, vessel, plane, train, heavy equip-  
9 ment or machinery powered by an internal combustion engine.

10 [(r)] (t) “Person” means a natural person capable of being legally bound, a sole proprietorship,  
11 a corporation, a partnership, a limited liability company or partnership, a limited partnership, a  
12 for-profit or nonprofit unincorporated association, a business trust, two or more persons having a  
13 joint or common economic interest, any other person with legal capacity to contract or a public  
14 body.

15 [(s)] (u) “Post-consumer waste” means a finished material that would normally be disposed of  
16 as solid waste, having completed its life cycle as a consumer item. “Post-consumer waste” does not  
17 include manufacturing waste.

18 [(t)] (v) “Price agreement” means a public contract for the procurement of goods or services at  
19 a set price with:

20 (A) No guarantee of a minimum or maximum purchase; or

21 (B) An initial order or minimum purchase combined with a continuing contractor obligation to  
22 provide goods or services in which the contracting agency does not guarantee a minimum or maxi-  
23 mum additional purchase.

24 [(u)] (w) “Procurement” means the act of purchasing, leasing, renting or otherwise acquiring  
25 goods or services. “Procurement” includes each function and procedure undertaken or required to  
26 be undertaken by a contracting agency to enter into a public contract, administer a public contract  
27 and obtain the performance of a public contract under the Public Contracting Code.

28 [(v)] (x) “Proposer” means a person that submits a proposal in response to a request for pro-  
29 posals.

30 [(w)] (y) “Public body” has the meaning given that term in ORS 174.109.

31 [(x)] (z) “Public contract” means a sale or other disposal, or a purchase, lease, rental or other  
32 acquisition, by a contracting agency of personal property, services, including personal services,  
33 public improvements, public works, minor alterations, or ordinary repair or maintenance necessary  
34 to preserve a public improvement. “Public contract” does not include grants.

35 [(y)] (aa) “Public contracting” means procurement activities described in the Public Contracting  
36 Code relating to obtaining, modifying or administering public contracts or price agreements.

37 [(z)] (bb) “Public Contracting Code” or “code” means ORS chapters 279A, 279B and 279C.

38 [(aa)] (cc) “Public improvement” means a project for construction, reconstruction or major ren-  
39 ovation on real property by or for a contracting agency. “Public improvement” does not include:

40 (A) Projects for which no funds of a contracting agency are directly or indirectly used, except  
41 for participation that is incidental or related primarily to project design or inspection; or

42 (B) Emergency work, minor alteration, ordinary repair or maintenance necessary to preserve a  
43 public improvement.

44 [(bb)] (dd) “Public improvement contract” means a public contract for a public improvement.  
45 “Public improvement contract” does not include a public contract for emergency work, minor al-

1 terations, or ordinary repair or maintenance necessary to preserve a public improvement.

2 [(cc)] (ee) "Recycled material" means any material that would otherwise be a useless, unwanted  
3 or discarded material except for the fact that the material still has useful physical or chemical  
4 properties after serving a specific purpose and can, therefore, be reused or recycled.

5 [(dd)] (ff) "Recycled oil" means used oil that has been prepared for reuse as a petroleum product  
6 by refining, rerefining, reclaiming, reprocessing or other means, provided that the preparation or  
7 use is operationally safe, environmentally sound and complies with all laws and regulations.

8 [(ee)] (gg) "Recycled paper" means a paper product with not less than:

9 (A) Fifty percent of its fiber weight consisting of secondary waste materials; or

10 (B) Twenty-five percent of its fiber weight consisting of post-consumer waste.

11 [(ff)] (hh) "Recycled PETE" means post-consumer polyethylene terephthalate material.

12 [(gg)] (ii) "Recycled product" means all materials, goods and supplies, not less than 50 percent  
13 of the total weight of which consists of secondary and post-consumer waste with not less than 10  
14 percent of its total weight consisting of post-consumer waste. "Recycled product" includes any  
15 product that could have been disposed of as solid waste, having completed its life cycle as a con-  
16 sumer item, but otherwise is refurbished for reuse without substantial alteration of the product's  
17 form.

18 [(hh)] (jj) "Secondary waste materials" means fragments of products or finished products of a  
19 manufacturing process that has converted a virgin resource into a commodity of real economic  
20 value. "Secondary waste materials" includes post-consumer waste. "Secondary waste materials"  
21 does not include excess virgin resources of the manufacturing process. For paper, "secondary waste  
22 materials" does not include fibrous waste generated during the manufacturing process such as fibers  
23 recovered from waste water or trimmings of paper machine rolls, mill broke, wood slabs, chips,  
24 sawdust or other wood residue from a manufacturing process.

25 **(kk) "Services" mean services other than personal services designated under ORS**  
26 **279A.055, except that, for state contracting agencies with procurement authority under ORS**  
27 **279A.050 or 279A.140, "services" includes personal services as designated by the state con-**  
28 **tracting agencies.**

29 [(ii)] (LL) "Special government body" has the meaning given that term in ORS 174.117.

30 [(jj)] (mm) "State agency" means the executive department, except the Secretary of State and  
31 the State Treasurer in the performance of the duties of their constitutional offices.

32 [(kk)] (nn) "State contracting agency" means an executive department entity authorized by law  
33 to conduct a procurement.

34 [(LL)] (oo) "State government" has the meaning given that term in ORS 174.111.

35 [(mm)] (pp) "Used oil" has the meaning given that term in ORS 459A.555.

36 [(nn)] (qq) "Virgin oil" means oil that has been refined from crude oil and that has not been  
37 used or contaminated with impurities.

33 vate counsel or special legal assistants;

34 [(k)] **(L)** Contracts for the sale of timber from lands owned or managed by the State Board of  
35 Forestry and the State Forestry Department;

36 [(L)] **(m)** Contracts for forest protection or forest related activities, as described in ORS 477.406,  
37 by the State Forester or the State Board of Forestry;

2 agreements, bond documents, certificates of participation and other debt repayment agreements, and  
3 any associated contracts, agreements and documents, regardless of whether the obligations that the  
4 contracts, agreements or documents establish are general, special or limited, except that the State  
5 Treasurer's public contracting for goods and services[, as defined in ORS 279B.005,] is subject to  
6 ORS chapter 279B;

7 [(p)] (q) Contracts, agreements or other documents entered into, issued or established in con-  
8 nection with:

9 (A) The incurring of debt by a public body, including but not limited to the issuance of bonds,  
10 certificates of participation and other debt repayment obligations, and any associated contracts,  
11 agreements or other documents, regardless of whether the obligations that the contracts, agreements  
12 or other documents establish are general, special or limited;

13 (B) The making of program loans and similar extensions or advances of funds, aid or assistance  
14 by a public body to a public or private body for the purpose of carrying out, promoting or sustaining  
15 activities or programs authorized by law; or

16 (C) The investment of funds by a public body as authorized by law, and other financial trans-  
17 actions of a public body that by their character cannot practically be established under the com-  
18 petitive contractor selection procedures of ORS 279B.050 to 279B.085;

19 [(q)] (r) Contracts for employee benefit plans as provided in ORS 243.105 (1), 243.125 (4), 243.221,  
20 243.275, 243.291, 243.303 and 243.565; or

21 [(r)] (s) Any other public contracting of a public body specifically exempted from the code by  
22 another provision of law.

23 (3) The Public Contracting Code does not apply to the [public] contracting activities of:

24 (a) The Oregon State Lottery Commission;

25 (b) The Oregon University System and member institutions, except as provided in ORS 351.086;

26 (c) The legislative department;

27 (d) The judicial department;

28 (e) Semi-independent state agencies listed in ORS 182.451 and 182.454, except as provided in ORS  
29 279.835 to 279.855 and 279A.250 to 279A.290;

30 (f) Oregon Corrections Enterprises;

31 (g) The Oregon Film and Video Office, except as provided in ORS 279A.100 and 279A.250 to  
32 279A.290;

33 (h) The Travel Information Council, except as provided in ORS 279A.250 to 279A.290;

34 (i) The Oregon 529 College Savings Network and the Oregon 529 College Savings Board;

35 (j) The Oregon Innovation Council; [or]

36 **(k) The Oregon Utility Notification Center; or**

39 qualified nonprofit agencies providing employment opportunities for disabled individuals under ORS

41 **SECTION 3.** ORS 279A.050 is amended to read:

42 279A.050. [(1)] (1)(a) Except as otherwise provided in the Public Contracting Code, a contracting  
43 agency shall exercise all [rights, powers and] **procurement** authority in accordance with the pro-  
44 visions of the Public Contracting Code.

45 **(b) When a contracting agency has authority under this section to carry out functions**



1 **described in this section, or has authority to make procurements under a provision of law**  
2 **other than the Public Contracting Code, the contracting agency is not required to exercise**  
3 **that authority in accordance with the provisions of the code if, under ORS 279A.025, the code**  
4 **does not apply to the contract or contracting authority.**

5 (2) Except as otherwise provided in the Public Contracting Code, for state agencies the Director  
6 of the Oregon Department of Administrative Services has all *[of the rights, powers and]* **the** au-  
7 thority *[necessary]* to carry out the provisions of the Public Contracting Code.

8 (3) Except as otherwise provided in the Public Contracting Code, the Director of Transportation  
9 has all *[of the rights, powers and]* **the** authority to:

10 (a) Procure or supervise the procurement of all services and personal services to construct, ac-  
11 quire, plan, design, maintain and operate passenger terminal facilities and motor vehicle parking  
12 facilities in connection with any public transportation system in accordance with ORS 184.689 (5);

13 (b) Procure or supervise the procurement of all goods, services, public improvements and per-  
14 sonal services relating to the operation, maintenance or construction of highways, bridges and other  
15 transportation facilities that are subject to the authority of the Department of Transportation; and

16 (c) Establish standards for, prescribe forms for and conduct the prequalification of prospective  
17 bidders on public improvement contracts related to the operation, maintenance or construction of  
18 highways, bridges and other transportation facilities that are subject to the authority of the De-  
19 partment of Transportation.

20 (4) Except as otherwise provided in the Public Contracting Code, the Secretary of State has all  
21 *[of the rights, powers and]* **the** authority to procure or supervise the procurement of goods, services  
22 and personal services related to programs under the *[direct]* authority of the Secretary of State.

23 (5) Except as otherwise provided in the Public Contracting Code, the State Treasurer has all  
24 *[of the rights, powers and]* **the** authority to procure or supervise the procurement of goods, services  
25 and personal services related to programs under the authority of the State Treasurer.

26 *[(6) The following specific limited authorities are subject to the provisions of the Public Contracting*  
27 *Code:]*

34 (B) For the purpose of providing care to individuals with mental retardation or other develop-  
35 mental disabilities, subject to applicable provisions of ORS 427.335;

36 *[(b) The State Department of Fish and Wildlife to procure or supervise the procurement of all*  
37 *goods, services, public improvements and personal services relating to dams, fishways, ponds and re-*  
38 *lated fish and game propagation facilities;]*

39 **(b) The State Department of Fish and Wildlife to procure or supervise the procurement**  
40 **of construction materials, equipment, supplies, services and personal services for public im-**  
41 **provements, public works or ordinary construction described in ORS 279C.320 that is subject**  
42 **to the authority of the State Department of Fish and Wildlife;**

43 (c) The State Parks and Recreation Department to procure or supervise the procurement of all  
44 goods, services, public improvements and personal services relating to state parks;

45 *[(d) The Oregon Department of Aviation to procure or supervise the procurement of all goods,*

1 *services, public improvements and personal services related to airports owned or operated by the*  
2 *state;]*

3 **(d) The Oregon Department of Aviation to procure or supervise the procurement of**  
4 **construction materials, equipment, supplies, services and personal services for public im-**  
5 **provements, public works or ordinary construction described in ORS 279C.320 that is subject**  
6 **to the authority of the Oregon Department of Aviation;**

7 (e) The Economic and Community Development Department to procure or supervise the pro-  
8 curement of all goods, services, personal services and public improvements related to its foreign  
9 trade offices operating outside the state;

10 *[(f) The Attorney General to enter into contracts as necessary to exercise the authority granted in*  
11 *ORS chapter 180;]*

12 *[(g)]* **(f) The Housing and Community Services Department to procure or supervise the procure-**  
13 **ment of goods, services and personal services as provided in ORS 279A.025 (2)(o);**

14 *[(h) The Department of Corrections to procure or supervise the procurement of goods, services and*  
15 *personal services for the construction of all new buildings or additions for its institutions;]*

16 **(g) The Department of Corrections to procure or supervise the procurement of con-**  
17 **struction materials, equipment, supplies, services and personal services for public improve-**  
18 **ments, public works or ordinary construction described in ORS 279C.320 that is subject to**  
19 **the authority of the Department of Corrections;**

20 *[(i)]* **(h) The Department of Corrections, subject to any applicable provisions of ORS 279A.120,**  
21 **279A.125, 279A.145 and 283.110 to 283.395, to procure or supervise the procurement of goods for its**  
22 **institutions;**

23 *[(j)]* **(i) The Department of Veterans' Affairs to procure or supervise the procurement of real**  
24 **estate broker and principal real estate broker services related to programs under the department's**  
25 **authority; [and]**

26 **(j) The Oregon Military Department to procure or supervise the procurement of con-**  
27 **struction materials, equipment, supplies, services and personal services for public improve-**  
28 **ments, public works or ordinary construction described in ORS 279C.320 that is subject to**  
29 **the authority of the Oregon Military Department; and**

30 (k) Any state agency to *[make procurements]* **conduct a procurement** when the agency is spe-  
31 cifically authorized by any provision of law other than the Public Contracting Code to enter into a  
32 contract.

33 **(7) Notwithstanding this section and ORS 279A.140 (1), the Director of the Oregon De-**  
34 **partment of Administrative Services has exclusive authority to procure or supervise the**  
35 **procurement of all state agency information technology contracts and all price agreements**  
36 **on behalf of the state agencies identified in subsection (6)(a) to (j) of this section under which**  
37 **more than one state agency may order goods, services or personal services unless the di-**  
38 **rector delegates this authority. This subsection does not apply to contracts under which the**  
39 **contractor delivers to the state agency information technology products or services inci-**  
40 **idental to the performance of personal services contracts described in ORS chapter 279C or**  
41 **construction contracts described in ORS chapter 279C. A state agency identified in sub-**  
42 **section (3) or (6)(a) to (j) of this section may not establish a price agreement or enter into**

1 279A.200. (1) As used in ORS 279A.200 to 279A.225:

2 (a) "Administering contracting agency" means a [*contracting agency*] **governmental body in**  
3 **this state or in another jurisdiction** that solicits and establishes the original contract for **the**  
4 procurement of goods, services or public improvements in a cooperative procurement.

5 (b) "Cooperative procurement" means a procurement conducted [*by or*] on behalf of [*one or*]  
6 more [*contracting agencies*] **than one governmental body**. "Cooperative procurement" includes but  
7 is not limited to [*multiparty*] **multiagency** contracts and price agreements. "**Cooperative procure-**  
8 **ment**" **does not include an agreement formed among only governmental bodies under ORS**  
9 **chapter 190 or by a statute, charter provision, ordinance or other authority for establishing**  
10 **agreements between or among governmental bodies or agencies or tribal governing bodies**  
11 **or agencies**.

40 may make or authorize others to make emergency procurements of goods or services in an emer-  
41 gency. The contracting agency shall document the nature of the emergency and describe the method

9 a series of contracts over time [*for the acquisition of a specified class of goods or services*] **or for**  
10 **multiple projects.**

11 (b) "Contract-specific special procurement" means a contracting procedure that differs from the  
12 procedures described in ORS 279B.055, 279B.060, 279B.065 and 279B.070 and is for the purpose of  
13 entering into a single contract or a number of related contracts [*for the acquisition of specified goods*  
14 *or services*] on a one-time basis or for a single project.

15 (c) "Special procurement" means, unless the context requires otherwise, a class special pro-  
16 curement, a contract-specific special procurement or both.

17 (2) Except as provided in subsection (3) of this section, to seek approval of a special procure-  
18 ment, a contracting agency shall submit a written request to the Director of the Oregon Department  
19 of Administrative Services or the local contract review board, as applicable, that describes the  
20 [*proposed*] contracting procedure, the goods or services or the class of goods or services [*to be ac-*  
21 *quired through*] **that are the subject of** the special procurement and the circumstances that justify

7 279B.130. (1)(a) A contracting agency may debar a prospective bidder or proposer from consid-  
8 eration for award of the contracting agency's contracts for the reasons listed in subsection (2) of

11 (b) A contracting agency may not debar a prospective bidder or proposer under this section for

27 **serious as to justify disqualification.** A violation may include but is not limited to a failure to  
28 perform the terms of a contract or an unsatisfactory performance in accordance with the terms of

45 (1) "Brand name or equal specification" means a specification that uses one or more manufac-

1 turers' names, makes, catalog numbers or similar identifying characteristics to describe the standard  
2 of quality, performance, functionality or other characteristics needed to meet the contracting agency's  
3 requirements and that authorizes bidders or proposers to offer goods or services that are  
4 equivalent or superior to those named or described in the specification.

6 names, makes, manufacturer's names, catalog numbers or similar identifying characteristics.

7 (3) "Specification" means any description of the physical or functional characteristics of, or of

9 a description of any requirement for inspecting, testing or preparing goods or services for delivery.  
10 When a solicitation required or authorized by ORS 279B.050 (4) **or** (5) to be conducted under ORS  
11 279B.055 or 279B.060 calls in whole or in part for the performance of personal services as designated  
12 under ORS 279A.055, "specification" also includes any description of the characteristics or nature  
13 of the personal services.

14 **SECTION 10.** ORS 279B.270 is amended to read:

15 279B.270. (1) A state contracting agency procuring goods[, *materials, equipment*] or personal  
16 services shall:

17 (a) Review the contracting agency's current procurement specifications in order to eliminate,  
18 wherever economically feasible, discrimination against the procurement of recovered resources or  
19 recycled materials.

20 (b) Provide incentives, wherever economically feasible, in all procurement specifications issued  
21 by the contracting agency for the maximum possible use of recovered resources and recycled mate-  
22 rials.

23 (c) Develop procurement practices that, to the maximum extent economically feasible, ensure the  
24 procurement of materials that are recycled or that may be recycled or reused when discarded.

25 (d) Establish management practices that minimize the volume of solid waste generated by reus-

27 consumed and discarded.

28 (e) Use, or require persons with whom the contracting agency contracts to use in the perform-  
29 ance of the contract work, to the maximum extent economically feasible, recycled paper and recy-

31 (2) An invitation to bid or a request for proposals issued by a state contracting agency under  
32 this chapter shall include the following language: "Vendors shall use recyclable products to the

36 tablished by rule by the Oregon Department of Administrative Services.

37 **SECTION 11.** ORS 279B.405 is amended to read:

38 279B.405. (1) As used in this section:

39 (a) "Brand name" means a brand name specification as defined in ORS 279B.200.

40 (b) "Legally flawed" means that a solicitation document contains terms or conditions that are  
41 contrary to law.

42 (c) "Unnecessarily restrictive" means that specifications limit competition arbitrarily, without  
43 reasonably promoting the fulfillment of the procurement needs of a contracting agency.

44 [(2)(a)] (2) A prospective bidder, proposer or offeror for a public contract solicited under ORS  
45 279B.055, 279B.060 or 279B.085 may file a protest with the contracting agency if the prospective

1 bidder, proposer or offeror believes that the procurement process is contrary to law or that a so-  
2 licitation document is unnecessarily restrictive, is legally flawed or improperly specifies a brand  
3 name. If a prospective bidder, proposer or offeror fails to timely file such a protest, the prospective  
4 bidder, proposer or offeror may not challenge the contract on grounds under this subsection in any  
5 future legal or administrative proceeding.

6 *[(b) Notwithstanding paragraph (a) of this subsection, a contract-specific special procurement under*  
7 *ORS 279B.085 may not be protested, challenged or reviewed unless the approval of the special pro-*  
8 *curement by the Director of the Oregon Department of Administrative Services or a local contract re-*  
9 *view board, as applicable, has been invalidated by a reviewing circuit court under ORS 279B.400.]*

10 (3) The contracting agency, pursuant to rules adopted under ORS 279A.065, shall notify pro-  
11 spective bidders, proposers or offerors of the time and manner in which a protest under this section  
12 may be filed and considered. Before seeking judicial review, a prospective bidder, proposer or offeror  
13 must file a protest with the contracting agency and exhaust all available administrative remedies.

14 (4) The contracting agency shall consider the protest if the protest is timely filed and contains  
15 the following:

16 (a) Sufficient information to identify the solicitation that is the subject of the protest;

17 (b) The grounds that demonstrate how the procurement process is contrary to law or how the  
18 solicitation document is unnecessarily restrictive, is legally flawed or improperly specifies a brand  
19 name;

20 (c) Evidence or supporting documentation that supports the grounds on which the protest is  
21 based; and

22 (d) The relief sought.

23 (5) If the protest meets the requirements of subsection (4) of this section, the contracting agency  
24 shall consider the protest and issue a decision in writing. Otherwise, the contracting agency shall  
25 promptly notify the prospective bidder, proposer or offeror that the protest is untimely or that the  
26 protest failed to meet the requirements of subsection (4) of this section and give the reasons for the  
27 failure.

28 (6) The contracting agency shall issue a decision on the protest in accordance with rules  
29 adopted under ORS 279A.065 no *[less]* **fewer** than three business days before bids, proposals or offers  
30 are due, unless a written determination is made by the agency that circumstances exist that  
31 *[require]* **justify** a shorter time limit.

32 (7) A decision of a contracting agency on a protest under this section, including a protest of a  
33 special procurement, is subject to judicial review only if the *[suit]* **action** or writ of review is filed  
34 before the opening of bids, proposals or offers.

35 (8)(a) A decision of a state contracting agency on a protest under this section is reviewable by  
36 the Circuit Court for Marion County or the circuit court for the county in which the principal of-  
37 fices of the state contracting agency are located.

38 (b) A decision of a local contracting agency on a protest under this section is reviewable by the  
39 circuit court for the county in which the principal offices of the local contracting agency are lo-  
40 cated.

41 (9) If judicial review of a contracting agency's decision on a protest under this section is sought,  
42 the contracting agency may not proceed with contract execution unless the contracting agency de-  
43 termines that there is a compelling governmental interest in proceeding or that the goods and ser-  
44 vices are urgently needed. If the contracting agency makes such a determination, the contracting  
45 agency shall set forth the reasons for the determination in writing and immediately provide them



1 to the prospective bidder, proposer or offeror that filed the protest. Thereafter, after joining the  
2 contractor as a party to the litigation and upon motion from the person filing the protest, the court  
3 may nonetheless stay the performance of the contract if the court finds that the contracting agen-  
4 cy's determination of the existence of a compelling governmental interest in proceeding with con-  
5 tract execution, or the contracting agency's determination that the goods or services were urgently  
6 needed, was not supported by substantial evidence or constituted a manifest abuse of discretion. In  
7 granting a stay, the court may require the person seeking the stay to post a bond in an amount  
8 sufficient to protect the contracting agency and the public from costs associated with delay in con-  
9 tract performance.

10 (10) In its review, the court shall give due deference to any factual decision made by the con-  
11 tracting agency and may not substitute its judgment for that of the contracting agency, but shall  
12 review all questions of law de novo. Thereafter:

13 (a) If a contract has not been executed and the court rules in favor of the party that sought  
14 judicial review, the court shall remand the procurement process to the contracting agency for a  
15 determination of whether and how to continue with the procurement process in light of the court's  
16 decision.

18 been executed, the court shall include in its order a determination whether the party that signed  
19 the contract with the contracting agency is entitled to reimbursement under the conditions of, and

27 proposers who submit proposals the agency has determined to be closely competitive or to have a  
28 reasonable chance of being selected for award. The discussions may be conducted for the purpose  
29 of clarification to ensure full understanding of, and responsiveness to, the solicitation requirements.  
30 The contracting agency shall accord proposers fair and equal treatment with respect to any oppor-  
31 tunity for discussion and revision of proposals. Revisions of proposals may be permitted after the

3 of wage and, if applicable, the federal prevailing rate of wage required under the Davis-Bacon Act

5 works employed in the performance of the contract either by the contractor or subcontractor or  
6 other person doing or contracting to do the whole or any part of the work contemplated by the

36           279C.836. (1) Except as provided in subsection **(4)**, **(7)** or **(8)** of this section, before starting work  
37 on a contract or subcontract for a public works project, a contractor or subcontractor shall file with  
38 the Construction Contractors Board a public works bond with a corporate surety authorized to do  
39 business in this state in the amount of \$30,000. The bond must provide that the contractor or sub-  
40 contractor will pay claims ordered by the Bureau of Labor and Industries to workers performing  
41 labor upon public works projects. The bond must be a continuing obligation, and the surety's li-  
42 ability for the aggregate of claims that may be payable from the bond may not exceed the penal sum  
43 of the bond. The bond must remain in effect continuously until depleted by claims paid under this  
44 section, unless the surety sooner cancels the bond. The surety may cancel the bond by giving 30

1 and Industries. When the bond is canceled, the surety is relieved of further liability for work per-  
2 formed on contracts entered into after the cancellation. The cancellation does not limit the surety's  
3 liability for work performed on contracts entered into before the cancellation.

4 (2) Before permitting a subcontractor to start work on a public works project, the contractor  
5 shall verify that the subcontractor has filed a public works bond as required under this section,  
6 [or] has elected not to file a public works bond under subsection (7) of this section **or is exempt**  
7 **under subsection (4) or (8) of this section.**

8 (3) A contractor or subcontractor is not required under this section to file a separate public  
9 works bond for each public works project for which the contractor or subcontractor has a contract.

10 (4) A person that is not required under ORS 279C.800 to 279C.870 to pay prevailing rates of  
11 wage on a public works project is not required to file a public works bond under this section.

12 (5) A public works bond required by this section is in addition to any other bond the contractor  
13 or subcontractor is required to obtain.

14 (6) The board may, by rule, require a contractor or subcontractor to obtain a new public works  
15 bond if a surety pays a claim out of an existing public works bond. The new bond must be in the  
16 amount of \$30,000. The board may allow a contractor or subcontractor to obtain, instead of a new  
17 bond, a certification that the surety remains liable for the full penal sum of the existing bond,

41 rules necessary to perform the duties required of the board by this section.

42 (10) The Commissioner of the Bureau of Labor and Industries, with approval of the board, shall  
43 adopt rules that establish language for public works bonds.

44 **SECTION 39.** ORS 279C.870 is amended to read:

45 279C.870. (1) The Commissioner of the Bureau of Labor and Industries or any other person may

1 bring a civil action in any court of competent jurisdiction to require a public agency under a public  
2 contract with a contractor to withhold twice the wages in dispute if it is shown that the contractor  
3 or subcontractor on the contract has intentionally failed or refused to pay the prevailing rate of  
4 wage to workers employed on that contract and to require the contractor to pay the prevailing rate  
5 of wage and any deficiencies that can be shown to exist because of improper wage payments already  
6 made. In addition to other relief, the court may also enjoin the contractor or subcontractor from  
7 committing future violations. The contractor or subcontractor involved shall be named as a party  
8 in all civil actions brought under this section. In addition to other costs, the court may award the  
9 prevailing party reasonable attorney fees at the trial and on appeal. However, attorney fees may  
10 not [may] be awarded against the commissioner under this section.

11 (2) The court shall require any party, other than the commissioner, that brings a civil action  
12 under this section to post a bond sufficient to cover the estimated attorney fees and costs to the  
13 public agency and to the contractor or subcontractor of any temporary restraining order, prelimi-  
14 nary injunction or permanent injunction awarded in the action, in the event that the party bringing  
15 the action does not ultimately prevail.

16 (3) In addition to any other relief, the court in a civil action brought under this section may  
17 enjoin the public agency from contracting with the contractor or subcontractor if the court finds  
18 that the commissioner would be entitled to place the contractor or subcontractor on the ineligible  
19 list established under ORS 279C.860 (1). If the court issues such an injunction, the commissioner  
20 shall place the contractor or subcontractor on the list for a period of three years, subject to the  
21 provision of ORS 279C.860 (2).

22 **SECTION 40. Section 41 of this 2007 Act is added to and made a part of ORS 279C.100 to**  
23 **279C.125.**

24 **SECTION 41. (1) Notwithstanding the public records law, ORS 192.410 to 192.505, if a**  
25 **contracting agency solicits a contract for architectural, engineering or land surveying ser-**  
26 **vices or related services by a competitive proposal:**

27 **(a) Proposals may be opened so as to avoid disclosure of contents to competing proposers**  
28 **during, when applicable, the process of negotiation.**

29 **(b) Proposals are not required to be open for public inspection until after the notice of**  
30 **intent to award a contract is issued.**

31 **(2) Notwithstanding any requirement to make proposals open to public inspection after**  
32 **the contracting agency's issuance of notice of intent to award a contract, a contracting**  
33 **agency may withhold from disclosure to the public trade secrets, as defined in ORS 192.501,**  
34 **and information submitted to a public body in confidence, as described in ORS 192.502, that**  
35 **are contained in a proposal. The fact that proposals are opened at a public meeting as defined**  
36 **in ORS 192.610 does not make their contents subject to disclosure, regardless of whether the**  
37 **public body opening the proposals fails to give notice of or provide for an executive session**  
38 **for the purpose of opening proposals. If a request for proposals is canceled after proposals**  
39 **are received, the contracting agency may return a proposal to the proposer that made the**  
40 **proposal. The contracting agency shall keep a list of returned proposals in the file for the**  
41 **solicitation.**

42 **SECTION 42. Sections 43, 44 and 45 of this 2007 Act are added to and made a part of ORS**  
43 **279C.800 to 279C.870.**

44 **SECTION 43. (1) The Commissioner of the Bureau of Labor and Industries shall, upon the**  
45 **request of a public agency or other interested person, make a determination about whether**

1 a project or proposed project is or would be a public works on which payment of the pre-  
2 vailing rate of wage is or would be required under ORS 279C.840.

3 (2) The requester shall provide the commissioner with information necessary to enable  
4 the commissioner to make the determination.

5 (3) The commissioner shall make the determination within 60 days after receiving the  
6 request or 60 days after the requester has provided the commissioner with the information  
7 necessary to enable the commissioner to make the determination, whichever is later. The  
8 commissioner may take additional time to make the determination if the commissioner and  
9 the requester mutually agree that the commissioner may do so.

10 (4) The commissioner shall afford the requester or a person adversely affected or  
11 aggrieved by the commissioner's determination a hearing in accordance with ORS 183.413 to  
12 183.470. An order the commissioner issues under ORS 183.413 to 183.470 is subject to judicial  
13 review as provided in ORS 183.482.

14 (5) The commissioner shall adopt rules establishing the process for requesting and mak-  
15 ing the determinations described in this section.

16 **SECTION 44.** (1)(a) A public agency may not divide a public works project into more than  
17 one contract for the purpose of avoiding compliance with ORS 279C.800 to 279C.870.

18 (b) When the Commissioner of the Bureau of Labor and Industries determines that a  
19 public agency has divided a public works project into more than one contract for the purpose  
20 of avoiding compliance with ORS 279C.800 to 279C.870, the commissioner shall issue an order  
21 compelling compliance.

22 (c) In making determinations under this subsection, the commissioner shall consider:

23 (A) The physical separation of the project structures;

24 (B) The timing of the work on project phases or structures;

25 (C) The continuity of project contractors and subcontractors working on project parts  
26 or phases;

27 (D) The manner in which the public agency and the contractors administer and imple-  
28 ment the project;

29 (E) Whether a single public works project includes several types of improvements or  
30 structures; and

31 (F) Whether the combined improvements or structures have an overall purpose or func-  
32 tion.

33 (2) If a project is a public works of the type described in ORS 279C.800 (6)(a)(B) or (C),  
34 the commissioner shall divide the project, if appropriate, after applying the considerations  
35 set forth in subsection (1)(c) of this section to separate the parts of the project that include  
36 funds of a public agency or that will be occupied or used by a public agency from the parts  
37 of the project that do not include funds of a public agency and that will not be occupied or  
38 used by a public agency. If the commissioner divides the project, any part of the project that  
39 does not include funds of a public agency and that will not be occupied or used by a public  
40 agency is not subject to ORS 279C.800 to 279C.870.

41 (3) If a project includes parts that are owned by a public agency and parts that are owned  
42 by a private entity, the commissioner shall divide the project, if appropriate, after applying  
43 the considerations set forth in subsections (1)(c) and (2) of this section to separate the parts  
44 of the project that are public works from the parts of the project that are not public works.  
45 If the commissioner divides the project, parts of the project that are not public works are

1 not subject to ORS 279C.800 to 279C.870.

2 **SECTION 45.** In accordance with applicable provisions of ORS chapter 183, the Commis-  
3 sioner of the Bureau of Labor and Industries shall adopt rules necessary to administer ORS  
4 279C.800 to 279C.870.

5 **SECTION 46.** Section 332a, chapter 794, Oregon Laws 2003, is repealed.

6 **SECTION 47.** (1) Sections 41, 43 and 44 of this 2007 Act, the amendments to ORS 279A.010,  
7 279A.025, 279A.050, 279A.200, 279B.005, 279B.050, 279B.085, 279B.130, 279B.200, 279B.270,  
8 279B.405, 279B.415, 279C.320, 279C.335, 279C.345, 279C.350, 279C.355, 279C.365, 279C.375,  
9 279C.390, 279C.400, 279C.405, 279C.410, 279C.460, 279C.800, 279C.810, 279C.815, 279C.830, 279C.836  
10 and 279C.870 and sections 105, 105b, 110, 113 and 132, chapter 794, Oregon Laws 2003, by  
11 sections 1 to 39 of this 2007 Act and the repeal of section 332a, chapter 794, Oregon Laws  
12 2003, by section 46 of this 2007 Act apply only to public contracts first advertised, but if not  
13 advertised then entered into, on or after the effective date of this 2007 Act.

14 (2) Sections 43 and 44 of this 2007 Act and the amendments to ORS 279C.800, 279C.810,  
15 279C.815 and 279C.830 by sections 34, 35, 36 and 37 of this 2007 Act do not apply to develop-  
16 ment and disposition agreements signed by an urban renewal agency before the effective date  
17 of this 2007 Act in connection with public-private projects for which no contracts for con-  
18 struction are advertised.

19 (3) Sections 43 and 44 of this 2007 Act and the amendments to ORS 279C.800, 279C.810,  
20 279C.815 and 279C.830 by sections 34, 35, 36 and 37 of this 2007 Act do not apply to projects  
21 funded in whole or in part by bonds issued by the State of Oregon if the State Treasurer is-  
22 sues the bonds for the project before the effective date of this 2007 Act.

23 **SECTION 48.** This 2007 Act being necessary for the immediate preservation of the public  
24 peace, health and safety, an emergency is declared to exist, and this 2007 Act takes effect  
25 July 1, 2007.
