

HOUSE AMENDMENTS TO HOUSE BILL 2171

1 On page 2 of the printed bill, delete lines 8 through 12 and insert:

2 “(1) Notwithstanding any other provision of this chapter, a person may sell and ship wine or
3 cider directly to a resident of Oregon only if the person holds a direct shipper permit. The Oregon
4 Liquor Control Commission shall issue a direct shipper permit only to:

5 “(a) A person that holds a license issued by this state or another state that authorizes the
6 manufacture of wine or cider;

7 “(b) A person that holds a license issued by this state or another state that authorizes the sale
8 of wine or cider produced only from grapes or other fruit grown under the control of the person;

9 “(c) A person that holds a license authorizing the sale of wine or cider at retail; or

10 “(d) A nonprofit trade association that holds a temporary sales license under ORS 471.190 and
11 that has a membership primarily composed of persons holding winery licenses issued under ORS
12 471.223 or grower sales privilege licenses issued under ORS 471.227.”.

13 In line 15, delete “manufacturer”.

14 In line 16, delete “manufacturing”.

15 Delete lines 18 through 21 and insert “state, or the application is by a nonprofit trade associ-
16 ation described in subsection (1)(d) of this section, the person or association must pay a \$50 regis-
17 tration fee and maintain a bond or other security described in ORS 471.155 in the minimum amount
18 of \$1,000.

19 “(3) Sales and shipments under a direct shipper permit:

20 “(a) May be made only to a person who is at least 21 years of age;

21 “(b) May be made only for personal use and not for the purpose of resale; and

22 “(c) May not exceed two cases, containing not more than nine liters per case, to any resident
23 per month.”.

24 In line 23, delete the first “in” and insert “of”.

25 In line 32, delete “on or be-”.

26 In line 33, delete “fore the 20th day of each month”.

27 In line 34, delete “during the preceding calendar month” and insert “as required by ORS chapter
28 473”.

29 In line 37, after “request” insert “and shall make those records available to the commission in
30 this state”.

31 In line 45, delete “manufacturing”.

32 On page 3, line 1, delete “pay taxes” and insert “timely pay to the commission all taxes imposed
33 under ORS chapter 473”.

34 In line 4, delete “a manufacturing” and insert “an annual”.

35 In line 5, delete “department” and insert “commission”.

- 1 In line 6, delete “a manufac-” and insert “an annual”.
- 2 In line 7, delete “turing”.
- 3 In line 8, delete “manufacturing”.
- 4 In line 11, delete the second “a” and insert “the”.
- 5 In line 12, delete “manufacture wine or” and insert “hold a direct shipper permit”.
- 6 In line 13, delete “cider”.
