# SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Creates Oregon Healthy Kids Program, which includes private health option to provide health care coverage to children. Imposes duties on Department of Human Services and Office of Private Health Partnerships to carry out program.

Creates grant program in Office of Private Health Partnerships to fund outreach, enrollment and retention activities related to Oregon Healthy Kids Program.

Establishes Private Health Option Program Account. Continuously appropriates moneys in account to Office of Private Health Partnerships for purposes of administering private health option. Establishes Healthy Oregon Kids Program Fund. Continuously appropriates moneys in

Establishes Healthy Oregon Kids Program Fund. Continuously appropriates moneys in fund to Department of Human Services for purposes of Oregon Healthy Kids Program.

Increases cigarette and other tobacco products taxes. Distributes tax revenues from increase to [Private Health Option Program Account, Oregon Health Plan Fund and] Tobacco Use Reduction Account and [to Department of Human Services for physician and health care provider reimbursement rate increases] **Oregon Healthy Kids Program Fund**.

Applies tax increases to cigarette and tobacco products tax reporting periods beginning on or after later of October 1, 2007, or first day of calendar month following effective date of Act. Revises allocation of moneys collected by imposition of certain tax on cigarette distribu-

Revises allocation of moneys collected by imposition of certain tax on cigarette distributors.

Takes effect on 91st day following adjournment sine die.

5 Be It Enacted by the People of the State of Oregon:

# **OREGON HEALTHY KIDS PROGRAM**

9 <u>SECTION 1.</u> Sections 2, 3, 12, 12a and 13 of this 2007 Act are added to and made a part
 10 of ORS chapter 414.

11 <u>SECTION 2.</u> (1) The Oregon Healthy Kids Program is created to provide health care 12 coverage for Oregon's children. The program is composed of:

(a) Medical assistance administered by the Department of Human Services provided to
 children under the state programs funded by Title XIX of the Social Security Act, under the
 Children's Health Insurance Program funded by Title XXI of the Social Security Act and
 under state programs funded by the Legislative Assembly;

(b) A private health option administered by the Office of Private Health Partnerships
 under sections 6 and 7 of this 2007 Act;

1 (c) A statewide Healthy Kids Advice Line; and

2 (d) A statewide Healthy Kids Healthcare Access Line.

3 (2) A child or a person authorized to act on behalf of a child may apply to the Department

of Human Services for a determination of the child's eligibility for the Oregon Healthy Kids
 Program.

6 (3) When an application is received by the department under subsection (2) of this sec-7 tion, the department shall determine whether the child is eligible for medical assistance. The 8 department shall enroll an eligible child in an appropriate medical assistance program re-9 ferred to in subsection (1) of this section.

(4) If the department determines that a child for whom application has been made under
 subsection (2) of this section is not eligible for medical assistance but is eligible for enroll ment in the private health option, the department shall transfer the application to the Office
 of Private Health Partnerships to complete the enrollment process.

(5) The Department of Human Services and the Office of Private Health Partnerships
 shall streamline and simplify the application process for the Oregon Healthy Kids Program,
 by means including the development and implementation of an online application process for
 the program.

18 <u>SECTION 3.</u> (1)(a) Except as provided in subsection (2) of this section, to be eligible for 19 the private health option under sections 6 and 7 of this 2007 Act or for the Children's Health 20 Insurance Program funded by Title XXI of the Social Security Act, a child must be uninsured 21 for a minimum of 60 consecutive days immediately preceding enrollment.

(b) As used in this subsection, "uninsured" means that a person is not enrolled in an unsubsidized or privately funded health benefit plan.

(2) The Department of Human Services may adopt rules specifying exceptions to the re quirement in subsection (1) of this section.

(3) A child is eligible for enrollment in the Children's Health Insurance Program only if
 the household income of the child's family is no more than 200 percent of the federal poverty
 guidelines.

(4) The department shall adopt rules for annually renewing enrollment in the Oregon
 Healthy Kids Program.

31 SECTION 4. ORS 414.025 is amended to read:

414.025. As used in this chapter, unless the context or a specially applicable statutory definition
 requires otherwise:

(1) "Category of aid" means assistance provided by the Oregon Supplemental Income Program,
 temporary assistance for needy families granted under ORS 418.035 to 418.125 or federal Supplemental Security Income payments.

(2) "Categorically needy" means, insofar as funds are available for the category, a person who
 is a resident of this state and who:

39 (a) Is receiving a category of aid.

40 (b) Would be eligible for, but is not receiving a category of aid.

41 (c) Is in a medical facility and, if the person left such facility, would be eligible for a category42 of aid.

(d) Is under the age of 21 years and would be a dependent child under the program for temporary assistance for needy families except for age and regular attendance in school or in a course
of professional or technical training.

1 (e)(A) Is a caretaker relative named in ORS 418.035 (2)(a)(C) who cares for a dependent child 2 who would be a dependent child under the program for temporary assistance for needy families ex-3 cept for age and regular attendance in school or in a course of professional or technical training; 4 or

(B) Is the spouse of such caretaker relative and fulfills the requirements of ORS 418.035 (1).

6 (f) Is under the age of 21 years, is in a foster family home or licensed child-caring agency or 7 institution under a purchase of care agreement and is one for whom a public agency of this state 8 is assuming financial responsibility, in whole or in part.

9 (g) Is a spouse of an individual receiving a category of aid and who is living with the recipient 10 of a category of aid, whose needs and income are taken into account in determining the cash needs 11 of the recipient of a category of aid, and who is determined by the Department of Human Services 12 to be essential to the well-being of the recipient of a category of aid.

(h) Is a caretaker relative named in ORS 418.035 (2)(a)(C) who cares for a dependent child receiving temporary assistance for needy families or is the spouse of such caretaker relative and fulfills the requirements of ORS 418.035 (1).

(i) Is under the age of 21 years, is in a youth care center and is one for whom a public agency
 of this state is assuming financial responsibility, in whole or in part.

(j) Is under the age of 21 years and is in an intermediate care facility which includes institutions
for the mentally retarded; or is under the age of 22 years and is in a psychiatric hospital.

(k) Is under the age of 21 years and is in an independent living situation with all or part of the
 maintenance cost paid by the Department of Human Services.

(L) Is a member of a family that received temporary assistance for needy families in at least three of the six months immediately preceding the month in which such family became ineligible for such assistance because of increased hours of or increased income from employment. As long as the member of the family is employed, such families will continue to be eligible for medical assistance for a period of at least six calendar months beginning with the month in which such family became ineligible for assistance because of increased hours of employment or increased earnings.

(m) Is an adopted person under 21 years of age for whom a public agency is assuming financial
 responsibility in whole or in part.

(n) Is an individual or is a member of a group who is required by federal law to be included in
 the state's medical assistance program in order for that program to qualify for federal funds.

(o) Is an individual or member of a group who, subject to the rules of the department and within
available funds, may optionally be included in the state's medical assistance program under federal
law and regulations concerning the availability of federal funds for the expenses of that individual
or group.

(p) Is a pregnant woman who would be eligible for temporary assistance for needy families in cluding such aid based on the unemployment of a parent, whether or not the woman is eligible for
 cash assistance.

(q) Would be eligible for temporary assistance for needy families pursuant to 42 U.S.C. 607 based
 upon the unemployment of a parent, whether or not the state provides cash assistance.

(r) Except as otherwise provided in this section and to the extent of available funds, is a pregnant woman or child for whom federal financial participation is available under Title XIX or Title
XXI of the federal Social Security Act.

44 (s) Is not otherwise categorically needy and is not eligible for care under Title XVIII of the 45 federal Social Security Act or is not a full-time student in a post-secondary education program as

defined by the Department of Human Services by rule, but whose family income is less than the 1 2 federal poverty [level] guidelines and whose family investments and savings equal less than the investments and savings limit established by the department by rule. 3 (3) "Health benefit plan" has the meaning given that term in ORS 735.720. 4  $\mathbf{5}$ [(3)] (4) "Income" has the meaning given that term in ORS 411.704. [(4)] (5) "Investments and savings" means cash, securities as defined in ORS 59.015, negotiable 6 instruments as defined in ORS 73.0104 and such similar investments or savings as the Department 7 of Human Services may establish by rule that are available to the applicant or recipient to con-8 9 tribute toward meeting the needs of the applicant or recipient. [(5)] (6) "Medical assistance" means so much of the following medical and remedial care and 10 services as may be prescribed by the Department of Human Services according to the standards 11 12 established pursuant to ORS 414.065, including payments made for services provided under an in-13 surance or other contractual arrangement and money paid directly to the recipient for the purchase of medical care: 14 15 (a) Inpatient hospital services, other than services in an institution for mental diseases; 16 (b) Outpatient hospital services; (c) Other laboratory and X-ray services; 17 18 (d) Skilled nursing facility services, other than services in an institution for mental diseases; 19 (e) Physicians' services, whether furnished in the office, the patient's home, a hospital, a skilled nursing facility or elsewhere; 20(f) Medical care, or any other type of remedial care recognized under state law, furnished by 2122licensed practitioners within the scope of their practice as defined by state law; 23(g) Home health care services; (h) Private duty nursing services; 24 (i) Clinic services; 25(j) Dental services; 2627(k) Physical therapy and related services; (L) Prescribed drugs, including those dispensed and administered as provided under ORS chapter 28689; 2930 (m) Dentures and prosthetic devices; and eyeglasses prescribed by a physician skilled in diseases 31 of the eye or by an optometrist, whichever the individual may select; (n) Other diagnostic, screening, preventive and rehabilitative services; 32(o) Inpatient hospital services, skilled nursing facility services and intermediate care facility 33 34 services for individuals 65 years of age or over in an institution for mental diseases; 35 (p) Any other medical care, and any other type of remedial care recognized under state law; (q) Periodic screening and diagnosis of individuals under the age of 21 years to ascertain their 36 37 physical or mental impairments, and such health care, treatment and other measures to correct or 38 ameliorate impairments and chronic conditions discovered thereby; (r) Inpatient hospital services for individuals under 22 years of age in an institution for mental 39 diseases; and 40 (s) Hospice services. 41 [(6)] (7) "Medical assistance" includes any care or services for any individual who is a patient 42 in a medical institution or any care or services for any individual who has attained 65 years of age 43 or is under 22 years of age, and who is a patient in a private or public institution for mental dis-44 "Medical assistance" includes "health services" as defined in ORS 414.705. "Medical assist-45 eases.

1 ance" does not include care or services for an inmate in a nonmedical public institution.

2 [(7)] (8) "Medically needy" means a person who is a resident of this state and who is considered 3 eligible under federal law for medically needy assistance.

4 [(8)] (9) "Resources" has the meaning given that term in ORS 411.704. For eligibility purposes, 5 "resources" does not include charitable contributions raised by a community to assist with medical 6 expenses.

7 <u>SECTION 5.</u> Sections 6 to 11 of this 2007 Act are added to and made a part of ORS 8 chapter 735.

9 <u>SECTION 6.</u> (1) The Office of Private Health Partnerships shall administer a private
 10 health option to expand private health care coverage for Oregon's children.

(2) The office shall contract with carriers to provide health benefit plans approved under
 section 7 of this 2007 Act. The office will manage the collection and payment of premiums
 for children participating in the plans.

(3) The office shall provide a subsidy for a health benefit plan provided pursuant to a contract entered into under this section for a child whose family's household income is more than 200 percent but no more than 300 percent of the federal poverty guidelines. The amount of the subsidy shall be determined in accordance with subsection (4) of this section and is payable to the carrier in the manner specified by the contract.

(4) The office shall adopt rules for determining the subsidies to be paid under this section
 based upon the following factors:

22 (b) Family size; and

23 (c) Other factors established by the office.

(5) The office shall adopt rules under which families with household incomes that are
 more than 300 percent of the federal poverty guidelines may purchase health benefit plans
 offered through the private health option.

(6) A child who was not born in this state may qualify for health care coverage under this
section only if the child has lived in this state for 180 days.

(7) Notwithstanding subsection (6) of this section, a child may qualify for health care
 coverage under this section to the extent required by federal law as a condition of the state
 receiving federal funds.

(8) The office shall adopt verification requirements to ensure that recipients of health
 care coverage under this section are legal residents of Oregon.

(9) The office shall contract with community health centers and safety net clinics to
 provide health care services to children who are not enrolled in a health benefit plan.

36 (10) As used in this section and section 7 of this 2007 Act:

37 (a) "Carrier" has the meaning given that term in ORS 735.700.

(b) "Child" means a person under 19 years of age.

(c) "Community health centers and safety net clinics" means nonprofit medical clinics
that provide primary physical health, vision, dental or mental health services to low-income
patients without charge or using a sliding fee scale based on the income of the patient.
"Community health centers and safety net clinics" includes school-based clinics.

43 (d) "Health benefit plan" has the meaning given that term in ORS 735.720.

44 <u>SECTION 7.</u> (1) The Office of Private Health Partnerships must approve health benefit 45 plans offered through the private health option described in section 6 of this 2007 Act. To be

1 approved, health benefit plans must offer benefit packages comparable to those provided

2 under section 2 (1)(a) of this 2007 Act, must cover mental health, vision and dental services

and must cover health care services provided by community health centers and safety net
 clinics.

5 (2) Approved health benefit plans may impose copayments or co-insurance amounts that 6 are based upon a family's ability to pay as determined according to criteria adopted by the 7 office by rule.

(3) Approved health benefit plans may not exclude coverage of pre-existing conditions.

<u>SECTION 8.</u> (1) The Office of Private Health Partnerships is responsible for marketing
 the Oregon Healthy Kids Program statewide, as well as coordinating, with the Department
 of Human Services, statewide enrollment training and outreach.

(2) In addition to the duties described in subsection (1) of this section, to maximize the enrollment and retention of eligible children in the Oregon Healthy Kids Program, the office shall develop and administer a grant program to provide funding to organizations and local groups for outreach and enrollment activities. The department and the office shall collaborate in developing and administering the grant program.

(3) The criteria for awarding grants under subsection (2) of this section shall include, but
 are not limited to, the extent to which a grantee offers:

(a) Information and assistance to a diverse geographic area or a culturally diverse community in the state, including communities that need the information and assistance provided in alternative formats and in languages other than English;

(b) Assistance with the application process; and

(c) Assistance to individuals and families in enrolling and maintaining enrollment in the
 Oregon Healthy Kids Program.

25 <u>SECTION 9.</u> Notwithstanding eligibility criteria and subsidy amounts determined pursu-26 ant to section 6 of this 2007 Act, subsidies under the private health option shall be provided 27 to eligible children to the extent the Legislative Assembly appropriates funds for that pur-28 pose or establishes expenditure limitations to provide such subsidies.

<u>SECTION 10.</u> There is established in the State Treasury, separate and distinct from the General Fund, the Private Health Option Program Account, which shall consist of moneys appropriated to the account by the Legislative Assembly and all moneys transferred as reimbursements to the account by the Department of Human Services under section 12 of this 2007 Act. All moneys in the Private Health Option Program Account are continuously appropriated to the Office of Private Health Partnerships to carry out the provisions of sections 6, 7 and 8 of this 2007 Act.

36 <u>SECTION 11.</u> (1) Except as otherwise provided in this section and ORS 735.710, the Office 37 of Private Health Partnerships and the Department of Human Services may not disclose in-38 formation provided as part of an application for enrollment in the Oregon Healthy Kids 39 Program except for purposes directly connected with the administration of the program.

(2) The office and the department may exchange applicant information with other state
and federal agencies for the purposes of determining eligibility for and administering the
Oregon Healthy Kids Program, identifying economic trends relevant to administration of the
program and providing the report required by section 13 of this 2007 Act.

(3) In accordance with applicable state and federal law, the office or the department may
 request that applicants provide their Social Security numbers and may use those numbers

1 in the administration of the Oregon Healthy Kids Program.

2 <u>SECTION 12.</u> (1) The Department of Human Services shall apply to the Centers for 3 Medicare and Medicaid Services for the waivers necessary to implement sections 2, 3, 6, 7 4 and 8 of this 2007 Act and to obtain federal financial participation for health care coverage 5 provided to children through the Oregon Healthy Kids Program.

6 (2) The department shall adopt rules implementing sections 2 and 3 of this 2007 Act as 7 soon as practicable after receipt of the necessary waivers. The Office of Private Health 8 Partnerships shall adopt rules implementing sections 6, 7 and 8 of this 2007 Act as soon as 9 practicable after receipt of the necessary waivers.

(3) The office and the department shall work cooperatively to obtain federal financial
 participation under subsection (1) of this section.

14 <u>SECTION 12a.</u> (1) The Oregon Healthy Kids Program Fund is established in the State 15 Treasury, separate and distinct from the General Fund. Interest earned by the Oregon 16 Healthy Kids Program Fund shall be credited to the fund.

(2) Moneys in the Oregon Healthy Kids Program Fund are continuously appropriated to
 the Department of Human Services for purposes of the Oregon Healthy Kids Program cre ated by section 2 of this 2007 Act.

(3) Notwithstanding subsection (2) of this section, if and to the extent that the Legislative
Assembly determines that the Oregon Healthy Kids Program is fully funded, moneys in the
Oregon Healthy Kids Program Fund established by this section may be used, in amounts
determined by the Legislative Assembly, to fund other health services provided by the department.

25 <u>SECTION 13.</u> The Office for Oregon Health Policy and Research shall analyze and evalu-26 ate the implementation of the Oregon Healthy Kids Program and report its findings to the 27 Legislative Assembly every two years. The report shall include at least the following infor-28 mation for the preceding two-year period:

(1) An estimate of the number of children who are eligible for but not enrolled in the
 program;

31 (2) The number of children enrolled in the program;

(3) The number of children disenrolled from the program and the reasons for disenroll ment;

(4) A description of any identified barriers to enrolling or maintaining enrollment of
 children in the program and a description of the plans developed by the office and the De partment of Human Services to overcome the barriers; and

(5) An estimate of the number of families who have voluntarily discontinued employer sponsored dependent health coverage and enrolled their children in the program.

(3) The Oregon Medical Insurance Pool Board shall bill the Family Health Insurance Assistance
Program for the total amount of the premium received by the Oregon Medical Insurance Pool Board
and for the amount of other costs. The program shall forward the bill to the department.

(4) The department shall pay the program an amount equal to the portion of the premium that
is a subsidy and for other costs. The program shall forward the payment to the Oregon Medical
Insurance Pool Board.

# CIGARETTE TAX

#### (Permanent Tax)

30 <u>SECTION 18.</u> Sections 19, 20 and 22 to 25 of this 2007 Act are added to and made a part 31 of ORS 323.005 to 323.482.

32 <u>SECTION 19.</u> (1) Notwithstanding ORS 323.030 (2) and in addition to and not in lieu of any 33 other tax, every distributor shall pay a tax upon distributions of cigarettes at the rate of 34 42.25 mills for the distribution of each cigarette in this state.

(2) Any cigarette for which a tax has once been imposed under ORS 323.005 to 323.482
 may not be subject upon a subsequent distribution to the taxes imposed by ORS 323.005 to
 323.482.
