SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Changes terminology regarding fees for electrician, boiler repair and plumbing licenses. Eliminates fee for taking electrician license qualifying examination. Deletes requirement specifying minimum hours of continuing education to renew certain boiler repair licenses. Changes requirement regarding format of journeyman plumber licensing examination. [*Allows regulatory body that offers extended renewal periods for license to also offer extended initial period for license.*] Deletes statutory specification of license term for electrical licenses. Deletes statutory specification of renewal term for boiler inspector licenses.

5 **Be It Enacted by the People of the State of Oregon:**

6 **SECTION 1.** ORS 446.210 is amended to read:

7 446.210. (1) The Director of the Department of Consumer and Business Services shall issue a
8 limited maintenance electrician's license to a person who:

9 (a) Pays the **applicable application** fee required under ORS 479.840;

10 (b) Complies with ORS 479.510 to 479.945 and the rules adopted under ORS 455.117 and 479.510
11 to 479.945;

12 (c) Passes a written examination administered as provided by department rule on basic electrical
13 principles on repair and maintenance of electrical wiring and equipment used in a manufactured
14 structure; and

15 (d) Submits proof as provided by department rule that the person has sufficient experience in
16 the repair and maintenance of electrical problems of the type and nature found in a manufactured
17 structure.

18 (2) A person licensed under this section may repair and maintain electrical wiring and equip-
19 ment used in a manufactured structure.

20 **NOTE:** Section 2 was deleted by amendment. Subsequent sections were not renumbered.

21 **SECTION 3.** ORS 479.530 is amended to read:

22 479.530. As used in ORS 479.510 to 479.945 and 479.995, unless the context requires otherwise:

23 (1) "Approved testing laboratory" means a testing laboratory that meets criteria for electrical
24 product evaluation established by the Director of the Department of Consumer and Business Ser-

1 vices with the approval of the Electrical and Elevator Board under ORS 479.730.

2 (2) "Board" means the Electrical and Elevator Board established under ORS 455.138.

3 (3) "Certified electrical product" means an electrical product that is certified under ORS 479.760
4 and that is not decertified.

5 (4) "Competent inspection service" means an electrical inspection service of a city or county
6 administered under ORS 455.148 or 455.150 that employs electrical inspectors who are certified to
7 meet standards under ORS 479.810.

8 (5) "Commercial electrical air conditioning equipment" means heating, cooling, refrigeration,
9 dehumidifying, humidifying and filtering equipment used for climatizing or moving of air if used in
10 commerce, industry or government and if installed in a place not accessible to the general public
11 other than the switches regulating the operation of the equipment.

12 (6) "Demarcation point" means the place of interconnection between the communications cabl-
13 ing, terminal equipment or protective apparatus of the telecommunications service provider and the
14 customer's premises.

15 (7) "Department" means the Department of Consumer and Business Services.

16 (8) "Director" means the Director of the Department of Consumer and Business Services.

17 (9) "Dwelling unit" means one or more rooms for the use of one or more persons as a house-
18 keeping unit with space for eating, living and sleeping and permanent provisions for cooking and
19 sanitation.

20 (10) "Electrical installations" means the construction or installation of electrical wiring and the
21 permanent attachment or installation of electrical products in or on any structure that is not itself
22 an electrical product. "Electrical installation" also means the maintenance or repair of installed
23 electrical wiring and permanently attached electrical products. "Electrical installation" does not
24 include an oil module.

25 (11) "Electrical product" means any electrical equipment, material, device or apparatus that,
26 except as provided in ORS 479.540, requires a license or permit to install and either conveys or is
27 operated by electrical current.

28 (12) "Equipment" means any material, fittings, devices, appliances, fixtures, apparatus or the like
29 that are used as part of or in connection with an electrical installation.

30 (13) "Field evaluation firm" means an independent organization that provides:

31 (a) Evaluations or testing, or both; and

32 (b) Documentation regarding compliance with electrical product safety standards and with the
33 electrical installation safety code.

34 (14) "Industrial electrical equipment" means electrical products used in industry or government
35 that utilizes electric energy for mechanical, chemical, heating, lighting or similar purposes, that is
36 designed to service or produce a product and that is used directly in the production of the service
37 or product.

38 (15) "Installation label" means an adhesive tag issued by governmental agencies that administer
39 the Electrical Safety Law to licensed electrical contractors for application to those minor electrical
40 installations for which the board by rule determines to be appropriate for random inspections.

41 (16) "License" means [*an annual*] a permit issued by the department under ORS 479.630 author-
42 izing the person whose name appears as licensee thereon to act as an electrical contractor, super-
43 vising electrician, journeyman electrician, apprentice electrician or limited elevator journeyman as
44 indicated thereon.

45 (17) "Minimum safety standards" means safety standards prescribed by concurrence of the board

1 and the director under ORS 479.730.

2 (18) "Multifamily dwelling" means a building containing more than one dwelling unit.

3 (19) "Oil module" means a prefabricated structure manufactured to the specifications of the
4 purchaser and used outside this state in the exploration for or processing or extraction of petroleum
5 products.

6 (20) "Permit" means an official document or card issued by the enforcing agency to authorize
7 performance of a specified electrical installation.

8 (21) "Single family dwelling" means a building consisting solely of one dwelling unit.

9 (22) "Telecommunications service provider" means a telecommunications carrier as defined in
10 ORS 133.721 or a telecommunications utility or competitive telecommunications provider, both as
11 defined in ORS 759.005.

12 (23) "Uncertified product" means any electrical product that is not an electrical product certi-
13 fied under ORS 479.760.

14 **SECTION 4.** ORS 479.630 is amended to read:

15 479.630. If the person pays the applicable [*examination and license fees*] **application fee** required
16 under ORS 479.840 and complies with ORS 479.510 to 479.945 and the rules adopted under ORS
17 455.117 and 479.510 to 479.945, the Department of Consumer and Business Services shall issue:

18 (1) An electrical contractor's license to a person engaging in or carrying on a business of mak-
19 ing electrical installations.

20 (2) A general supervising electrician's license to a person who:

21 (a) Passes a written examination prepared by the Electrical and Elevator Board and adminis-
22 tered by the department; and

23 (b) Submits proof satisfactory to the board that the person has had at least four years of expe-
24 rience as a general journeyman electrician or its equivalent, as determined by the board by rule, in
25 installing, maintaining and repairing electrical wires and equipment.

26 (3) A limited supervising electrician's license to a person who qualifies under this subsection.
27 A person licensed under this subsection is authorized to supervise the class of electrical work in-
28 cluded in the branch of the electrical trade and for which the person has passed the examination
29 administered by the department. A person qualifies under this subsection if the person:

30 (a) Passes a written examination prepared by the board and administered by the department; and

31 (b) Submits proof satisfactory to the board that the person has had at least four years of spe-
32 cialized experience in a recognized branch of the electrical trade on the journeyman level.

33 (4) A general journeyman electrician's license to a person who:

34 (a) Passes a written examination prepared by the board and administered by the department; and

35 (b) Submits proof satisfactory to the board that:

36 (A) The person has had at least four years of general experience as an apprentice or its equiv-
37 alent, as determined by the board by rule, in installing, maintaining and repairing electrical wires
38 and equipment, including not fewer than 1,000 hours in wiring on single or multifamily dwelling
39 units; or

40 (B) If the person is licensed as a limited residential electrician under subsection (14) of this
41 section, subsequent to receiving that license, the person has worked for at least two years as a
42 limited residential electrician and subsequent to those two years has completed an additional two
43 years' experience as an apprentice or its equivalent, as determined by the board by rule, for that
44 period of apprenticeship time worked exclusively in installing, maintaining and repairing electrical
45 wires and equipment in the commercial and industrial branches of the electrical trade under the

1 supervision of a licensed electrical contractor.

2 (5) A limited journeyman electrician's license to a person who qualifies under this subsection.
3 A person licensed under this subsection is authorized to perform the class of electrical work in-
4 cluded in the branch of the electrical trade for which the person has passed the examination ad-
5 ministered by the department. A person qualifies under this subsection if the person:

6 (a) Passes a written examination prepared by the board and administered by the department; and

7 (b) Submits proof satisfactory to the board that the person has had at least four years of spe-
8 cialized experience as an apprentice or its equivalent, as determined by the board by rule, in a re-
9 cognized branch of the electrical trade.

10 (6) A limited elevator journeyman license to a person who qualifies under this subsection. A
11 person licensed under this subsection is authorized to install, maintain and repair elevators, in-
12 cluding all electrical and mechanical systems. A person qualifies under this subsection if the person
13 has completed an elevator apprenticeship program, including both electrical and mechanical training
14 components, approved by the board by rule and the person submits an application for licensure to
15 the board in writing. A person issued a license under this subsection is exempt from continuing ed-
16 ucation requirements established under ORS 455.117 and 479.680.

17 (7) An electrical apprentice's license to a person who has complied with ORS 660.002 to 660.210
18 as an electrical apprentice.

19 (8) An electrical apprentice's license to a trainee toward a limited residential electrician's li-
20 cense who has complied with ORS 660.002 to 660.210 as an electrical apprentice.

21 (9) An electrical apprentice's license to a trainee toward a limited journeyman's license in a
22 recognized branch of the electrical trade who is employed by an employer who also:

23 (a) Employs a holder of either a general journeyman electrician's license or a limited
24 journeyman electrician's license; and

25 (b) Conducts an electrical training program in a recognized branch of the electrical trade ap-
26 proved by the board as being a training program that will adequately prepare the trainee for the
27 limited journeyman's license.

28 (10) A limited maintenance electrician's license to a person who qualifies under this subsection.
29 A person licensed under this subsection is authorized to maintain, repair and replace electrical in-
30 stallations, including electrical components, required on the premises of industrial plants, commer-
31 cial office buildings, buildings occupied by the state or a local government entity or facilities
32 designated by the board. The following apply to this subsection:

33 (a) A person qualifies under this subsection if the person:

34 (A) Passes a written examination prepared by the board and administered by the department on
35 repair, replacement and maintenance of equipment of the type and nature normally used in an in-
36 dustrial plant, commercial office building or government building and on the use of testing equip-
37 ment; and

38 (B)(i) Completes a two-year training program approved by the board that provides for training
39 and supervision of the trainee or apprentice; or

40 (ii) Submits proof satisfactory to the board that the person has had sufficient experience and
41 related educational training in the repair, replacement and maintenance of electrical wiring and
42 equipment of the type and nature used in an industrial plant, commercial office building or govern-
43 ment building, as determined by the board or by an appropriate local apprenticeship committee re-
44 cognized by the State Apprenticeship and Training Council.

45 (b) An annual inspection of the premises upon which electrical work is performed by persons

1 licensed under this subsection shall be made by the electrical inspector for an annual fee determined
2 by the board by rule, based upon the time required for the inspection, payable to the department.

3 (c) A person licensed under this subsection may be employed directly by the owner, or owner's
4 agent, of any government building or commercial office building. A building owner or owner's agent
5 need not be licensed under this section to supervise a limited maintenance electrician.

6 (d) The department, in consultation with the board, shall adopt rules defining government
7 buildings and commercial office buildings subject to this subsection.

8 (11) A limited building maintenance electrician's license to a person who qualifies under this
9 subsection. The following apply to this subsection:

10 (a) A person licensed under this subsection is authorized to maintain, repair and replace the
11 following electrical installations required on the premises of commercial office buildings, buildings
12 occupied by the state or a local government entity or facilities designated by the board in electrical
13 systems not exceeding 300 volts to ground:

- 14 (A) Electrical appliances;
- 15 (B) Light switches;
- 16 (C) Light fixtures;
- 17 (D) Fans;
- 18 (E) Receptacles; and
- 19 (F) Fluorescent ballasts.

20 (b) A person qualifies under this subsection if the person:

21 (A) Passes a written examination prepared by the board and administered by the department on
22 maintenance, repair and replacement of equipment of the type and nature normally used in a com-
23 mercial office building or government building and on the use of testing equipment; and

24 (B) Submits proof satisfactory to the board that the person has:

25 (i) Had sufficient experience in the maintenance, repair and replacement of electrical wiring and
26 equipment of the type and nature normally used in a commercial office building or government
27 building; or

28 (ii) Completed a one-year training course, with classroom and on-the-job training components
29 approved by the board, on the maintenance, repair and replacement of electrical wiring and equip-
30 ment of the type and nature normally used in a commercial office building or government building.

31 (c) An annual inspection of the premises upon which electrical work is performed by persons
32 licensed under this subsection shall be made by the electrical inspector for an annual fee determined
33 by the board by rule, based upon the time required for the inspection, payable to the department,
34 or the inspection shall be performed under an electrical master permit program.

35 (d) Building owners may perform work regulated by this subsection and for which a license is
36 required under this subsection without obtaining a license.

37 (e) A person who owns more than 50 percent of a corporation that controls a building is a
38 building owner.

39 (f) A person licensed under this subsection may be employed by the owner of a commercial office
40 building or the owner's agent. A building owner or owner's agent need not be licensed under this
41 section to supervise a limited building maintenance electrician.

42 (12) A limited maintenance specialty contractor license to a person who qualifies under this
43 subsection. A person licensed under this subsection is authorized to engage in the electrical work
44 related to the repair, service, maintenance, installation or replacement of existing, built-in or per-
45 manently connected appliances, fluorescent ballasts or similar equipment and to employ individuals

1 to engage in that work. This subsection does not authorize the installation of appliances, ballasts
2 or other equipment if there is no existing installation of similar equipment. A person qualifies under
3 this subsection if the person submits:

4 (a) Proof satisfactory to the board that the person has had sufficient experience in the type of
5 work permitted under the license issued under this subsection; and

6 (b) Maintains with the board a current list of all individuals employed by the person to engage
7 in work permitted under this subsection.

8 (13) A limited pump installation specialty contractor license to a person who qualifies under this
9 subsection. A person licensed under this subsection is authorized to engage in electrical work re-
10 lated to the testing, repair, service, maintenance, installation or replacement of new or existing
11 pump equipment for potable or irrigation water systems, sump pumps, effluent pumps and ground
12 water pumps on residential and agricultural property, to employ individuals to engage in such work.
13 A person qualifies under this subsection if the person:

14 (a) Submits proof satisfactory to the board that the person has had sufficient experience in the
15 type of work permitted under the license issued under this subsection; and

16 (b) Maintains with the board a current list of all individuals employed by the person to engage
17 in work permitted under this subsection.

18 (14) A limited residential electrician's license to a person who qualifies under this subsection.
19 A person licensed under this subsection is authorized to perform the class of electrical work in-
20 cluded in the branch of the electrical trade for which the person has passed the examination ad-
21 ministered by the department and approved by the board. However, a person licensed under this
22 subsection shall perform the electrical work allowed by the license only on single and multifamily
23 dwelling units not exceeding three floors above grade. For purposes of this subsection, the first floor
24 of a building is the floor that is designed for human habitation and that has 50 percent or more of
25 its perimeter level with or above finished grade of the exterior wall line. A person qualifies under
26 this subsection if the person:

27 (a) Has received the same number of hours of electrical safety training as required by rule for
28 an electrical apprentice or its equivalent and who has received training in electrical theory;

29 (b) Submits documented proof to the board of at least two years of apprenticeship or trainee
30 experience in residential wiring of single and multifamily dwelling units or its equivalent, as deter-
31 mined by the board by rule; and

32 (c) Passes a written examination prepared by the board and administered by the department.

33 (15) A Class I or Class II oil module electrician's license to a person who passes a written ex-
34 amination prepared by the board and administered by the department.

35 (16) A limited renewable energy contractor license to a person who:

36 (a) Employs at least one full-time renewable energy technician; and

37 (b) Does not engage in electrical work other than work that may be performed by a limited
38 renewable energy technician. A limited renewable energy contractor may not make, direct, supervise
39 or control the making of an electrical installation unless the contractor is licensed for that activity.

40 (17) A limited renewable energy technician license to a person who qualifies under this sub-
41 section. A person qualifies for licensing as a limited renewable energy technician if the person
42 completes a two-year apprenticeship program and passes an examination approved by the board. A
43 person licensed under this subsection may, while in the employ of a licensed electrical contractor
44 or a limited renewable energy contractor:

45 (a) Install, maintain, replace or repair electrical wiring and electrical products that convey or

1 operate on renewable electrical energy not exceeding 25 kilowatts AC; and

2 (b) Make electrical installations not exceeding 25 kilowatts AC:

3 (A) On devices using renewable energy involving wind, solar energy systems, micro-
4 hydroelectricity, photovoltaic systems or fuel cells.

5 (B) Up to the load side of an inverter.

6 (C) To connect generators that are sized to facilitate the inverter in an off-grid system.

7 **SECTION 5.** ORS 479.840 is amended to read:

8 479.840. (1) Upon [*receipt*] **receiving payment** of the [*following*] **applicable application** fee, the
9 Department of Consumer and Business Services [*shall*] **may** issue or renew a license or permit ap-
10 plied for under ORS 479.510 to 479.945. **The fee to apply for or renew a license is:**

11 (a) \$125 **per year** for an electrical contractor license for each place of business operated by the
12 applicant.

13 (b) \$125 **per year** for a limited energy contractor, **restricted energy contractor** or limited sign
14 contractor license.

15 (c) \$25 **per year** for a pump specialty contractor or limited maintenance specialty contractor
16 license.

17 (d) \$150 **per year** for an elevator contractor license.

18 (e) \$100 for a **three-year** license for a:

19 (A) General journeyman electrician;

20 (B) General supervising electrician;

21 (C) Limited supervising industrial electrician;

22 (D) Limited supervising manufacturing plant electrician;

23 (E) Limited journeyman industrial electrician;

24 (F) Limited maintenance industrial electrician;

25 (G) Limited maintenance manufactured dwelling or recreational vehicle electrician;

26 (H) Limited journeyman manufacturing plant electrician; or

27 (I) Limited journeyman railroad electrician.

28 (f) \$50 for a **three-year** license for a:

29 (A) Limited elevator journeyman;

30 (B) Class A or Class B limited energy technician;

31 (C) Limited journeyman sign electrician;

32 (D) Limited journeyman sign service electrician;

33 (E) Limited journeyman stage electrician; or

34 (F) Limited building maintenance electrician.

35 [*g*] \$10 for the right to take the written qualifying examination.]

36 (2) The Electrical and Elevator Board shall set uniform permit fees, by rule, not to exceed the
37 cost of administration.

38 (3) The fees provided for in this section do not apply to persons paying inspection fees under the
39 terms of ORS 479.560 (3) or 479.630 (10).

40 (4) Each electrical contractor may furnish to the department a corporate surety bond to be ap-
41 proved by the department, an irrevocable letter of credit issued by an insured institution as defined
42 in ORS 706.008 or a cash bond under procedures approved by the department, in the sum of \$2,000
43 guaranteeing the payment of all fees provided for under ORS 479.510 to 479.945. Before commencing
44 any electrical job an electrical contractor who has a current bond or letter of credit under this
45 subsection may apply to the department for a working permit which shall cost an amount established

1 by the department by rule. The working permit shall authorize the electrical contractor to com-
2 mence work. The total of all fees due for permits for each job, and the time such fees are payable,
3 shall be determined by the department by administrative rule under ORS 479.730. The contractor
4 shall keep the bond or letter of credit in force at all times. Any cancellation or revocation of the
5 bond or letter of credit shall revoke and suspend the license issued to the principal until such time
6 as a new bond or letter of credit shall be filed and approved. The department may bring an action
7 against the surety named in the bond or the letter of credit issuer with or without joining in such
8 action the principal named in the bond or letter of credit.

9 **SECTION 6.** ORS 479.910 is amended to read:

10 479.910. (1) Upon payment of an *[examination and license]* **application** or renewal fee, the De-
11 partment of Consumer and Business Services shall issue a Class B limited energy technician license
12 to a person who qualifies under ORS 479.915. A person licensed under this section may perform
13 limited energy electrical activity except protective signaling as defined in ORS 479.905.

14 (2) A person licensed under this section shall comply with the permit and code compliance re-
15 quirements under ORS 479.510 to 479.945.

16 (3) The *[examination and license]* **application** fee, and the renewal fee, for a Class B limited
17 energy technician license are the same as those for a Class A limited energy technician license.

18 (4) The Electrical and Elevator Board shall establish continuing education requirements for
19 persons licensed under this section, not to exceed 24 hours of classes every three years.

20 **SECTION 7.** ORS 479.945 is amended to read:

21 479.945. (1) A restricted energy contractor's license is created for persons engaged in HVAC and
22 such other categories as established by the Electrical and Elevator Board by rule under ORS
23 455.117.

24 (2) A person licensed as a restricted energy contractor under this section and the person's em-
25 ployees may install, alter, maintain, replace or repair electrical wiring and electrical products that
26 are within the scope of the contractor's license issued under this section. A person covered by this
27 subsection does not have to obtain a license under ORS 479.910.

28 (3) The license issued under this section shall limit the scope of activities that the licensee and
29 licensee's employees may engage in and in no instance may the scope of the license exceed that of
30 a Class B limited energy technician.

31 (4) *[An applicant]* **A person applying** for licensing under this section shall **pay the applicable**
32 **application fee required under ORS 479.840 and** provide proof satisfactory to the board that the
33 person has experience of the type of work covered by the license indorsement. *[and shall pay the fees*
34 *required by ORS 479.840 (1)(b) for a limited energy contractor.]*

35 (5) A restricted energy contractor licensee under this section shall:

36 (a) Maintain with the board a current list of all individuals employed by the licensee to engage
37 in work permitted by this section;

38 (b) Issue an identification card to each employee working under the provisions of this section
39 and identify the contractor, date of issue, contractor's identification number with the board and the
40 Construction Contractors Board; and

41 (c) Maintain with the board a current form of identification card used by the contractor.

42 (6) A person holding a limited maintenance specialty contractor's license under ORS 479.630 (12)
43 who also registers under this section shall comply with the identification card requirements of sub-
44 section (5) of this section, but need not file a separate list of employees unless the work under the
45 contractor's license is done by different employees.

1 **SECTION 8.** ORS 480.545 is amended to read:

2 480.545. (1) Under ORS chapter 183 the Board of Boiler Rules may adopt and enforce rules and
3 minimum safety standards to carry out ORS 480.510 to 480.670 and adopt standards for persons
4 performing welding on boilers and pressure vessels.

5 (2) All proceedings in the administration of ORS 480.510 to 480.670 shall be conducted under
6 ORS chapter 183 and, additionally, where applicable, under ORS 480.615.

7 (3) In addition to the rules otherwise provided, and subject to ORS chapter 183, the board shall
8 adopt rules concerning the times, dates, frequency and manner of giving notice to interested persons
9 of intention to consider one or more of the things which the board may consider under this section.

10 (4) All rules and minimum safety standards adopted under this section shall be reasonable and
11 in substantial conformity with generally accepted nationwide engineering standards. In adopting
12 rules the board shall consider the probability, extent and gravity of injuries to health and property
13 which would result from the failure to adopt the standards being considered and the standards fol-
14 lowed, proposed or approved by members of affected industries.

15 (5) The board[, *by rule,*] shall adopt **rules establishing a continuing education requirement**
16 **for persons described in ORS 480.630 (8) and** fees necessary for the administration and enforce-
17 ment of the continuing education requirement [*under ORS 480.630*].

18 (6) Any rule adopted by the board under ORS 480.510 to 480.670 shall be submitted to the Di-
19 rector of Department of Consumer and Business Services. The director shall have 30 calendar days
20 from the date of adoption of the rules to review them. If the director fails to disapprove the rules
21 within the 30-day period, the rules become effective in accordance with their terms and as provided
22 by law. If the director disapproves the rules within the 30-day period, the rules immediately shall
23 be returned to the board with the director's written objections, and the rules do not become effec-
24 tive until approved by the director.

25 **SECTION 9.** ORS 480.605 is amended to read:

26 480.605. The Department of Consumer and Business Services may:

27 (1) Collect fees for shop inspections, inspections of vessels and for inspection of vessels which
