**SUMMARY**

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Removes discretion of applicant for renewal of license to choose between normal license term and extended term offered by agency.

Modifies expiration date for certain licenses, permits and certificates to allow agency to establish different expiration date by rule.

**Allows agency, without prior notice or hearing, to amend rules to change name of office, program or division or to correct address and telephone numbers referred to in rules.**

**Changes authorization for establishing combined license processing pilot projects within Department of Consumer and Business Services to combined license processing programs.**

**Provides for payment of licenses directly to agency if agency contracts with county or other public body for issuing licenses on behalf of agency. Establishes conditions.**

**Removes requirement that Director of Oregon Department of Aviation have airport operations or management experience.**

9 **Be It Enacted by the People of the State of Oregon:**

10 **SECTION 1.** ORS 183.705 is amended to read:

11 183.705. (1) Notwithstanding any other provision of law, an agency that issues licenses that must  
12 be renewed on an annual basis under the laws administered by the agency also may offer those li-  
13 censes with terms of two, three, four or five years. Notwithstanding any other provision of law, an  
14 agency that issues licenses that must be renewed on a biennial basis under the laws administered  
15 by the agency also may offer those licenses with terms of three, four or five years. Extended terms  
16 may be offered only for renewed licenses[,] and may not be offered for initial applications for li-  
17 censes.

18 (2) An agency may offer an extended term under this section for a license issued by the agency  
19 only after adopting a rule authorizing the extended term. An agency may adopt a rule authorizing  
20 an extended term only if the agency finds that the extended term is consistent with public safety  
21 and with the objectives of the licensing requirement. An agency by rule may prohibit extended terms

1 based on prior license discipline of an applicant.

2 (3) *[If an agency offers an extended term under this section for a license issued by the agency, the*  
3 *agency shall allow an applicant for renewal of a license to choose between the license term provided*  
4 *under the laws administered by the agency and any extended term offered by the agency under this*  
5 *section.]* An applicant must meet all qualifications established by the agency to be granted an ex-  
6 tended term.

7 (4) An agency may not offer an extended term under this section if:

8 (a) Another agency or a local government, as defined by ORS 174.116, is authorized by statute  
9 to make a recommendation on the issuance of the license;

10 (b) The agency or the local government, as defined by ORS 174.116, that has authority to make  
11 a recommendation on the issuance of the license has recommended against the issuance of the li-  
12 cense; and

13 (c) The recommendation of the agency or the local government, as defined by ORS 174.116, is  
14 based on licensing criteria established by statute or by rule.

15 (5) An extended term granted under this section may be revoked by an agency if the agency  
16 determines that the licensee is subject to discipline under the licensing criteria applicable to the  
17 licensee. An agency offering extended terms under this section by rule may establish other grounds  
18 for revoking an extended term under this section.

19 (6) Notwithstanding any other provision of law, an agency that offers an extended term under  
20 this section for a license issued by the agency shall increase the annual or biennial license fee es-  
21 tablished by statute by a percentage no greater than necessary to ensure that there is no revenue  
22 loss by reason of the extended term.

23 (7) Notwithstanding any other provision of law, an agency that offers an extended term under  
24 this section for a license issued by the agency shall increase any annual or biennial continuing ed-  
25 ucation requirement established by statute as necessary to ensure that there is no reduction in the  
26 continuing education requirement for licensees by reason of the extended term.

29 435.050. (1) All licenses shall be issued by the State Board of Pharmacy on written application  
30 and payment of an annual license fee for each manufacturer or wholesale license, which fee shall  
31 not exceed \$300.

32 (2) Licenses shall be in effect for one year from January 1 of each year **or such date as may**  
33 **be specified by board rule.**

34 **SECTION 4.** ORS 438.130 is amended to read:

35 438.130. (1) The application for a license for a clinical laboratory shall be made on forms pro-  
36 vided by the Department of Human Services and shall be executed by the owner or one of the  
37 owners or by an officer of the firm or corporation owning the clinical laboratory, or in the case of  
38 a county or municipality, by the public official responsible for operation of the laboratory, or in the  
39 case of an institution, by the administrator of the institution. The application shall contain the  
40 names of the owner, the director or directors of the clinical laboratory, the location and physical  
41 description of the clinical laboratory, the laboratory specialties for which a license is requested and  
42 such other information as the department may require.

43 (2)(a) The application shall be accompanied by an annual or biennial license fee to be estab-  
44 lished by the department. The fee shall be based on test volume, test complexity, the number of

6 (b) The department may establish prorated fees for licenses issued for a year or less and when  
 7 there is a change in the laboratory's owner, director or address. A prorated license fee shall be is-  
 8 sued to a laboratory accredited by an organization recognized by the department.

9 (3) Unless sooner voided, suspended or revoked, all licenses issued under this section expire on  
 10 June 30 of the *[one-]* **one-year** or two-year cycle following the date of issuance *[and]* **or on such**  
 11 **date as may be specified by department rule. Licenses issued under this section** shall be  
 12 renewable in the manner prescribed by the department.

13 (4) Subject to prior approval of the Oregon Department of Administrative Services and a report  
 14 to the Emergency Board prior to adopting the fees and charges, the fees and charges established

 25 *of Consumer and Business Services]* by **department** rule.

26 *[(2)]* (3) Except as provided in ORS 460.055, a holder of a valid elevator inspector certificate of  
 27 competency or elevator operating permit who has complied with ORS 460.005 to 460.175 and the

 33 **on such date as may be specified by rule of the State Department of Fish and Wildlife. The**  
 34 **licenses may** be renewed annually thereafter upon application and payment of fees required there-  
 35 for.

36 **SECTION 7.** ORS 508.781 is amended to read:

37 508.781. An individual who obtained the permit required by ORS 508.775 for a particular calen-  
 38 dar year is eligible to obtain renewal of the permit in a subsequent calendar year, upon application  
 39 and payment of the fees therefor by December 31 of the permit year **or by such date as may be**  
 40 **specified by rule of the State Department of Fish and Wildlife.**

41 **SECTION 8.** ORS 508.807 is amended to read:

42 508.807. (1) An individual who obtained the permit required by ORS 508.801 for a particular  
 43 calendar year is eligible to obtain renewal of the permit in a subsequent calendar year, *[upon ap-*  
 44 *plication by December 31 of the permit year and payment of the fees therefor, and]* upon obtaining the  
 45 annual boat license referred to in ORS 508.285[.]. **The permit must be renewed, and the boat li-**

1 **cense obtained**, not later than December 31 of each year **or such date as may be established by**  
 2 **rule of the State Department of Fish and Wildlife.**

3 (2) Notwithstanding any other provision of law, an individual who permanently loses the ser-

8 508.892. (1) An individual who obtained the permit required by ORS 508.880 for a particular  
 9 calendar year is eligible to obtain renewal of the permit in a subsequent calendar year[,] upon ap-  
 10 plication [*by December 31 of the permit year*] and payment of the fees therefor and upon obtaining  
 11 the annual boat license referred to in ORS 508.285 [*not later than December 31 of each year*]. **The**  
 12 **permit must be applied for, and the boat license obtained, not later than December 31 of each**  
 13 **year or such date as may be established by rule of the State Department of Fish and Wildlife.**

14 (2) An individual who permanently loses the services of a vessel through capsizing, sinking, fire,  
 15 collision or other catastrophic accident shall remain eligible to obtain a vessel permit for a re-  
 16 placement vessel for two years from the date of loss.

18 508.947. (1) The State Department of Fish and Wildlife may issue a black rockfish and blue  
 19 rockfish vessel permit to an owner of a vessel that landed a minimum of 750 pounds of nontrawl  
 20 caught black rockfish, blue rockfish or nearshore fish in any one calendar year between January  
 21 1, 1995, and January 1, 2001, or in the six-month period between January 1, 2001, and July 1, 2001,  
 22 for delivery to a fish processor licensed pursuant to ORS 508.025.

23 (2) The department may issue a black rockfish and blue rockfish vessel permit with a nearshore  
 24 fish endorsement to an owner of a vessel that was issued a permit under the Interim Nearshore  
 25 Fisheries Plan through the Developmental Fisheries Program.

26 (3) The department may renew a black rockfish and blue rockfish vessel permit or a black  
 27 rockfish and blue rockfish vessel permit with a nearshore fish endorsement if the vessel made a  
 28 minimum of five commercial fish landings during the calendar year prior to the request for renewal  
 29 for delivery to a fish processor licensed pursuant to ORS 508.025.

30 (4) Permits issued under this section expire on December 31 of each year **or on such date as**  
 31 **may be specified by department rule.** An owner of a vessel with a permit must submit a renewal  
 32 application to the department by January 1 of each year **or by such date as may be specified by**  
 33 **department rule.** If the owner of a vessel with a permit does not **timely** submit a renewal appli-  
 34 cation [*by January 1*], the department shall, not [*later than February 1*] **more than 30 days after**

44 **SECTION 11.** ORS 537.747 is amended to read:

45 537.747. (1) No person shall advertise services to construct, alter, abandon or convert wells, of-

1 fer to enter or enter into a contract with another person or public agency to construct, alter,  
2 abandon or convert a well for such other person, cause any well construction, alteration, abandon-  
3 ment or conversion to be performed under such a contract or operate well drilling machinery with-  
4 out possessing a water well constructor's license therefor in good standing issued by the Water  
5 Resources Department. The department shall adopt a single water well constructor's license that  
6 may specify the type of well, type of well alteration or construction or type of well drilling machine  
7 operation for which the water well constructor is qualified.

8 (2) Notwithstanding subsection (1) of this section, a person may operate a well drilling machine  
9 without a water well constructor's license if supervised by one who possesses such a license.

10 (3) A person shall be qualified to receive a water well constructor's license if the person:

11 (a) Is at least 18 years of age.

12 (b) Has passed a written examination conducted by the department to determine fitness to op-  
13 erate as a water well constructor.

14 (c) Has paid a license fee and an examination fee according to the fee schedule set forth under  
15 subsection (6) of this section.

16 (d) Has one year or more experience in the operation of well drilling machinery.

17 (4) Upon fulfillment of all the requirements set out in subsection (3) of this section, the depart-  
18 ment shall issue the applicant a water well constructor's license in a form prescribed by the de-  
19 partment. The license may be issued for a period of two years.

20 (5) A water well constructor's license shall expire on June 30 **or on such date as may be**  
21 **specified by department rule.** A person may renew a license by submitting an application and the  
22 appropriate fees any time before the license expires but not later than one year after the license  
23 expires. At the time of application, the person shall provide the department with evidence of com-  
24 pliance with the continuing education requirements established pursuant to section 4, chapter 496,  
25 Oregon Laws 2001. A person who renews a license within the 12 months after the license expires  
26 may either pay a penalty fee set forth under subsection (6)(d) of this section or requalify for a water  
27 well constructor's license in accordance with subsection (3) of this section. If a person fails to renew  
28 a license within 12 months after expiration the person must comply with the requirements of sub-  
29 section (3) of this section for a new water well constructor's license.

30 (6) The department shall collect in advance the following fees:

31 (a) An examination fee of \$20.

32 (b) A license fee of \$150.

33 (c) A renewal fee of \$150.

34 (d) Unless a person requalifies for a water well constructor's license in accordance with sub-  
35 section (3) of this section, a water well constructor shall pay a renewal fee of \$250 if the license is  
36 renewed within 12 months after expiration.

37 (e) If a person requalifies for a water well constructor's license under subsection (3) of this  
38 section, the person shall pay the renewal fee established under paragraph (c) of this subsection.

39 (7) The department may revoke, suspend or refuse to renew any water well constructor's license  
40 when it appears to the satisfaction of the department, after notice and opportunity to be heard by  
41 the licensee, that the licensee has failed to comply with the provisions of ORS 537.505 to 537.795  
42 and 537.992 applicable to such licensee or any order or rule adopted thereunder applicable to such  
43 licensee, or has made a material misstatement of fact on an application for a license or well log or  
44 established a pattern of conduct that willfully or negligently violates any provision of ORS 537.505  
45 to 537.795 and 537.992, or any rule adopted pursuant thereto, applicable to such licensee.

1 (8) The provisions of subsection (3) of this section requiring one year or more experience in the  
2 operation of well drilling machinery do not apply to any person who, on July 1, 1981, holds the li-  
3 cense required by this section and who continues thereafter to maintain the license in good stand-  
4 ing.

5 (9) The fees collected under subsection (6) of this section shall be paid into the Water Resources  
6 Department Water Right Operating Fund. Such moneys are continuously appropriated to the Water  
7 Resources Department to pay the department's expenses in administering and enforcing the water  
8 well constructor's licensing program.

9 **SECTION 12.** ORS 537.747, as amended by section 8, chapter 496, Oregon Laws 2001, and sec-  
10 tion 10, chapter 594, Oregon Laws 2003, is amended to read:

11 537.747. (1) No person shall advertise services to construct, alter, abandon or convert wells, of-  
12 fer to enter or enter into a contract with another person or public agency to construct, alter,  
13 abandon or convert a well for such other person, cause any well construction, alteration, abandon-  
14 ment or conversion to be performed under such a contract or operate well drilling machinery with-  
15 out possessing a water well constructor's license therefor in good standing issued by the Water  
16 Resources Department.

17 (2) Notwithstanding subsection (1) of this section, a person may operate a well drilling machine  
18 without a water well constructor's license if supervised by one who possesses such a license.

19 (3) A person shall be qualified to receive a water well constructor's license if the person:

20 (a) Is at least 18 years of age.

21 (b) Has passed a written examination conducted by the department to determine fitness to op-  
22 erate as a water well constructor.

23 (c) Has paid a license fee and an examination fee according to the fee schedule set forth under  
24 subsection (6) of this section.

25 (d) Has one year or more experience in the operation of well drilling machinery.

26 (4) Upon fulfillment of all the requirements set out in subsection (3) of this section, the depart-  
27 ment shall issue the applicant a water well constructor's license in a form prescribed by the de-

30 **specified by department rule.** A person may renew a license by submitting an application and the  
31 appropriate fees any time before the license expires but not later than one year after the license  
32 expires. A person who renews a license within the 12 months after the license expires may either  
33 pay a penalty fee set forth under subsection (6)(d) of this section or requalify for a water well  
34 constructor's license in accordance with subsection (3) of this section. If a person fails to renew a  
35 license within 12 months after expiration the person must comply with the requirements of sub-  
36 section (3) of this section for a new water well constructor's license.

10 to 537.795 and 537.992, or any rule adopted pursuant thereto, applicable to such licensee.

11 (8) The provisions of subsection (3) of this section requiring one year or more experience in the  
12 operation of well drilling machinery do not apply to any person who, on July 1, 1981, holds the li-  
13 cense required by this section and who continues thereafter to maintain the license in good stand-  
14 ing.

15 (9) The fees collected under subsection (6) of this section shall be paid into the Water Resources  
16 Department Water Right Operating Fund. Such moneys are continuously appropriated to the Water  
17 Resources Department to pay the department's expenses in administering and enforcing the water  
18 well constructor's licensing program.

19 **SECTION 13.** ORS 571.075 is amended to read:

20 571.075. (1) The fees for the renewal of the annual licenses and the fees for inspections required  
21 by ORS 571.005 to 571.230 and 571.991 shall be paid with the application for license renewal and  
22 before July 1 of each year **or before such date as may be specified by rule of the State De-**  
23 **partment of Agriculture.**

24 (2) Failure to pay the fees when due forfeits the right to operate as a grower, dealer or agent.

25 (3) Any person who has been previously licensed to grow or sell nursery stock and whose right  
26 to grow or sell has been forfeited shall not be issued a renewal license except upon written appli-  
27 cation to the [*State Department of Agriculture*] **department** accompanied by a sum of money equal  
28 to the regular license fee, as provided in ORS 571.057.

29 **SECTION 14.** ORS 571.535 is amended to read:

30 571.535. (1) The fees for the renewal of the annual licenses required by ORS 571.505 to 571.580  
31 shall be paid with the application for license renewal and before July 1 of each year **or before such**  
32 **date as may be specified by rule of the State Department of Agriculture.**

33 (2) Failure to pay the fees when due forfeits the right to operate as a grower.

34 (3) Any person who has been previously licensed to grow Christmas tree stock and whose right  
35 to grow has been forfeited shall not be issued a renewal license except upon written application to  
36 the [*State Department of Agriculture*] **department** accompanied by a sum of money equal to the  
37 regular license fee.

38 **SECTION 15.** ORS 585.040 is amended to read:

39 585.040. Upon the filing of the application and the payment of appropriate fees, the State De-  
40 partment of Agriculture shall, if [*it*] **the department** is satisfied that the applicant is entitled  
41 thereto, issue to the applicant a license to conduct the business of wholesale produce dealer, retail  
42 produce peddler or cash buyer, as the case may be. The licenses shall be in the form the department  
43 prescribes and shall expire on June 30 of each year **or on such date as may be specified by de-**  
44 **partment rule.**

45 **SECTION 16.** ORS 586.270 is amended to read:

1 586.270. (1) Every person operating any public warehouse in this state shall, before July 1 of  
2 each year **or such date as may be specified by rule of the State Department of Agriculture**,  
3 procure from the [*State Department of Agriculture*] **department** a license for each such warehouse  
4 so operated for the ensuing year, before transacting business at such public warehouse; but the  
5 holder of a license to store grain under the United States Warehouse Act shall furnish the depart-  
6 ment with a copy of such license and bond and, having furnished such copies, is not required to  
7 secure a state license or pay state warehouse inspection fees during the time the license holder  
8 continues to operate under the federal license. The license shall be posted in a conspicuous place  
9 in the office of each warehouse.

18 \$50,000.

20 586.210 to 586.730.

21 (3) The applicant shall submit with the application an annual license fee of \$500 for each public  
22 warehouse.

23 (4) The department shall issue a license to the applicant if it finds that the application is in due  
24 form and the applicant has complied with the provisions of ORS 586.210 to 586.730.

25 **SECTION 17.** ORS 601.030 is amended to read:

26 601.030. Before any person shall engage in the business of disposing of the bodies, carcasses or  
27 parts of animals by rendering, burning, burying or any other means, the person shall procure from  
28 the State Department of Agriculture a license. All such licenses shall expire on June 30 next suc-  
29 ceeding their date of issuance **or on such date as may be specified by department rule.**

30 **SECTION 18.** ORS 601.080 is amended to read:

31 601.080. (1) Before any person, not holding a license for the disposal of bodies, carcasses or parts  
32 of animals, transports for hire the bodies, carcasses or parts of animals upon the highways of the  
33 state, the person shall obtain a license for such truck or conveyance used, from the State Depart-  
34 ment of Agriculture.

15 (B) Have not had an outfitting and guiding license, permit or certificate revoked, suspended or  
16 canceled by another state or by an agency of the government of the United States;

17 (C) Have not been denied the right to apply for an outfitting and guiding license, permit or  
18 certificate by another state or by an agency of the government of the United States; and

19 (D) Have not been convicted of guiding without registration as required by this subsection.

7 (11)(a) Except as provided in paragraph (c) of this subsection, a rule is not valid unless adopted  
8 in substantial compliance with the provisions of this section in effect on the date that the notice  
9 required under subsection (1) of this section is delivered to the Secretary of State for the purpose  
10 of publication in the bulletin referred to in ORS 183.360.

11 (b) In addition to all other requirements with which rule adoptions must comply, a rule is not  
12 valid if the rule has not been submitted to the Legislative Counsel in the manner required by ORS

32 plementation of combined license processing [*pilot projects*] **programs**. Any agency participating in  
33 a combined license processing [*pilot project*] **program** may:

34 (a) Agree to be bound by the rules adopted by the Department of Consumer and Business Ser-  
35 vices; and

36 (b) Adopt any other rules necessary for participation in a combined license processing [*pilot*  
37 *project*] **program**.

38 **SECTION 60.** Sections 2 and 3, chapter 73, Oregon Laws 2005, are repealed.

39 **SECTION 61.** If an agency of the executive department, as defined in ORS 174.112, enters  
40 into a contract with a county or other public body, as defined in ORS 174.109, for the purpose  
41 of issuing licenses on behalf of the agency, the agency, by rule, shall provide that payment  
42 for the licenses be made directly to the agency if:

43 (1) The agency has implemented a functioning licensing software system that is approved  
44 by the Oregon Department of Administrative Services; and

45 (2) The agency pays to the county or other public body the same amounts under the



1 **contract that the county or other public body would have received if the county or other**  
2 **public body had collected the license fees.**

3 **SECTION 62.** ORS 835.106 is amended to read:

4 835.106. (1) The Governor shall appoint the Director of the Oregon Department of Aviation,  
5 subject to confirmation by the Senate pursuant to ORS 171.562 and 171.565, who holds office at the  
6 pleasure of the Governor.

7 *[(2) The Governor may not appoint a person as director unless the person has experience in airport*  
8 *operations or management.]*

9 *[(3)]* (2) Subject to policy direction by the State Aviation Board, the director shall:

10 (a) Be the administrative head of the department;

11 (b) Have power, within applicable budgetary limitations, and in accordance with ORS chapter  
12 240, to hire, assign, reassign and coordinate personnel of the department and prescribe their duties  
13 and fix their compensation, subject to the State Personnel Relations Law;

14 (c) Administer the laws of the state concerning aviation; and

15 (d) Intervene, as authorized by the board, pursuant to the rules of practice and procedure, in the  
16 proceedings of state and federal agencies that may substantially affect the interests of the consum-  
17 ers and providers of aviation services within Oregon.

18 *[(4)]* (3) In addition to duties otherwise required by law, the director shall prescribe regulations  
19 for the government of the department, the conduct of its employees, the assignment and performance  
20 of its business and the custody, use and preservation of its records, papers and property in a manner  
21 consistent with applicable law.

22 *[(5)]* (4) The director may delegate to any of the employees of the department the exercise or  
23 discharge in the director's name of any duty, function or power of whatever character, vested in or  
24 imposed by law upon the director, including duties, functions or powers delegated to the director  
25 by the board. The official act of any person acting in the director's name and by the authority of  
26 the director shall be considered to be an official act of the director.

27 *[(6)]* (5) The director shall have authority to require a fidelity bond of any officer or employee  
28 of the department who has charge of, handles or has access to any state money or property, and  
29 who is not otherwise required by law to give a bond. The amounts of the bonds shall be fixed by the  
30 director, except as otherwise provided by law, and the sureties shall be approved by the director.  
31 The department shall pay the premiums on the bonds.

32 *[(7)]* (6) The director shall prepare and submit to the board on or about December 31 of each  
33 year an annual report for the 12 months ending the prior June 30. The annual report shall set forth  
34 all that the department has done during the year. The report shall contain a statement of the parts  
35 of the state aviation system that were constructed, reconstructed or improved during the period,  
36 together with a statement showing in a general way the status of the state aviation system.
