

# House Bill 2243

Ordered printed by the Speaker pursuant to House Rule 12.00A (5). Pre-session filed (at the request of Governor Theodore R. Kulongoski for Department of Consumer and Business Services and Office of Regulatory Streamlining of Department of Consumer and Business Services)

## SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Removes discretion of applicant for renewal of license to choose between normal license term and extended term offered by agency.

Modifies expiration date for certain licenses, permits and certificates to allow agency to establish different expiration date by rule.

7 **Be It Enacted by the People of the State of Oregon:**

8 **SECTION 1.** ORS 183.705 is amended to read:

9 183.705. (1) Notwithstanding any other provision of law, an agency that issues licenses that must  
10 be renewed on an annual basis under the laws administered by the agency also may offer those li-  
11 censes with terms of two, three, four or five years. Notwithstanding any other provision of law, an  
12 agency that issues licenses that must be renewed on a biennial basis under the laws administered  
13 by the agency also may offer those licenses with terms of three, four or five years. Extended terms  
14 may be offered only for renewed licenses[,] and may not be offered for initial applications for li-  
15 censes.

16 (2) An agency may offer an extended term under this section for a license issued by the agency  
17 only after adopting a rule authorizing the extended term. An agency may adopt a rule authorizing  
18 an extended term only if the agency finds that the extended term is consistent with public safety  
19 and with the objectives of the licensing requirement. An agency by rule may prohibit extended terms  
20 based on prior license discipline of an applicant.

21 (3) *[If an agency offers an extended term under this section for a license issued by the agency, the*  
22 *agency shall allow an applicant for renewal of a license to choose between the license term provided*  
23 *under the laws administered by the agency and any extended term offered by the agency under this*  
24 *section.]* An applicant must meet all qualifications established by the agency to be granted an ex-  
25 tended term.

26 (4) An agency may not offer an extended term under this section if:

27 (a) Another agency or a local government, as defined by ORS 174.116, is authorized by statute  
28 to make a recommendation on the issuance of the license;

29 (b) The agency or the local government, as defined by ORS 174.116, that has authority to make

1 a recommendation on the issuance of the license has recommended against the issuance of the li-  
2 cense; and

3 (c) The recommendation of the agency or the local government, as defined by ORS 174.116, is  
4 based on licensing criteria established by statute or by rule.

5 (5) An extended term granted under this section may be revoked by an agency if the agency  
6 determines that the licensee is subject to discipline under the licensing criteria applicable to the  
7 licensee. An agency offering extended terms under this section by rule may establish other grounds  
8 for revoking an extended term under this section.

9 (6) Notwithstanding any other provision of law, an agency that offers an extended term under  
10 this section for a license issued by the agency shall increase the annual or biennial license fee es-  
11 tablished by statute by a percentage no greater than necessary to ensure that there is no revenue  
12 loss by reason of the extended term.

13 (7) Notwithstanding any other provision of law, an agency that offers an extended term under  
14 this section for a license issued by the agency shall increase any annual or biennial continuing ed-  
15 ucation requirement established by statute as necessary to ensure that there is no reduction in the  
16 continuing education requirement for licensees by reason of the extended term.

17 **SECTION 2.** ORS 377.730 is amended to read:

18 377.730. (1) A person shall not engage in the business of erecting or maintaining outdoor ad-  
19 vertising signs for other persons without first obtaining an annual license therefor from the Director  
20 of Transportation and paying the annual license fee established by the Department of Transportation  
21 by rule as provided in ORS 377.729.

22 (2) An application for a license or renewal thereof shall be made on a form furnished by the  
23 director, shall contain such pertinent information as the director may require and shall be accom-  
24 panied by the applicable annual fee. A license granted under this section expires on June 30 of each  
25 year **or on such date as may be specified by department rule**. The fee shall not be prorated. The  
26 director shall by certified mail send to each licensee a notice of expiration of license and a renewal  
27 application form not less than 30 days before the date of expiration.

28 (3) If the director finds that an applicant has knowingly provided materially false or misleading  
29 information in the application or that a licensee has violated any of the provisions of ORS 377.700  
30 to 377.840, the director may revoke, suspend for a period of up to one year or refuse to renew the  
31 license unless a corrected application is filed or the violation ceases, within 30 days after written  
32 notice to do so is mailed to the applicant or licensee. During the suspension of a license, the  
33 licensee may continue in business, but shall not erect or reconstruct any sign requiring a permit  
34 under ORS 377.700 to 377.840.

35 **SECTION 3.** ORS 435.050 is amended to read:

36 435.050. (1) All licenses shall be issued by the State Board of Pharmacy on written application  
37 and payment of an annual license fee for each manufacturer or wholesale license, which fee shall  
38 not exceed \$300.

39 (2) Licenses shall be in effect for one year from January 1 of each year **or such date as may**  
40 **be specified by board rule**.

41 **SECTION 4.** ORS 438.130 is amended to read:

42 438.130. (1) The application for a license for a clinical laboratory shall be made on forms pro-  
43 vided by the Department of Human Services and shall be executed by the owner or one of the  
44 owners or by an officer of the firm or corporation owning the clinical laboratory, or in the case of  
45 a county or municipality, by the public official responsible for operation of the laboratory, or in the

1 case of an institution, by the administrator of the institution. The application shall contain the  
 2 names of the owner, the director or directors of the clinical laboratory, the location and physical  
 3 description of the clinical laboratory, the laboratory specialties for which a license is requested and  
 4 such other information as the department may require.

5 (2)(a) The application shall be accompanied by an annual or biennial license fee to be estab-  
 6 lished by the department. The fee shall be based on test volume, test complexity, the number of  
 7 specialties performed and private laboratory accreditation. For each level of laboratory testing, the  
 8 fee shall be not more than 100 percent of the corresponding fee charged by the federal laboratory  
 9 certification program known as the Clinical Laboratory Improvement Amendments of 1988 (P.L.  
 10 100-578, 42 U.S.C. 201 and 263a) in effect on July 1, 1999. The fee for substance of abuse screening  
 11 laboratories not certified under the Clinical Laboratory Improvement Amendments of 1988 shall be  
 12 comparable to the clinical laboratory fee established under this section.

13 (b) The department may establish prorated fees for licenses issued for a year or less and when  
 14 there is a change in the laboratory's owner, director or address. A prorated license fee shall be is-  
 15 sued to a laboratory accredited by an organization recognized by the department.

16 (3) Unless sooner voided, suspended or revoked, all licenses issued under this section expire on  
 17 June 30 of the ~~[one-]~~ **one-year** or two-year cycle following the date of issuance ~~[and]~~ **or on such**  
 18 **date as may be specified by department rule. Licenses issued under this section** shall be  
 19 renewable in the manner prescribed by the department.

20 (4) Subject to prior approval of the Oregon Department of Administrative Services and a report

 30 **of Consumer and Business Services.**

31 *[(b)]* (2) An elevator operating permit *[is as]* **expires on a date** established *[by the Department*  
 32 *of Consumer and Business Services]* by **department** rule.

33 *[(2)]* (3) Except as provided in ORS 460.055, a holder of a valid elevator inspector certificate of  
 34 competency or elevator operating permit who has complied with ORS 460.005 to 460.175 and the  
 35 rules adopted under ORS 460.085 (1) is entitled to renewal at the expiration of the certificate or  
 36 permit.

37 **SECTION 6.** ORS 508.470 is amended to read:

38 508.470. All licenses for which fees are provided for under ORS 508.285 unless otherwise speci-  
 39 fied in law expire as of midnight, December 31, following the dates of their issuance~~], and shall]~~ **or**  
 40 **on such date as may be specified by rule of the State Department of Fish and Wildlife. The**  
 41 **licenses may** be renewed annually thereafter upon application and payment of fees required there-  
 42 for.

43 **SECTION 7.** ORS 508.781 is amended to read:

44 508.781. An individual who obtained the permit required by ORS 508.775 for a particular calen-  
 45 dar year is eligible to obtain renewal of the permit in a subsequent calendar year, upon application

1 and payment of the fees therefor by December 31 of the permit year **or by such date as may be**  
 2 **specified by rule of the State Department of Fish and Wildlife.**

3 **SECTION 8.** ORS 508.807 is amended to read:

4 508.807. (1) An individual who obtained the permit required by ORS 508.801 for a particular  
 5 calendar year is eligible to obtain renewal of the permit in a subsequent calendar year[, *upon ap-*  
 6 *plication by December 31 of the permit year and payment of the fees therefor, and*] upon obtaining the  
 7 annual boat license referred to in ORS 508.285[.]. **The permit must be renewed, and the boat li-**  
 8 **cence obtained,** not later than December 31 of each year **or such date as may be established by**  
 9 **rule of the State Department of Fish and Wildlife.**

10 (2) Notwithstanding any other provision of law, an individual who permanently loses the ser-  
 11 vices of a vessel through capsizing, sinking, fire, collision or other catastrophic accident has a pe-  
 12 riod of two years from the date of loss to replace the vessel without losing eligibility to renew the  
 13 vessel permit.

14 **SECTION 9.** ORS 508.892 is amended to read:

15 508.892. (1) An individual who obtained the permit required by ORS 508.880 for a particular  
 16 calendar year is eligible to obtain renewal of the permit in a subsequent calendar year[,] upon ap-  
 17 plication [*by December 31 of the permit year*] and payment of the fees therefor and upon obtaining  
 18 the annual boat license referred to in ORS 508.285 [*not later than December 31 of each year*]. **The**  
 19 **permit must be applied for, and the boat license obtained, not later than December 31 of each**  
 20 **year or such date as may be established by rule of the State Department of Fish and Wildlife.**

21 (2) An individual who permanently loses the services of a vessel through capsizing, sinking, fire,  
 22 collision or other catastrophic accident shall remain eligible to obtain a vessel permit for a re-  
 23 placement vessel for two years from the date of loss.

24 **SECTION 10.** ORS 508.947 is amended to read:

25 508.947. (1) The State Department of Fish and Wildlife may issue a black rockfish and blue  
 26 rockfish vessel permit to an owner of a vessel that landed a minimum of 750 pounds of nontrawl  
 27 caught black rockfish, blue rockfish or nearshore fish in any one calendar year between January  
 28 1, 1995, and January 1, 2001, or in the six-month period between January 1, 2001, and July 1, 2001,  
 29 for delivery to a fish processor licensed pursuant to ORS 508.025.

30 (2) The department may issue a black rockfish and blue rockfish vessel permit with a nearshore  
 31 fish endorsement to an owner of a vessel that was issued a permit under the Interim Nearshore  
 32 Fisheries Plan through the Developmental Fisheries Program.

33 (3) The department may renew a black rockfish and blue rockfish vessel permit or a black  
 34 rockfish and blue rockfish vessel permit with a nearshore fish endorsement if the vessel made a  
 35 minimum of five commercial fish landings during the calendar year prior to the request for renewal  
 36 for delivery to a fish processor licensed pursuant to ORS 508.025.

37 (4) Permits issued under this section expire on December 31 of each year **or on such date as**  
 38 **may be specified by department rule.** An owner of a vessel with a permit must submit a renewal  
 39 application to the department by January 1 of each year **or by such date as may be specified by**  
 40 **department rule.** If the owner of a vessel with a permit does not **timely** submit a renewal appli-  
 41 cation [*by January 1*], the department shall, not [*later than February 1*] **more than 30 days after**  
 42 **the application was due,** send to the owner by certified letter a notice of the failure to submit the  
 43 renewal application. An owner may **submit a late application to** renew a permit [*later than Janu-*  
 44 *ary 1, but not later than April 1,*] **not more than 90 days after the application was due** if the  
 45 owner pays a \$150 late fee in addition to the fee required in ORS 508.949.

1 (5) In making determinations regarding initial eligibility for and renewal of a permit issued un-  
2 der this section, the department may consider department records and receipts and accounts, con-  
3 tracts and other business records of private parties that the department considers reliable.

4 (6) Except as provided in ORS 508.955, new vessel permits may not be issued under this section  
5 after December 30, 2005.

6 **SECTION 11.** ORS 537.747 is amended to read:

7 537.747. (1) No person shall advertise services to construct, alter, abandon or convert wells, of-  
8 fer to enter or enter into a contract with another person or public agency to construct, alter,  
9 abandon or convert a well for such other person, cause any well construction, alteration, abandon-  
10 ment or conversion to be performed under such a contract or operate well drilling machinery with-  
11 out possessing a water well constructor's license therefor in good standing issued by the Water  
12 Resources Department. The department shall adopt a single water well constructor's license that  
13 may specify the type of well, type of well alteration or construction or type of well drilling machine  
14 operation for which the water well constructor is qualified.

15 (2) Notwithstanding subsection (1) of this section, a person may operate a well drilling machine  
16 without a water well constructor's license if supervised by one who possesses such a license.

17 (3) A person shall be qualified to receive a water well constructor's license if the person:

18 (a) Is at least 18 years of age.

19 (b) Has passed a written examination conducted by the department to determine fitness to op-  
20 erate as a water well constructor.

21 (c) Has paid a license fee and an examination fee according to the fee schedule set forth under  
22 subsection (6) of this section.

23 (d) Has one year or more experience in the operation of well drilling machinery.

24 (4) Upon fulfillment of all the requirements set out in subsection (3) of this section, the depart-  
25 ment shall issue the applicant a water well constructor's license in a form prescribed by the de-  
26 partment. The license may be issued for a period of two years.

27 (5) A water well constructor's license shall expire on June 30 **or on such date as may be**  
28 **specified by department rule.** A person may renew a license by submitting an application and the  
29 appropriate fees any time before the license expires but not later than one year after the license  
30 expires. At the time of application, the person shall provide the department with evidence of com-  
31 pliance with the continuing education requirements established pursuant to section 4, chapter 496,  
32 Oregon Laws 2001. A person who renews a license within the 12 months after the license expires  
33 may either pay a penalty fee set forth under subsection (6)(d) of this section or requalify for a water  
34 well constructor's license in accordance with subsection (3) of this section. If a person fails to renew  
35 a license within 12 months after expiration the person must comply with the requirements of sub-  
36 section (3) of this section for a new water well constructor's license.

37 (6) The department shall collect in advance the following fees:

38 (a) An examination fee of \$20.

39 (b) A license fee of \$150.

40 (c) A renewal fee of \$150.

41 (d) Unless a person requalifies for a water well constructor's license in accordance with sub-  
42 section (3) of this section, a water well constructor shall pay a renewal fee of \$250 if the license is  
43 renewed within 12 months after expiration.

44 (e) If a person requalifies for a water well constructor's license under subsection (3) of this  
45 section, the person shall pay the renewal fee established under paragraph (c) of this subsection.

1 (7) The department may revoke, suspend or refuse to renew any water well constructor's license  
 2 when it appears to the satisfaction of the department, after notice and opportunity to be heard by  
 3 the licensee, that the licensee has failed to comply with the provisions of ORS 537.505 to 537.795  
 4 and 537.992 applicable to such licensee or any order or rule adopted thereunder applicable to such  
 5 licensee, or has made a material misstatement of fact on an application for a license or well log or  
 6 established a pattern of conduct that willfully or negligently violates any provision of ORS 537.505  
 7 to 537.795 and 537.992, or any rule adopted pursuant thereto, applicable to such licensee.

8 (8) The provisions of subsection (3) of this section requiring one year or more experience in the  
 9 operation of well drilling machinery do not apply to any person who, on July 1, 1981, holds the li-  
 10 cense required by this section and who continues thereafter to maintain the license in good stand-  
 11 ing.

12 (9) The fees collected under subsection (6) of this section shall be paid into the Water Resources  
 13 Department Water Right Operating Fund. Such moneys are continuously appropriated to the Water  
 14 Resources Department to pay the department's expenses in administering and enforcing the water  
 15 well constructor's licensing program.

16 **SECTION 12.** ORS 537.747, as amended by section 8, chapter 496, Oregon Laws 2001, and sec-  
 17 tion 10, chapter 594, Oregon Laws 2003, is amended to read:

18 537.747. (1) No person shall advertise services to construct, alter, abandon or convert wells, of-  
 19 fer to enter or enter into a contract with another person or public agency to construct, alter,  
 20 abandon or convert a well for such other person, cause any well construction, alteration, abandon-  
 21 ment or conversion to be performed under such a contract or operate well drilling machinery with-  
 22 out possessing a water well constructor's license therefor in good standing issued by the Water  
 23 Resources Department.

24 (2) Notwithstanding subsection (1) of this section, a person may operate a well drilling machine  
 25 without a water well constructor's license if supervised by one who possesses such a license.

26 (3) A person shall be qualified to receive a water well constructor's license if the person:

27 (a) Is at least 18 years of age.

28 (b) Has passed a written examination conducted by the department to determine fitness to op-  
 29 erate as a water well constructor.

30 (c) Has paid a license fee and an examination fee according to the fee schedule set forth under  
 31 subsection (6) of this section.

32 (d) Has one year or more experience in the operation of well drilling machinery.

33 (4) Upon fulfillment of all the requirements set out in subsection (3) of this section, the depart-  
 34 ment shall issue the applicant a water well constructor's license in a form prescribed by the de-  
 35 partment. The license may be issued for a period of either one year or five years.

36 (5) A water well constructor's license shall expire on June 30 **or on such date as may be**  
 37 **specified by department rule.** A person may renew a license by submitting an application and the  
 38 appropriate fees any time before the license expires but not later than one year after the license  
 39 expires. A person who renews a license within the 12 months after the license expires may either  
 40 pay a penalty fee set forth under subsection (6)(d) of this section or requalify for a water well  
 41 constructor's license in accordance with subsection (3) of this section. If a person fails to renew a  
 42 license within 12 months after expiration the person must comply with the requirements of sub-  
 43 section (3) of this section for a new water well constructor's license.

44 (6) The department shall collect in advance the following fees:

45 (a) An examination fee of \$20.

1 (b) A license fee of \$50 for a license issued for one year, or \$200 for a license issued for a period  
 2 of five years.

3 (c) A renewal fee of \$50 for a one-year license renewed before the license expires or \$200 for  
 4 a five-year license renewed before the license expires.

5 (d) Unless a person requalifies for a water well constructor's license in accordance with sub-  
 6 section (3) of this section, a water well constructor shall pay a renewal fee of \$100 for a one-year  
 7 license if the license is renewed within 12 months after expiration or \$250 for a five-year license if  
 8 the license is renewed within 12 months after expiration.

9 (e) If a person requalifies for a water well constructor's license under subsection (3) of this  
 10 section, the person shall pay the renewal fee established under paragraph (c) of this subsection.

11 (7) The department may revoke, suspend or refuse to renew any water well constructor's license  
 12 when it appears to the satisfaction of the department, after notice and opportunity to be heard by  
 13 the licensee, that the licensee has failed to comply with the provisions of ORS 537.505 to 537.795  
 14 and 537.992 applicable to such licensee or any order or rule adopted thereunder applicable to such  
 15 licensee, or has made a material misstatement of fact on an application for a license or well log or  
 16 established a pattern of conduct that willfully or negligently violates any provision of ORS 537.505  
 17 to 537.795 and 537.992, or any rule adopted pursuant thereto, applicable to such licensee.

18 (8) The provisions of subsection (3) of this section requiring one year or more experience in the  
 19 operation of well drilling machinery do not apply to any person who, on July 1, 1981, holds the li-  
 20 cense required by this section and who continues thereafter to maintain the license in good stand-  
 21 ing.

22 (9) The fees collected under subsection (6) of this section shall be paid into the Water Resources  
 23 Department Water Right Operating Fund. Such moneys are continuously appropriated to the Water  
 24 Resources Department to pay the department's expenses in administering and enforcing the water  
 25 well constructor's licensing program.

26 **SECTION 13.** ORS 571.075 is amended to read:

27 571.075. (1) The fees for the renewal of the annual licenses and the fees for inspections required  
 28 by ORS 571.005 to 571.230 and 571.991 shall be paid with the application for license renewal and  
 29 before July 1 of each year **or before such date as may be specified by rule of the State De-**  
 30 **partment of Agriculture.**

31 (2) Failure to pay the fees when due forfeits the right to operate as a grower, dealer or agent.

32 (3) Any person who has been previously licensed to grow or sell nursery stock and whose right  
 33 to grow or sell has been forfeited shall not be issued a renewal license except upon written appli-  
 34 cation to the [*State Department of Agriculture*] **department** accompanied by a sum of money equal  
 35 to the regular license fee, as provided in ORS 571.057.

36 **SECTION 14.** ORS 571.535 is amended to read:

37 571.535. (1) The fees for the renewal of the annual licenses required by ORS 571.505 to 571.580  
 38 shall be paid with the application for license renewal and before July 1 of each year **or before such**  
 39 **date as may be specified by rule of the State Department of Agriculture.**

40 (2) Failure to pay the fees when due forfeits the right to operate as a grower.

41 (3) Any person who has been previously licensed to grow Christmas tree stock and whose right  
 42 to grow has been forfeited shall not be issued a renewal license except upon written application to  
 43 the [*State Department of Agriculture*] **department** accompanied by a sum of money equal to the  
 44 regular license fee.

45 **SECTION 15.** ORS 585.040 is amended to read:

1 585.040. Upon the filing of the application and the payment of appropriate fees, the State De-  
2 partment of Agriculture shall, if [it] **the department** is satisfied that the applicant is entitled  
3 thereto, issue to the applicant a license to conduct the business of wholesale produce dealer, retail  
4 produce peddler or cash buyer, as the case may be. The licenses shall be in the form the department  
5 prescribes and shall expire on June 30 of each year **or on such date as may be specified by de-**  
6 **partment rule.**

7 **SECTION 16.** ORS 586.270 is amended to read:

8 586.270. (1) Every person operating any public warehouse in this state shall, before July 1 of  
9 each year **or such date as may be specified by rule of the State Department of Agriculture,**  
10 procure from the [*State Department of Agriculture*] **department** a license for each such warehouse  
11 so operated for the ensuing year, before transacting business at such public warehouse; but the  
12 holder of a license to store grain under the United States Warehouse Act shall furnish the depart-  
13 ment with a copy of such license and bond and, having furnished such copies, is not required to  
14 secure a state license or pay state warehouse inspection fees during the time the license holder  
15 continues to operate under the federal license. The license shall be posted in a conspicuous place  
16 in the office of each warehouse.

17 (2) Application for a license under this section shall be made to the department upon forms  
18 furnished by it. The application shall include:

19 (a) The name and address of the applicant.

20 (b) The location of each public warehouse of the applicant.

21 (c) The total rated storage capacity in bushels of each public warehouse.

22 (d) The tariff schedule of charges to be made at each public warehouse for the handling, storage  
23 and shipment of grain during the license year.

24 (e) Documentation satisfactory to the department that the applicant has net assets of at least  
25 \$50,000.

26 (f) Such other information as the department deems necessary to carry out the purposes of ORS  
27 586.210 to 586.730.

28 (3) The applicant shall submit with the application an annual license fee of \$500 for each public  
29 warehouse.

30 (4) The department shall issue a license to the applicant if it finds that the application is in due  
31 form and the applicant has complied with the provisions of ORS 586.210 to 586.730.

32 **SECTION 17.** ORS 601.030 is amended to read:

 34 to each licensed operator of a funeral establishment or immediate disposition company and to each  
 35 cemetery and crematorium holding a certificate of authority under ORS 692.275, addressed to the  
 36 licensee or certificate holder at the licensee's or certificate holder's last-known address, a notice  
 37 that the renewal fee is due and payable and that if the fee is not paid by the renewal date the li-  
 38 cense or certificate of authority shall lapse. The notice shall be mailed to each licensed funeral  
 39 service practitioner and to each licensed embalmer *[on or before November 1 of each odd-numbered*  
 40 *year]* **at least 60 days before the license expires.** The notice shall be mailed to each licensed op-  
 41 erator of a funeral establishment or immediate disposition company and to each cemetery and  
 42 crematorium holding a certificate of authority under ORS 692.275 *[on or before November 1 of each*  
 43 *even-numbered year]* **at least 60 days before the license or certificate of authority expires.** *[On*  
 44 *or after July 1, 1986,]* The board may impose continuing education requirements as a prerequisite for  
 45 relicensure.



1 (4) Subject to prior approval of the Oregon Department of Administrative Services and a report  
 2 to the Emergency Board prior to adopting the fees and charges, the fees and charges established  
 3 under this section shall not exceed the cost of administering the regulatory program of the State

 22 ister with the State Marine Board. Each registration shall be submitted annually on a form provided  
 23 by the board and shall include the following information:

24 (a) The name, residence address, and residence telephone number of the person providing out-  
 25 fitting and guiding services, and all business names, addresses and telephone numbers under which  
 26 outfitting and guiding services are provided.

27 (b) If the outfitting and guiding services are to be performed in the business name of an indi-  
 28 vidual, proof of possession of a current certificate issued to the individual:

29 (A) By the American Red Cross upon completion of its multimedia course; or

30 (B) Upon completion of any equivalent medical or American Red Cross training course approved  
 31 by the board.

32 (c) If the outfitting and guiding services are to be performed in the business name of a person  
 33 other than an individual, the outfitter and guide must provide the names of all employees, agents  
 34 and parties in interest who physically provide, or who directly assist in physically providing, out-  
 35 fitting and guiding services in Oregon, together with the affidavit of the outfitter and guide that  
 36 each such employee, agent or party in interest possesses:

37 (A) A current certificate issued to the employee, agent or party in interest:

38 (i) By the American Red Cross upon completion of its multimedia course; or

39 (ii) Upon completion of any equivalent medical or American Red Cross training course approved  
 40 by the board.

41 (B) A valid United States Coast Guard vessel operator license if operating a motorboat on  
 42 navigable waters of the United States.

43 (d) A description of:

44 (A) The outfitting and guiding services, and any equipment, supplies, livestock and materials  
 45 provided by the outfitter and guide;

1 (B) The geographic area in which the outfitter and guide provides the outfitting and guiding  
 2 services, and any equipment, supplies, livestock and materials; and

3 (C) The experience of the outfitter and guide in providing the outfitting and guiding services,  
 4 and equipment, supplies, livestock and materials.

5 (e) Proof that the outfitter and guide has liability insurance covering occurrences by the out-  
 6 fitter and guide, and the employees of the outfitter and guide, which result in bodily injury or  
 7 property damage. Such insurance shall be not less than \$300,000 combined single limit per occur-  
 8 rence general liability coverage.

9 (f) Certification by the outfitter and guide that the outfitter and guide will maintain the insur-  
 10 ance required by paragraph (e) of this subsection continuously in full force and effect for a period  
 11 of not less than one year from the date the certificate of registration described in this section is  
 12 issued by the board.

13 (g) The affidavit of the outfitter and guide stating that for a period of not less than 24 months  
 14 immediately prior to making the registration application the outfitter and guide and each person  
 15 who provides or assists in directly providing outfitting and guiding services:

16 (A) Have not been convicted of:

17 (i) Any criminal offense or violation under this chapter or ORS chapter 477, 496, 497, 498, 501,  
 18 506, 508, 509 or 511 or any rule adopted pursuant thereto; or

19 (ii) Any violation of the wildlife laws which occurred while acting as an outfitter and guide and  
 20 which resulted in court-ordered revocation of the hunting or fishing license of the outfitter and  
 21 guide;

22 (B) Have not had an outfitting and guiding license, permit or certificate revoked, suspended or  
 23 canceled by another state or by an agency of the government of the United States;

24 (C) Have not been denied the right to apply for an outfitting and guiding license, permit or  
 25 certificate by another state or by an agency of the government of the United States; and

26 (D) Have not been convicted of guiding without registration as required by this subsection.

27 (2) In addition to the requirements of subsection (1) of this section, a person who acts or offers  
 28 to act as an outfitter and guide using boats that are under the direct operation of an outfitter and  
 29 guide or an employee of an outfitter and guide to carry passengers on the waters of this state shall  
 30 submit proof:

31 (a) That the outfitter and guide possesses a valid United States Coast Guard vessel operator li-  
 32 cense if operating a motorboat on navigable waters of the United States; and

33 (b) Of liability insurance.

34 (3)(a) A person who registers as an outfitter and guide and who accepts deposits from clients in  
 35 excess of \$100 per person shall submit a bond or other financial security in the amount of \$5,000 to  
 36 the board at the time of registration. The bond or other financial security shall be held by the board  
 37 for the benefit of clients of the outfitter and guide who pay a money deposit to the outfitter and  
 38 guide in anticipation of services to be received. The bond or other financial security amount shall  
 39 be released to such client or clients conditioned upon a failure of the outfitter and guide to return

 11 of registration. The board shall also issue to each registrant proof of compliance with the require-

25 (2) The director may charge and collect a license fee from each pawnbroker, according to a li-  
 26 cense fee schedule established by the director by rule, for the purpose of defraying the costs of  
 27 performing supervision, enforcement and other duties imposed by law upon the director in respect  
 28 to pawnbrokers. In setting the license fee schedule and allocating license fees among pawnbrokers,  
 29 the director shall take into consideration the costs of performing the duties of the director relative  
 30 to each pawnbroker, the amount of all other moneys paid to the director under this chapter and the  
 31 cost of developing and maintaining a reasonable emergency fund. License fees under this subsection

 41 receiving aviation instruction, every pilot operating within this state shall register with the Oregon  
 42 Department of Aviation within 60 days of issuance of any appropriate effective federal certificate,  
 43 permit, rating or license relating to competency as a pilot except that student pilots shall register  
 44 prior to their first solo flight. A nonresident pilot of a scheduled or nonscheduled airline, certificated  
 45 by the appropriate federal agency, is not required to register under the provisions of this section

1 unless the nonresident pilot engages in the piloting of aircraft other than such certificated opera-  
2 tion. Nonresidents operating within this state, other than in a commercial operation, shall register  
3 with the department within 60 days of the date of arrival within the state. Pilots operating com-  
4 mercially shall register prior to any commercial operation.

5 (2) Every registered pilot shall renew the first registration on the anniversary of the [*pilot's*  
6 *birthdate*] **first registration date**. After the first renewal, each pilot shall renew registration on the
