

# House Bill 2245

Ordered printed by the Speaker pursuant to House Rule 12.00A (5). Pre-session filed (at the request of Governor Theodore R. Kulongoski for Oregon Student Assistance Commission)

## SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Establishes ASPIRE program within Oregon Student Assistance Commission to provide mentoring and resources to help students access education and training beyond high school.

Establishes ASPIRE Program Fund. Continuously appropriates moneys in fund to commission for program.

Declares emergency, effective July 1, 2007.

## A BILL FOR AN ACT

1  
2 Relating to Oregon Student Assistance Commission; creating new provisions; amending ORS 348.570;  
3 appropriating money; and declaring an emergency.

4 **Be It Enacted by the People of the State of Oregon:**

5 **SECTION 1. Section 2 of this 2007 Act is added to and made a part of ORS 348.505 to**  
6 **348.695.**

7 **SECTION 2. (1) There is established within the Oregon Student Assistance Commission**  
8 **the Access to Student assistance Programs In Reach of Everyone (ASPIRE) program.**  
9 **Through the program, the commission may provide students in Oregon secondary schools**  
10 **with information about financial aid and education and training options beyond high school.**  
11 **The objectives of the program are to:**

12 **(a) Provide mentoring and resources to help students access education and training be-**  
13 **yond high school;**

14 **(b) Help high schools build a sustainable community of volunteer mentors; and**

15 **(c) Educate students and families about the scholarship application process and other**  
16 **options for paying for post-secondary education.**

17 **(2) The program shall bring together students, school staff, community volunteers and**  
18 **parents to help students overcome obstacles to their continuing education. The program may**  
19 **provide Oregon high schools and home school resource centers with training, technical as-**  
20 **sistance and other resources needed to establish a volunteer-based program. Adult volun-**  
21 **teers who are trained through the program may provide mentoring, training and**  
22 **encouragement to students about post-secondary options and financial aid.**

23 **(3) A student, high school or home school resource center may not be required to par-**  
24 **ticipate in the program.**

25 **SECTION 3. ORS 348.570 is amended to read:**

26 348.570. (1) There is established in the State Treasury a fund, separate and distinct from the  
27 General Fund, to be known as the Oregon Student Assistance Fund for investment as provided by  
28 ORS 293.701 to 293.820 and for the payment of the expenses of the Oregon Student Assistance  
29 Commission in carrying out the purposes of ORS 348.210 to 348.250, 348.505 to 348.615, 348.696 and

1 348.992. Interest earned by the fund shall be credited to the fund.

2 (2) There is established in the State Treasury a fund, separate and distinct from the General  
 3 Fund, to be known as the Student Loan Guarantee Fund, which may be invested in the same manner  
 4 as the Oregon Student Assistance Fund. This fund shall receive funds from federal, state or private  
 5 sources for the purpose of guarantying payment of loans made by eligible lending institutions to  
 6 students who are enrolled or accepted for enrollment at any eligible institution and parents of those  
 7 students, under the provisions of the Higher Education Act of 1965 as amended and for administra-  
 8 tive expenses of guarantying loans. This fund, including the interest earnings on the fund, if any,  
 9 is continuously appropriated to the commission for those purposes for which such funds were pro-  
 10 vided to, received or collected by the commission.

11 (3) There is established in the State Treasury a fund, separate and distinct from the General  
 12 Fund, to be known as the Alternative Student Loan Program Fund for investment as provided by  
 13 ORS 293.701 to 293.820 and for the payment of expenses of the commission in carrying out the pur-  
 14 poses of ORS 348.625 to 348.695. This fund, including the interest earnings on the fund, if any, is  
 15 continuously appropriated to the commission for those purposes for which such funds were provided  
 16 to, received or collected by the commission.

17 (4)(a) There is established in the General Fund an account to be known as the Nursing Services  
 18 Account. Funds in the account shall be used for the payment of expenses of the Nursing Services  
 19 Program created in ORS 442.540.

20 (b) The account shall consist of:

21 (A) Funds appropriated to the Oregon Student Assistance Commission for deposit into the ac-  
 22 count;

23 (B) Collections and penalties received by the commission under ORS 442.545; and

24 (C) Any donations or grants received by the commission for purposes of the Nursing Services  
 25 Program.

26 (c) Any funds in the account that are not expended in any biennium shall be retained in the  
 27 account and may be expended in the next biennium.

28 (5) There is established in the State Treasury a fund, separate and distinct from the General  
 29 Fund, to be known as the Former Foster Youth Scholarship Fund. Moneys received from appropri-  
 30 ations, donations and grants shall be credited to the fund. Moneys in the fund are continuously ap-  
 31 propriated to the Oregon Student Assistance Commission for the purposes of investment, as provided  
 32 by ORS 293.701 to 293.820, and for carrying out the provisions of ORS 348.270 (1)(b). Interest earned  
 33 by the fund shall be credited to the fund.

34 **(6) There is established in the State Treasury a fund, separate and distinct from the**  
 35 **General Fund, to be known as the ASPIRE Program Fund. Moneys received from appropri-**  
 36 **ations, donations and grants shall be credited to the ASPIRE Program Fund. Moneys in the**  
 37 **fund are continuously appropriated to the Oregon Student Assistance Commission for the**  
 38 **purposes of investment, as provided by ORS 293.701 to 293.820, and for carrying out the pro-**  
 39 **visions of section 2 of this 2007 Act. Interest earned by the fund shall be credited to the fund.**

40 **SECTION 4.** ORS 348.570, as amended by section 5, chapter 360, Oregon Laws 2003, is amended  
 41 to read:

42 348.570. (1) There is established in the State Treasury a fund, separate and distinct from the  
 43 General Fund, to be known as the Oregon Student Assistance Fund for investment as provided by  
 44 ORS 293.701 to 293.820 and for the payment of the expenses of the Oregon Student Assistance  
 45 Commission in carrying out the purposes of ORS 348.210 to 348.250, 348.505 to 348.615, 348.696 and

2 (2) There is established in the State Treasury a fund, separate and distinct from the General

 9 Higher Education Act of 1965 as amended and for administrative expenses of guarantying loans. This  
 10 fund, including the interest earnings on the fund, if any, is continuously appropriated to the com-  
 11 mission for those purposes for which such funds were provided to, received or collected by the  
 12 commission.

13 (3) There is established in the State Treasury a fund, separate and distinct from the General  
 14 Fund, to be known as the Alternative Student Loan Program Fund for investment as provided by  
 15 ORS 293.701 to 293.820 and for the payment of expenses of the commission in carrying out the pur-  
 16 poses of ORS 348.625 to 348.695. This fund, including the interest earnings on the fund, if any, is

 41 **visions of section 2 of this 2007 Act. Interest earned by the fund shall be credited to the fund.**

42 **SECTION 5. This 2007 Act being necessary for the immediate preservation of the public**  
 43 **peace, health and safety, an emergency is declared to exist, and this 2007 Act takes effect**  
 44 **July 1, 2007.**
