# House Bill 2245

Ordered printed by the Speaker pursuant to House Rule 12.00A (5). Presession filed (at the request of Governor Theodore R. Kulongoski for Oregon Student Assistance Commission)

#### SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Establishes ASPIRE program within Oregon Student Assistance Commission to provide mentoring and resources to help students access education and training beyond high school.

Establishes ASPIRE Program Fund. Continuously appropriates moneys in fund to commission for program.

Declares emergency, effective July 1, 2007.

#### A BILL FOR AN ACT

2 Relating to Oregon Student Assistance Commission; creating new provisions; amending ORS 348.570;

3 appropriating money; and declaring an emergency.

4 Be It Enacted by the People of the State of Oregon:

5 <u>SECTION 1.</u> Section 2 of this 2007 Act is added to and made a part of ORS 348.505 to 6 348.695.

SECTION 2. (1) There is established within the Oregon Student Assistance Commission
the Access to Student assistance Programs In Reach of Everyone (ASPIRE) program.
Through the program, the commission may provide students in Oregon secondary schools
with information about financial aid and education and training options beyond high school.
The objectives of the program are to:

(a) Provide mentoring and resources to help students access education and training be yond high school;

14 (b) Help high schools build a sustainable community of volunteer mentors; and

(c) Educate students and families about the scholarship application process and other
 options for paying for post-secondary education.

17 (2) The program shall bring together students, school staff, community volunteers and 18 parents to help students overcome obstacles to their continuing education. The program may 19 provide Oregon high schools and home school resource centers with training, technical as-20 sistance and other resources needed to establish a volunteer-based program. Adult volun-21 teers who are trained through the program may provide mentoring, training and 22 encouragement to students about post-secondary options and financial aid.

(3) A student, high school or home school resource center may not be required to par ticipate in the program.

(4)(a) There is established in the General Fund an account to be known as the Nursing Services

Program created in ORS 442.540.

(A) Funds appropriated to the Oregon Student Assistance Commission for deposit into the ac-count;

(B) Collections and penalties received by the commission under ORS 442.545; and

(C) Any donations or grants received by the commission for purposes of the Nursing ServicesProgram.

(c) Any funds in the account that are not expended in any biennium shall be retained in theaccount and may be expended in the next biennium.

(5) There is established in the State Treasury a fund, separate and distinct from the General Fund, to be known as the Former Foster Youth Scholarship Fund. Moneys received from appropriations, donations and grants shall be credited to the fund. Moneys in the fund are continuously appropriated to the Oregon Student Assistance Commission for the purposes of investment, as provided by ORS 293.701 to 293.820, and for carrying out the provisions of ORS 348.270 (1)(b). Interest earned by the fund shall be credited to the fund.
