

SENATE AMENDMENTS TO A-ENGROSSED HOUSE BILL 2252

1 On page 2 of the printed A-engrossed bill, delete lines 20 through 43 and insert:

2 “**SECTION 4.** ORS 696.790 is amended to read:

3 “696.790. For the purpose of requesting a state or nationwide criminal records check under ORS
4 181.534, the Real Estate Commissioner may require *[any applicant or licensee regulated under this*
5 *chapter to provide fingerprints.]* **the fingerprints of an individual who:**

6 “(1) **Is applying for a license, or renewal of a license, under this chapter; or**

7 “(2)(a)(A) **Is employed or applying for employment by the Real Estate Agency; or**

8 “(B) **Provides services or seeks to provide services to the Real Estate Agency as a con-**
9 **tractor or volunteer; and**

10 “(b) **Is, or will be, working or providing services in a position:**

11 “(A) **In which the individual is providing information technology services and has control**
12 **over, or access to, information technology systems that would allow the individual to harm**
13 **the information technology systems or the information contained in the systems;**

14 “(B) **In which the individual has access to information that state or federal laws, rules**
15 **or regulations prohibit disclosing or define as confidential;**

16 “(C) **That has payroll functions or in which the individual has responsibility for receiving,**
17 **receipting or depositing money or negotiable instruments, for billing, collections or other fi-**
18 **nancial transactions or for purchasing or selling property or has access to property held in**
19 **trust or to private property in the temporary custody of the state;**

20 “(D) **That has mailroom duties as a primary duty or job function;**

21 “(E) **That has personnel or human resources functions as a primary responsibility;**

22 “(F) **In which the individual has access to Social Security numbers, dates of birth or**
23 **criminal background information of employees or members of the public; or**

24 “(G) **In which the individual has access to tax or financial information about individuals**
25 **or business entities.”.**

26 On page 3, delete lines 9 through 27 and insert:

27 “**SECTION 6.** ORS 673.465 is amended to read:

28 “673.465. For the purpose of requesting a state or nationwide criminal records check under ORS
29 181.534, the Oregon Board of Accountancy may require the fingerprints of a person who *[is]*:

30 “(1) **Is applying for a license, certificate, registration or permit that is issued by the board;**

31 “(2) **Is applying for renewal of a license, certificate, registration or permit that is issued by the**
32 **board;**

33 “(3) **Is under investigation by the board; [or]**

34 “(4) **Is applying for authority to practice public accountancy pursuant to ORS 673.153[.]; or**

35 “(5)(a)(A) **Is employed or applying for employment by the board; or**

1 **“(B) Provides services or seeks to provide services to the board as a contractor or ven-**
2 **dor; and**

3 **“(b) Is, or will be, working or providing services in a position:**

4 **“(A) In which the person has or will have access to individual Social Security numbers,**
5 **dates of birth, credit card information or information that is confidential under state or**
6 **federal laws, rules or regulations; or**

7 **“(B) In which the person is providing information technology services and has control**
8 **over, or access to, information technology systems that would allow the person to harm or**
9 **make unlawful use of the information technology systems or the information contained in**
10 **the systems.”.**
