## House Bill 2297

Sponsored by Representative TOMEI (Presession filed.)

## SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Establishes speed limit of 15 miles per hour for narrow roadways in residence districts.

2	Relating to speed in residence districts; creating new provisions; and amending ORS 811.105 and
3	811.111.
4	Be It Enacted by the People of the State of Oregon:
5	SECTION 1. Section 2 of this 2007 Act is added to and made a part of the Oregon Vehicle
6	Code.
7	SECTION 2. "Narrow roadway" means a roadway that is:
8	(1) Located in a residence district;
9	(2) Intended for through vehicular traffic; and
10	(3) Not of sufficient width to allow one lane of traffic in each direction.
11	SECTION 3. ORS 811.105 is amended to read:
12	811.105. (1) Any speed in excess of a designated speed posted by authority granted under ORS
13	810.180 is prima facie evidence of violation of the basic speed rule under ORS 811.100.
14	(2) If no designated speed is posted by authority granted under ORS 810.180, any speed in excess
15	of one of the following speeds is prima facie evidence of violation of the basic speed rule:
16	(a) Fifteen miles per hour when driving on an alley or a narrow roadway.
17	(b) Twenty miles per hour in a business district.
18	(c) Twenty-five miles per hour in any public park.
19	(d) Twenty-five miles per hour on a highway in a residence district if:
20	(A) The residence district is not located within a city; and
21	(B) The highway is neither an arterial nor a collector highway.
22	(e) Fifty-five miles per hour in locations not otherwise described in this section.
23	SECTION 4. ORS 811.111 is amended to read:
24	811.111. (1) A person commits the offense of violating a speed limit if the person:
25	(a) Drives a vehicle on an interstate highway at a speed greater than 65 miles per hour or, if
26	a different speed is posted under ORS 810.180 (3), at a speed greater than the posted speed.
27	(b) Notwithstanding paragraph (a) of this subsection, drives any of the following vehicles at a
28	speed greater than 55 miles per hour on any highway or, if a different speed is posted under ORS
29	810.180 (3), at a speed greater than the posted speed:
30	(A) A motor truck with a gross vehicle weight rating of more than 10,000 pounds or a truck
31	tractor with a gross vehicle weight rating of more than 8,000 pounds.

32 (B) A school bus.

(C) A school activity vehicle. 1 2 (D) A worker transport bus. (E) A bus operated for transporting children to and from church or an activity or function au-3 thorized by a church. 4 (F) Any vehicle used in the transportation of persons for hire by a nonprofit entity as provided 5 in ORS 825.017 (9). 6 7 (c) Drives a vehicle or conveyance on any part of the ocean shore in this state at a speed greater than any of the following: 8 9 (A) Any designated speed for ocean shores that is established and posted under ORS 810.180. (F) Fifty-five miles per hour in locations not otherwise described in this paragraph. 19 (e) Drives a vehicle in a school zone at a speed greater than 20 miles per hour if the school zone 20is: 2122(A) A segment of highway described in ORS 801.462 (1)(a) and: 23(i) The school zone has a flashing light used as a traffic control device and operated under ORS 811.106 and the flashing light indicates that children may be arriving at or leaving school; or 24(ii) If the school zone does not have a flashing light used as a traffic control device, the person 25drives in the school zone between 7 a.m. and 5 p.m. on a day when school is in session. 2627(B) A crosswalk described in ORS 801.462 (1)(b) and: (i) A flashing light used as a traffic control device and operated under ORS 811.106 indicates 28that children may be arriving at or leaving school; or 2930 (ii) Children are present, as described in ORS 811.124. 31 (2) The offense described in this section, violating a speed limit, is punishable as provided in ORS 811.109. 32
