SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Permits public body or person using private collection agency to collect debt to add fee in amount that in whole or in part compensates public body or person for fee charged by private collection agency.

Declares emergency, effective on passage.

2 Relating to collection of debt; creating new provisions; amending ORS 697.105 and 697.115; and de-
3 claring an emergency.

4 **Be It Enacted by the People of the State of Oregon:**

5 **SECTION 1.** ORS 697.105 is amended to read:

6 697.105. (1) Except as provided in ORS 1.202 and 293.231, if a public body, as defined in ORS
7 174.109, uses a private collection agency to collect a debt owed to the public body, the public body
8 may add a reasonable fee to the amount of the debt, payable by the debtor, **to compensate the**
9 **public body, in whole or in part**, for the collection agency fee incurred or to be incurred.

10 (2) A fee may not be added under subsection (1) of this section unless the public body has pro-
11 vided notice to the debtor:

12 (a) Of the existence of the debt;

13 (b) That the debt may be assigned to a private collection agency for collection; and

14 (c) Of the amount of the fee that may be added to the debt under subsection (1) of this section.

15 (3) Except as provided by federal law, the public body may not add a fee under this section that
16 exceeds the collection fee of the private collection agency.

17 **SECTION 2.** ORS 697.115 is amended to read:

18 697.115. (1) As used in this section, "commercial debt" means any obligation for payment of
19 money or thing of value arising out of an agreement or contract, express or implied, in which the
20 transaction that is the subject of the agreement or contract is not primarily for personal, family or
21 household purposes.

22 (2) A person using a private collection agency to collect a commercial debt owed to the person
23 may add a reasonable fee to the amount of the commercial debt, payable by the debtor, **to com-**
24 **pensate the person, in whole or in part**, for the collection agency fee incurred or to be incurred.

25 A person may not add a fee under this section that:

26 (a) Exceeds the collection fee of the private collection agency; or

27 (b) Was not authorized in the agreement or contract creating the commercial debt.

28 **SECTION 3. The amendments to ORS 697.105 and 697.115 by sections 1 and 2 of this 2007**
29 **Act apply to debts assigned to private collection agencies on or after the effective date of this**
30 **2007 Act.**

1 **SECTION 4. This 2007 Act being necessary for the immediate preservation of the public**
2 **peace, health and safety, an emergency is declared to exist, and this 2007 Act takes effect**
3 **on its passage.**
