## **SUMMARY**

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

[Repeals provision allowing health insurance policies to exclude coverage for loss due to insured's use of intoxicants or controlled substances.]

Requires health insurance policy other than disability income policy to provide coverage or reimbursement of medical expenses related to insured's use of alcohol or controlled substance.

## A BILL FOR AN ACT

2 Relating to health insurance policies; creating new provisions; and amending ORS 743.480 and 750.055.

## Be It Enacted by the People of the State of Oregon:

**SECTION 1.** ORS 743.480 is amended to read:

743.480. [A health insurance policy may contain a provision as follows: "INTOXICANTS AND CONTROLLED SUBSTANCES: The insurer shall not be liable for any loss sustained or contracted in consequence of the insured's being intoxicated or under the influence of any controlled substance unless administered on the advice of a physician."] A health insurance policy other than a disability income policy shall provide coverage or reimbursement of expenses for the medical treatment of injuries or illnesses caused in whole or in part by the insured's use of alcohol or a controlled substance to the same extent as and subject to limitations no more restrictive than those imposed on coverage or reimbursement of expenses arising from treatment of injuries or illnesses not caused by an insured's use of alcohol or a controlled substance.

SECTION 2. ORS 750.055 is amended to read:

The amendments to ORS 743.480 by section 1 of this 2007 Act do not apply to a policy, contract, subscriber agreement, rider or indorsement delivered or issued for delivery in this state by an insurer before the effective date of this 2007 Act. However, the amendments to ORS 743.480 by section 1 of this 2007 Act apply to a new, and to a renewal or extension of an existing, policy, contract, subscriber agreement, rider or indorsement delivered or issued for delivery in this state by an insurer on or after the effective date of this 2007 Act.
