**SUMMARY**

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Provides that Chief Justice of Supreme Court by rule may authorize use of electronic documents or electronic images of paper documents in lieu of original paper copies for any document, process or paper that is served, delivered, received, filed, entered or retained in any action or proceeding.

Provides that Chief Justice by rule may authorize use of electronic signatures or other form of identification for any document, process or paper that is served, delivered, received, filed, entered or retained in any action or proceeding.

Provides that Chief Justice by rule may authorize use of electronic transmission for service of [*summons, subpoena, process or other document*] **documents in proceeding, other than service of summons, initial complaint or petition.**

Allows State Court Administrator [*by rule*], **to extent directed by Chief Justice**, to establish procedures that provide for destruction of records, instruments, books, papers, transcripts and other documents filed in circuit court after making photographic film, microphotographic film, electronic image or other photographic or electronic copy of each document that is destroyed.

5 **Be It Enacted by the People of the State of Oregon:**

6 **SECTION 1.** ORS 1.002 is amended to read:

7 1.002. (1) The Supreme Court is the highest judicial tribunal of the judicial department of gov-  
8 ernment in this state. The Chief Justice of the Supreme Court is the presiding judge of the court  
9 and the administrative head of the judicial department of government in this state. The Chief Justice  
10 shall exercise administrative authority and supervision over the courts of this state consistent with  
11 applicable provisions of law and the Oregon Rules of Civil Procedure. The Chief Justice, to facilitate  
12 exercise of that administrative authority and supervision, may:

13 (a) Make rules and issue orders appropriate to that exercise.

14 (b) Require appropriate reports from the judges, other officers and employees of the courts of  
15 this state and municipal courts.

16 (c) Pursuant to policies approved by the Judicial Conference of the State of Oregon, assign or  
17 reassign on a temporary basis all judges of the courts of this state to serve in designated locations  
18 within or without the county or judicial district for which the judge was elected.

19 (d) Set staffing levels for all courts of the state operating under the Judicial Department and for  
20 all operations in the Judicial Department.

21 (e) Establish time standards for disposition of cases.

**NOTE:** Matter in **boldfaced** type in an amended section is new; matter [*italic and bracketed*] is existing law to be omitted. New sections are in **boldfaced** type.

1 (f) Establish budgets for the Judicial Department and all courts operating under the Judicial  
2 Department.

3 (g) Assign or reassign all court staff of courts operating under the Judicial Department.

4 (h) Pursuant to policies approved by the Judicial Conference of the State of Oregon, establish  
5 personnel rules and policies for judges of courts operating under the Judicial Department.

6 (i) Take any other action appropriate to the exercise of the powers specified in this section and  
7 other law, and appropriate to the exercise of administrative authority and supervision by the Chief  
8 Justice over the courts of this state.

9 (2) [*Subject to all other laws governing courts and court procedures,*] The Chief Justice may make  
10 rules for the use of electronic applications in the courts, including but not limited to rules relating  
11 to:

12 (a) Applications based on the use of the Internet and other similar technologies;

13 [(b) *Filing of electronic documents in court proceedings in lieu of hard copies of those*  
14 *documents;*]

15 **(b) The use of an electronic document, or use of an electronic image of a paper document**  
16 **in lieu of the original paper copy, for a document, process or paper that is served, delivered,**  
17 **received, filed, entered or retained in any action or proceeding;**

18 **(c) The use of electronic signatures or another form of identification for any document,**  
19 **process or paper that is served, delivered, received, filed, entered or retained in any action**  
20 **or proceeding and that is required by any law or rule to be signed;**

21 **(d) The use of electronic transmission for the service of documents in a proceeding, other**  
22 **than service of a summons or service of an initial complaint or petition;**

23 [(c)] (e) Payment of statutory or court-ordered monetary obligations through electronic media;

24 [(d)] (f) Electronic storage of court documents;

25 [(e)] (g) Use of electronic citations in lieu of the paper citation forms as allowed under ORS  
26 153.770, including use of electronic citations for parking ordinance violations that are subject to  
27 ORS 221.333 or 810.425;

28 [(f)] (h) Public access through electronic means to court documents that are required or au-  
29 thorized to be made available to the public by law; and

30 [(g)] (i) Transmission of open court proceedings through electronic media.

31 **(3) Rules adopted by the Chief Justice under subsection (2) of this section must be con-**  
32 **sistent with the laws governing courts and court procedures, but any person who serves,**  
33 **delivers, receives, files, enters or retains an electronic document, or an electronic image of**  
34 **a paper document in lieu of the original paper copy, in the manner provided by a rule of the**  
35 **Chief Justice under subsection (2) of this section shall be considered to have complied with**  
36 **any rule or law governing service, delivery, reception, filing, entry or retention of a paper**  
37 **document.**

38 [(3)] (4) Rules made and orders issued by the Chief Justice under this section shall permit as  
39 much variation and flexibility in the administration of the courts of this state as are appropriate to  
40 the most efficient manner of administering each court, considering the particular needs and cir-  
41 cumstances of the court, and consistent with the sound and efficient administration of the judicial  
42 department of government in this state.

43 [(4)] (5) The judges, other officers and employees of the courts of this state shall comply with  
44 rules made and orders issued by the Chief Justice. Rules and orders of a court of this state, or a  
45 judge thereof, relating to the conduct of the business of the court shall be consistent with applicable

1 rules made and orders issued by the Chief Justice.

2 [(5)] (6) The Chief Judge of the Court of Appeals and the presiding judge of each judicial district  
3 of this state are the administrative heads of their respective courts. They are responsible and ac-  
4 countable to the Chief Justice of the Supreme Court in the exercise of their administrative authority  
5 and supervision over their respective courts. Other judges of the Court of Appeals or court under  
6 a presiding judge are responsible and accountable to the Chief Judge or presiding judge, and to the  
7 Chief Justice, in respect to exercise by the Chief Justice, Chief Judge or presiding judge of admin-  
8 istrative authority and supervision.

9 [(6)] (7) The Chief Justice may delegate the exercise of any of the powers specified by this sec-  
10 tion to the presiding judge of a court, and may delegate the exercise of any of the administrative  
11 powers specified by this section to the State Court Administrator, as may be appropriate.

12 [(7)] (8) [Subsections (1) to (4) of] This section [apply] **applies** to justices of the peace and the  
13 justice courts of this state solely for the purpose of disciplining of justices of the peace and for the  
14 purpose of continuing legal education of justices of the peace.

15 **SECTION 2. (1) Pursuant to ORS 8.125 (11), the State Court Administrator may establish**  
16 **procedures that provide for the destruction of records, instruments, books, papers, tran-**  
17 **scripts and other documents filed in a circuit court after making a photographic film,**  
18 **microphotographic film, electronic image or other photographic or electronic copy of each**  
19 **document that is destroyed.**

20 **(2) A circuit court may use procedures established under subsection (1) of this section**  
21 **only if at the time of making the copy the trial court administrator for the court attaches**  
22 **to copy, attaches to the sealed container in which the copy is placed or incorporates into the**  
23 **copy:**

24 **(a) A certification that the copy is a correct copy of the original, or of a specified part**  
25 **of the original;**

26 **(b) The date on which the copy was made; and**

27 **(c) A certification that the copy was made under the trial court administrator's direction**  
28 **and control.**

29 **(3) A trial court administrator using film for copies under this section must promptly**  
30 **seal and store at least one original or negative copy of the film in a manner and place that**  
31 **will ensure that the film will not be lost, stolen or destroyed.**

32 **(4) A trial court administrator using electronic images for copies under procedures es-**  
33 **tablished under subsection (1) of this section must ensure that the electronic images are**  
34 **continuously updated into commonly used formats and, if necessary, transferred to media**  
35 **necessary to ensure that they are accessible through commonly used electronic or comput-**  
36 **erized systems.**

37 **(5) Copies of documents created under this section must be retained in lieu of the original**  
38 **documents for the period established by the schedule prescribed in ORS 8.125 (11).**

39 **SECTION 3.** ORS 7.020 is amended to read:

40 7.020. The register is a record wherein the clerk or court administrator shall enter, by its title,  
41 every action, suit or proceeding commenced in, or transferred or appealed to, the court, according  
42 to the date of its commencement, transfer or appeal. Thereafter, the clerk or court administrator  
43 shall note therein all the following:

44 (1) The date of any filing of any [paper or process] **document.**

45 (2) The date of making, filing and entry of any order, judgment, ruling or other direction of the

1 court in or concerning such action, suit or proceeding.

2 (3) Any other information required by statute, court order or rule.

3 **SECTION 4.** ORS 7.090 is amended to read:

4 7.090. The files of the court are all [*papers or process*] **documents** filed with or by the clerk of  
5 the court or court administrator, in any action, suit or proceeding therein, or before the judge.

6 **SECTION 5.** ORS 7.110 is amended to read:

7 7.110. (1) The records and files of the court shall be [*kept in the office of*] **maintained by** the  
8 clerk or court administrator of the respective trial or appellate court, and the clerk or court ad-  
9 ministrator is the custodian of and responsible for those records and files. [*The*] **Paper** records and  
10 files [*shall*] **may** not be taken out of the office, **and electronic records may not be removed from**  
11 **any file or electronic database**, by any person except[, ] when allowed by special order of the court  
12 or a judge [*thereof*] or general rule made by the court[, *by a judge of the court or an attorney*].

13 (2) Custody of and responsibility for records and files of the court relating to an action, suit or  
14 proceeding may be transferred to the clerk or court administrator of another court, for the purposes  
15 of storage and servicing, after the expiration of 25 years after the entry of final judgment in the  
16 action, suit or proceeding.

17 **SECTION 6.** ORS 7.250 is amended to read:

18 7.250. (1) The State Court Administrator and the courts of this state shall encourage persons  
19 who make **paper** filings in the courts, including all pleadings, motions, copies and other documents,  
20 to use paper that has been printed on both sides of each sheet. The courts of this state may not  
21 decline to accept any **paper** filing because the filing is printed on both sides of each sheet of paper.

22 (2) All **paper** filings in the courts of this state, including all pleadings, motions, copies and other  
23 documents, shall be printed on recycled paper if recycled paper is readily available at a reasonable  
24 price. The State Court Administrator and the courts of this state shall encourage persons who make  
25 **paper** filings in the courts to use recycled paper that has the highest available content of post-  
26 consumer waste, as defined in ORS 279A.010, and that is recyclable in office paper recycling pro-  
27 grams in the community in which the filing is made. A court of this state may not decline to accept  
28 any **paper** filing because the paper does not comply with the requirements of this subsection.

29 **SECTION 7.** ORS 8.120 is amended to read:

30 8.120. (1) The State Court Administrator shall, for the Supreme Court and Court of Appeals:

31 (a) Act as court administrator for the court.

32 (b) Keep the seal of the court, and affix it in all cases required by law.

33 (c) Record the proceedings of the court.

34 (d) Keep the records, files, books and [*papers*] **documents** pertaining to the court.

35 (e) File all [*papers*] **documents** delivered to the administrator for that purpose in any action or  
36 proceeding in the court.

37 (f) Attend the terms of the court, unless excused by the court, and administer oaths.

38 (g) Under the direction of the court enter its orders and judgments.

39 (h) Authenticate, by certificate or transcript, as may be required, the records, files or pro-  
40 ceedings of the court, or any [*paper*] **document** pertaining thereto, and filed with the administrator.

41 (i) In the performance of duties pertaining to the court, conform to the direction of the court.

42 (2) The State Court Administrator may delegate powers of the office of State Court Adminis-

1 8.225. (1) The trial court administrator for a judicial district has the duties, powers and func-  
2 tions prescribed by law or by rules of the circuit courts in the district.

3 (2) A trial court administrator shall, for each court served by the officer:

4 (a) Keep the seal of the court, and affix it in all cases required by law.

5 (b) Record the proceedings of the court.

6 (c) [*Keep*] **Maintain** the records, files, books and [*papers*] **other documents** pertaining to the  
7 court.

8 (d) File all [*papers*] **documents** delivered to the [*officer for that purpose*] **trial court adminis-**  
9 **trator** in any action or proceeding in the court.

10 (e) Attend the terms of the court, administer oaths and receive the verdict of a jury in any  
11 action or proceeding therein, in the presence and under the direction of the court.

12 (f) Under the direction of the court enter its orders and judgments.

13 (g) Authenticate, by certificate or transcript, as may be required, the records, files or pro-  
14 ceedings of the court, or any [*paper*] **document** pertaining thereto, and filed with the officer.

16 (3) A trial court administrator may take and certify the proof and acknowledgment of a  
17 conveyance of real property or any other written instrument authorized or required to be proved  
18 or acknowledged.

19 (4) A trial court administrator may delegate powers of the office of trial court administrator to  
20 employees of the trial court administrator.

21 (5) A trial court administrator shall designate a person to act as transcript coordinator for the  
22 court.

23 **SECTION 9.** ORS 18.412 is amended to read:

24 18.412. (1) At any time after the date of execution of an agreement to transfer the ownership  
25 of property in which a homestead exemption exists pursuant to ORS 18.395, the homestead owner  
26 or the owner's transferee may give notice of intent to discharge the property from the judgment lien  
27 to a judgment creditor. Each notice shall [*be styled as a paper in*] **bear the caption of** the action  
28 in which the judgment was recovered and shall:

29 (a) Identify the property and the judgment and state that the judgment debtor is about to  
30 transfer, or has transferred, the property and that the transfer is intended to discharge the property  
31 from any lien effect of the judgment;

32 (b) State the fair market value of the property on the date of the notice or of any applicable  
33 petition in bankruptcy, whichever is applicable, and list the encumbrances against the property, in-  
34 cluding the nature and date of each encumbrance, the name of the encumbrancer and the amount  
35 presently secured by each encumbrance;

36 (c) State that the property is claimed by the person giving the notice to be wholly exempt from  
37 the lien of the judgment or, if the value of the property exceeds the sum of the encumbrances  
38 specified as required under paragraph (b) of this subsection that are senior to the judgment lien and  
39 \$30,000 or \$39,600, whichever amount of the homestead exemption is applicable under ORS 18.395  
40 (1), that the amount of the excess or the amount due on the judgment, whichever is less, will be  
41 deposited with the court administrator for the court in which the judgment was entered for the use  
42 of the judgment holder; and

43 (d) Advise the holder of the judgment that the property may be discharged from any lien arising  
44 from the judgment, without further notice to the judgment creditor, unless prior to a specified date,  
45 which in no case may be earlier than 14 days after the date of mailing of the notice, the judgment

1 creditor files objections and a request for a hearing on the matter as provided in ORS 18.415.

2 (2) Each notice described by subsection (1) of this section shall be sent by certified mail to the  
3 judgment creditor, as shown by the court records, at the judgment creditor's present or last-known  
4 address according to the best knowledge of the person sending the notice. A copy of each notice,  
5 together with proof of mailing, may be filed with the court administrator for the court in which the  
6 judgment was entered and shall be filed by the court administrator with the records and files of the  
7 action in which the judgment was recovered.

9 19.500. Except as otherwise provided in this chapter, when any provision of this chapter requires  
10 that a *[paper]* **document** be served and filed, the *[paper]* **document** shall be served in the manner  
11 provided in ORCP 9 B on all other parties who have appeared in the action, suit or proceeding and  
12 who are not represented by the same counsel as the party serving the *[paper]* **document**, and shall  
13 be filed, with proof of service indorsed thereon, with the trial court administrator.

15 to read:

16 21.040. In cases of original jurisdiction in the Supreme Court, the plaintiff or moving party shall  
17 pay \$39 and the defendant or respondent shall pay \$22 on the filing of their first *[paper]*  
18 **document**.

19 **SECTION 12.** ORS 21.110, as amended by section 11, chapter 702, Oregon Laws 2005, is  
20 amended to read:

21 21.110. (1) Except as otherwise provided in this section, at the time of filing in the circuit court  
22 of any civil action, suit or proceeding, including appeals, the clerk of the circuit court shall collect  
23 from the plaintiff, appellant or moving party the sum of \$107 as a flat and uniform filing fee. In ad-  
24 dition, at the time of filing any appearance in any such action, suit or proceeding by any defendant  
25 or respondent appearing separately, or upon the part of defendants or respondents appearing jointly,  
26 the clerk shall collect from the party or parties the sum of \$83 as a flat and uniform filing fee.

27 (2) In the following actions, the clerk of the circuit court shall collect the sum of \$68 as a flat  
28 and uniform filing fee from the plaintiff, appellant or moving party at the time the action is filed,  
29 and shall collect the sum of \$53 as a flat and uniform filing fee from any defendant or respondent  
30 appearing separately, or upon the part of defendants or respondents appearing jointly, at the time  
31 of filing any appearance in the action:

32 (a) Actions for the recovery of money or damages only when the amount claimed does not ex-

39 claimed for such liens does not exceed \$10,000.

40 (e) Actions of interpleader, and in the nature of interpleader, when the amount of money or the  
41 value of the property involved does not exceed \$10,000.

42 (f) Actions for injunctive relief under ORS chapter 90 when the amount of any damages claimed  
43 does not exceed \$10,000.

44 (3) The clerk of the court shall collect the sum of \$300 as a flat and uniform filing fee from the  
45 petitioner in a proceeding under ORS 181.607 or 181.608, at the time the petition is filed. Fees

1 collected under this subsection shall be deposited into the Judicial Department Operating Account  
2 established in ORS 1.009.

3 (4) For purposes of subsection (2) of this section, the amount claimed, value of property, damages  
4 or any amount in controversy does not include any amount claimed as costs and disbursements or  
5 attorney fees as defined by ORCP 68 A.

6 (5) A [*paper or*] pleading **or other document** shall be filed by the clerk only if the fee required  
7 under this section is paid by the person filing the [*paper or pleading*] **document**, or if a request for  
8 a fee waiver or deferral is granted by the court. No part of any such filing fee shall be refunded to  
9 any party. The uniform fee shall cover all services to be performed by the court or clerk in any such  
10 action, suit or proceeding, except where additional fees are specially authorized by law.

28 **SECTION 13.** ORS 21.111, as amended by section 15, chapter 702, Oregon Laws 2005, is  
29 amended to read:

30 21.111. (1) In the proceedings specified in subsection (2) of this section, the clerk of the circuit  
31 court shall collect the sum of \$99 as a flat and uniform filing fee from the petitioner at the time the  
32 petition is filed, and shall collect the sum of \$51 as a flat and uniform filing fee from the respondent  
33 upon the respondent making an appearance.

34 (2) The filing fee established by subsection (1) of this section shall be collected by the clerk in  
35 the following proceedings:

36 (a) Proceedings for dissolution of marriage, annulment of marriage or separation.

37 (b) Filiation proceedings under ORS 109.124 to 109.230.

13 21.114. (1) In a court having jurisdiction, the clerk of the court shall charge and collect:

14 (a) In an adoption proceeding, a first appearance fee of \$39 from the party filing the petition for  
 15 adoption, and a first appearance fee of \$23 from an objecting party appearing separately or objecting  
 16 parties appearing jointly.

17 (b) In a change of name proceeding, a first appearance fee of \$39 from the party filing the ap-  
 18 plication for change of name, and a first appearance fee of \$23 from an objecting party appearing  
 19 separately or objecting parties appearing jointly.

20 (2) A [*paper or*] pleading **or other document** shall be filed by the clerk only if the fee required  
 21 under this section is paid or if a request for a fee waiver or deferral is granted by the court.

 29 proceeding under ORS chapter 125 or a probate, adoption or change of name proceeding, hearing  
 30 fees for reported hearings shall be collected as provided in this section. There is no hearing fee  
 31 under this section for a hearing not reported.

32 (2) As used in this section:

33 (a) "Hearing" means an actual appearance of one or more parties before the court for an ex-  
 34 amination by the court without a jury, other than a trial or during a trial for which a trial fee is  
 35 required, of issues of fact or law arising from a motion, application, petition or other [*paper*] **docu-**
