SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Creates Office of Homeland Security and Emergency Management in Oregon Military Department. Abolishes Office of Emergency Management and transfers functions to Office of Homeland Security and Emergency Management.

Prohibits unit of government from seizing firearms from individuals in lawful possession of firearms during declared emergency.

Declares emergency, effective on passage.

10 **Be It Enacted by the People of the State of Oregon:**

11 **SECTION 1. Section 2 of this 2007 Act is added to and made a part of ORS 401.260 to**
12 **401.325.**

13 **SECTION 2. (1) The Office of Homeland Security and Emergency Management is estab-**
14 **lished in the Oregon Military Department.**

15 **(2) The office shall be responsible for:**

16 **(a) Coordinating and facilitating private sector and governmental efforts to prevent,**
17 **prepare for, respond to and recover from emergencies; and**

18 **(b) Coordinating exercises and training, planning, preparedness, response, mitigation and**
19 **recovery activities with state and local emergency services agencies and organizations.**

20 **SECTION 3. (1) The Office of Homeland Security and Emergency Management is under**
21 **the supervision and control of a director, who is responsible for the performance of the du-**
22 **ties, functions and powers of the office.**

23 **(2) The Adjutant General, with the approval of the Governor, shall appoint the Director**
24 **of the Office of Homeland Security and Emergency Management, who holds office at the**
25 **pleasure of the Adjutant General.**

NOTE: Matter in **boldfaced** type in an amended section is new; matter [*italic and bracketed*] is existing law to be omitted. New sections are in **boldfaced** type.

1 (3) The director shall be paid a salary as provided by law or, if not so provided, as pre-
2 scribed by the Adjutant General, with the approval of the Governor.

3 (4) For purposes of administration, subject to the approval of the Adjutant General, the
4 director may organize and reorganize the office as the director considers necessary to
5 properly conduct the work of the office.

6 (5) The director may divide the functions of the office into administrative divisions.
7 Subject to the approval of the Adjutant General, the director may appoint an individual to
8 administer each division. The administrator of each division serves at the pleasure of the
9 director and is not subject to the provisions of ORS chapter 240. Each individual appointed
10 under this subsection must be well qualified by technical training and experience in the
11 functions to be performed by the individual.

12 SECTION 4. (1) The Director of the Office of Homeland Security and Emergency Man-
13 agement may, by written order filed with the Secretary of State, appoint a deputy director.
14 The deputy director serves at the pleasure of the director, has authority to act for the di-
15 rector in the absence of the director and is subject to the control of the director at all times.

16 (2) Subject to any applicable provisions of ORS chapter 240, the director shall appoint all
17 subordinate officers and employees of the Office of Homeland Security and Emergency
18 Management, prescribe their duties and fix their compensation.

19 SECTION 5. In accordance with applicable provisions of ORS chapter 183, the Director
20 of the Office of Homeland Security and Emergency Management may adopt rules necessary
21 for the administration of the laws that the Office of Homeland Security and Emergency
22 Management is charged with administering.

23 SECTION 6. (1) To aid and advise the Director of the Office of Homeland Security and
24 Emergency Management in the performance of the functions of the Office of Homeland Se-
25 curity and Emergency Management, the director may establish such advisory and technical
26 committees as the director considers necessary. The committees may be continuing or tem-
27 porary. The director shall determine the representation, membership, terms and organiza-
28 tion of the committees and shall appoint their members. The director is an ex officio member
29 of each committee.

30 (2) Members of the committees are not entitled to compensation, but in the discretion
31 of the director may be reimbursed from funds available to the office for actual and necessary
32 travel and other expenses incurred by them in the performance of their official duties in the
33 manner and amount provided in ORS 292.495.

34 SECTION 7. The Director of the Office of Homeland Security and Emergency Manage-
35 ment may enter into interagency agreements with other state agencies that the director
36 determines are necessary to carry out the duties of the Office of Homeland Security and
37 Emergency Management.

38 SECTION 8. (1) The following departments shall designate a person within each depart-
39 ment to act as a liaison with the Office of Homeland Security and Emergency Management:

- 40 (a) The Department of Transportation;
- 41 (b) The State Department of Agriculture;
- 42 (c) The Department of Environmental Quality;
- 43 (d) The Department of Human Services;
- 44 (e) The State Department of Energy;
- 45 (f) The Oregon Department of Administrative Services;

- 1 (g) The Department of State Police;
- 2 (h) The State Department of Geology and Mineral Industries; and
- 3 (i) The Oregon Military Department.

4 (2) Each person designated as a liaison under subsection (1) of this section shall assist
5 in the coordination of the functions of the person's department that relate to emergency
6 preparedness and response with similar functions of the Office of Homeland Security and
7 Emergency Management.

8 **SECTION 9.** (1) The Office of Emergency Management in the Department of State Police
9 is abolished. On the operative date of this section, the tenure of office of the Director of the
10 Office of Emergency Management ceases.

11 (2) All the duties, functions and powers of the Office of Emergency Management are
12 imposed upon, transferred to and vested in the Office of Homeland Security and Emergency
13 Management.

14 **SECTION 10.** (1) The Superintendent of State Police shall:

15 (a) Deliver to the Office of Homeland Security and Emergency Management all records
16 and property within the jurisdiction of the superintendent that relate to the duties, functions
17 and powers transferred by section 9 of this 2007 Act; and

18 (b) Transfer to the Office of Homeland Security and Emergency Management those em-
19 ployees engaged primarily in the exercise of the duties, functions and powers transferred by
20 section 9 of this 2007 Act.

21 (2) The Director of the Office of Homeland Security and Emergency Management shall
22 take possession of the records and property, and shall take charge of the employees and
23 employ them in the exercise of the duties, functions and powers transferred by section 9 of
24 this 2007 Act, without reduction of compensation but subject to change or termination of
25 employment or compensation as provided by law.

26 (3) The Adjutant General shall resolve any dispute between the Office of Emergency
27 Management and the Office of Homeland Security and Emergency Management relating to
28 transfers of records, property and employees under this section, and the Adjutant General's
29 decision is final.

30 **SECTION 11.** (1) The unexpended balances of amounts authorized to be expended by the
31 Office of Emergency Management for the biennium beginning July 1, 2007, from revenues
32 dedicated, continuously appropriated, appropriated or otherwise made available for the pur-
33 pose of administering and enforcing the duties, functions and powers transferred by section
34 9 of this 2007 Act are appropriated and transferred to and are available for expenditure by
35 the Office of Homeland Security and Emergency Management for the biennium beginning
36 July 1, 2007, for the purpose of administering and enforcing the duties, functions and powers
37 transferred by section 9 of this 2007 Act.

38 (2) The expenditure classifications, if any, established by Acts authorizing or limiting
39 expenditures by the Office of Emergency Management remain applicable to expenditures by
40 the Office of Homeland Security and Emergency Management under this section.

41 **SECTION 12.** The transfer of duties, functions and powers to the Office of Homeland
42 Security and Emergency Management by section 9 of this 2007 Act does not affect any action,
43 proceeding or prosecution involving or with respect to such duties, functions and powers
44 begun before and pending at the time of the transfer, except that the Office of Homeland
45 Security and Emergency Management is substituted for the Office of Emergency Manage-

1 ment in the action, proceeding or prosecution.

2 **SECTION 13.** (1) Nothing in sections 9 to 12 of this 2007 Act relieves a person of a li-
3 ability, duty or obligation accruing under or with respect to the duties, functions and powers
4 transferred by section 9 of this 2007 Act. The Office of Homeland Security and Emergency
5 Management may undertake the collection or enforcement of any such liability, duty or ob-
6 ligation.

7 (2) The rights and obligations of the Office of Emergency Management legally incurred
8 under contracts, leases and business transactions executed, entered into or begun before the
9 operative date of section 9 of this 2007 Act are transferred to the Office of Homeland Secu-
10 rity and Emergency Management. For the purpose of succession to these rights and obli-
11 gations, the Office of Homeland Security and Emergency Management is a continuation of
12 the Office of Emergency Management and not a new authority.

13 **SECTION 14.** Notwithstanding the transfer of duties, functions and powers by section 9
14 of this 2007 Act, the rules of the Office of Emergency Management in effect on the operative
15 date of section 9 of this 2007 Act continue in effect until superseded or repealed by rules of
16 the Office of Homeland Security and Emergency Management. References in rules of the
17 Office of Emergency Management to the Office of Emergency Management or an officer or
18 employee of the Office of Emergency Management are considered to be references to the
19 Office of Homeland Security and Emergency Management or an officer or employee of the
20 Office of Homeland Security and Emergency Management.

21 **SECTION 15.** Whenever, in any uncodified law or resolution of the Legislative Assembly
22 or in any rule, document, record or proceeding authorized by the Legislative Assembly, ref-
23 erence is made to the Office of Emergency Management or an officer or employee of the
24 Office of Emergency Management, the reference is considered to be a reference to the Office
25 of Homeland Security and Emergency Management or an officer or employee of the Office
26 of Homeland Security and Emergency Management.

27 **SECTION 16.** The Director of the Office of Homeland Security and Emergency Manage-
28 ment may be appointed before the operative date of section 9 of this 2007 Act and may take
29 any action before that date that is necessary to enable the director to exercise, on and after
30 the operative date of section 9 of this 2007 Act, the duties, functions and powers of the di-
31 rector pursuant to section 9 of this 2007 Act.

32 **SECTION 17.** Except as otherwise specifically provided in section 16 of this 2007 Act,
33 sections 1 to 15, 17a and 17b of this 2007 Act, the amendments to statutes and uncodified law
34 by sections 18 to 82 of this 2007 Act and the repeal of ORS 401.260 by section 83 of this 2007
35 Act become operative on January 1, 2008.

36 **SECTION 17a.** Section 17b of this 2007 Act is added to and made a part of ORS 401.015
37 to 401.105.

38 **SECTION 17b.** (1) As used in this section, "unit of government" means any department
39 or agency of the federal government, any state or any agency, office or department of a
40 state, any city, county, district, commission, authority, entity, port or other public corpo-
41 ration organized and existing under statutory law or under a voter-approved charter and any
42 intergovernmental entity created under ORS 190.003 to 190.130, 190.410 to 190.440 or 190.480
43 to 190.490.

44 (2) Notwithstanding ORS 401.065, 401.085, 401.095 and 401.115, during a state of emergency
45 declared under ORS 401.055, a unit of government may not seize a firearm from an individual

1 **who lawfully possesses the firearm.**

2 (3) **If a unit of government seizes a firearm from an individual during a state of emer-**
3 **gency in violation of this section, the individual may recover from the unit of government**
4 **that seized the firearm all costs incurred in the recovery of the firearm, including attorney**
5 **fees, court costs and any other costs incurred in the recovery of the firearm.**

6 **SECTION 18.** ORS 401.025 is amended to read:

7 401.025. As used in ORS 401.015 to 401.105, 401.260 to 401.325 and 401.355 to 401.580, unless the
8 context requires otherwise:

9 (1) "Beneficiary" has the meaning given that term in ORS 656.005.

10 (2) "Commission" means the Seismic Safety Policy Advisory Commission established under ORS
11 401.337.

12 (3) "Emergency" [*includes any*] **means a human caused or natural event or circumstance [*caus-***
13 **ing or threatening] that causes or threatens widespread:**

14 (a) Loss of life[,];

15 (b) Injury to person or property[,];

16 (c) Human suffering; or

17 (d) Financial loss[, *and includes, but is not limited to, fire, explosion, flood, severe weather,*
18 *drought, earthquake, volcanic activity, spills or releases of oil or hazardous material as defined in ORS*
19 *466.605, contamination, utility or transportation emergencies, disease, blight, infestation, crisis influx*
20 *of migrants unmanageable by the county, civil disturbance, riot, sabotage and war].*

21 (4) "Emergency management agency" means an organization created and authorized under ORS
22 401.015 to 401.105, 401.260 to 401.325 and 401.355 to 401.580 by the state, county or city to provide
23 for and [*assure*] **ensure** the conduct and coordination of functions for comprehensive emergency
24 program management.

25 (5) "Emergency program management" includes all the tasks and activities necessary to provide,
26 support and maintain the ability of the emergency services system to prevent or reduce the impact
27 of emergency or disaster conditions which includes, but is not limited to, coordinating development
28 of plans, procedures, policies, fiscal management, coordination with nongovernmental agencies and
29 organizations, providing for a coordinated communications and alert and notification network and
30 a public information system, personnel training and development and implementation of exercises to
31 routinely test the emergency services system.

32 (6) "Emergency program manager" means the person administering the emergency management
33 agency of a county or city.

34 (7) "Emergency service agency" means an organization within a local government which per-
35 forms essential services for the public's benefit prior to, during or following an emergency. This in-
36 cludes, but is not limited to, organizational units within local governments, such as law enforcement,
37 fire control, health, medical and sanitation services, public works and engineering, public informa-
38 tion and communications.

39 (8) "Emergency service worker" means an individual who, under the direction of an emergency
40 service agency or emergency management agency, performs emergency services and:

41 (a) Is a registered volunteer or independently volunteers to serve without compensation and is
42 accepted by the [*Office of Emergency Management*] **Office of Homeland Security and Emergency**
43 **Management** or the emergency management agency of a county or city; or

44 (b) Is a member of the Oregon State Defense Force acting in support of the emergency services
45 system.

1 (9) "Emergency services" includes those activities provided by state and local government
2 agencies with emergency operational responsibilities to prepare for and carry out any activity to
3 prevent, minimize, respond to or recover from an emergency. These activities include, without limi-
4 tation, coordination, preparedness planning, training, interagency liaison, fire fighting, oil or haz-
5 arduous material spill or release cleanup as defined in ORS 466.605, law enforcement, medical, health
6 and sanitation services, engineering and public works, search and rescue activities, warning and
7 public information, damage assessment, administration and fiscal management, and those measures
8 defined as "civil defense" in [section 3 of the Act of January 12, 1951, P.L. 81-920 (50 U.S.C. 2252)]
9 **50 U.S.C. app. 2252.**

10 (10) "Emergency services system" means that system composed of all agencies and organizations
11 involved in the coordinated delivery of emergency services.

12 (11) "**Human caused or natural event or circumstance**" includes, but is not limited to:

13 (a) **Fire, explosion, flood, severe weather, drought, earthquake, tsunami, volcanic activ-**
14 **ity, spills or releases of oil or hazardous material as defined in ORS 466.605, contamination,**
15 **utility or transportation emergencies, disease, blight, infestation, civil disturbance, riot,**
16 **sabotage and war; and**

17 (b) **A rapid influx of individuals from outside this state, a rapid migration of individuals**
18 **from one part of this state to another or a rapid displacement of individuals if the influx,**
19 **migration or displacement results from the type of event or circumstance described in par-**
20 **agraph (a) of this subsection.**

21 [(11)] (12) "Injury" means any personal injury sustained by an emergency service worker by
22 accident, disease or infection arising out of and in the course of emergency services or death re-
23 sulting proximately from the performance of emergency services.

24 [(12)] (13) "Local government" means any governmental entity authorized by the laws of this
25 state.

26 [(13)] (14) "Major disaster" means any event defined as a "major disaster" under 42 U.S.C.
27 5122(2).

28 [(14)] (15) "Oregon emergency management plan" means the state emergency preparedness op-
29 erations and management plan. The [(Office of Emergency Management)] **Office of Homeland Secu-**
30 **rity and Emergency Management** is responsible for coordinating emergency planning with
31 government agencies and private organizations, preparing the plan for the Governor's signature, and
32 maintaining and updating the plan as necessary.

33 [(15)] (16) "Search and rescue" means the acts of searching for, rescuing or recovering, by
34 means of ground or marine activity, any person who is lost, injured or killed while out of doors.
35 However, "search and rescue" does not include air activity in conflict with the activities carried
36 out by the Oregon Department of Aviation.

37 [(16)] (17) "Sheriff" means the chief law enforcement officer of a county.

38 **SECTION 19.** ORS 401.055 is amended to read:

39 401.055. (1) The Governor may declare a state of emergency by proclamation at the request of
40 a county governing body or after determining that an emergency has occurred or is imminent.

41 (2) All requests by a county governing body that the Governor declare an emergency shall be
42 sent to the [(Office of Emergency Management)] **Office of Homeland Security and Emergency**
43 **Management.** Cities must submit requests through the governing body of the county in which the
44 majority of the city's property is located. Requests from counties shall be in writing and include
45 the following:

1 (a) A certification signed by the county governing body that all local resources have been ex-
2 pended; and

3 (b) A preliminary assessment of property damage or loss, injuries and deaths.

4 (3)(a) If, in the judgment of the [*Superintendent of State Police*] **Adjutant General**, the Governor
5 cannot be reached by available communications facilities in time to respond appropriately to an
6 emergency, the [*superintendent*] **Adjutant General** shall notify the Secretary of State or, if the
7 Secretary of State is not available, the State Treasurer that the Governor is not available.

8 (b) After notice from the [*superintendent*] **Adjutant General** that the Governor is not available,
9 the elected state official so notified may declare a state of emergency pursuant to the provisions of
10 subsections (1) and (2) of this section.

11 (c) If the [*Superintendent of State Police*] **Adjutant General** is unavailable to carry out the du-
12 ties described in this subsection, such duties shall be performed by the [*Director of the Office of*
13 *Emergency Management*] **Director of the Office of Homeland Security and Emergency Manage-**
14 **ment.**

15 (4) Any state of emergency declared by the Secretary of State or State Treasurer pursuant to
16 this section has the same force and effect as if issued by the Governor, except that it must be af-
17 firmed by the Governor as soon as the Governor is reached. However, if the Governor does not set
18 aside the proclamation within 24 hours of being reached, the proclamation shall be considered af-
19 firmed by the Governor.

20 (5) Any proclamation of a state of emergency must specify the geographical area covered by the
21 proclamation. Such area shall be no larger than necessary to effectively respond to the emergency.

22 **SECTION 20.** ORS 401.270 is amended to read:

23 401.270. The Director of the [*Office of Emergency Management*] **Office of Homeland Security**
24 **and Emergency Management** shall be responsible for coordinating and facilitating **exercises and**
25 **training**, emergency planning, preparedness, response, **mitigation** and recovery activities with the
26 state and local emergency services agencies and organizations, and shall, with the approval of the
27 [*Superintendent of State Police*] **Adjutant General** or as directed by the Governor:

28 (1) Make rules that are necessary and proper for the administration and implementation of ORS
29 401.015 to 401.105, 401.260 to 401.325, 401.355 to 401.580 and 401.706;

30 (2) Coordinate the activities of all public and private organizations specifically related to pro-
31 viding emergency services within this state;

32 (3) Maintain a cooperative liaison with emergency management agencies and organizations of
33 local governments, other states and the federal government;

34 (4) Have such additional authority, duties and responsibilities authorized by ORS 401.015 to
35 401.105, 401.260 to 401.325 and 401.355 to 401.580 or as may be directed by the Governor;

36 (5) Administer grants relating to emergency program management, seismic rehabilitation, emer-
37 gency services for the state and the statewide 2-1-1 system as provided in ORS 401.294;

38 (6) Provide for and staff a State Emergency Operations Center to aid the Governor and the
39 [*Office of Emergency Management*] **Office of Homeland Security and Emergency Management** in
40 the performance of duties under ORS 401.015 to 401.105, 401.260 to 401.325, 401.355 to 401.580 and
41 401.706;

42 (7) Serve as the Governor's authorized representative for coordination of certain response ac-
43 tivities and managing the recovery process;

44 (8) Establish training and professional standards for local emergency program management per-
45 sonnel;

1 (9) Establish task forces and advisory groups to assist the office in achieving mandated respon-
2 sibilities;

3 (10) Enforce compliance requirements of federal and state agencies for receiving funds and
4 conducting designated emergency functions;

5 (11) Oversee the design, implementation and support of a statewide 2-1-1 system as provided
6 under ORS 401.288; and

7 (12) Coordinate the activities of state and local governments to enable state and local govern-
8 ments to work together during domestic incidents as provided in the National Incident Management
9 System established by the Homeland Security Presidential Directive 5 of February 28, 2003.

10 **SECTION 21.** ORS 401.275 is amended to read:

11 401.275. (1)(a) The Department of State Police shall maintain a system for the notification and
12 interagency coordination of state resources in response to [*natural and technological*] emergencies
13 [*and civil disorder*] involving multijurisdictional cooperation between the various levels of govern-
14 ment and private business entities.

15 **(b) The department shall provide the Office of Homeland Security and Emergency Man-**
16 **agement with a service level agreement that describes the continued daily operations and**
17 **maintenance of the system, the services and supplies needed to maintain the system 24 hours**
18 **a day, every day of the year and the policies and procedures that support the overall notifi-**
19 **cation system.**

20 (2) The notification system shall be managed by the [*Office of Emergency Management*] **Office**
21 **of Homeland Security and Emergency Management** as a continuously available communications
22 network and a component of the state's emergency operations center.

23 (3) The notification system shall be the primary point of contact by which any public agency
24 provides the state notification of an emergency or disaster, or requests access to state and federal
25 resources.

26 (4) Each department of state government, and those agencies of state government identified in
27 the Oregon emergency management plan with emergency service or administrative responsibilities,
28 shall appoint an emergency management coordinator as their representative to work with the office
29 on the development and implementation of emergency plans and procedures.

30 (5) The [*Department of State Police*] **Office of Homeland Security and Emergency Manage-**
31 **ment** shall adopt rules relating to the planning, administration and operation of the notification
32 system maintained under this section.

33 **SECTION 22.** ORS 401.280 is amended to read:

34 401.280. (1) The [*Office of Emergency Management*] **Office of Homeland Security and Emer-**
35 **gency Management** is designated as the sole agency of the State of Oregon for the purpose of ne-
36 gotiating agreements with the [*Federal Emergency Management Agency*] **United States Department**
37 **of Homeland Security** or other appropriate federal agency, on behalf of the state, for the acqui-
38 sition of federal funds for the purpose of providing emergency program management and emergency
39 services. All city or county emergency management programs, emergency service agencies and state
40 agencies applying for such funds shall coordinate with the [*Office of Emergency Management*] **office**
41 on development of proposals and shall submit applications to the agency to be reviewed or pro-
42 cessed, or both.

43 (2) The office is authorized to accept and receive on behalf of the state, counties and cities
44 federal funds for purpose of emergency program management and emergency services, to deposit
45 such funds in the [*Emergency Management*] **Homeland Security and Emergency Management**

1 Revolving Account and to authorize the disbursement and distribution of these funds in accordance
2 with the applicable agreement.

3 **SECTION 23.** ORS 401.288 is amended to read:

4 401.288. (1) Subject to subsection (3) of this section, the [*Office of Emergency Management*] **Office**
5 **of Homeland Security and Emergency Management** shall enter into a contract with a 2-1-1 sys-
6 tem facilitator to design, implement and support a statewide 2-1-1 system.

7 (2) The contract shall ensure that the 2-1-1 system facilitator:

8 (a) Creates a structure for a statewide 2-1-1 resources database that:

9 (A) Meets standards for information and referral systems databases established by a nationally
10 recognized corporation devoted to improving access to services through a mechanism of information
11 and referral; and

12 (B) Will be integrated with local resources databases maintained by approved 2-1-1 service pro-
13 viders;

14 (b) Develops a statewide resources database for the 2-1-1 system; and

15 (c) Maintains public information provided by state agencies and programs that provide health
16 and human services for access by 2-1-1 service providers.

28 (a) Proceeds of Article XI-N bonds that were issued to pay bond-related costs;

29 (b) Amounts appropriated or otherwise provided by the Legislative Assembly for deposit in the
30 bond administration fund; and

31 (c) Amounts transferred from the Emergency Services Seismic Fund by the [*Office of Emergency*
32 *Management*] **Office of Homeland Security and Emergency Management** as provided in ORS
33 286.788.

34 (2) The department may create separate accounts in the bond administration fund.

35 **SECTION 75.** ORS 286.788 is amended to read:

36 286.788. (1) The Emergency Services Seismic Fund is established in the State Treasury, separate
37 and distinct from the General Fund. Amounts in the seismic fund may be invested as provided in
38 ORS 293.701 to 293.820, and interest earned on the seismic fund must be credited to the seismic fund.
39 Amounts credited to the seismic fund are continuously appropriated to the [*Office of Emergency*
40 *Management*] **Office of Homeland Security and Emergency Management** for the purpose de-
41 scribed in ORS 286.782 (2)(a) and for the purpose of paying bond-related costs. The office shall de-
42 posit in the seismic fund:

43 (a) The net proceeds of Article XI-N bonds transferred pursuant to ORS 286.782 (3);

32 (3) The Department of Environmental Quality;

33 (4) The Department of Consumer and Business Services;

34 (5) The Department of Transportation;

35 (6) The Department of Human Services;

36 (7) The Environmental Health Sciences Center at Oregon State University;

37 (8) The [*Office of Emergency Management of the Department of State Police*] **Office of Homeland**
38 **Security and Emergency Management**; and

39 (9) Every public library as defined in ORS 357.400.

40 **SECTION 77.** Section 1, chapter 763, Oregon Laws 2005, is amended to read:

41 **Sec. 1.** (1) The State Department of Geology and Mineral Industries, in consultation with the
42 Seismic Safety Policy Advisory Commission, the [*Office of Emergency Management*] **Office of**
43 **Homeland Security and Emergency Management**, the Department of Human Services, the State
44 Board of Education, the State Board of Higher Education and any grant committee established
45 pursuant to a statewide grant program for seismic rehabilitation, shall develop a statewide seismic

1 needs assessment that includes seismic safety surveys of:

2 (a) Buildings that have a capacity of 250 or more persons and are routinely used for student
3 activities by kindergarten through grade 12 public schools, community colleges and education ser-
4 vice districts;

5 (b) Hospital buildings that contain an acute inpatient care facility;

6 (c) Fire stations; and

7 (d) Police stations, sheriffs' offices and similar facilities used by state, county, district and mu-
8 nicipal law enforcement agencies.

9 (2) The statewide seismic needs assessment shall consist of:

10 (a) Rapid visual screenings of the buildings specified in this section, conducted in accordance
11 with the standards for rapid visual screening procedures established in "Rapid Visual Screening of
12 Buildings for Potential Seismic Hazards: A Handbook," FEMA-154, 2002 Edition, or an equivalent
13 standard adopted by the State Department of Geology and Mineral Industries;

14 (b) The ranking of the rapid visual screening results in risk categories based on need, impor-
15 tance of the building to the community, risk to the building posed by its location, risk posed to the
16 community by the collapse of the building during a seismic event, projected cost of the necessary
17 seismic rehabilitation and other categories determined necessary by the State Department of
18 Geology and Mineral Industries; and

19 (c) The development of geographic information system (GIS) databases of survey data and the
20 sharing of that data with interested parties.

21 (3) The statewide seismic needs assessment may include:

22 (a) Rapid visual screenings conducted by entities or persons other than the State Department
23 of Geology and Mineral Industries;

24 (b) Questionnaires or other information gathering techniques to supplement the rapid visual

28 465.505. (1) In addition to any other applicable federal or state law and regulation, the following
29 waste minimization requirements shall apply to dry cleaning facilities:

30 (a) All wastes meeting the state and federal criteria for hazardous waste, excluding wastewater,
31 generated at any dry cleaning facility and containing dry cleaning solvents, including residues and
32 filters, shall be managed and disposed of, regardless of quantity generated, as hazardous wastes in
33 accordance with federal and state laws otherwise applicable to management of hazardous wastes,
34 except that, as to the cleanup of releases of dry cleaning solvents, ORS 465.503 shall apply rather
35 than ORS 466.205;

36 (b) Wastewater contaminated with dry cleaning solvents from the water separation process of
37 dry cleaning machines may not be discharged into any sanitary sewer or septic tank or into the
38 waters of this state;

39 (c) Dry cleaning operators shall manage solvent contaminated wastewater generated in the wa-
40 ter separation process in accordance with rules adopted by the Environmental Quality Commission;

41 (d) A dry cleaning facility may not include operation of transfer-type dry cleaning equipment
42 using perchloroethylene;

43 (e) All newly installed dry cleaning systems using perchloroethylene shall be of the dry-to-dry
44 type and be equipped with integral refrigerated condensers with an outlet temperature sensor for
45 the control of perchloroethylene emissions;

1 (f) All existing dry cleaning systems using perchloroethylene shall install refrigerated
2 condensers, or an equivalent;

3 (g) Every dry cleaning facility shall install secondary containment systems capable of containing
4 dry cleaning solvent under and around each machine or item of equipment in which any dry cleaning
5 solvent is used, treated or stored; and

6 (h) All perchloroethylene dry cleaning solvent shall be delivered to dry cleaning facilities by
7 means of closed, direct-coupled delivery systems.

29 as that person knows the spill or release is a reportable quantity.

30 **SECTION 80.** ORS 469.533 is amended to read:

31 469.533. Notwithstanding ORS chapter 401, the State Department of Energy in cooperation with
32 the Department of Human Services and the [Office of Emergency Management] **Office of Homeland**
33 **Security and Emergency Management** shall establish rules for the protection of health and pro-
34 cedures for the evacuation of people and communities who would be affected by radiation in the
35 event of an accident or a catastrophe in the operation of a nuclear power plant or nuclear instal-
36 lation.

37 **SECTION 81.** ORS 824.088 is amended to read:

38 824.088. (1) Each railroad that gives notice to the United States Department of Transportation
39 of an incident that occurs during the course of transporting hazardous materials as defined by fed-
40 eral regulations shall also give notice of the incident to the Director of the [Office of Emergency
41 Management of the Department of State Police] **Office of Homeland Security and Emergency**
42 **Management**.

43 (2) As soon as reasonably practicable, each railroad shall notify the director [of the Office of
44 Emergency Management of the Department of State Police] by telephone or similar means of commu-
45 nication of any derailment or fire involving or affecting hazardous material.

1 (3) To facilitate expedited and accurate notice to the director under this section, each train
 2 transporting hazardous materials in this state shall be equipped with at least two radio
 3 transmitter-receivers in good working order. In addition, 18 months after October 4, 1977, trains
 4 over 2,000 feet in length that are transporting hazardous materials shall be equipped with a radio
 5 handset in good working order capable of communicating with the radio transmitter-receivers. If the
 6 equipment required under this section does not function while the train is en route, the train may
 7 proceed to the next point of crew change where the equipment shall be replaced or repaired.

9 837.035. All moneys received by the Oregon Department of Aviation for the registration of pilot
 10 licenses as prescribed in ORS 837.020 shall be paid by the department to the State Treasurer, who
 11 shall deposit it in the General Fund to a special account to be known as the Aviation Search and
 12 Rescue Account. The money in the account established under this section shall be used by the [*Of-
 13 fice of Emergency Management of the Department of State Police*] **Office of Homeland Security and

 26 to compensate any member of a volunteer air search and rescue organization for injuries or loss of

 28 of the office [*of Emergency Management*]. The insurance may be obtained from a public or private
 29 insurer. The scope, coverage and benefits provided under the insurance shall not exceed those pro-

 37 person acting under the authority or direction of the [*Office of Emergency Management*] **office** for
 38 those injuries or losses resulting from the air search and rescue activities.

40 **SECTION 84.** This 2007 Act being necessary for the immediate preservation of the public
 41 peace, health and safety, an emergency is declared to exist, and this 2007 Act takes effect
 42 on its passage.
