

## HOUSE AMENDMENTS TO HOUSE BILL 2435

1 On page 1 of the printed bill, delete lines 5 through 31.

2 Delete pages 2 through 5 and insert:

3 **“SECTION 1. Section 2 of this 2007 Act is added to and made a part of the Oregon Vehicle**  
4 **Code.**

5 **“SECTION 2. (1) A person commits the offense of acting as a vehicle appraiser without**  
6 **a certificate if the person is not the holder of a vehicle appraiser certificate or a master**  
7 **vehicle appraiser certificate and the person:**

8 **“(a) Represents that the person is a vehicle appraiser; or**

9 **“(b) Appraises a vehicle.**

10 **“(2) This section does not apply to:**

11 **“(a) A person who holds a vehicle dealer certificate issued or renewed under ORS 822.020**  
12 **or 822.040; or**

13 **“(b) A person from another jurisdiction who holds a vehicle appraiser certificate requir-**  
14 **ing qualifications substantially similar to a vehicle appraiser or master vehicle appraiser in**  
15 **this state.**

16 **“(3) The offense described in this section, acting as a vehicle appraiser without a certif-**  
17 **icate, is a Class A violation.**

18 **“SECTION 3. ORS 819.230 is amended to read:**

19 **“819.230. (1) A person who is issued [an] a vehicle appraiser certificate or a master vehicle**  
20 **appraiser certificate by the Department of Transportation under this section is qualified to appraise**  
21 **any vehicle, including vehicles for sale under ORS 819.210 and 819.220.**

22 **“(2) The department shall establish rules to provide for issuance of vehicle appraiser certif-**  
23 **icates and master vehicle appraiser certificates under this section. Rules adopted by the depart-**  
24 **ment under this section shall provide for all of the following:**

25 **“(a) A method of ascertaining the qualifications and competence of individuals to conduct vehi-**  
26 **cle appraisals in accordance with the rules of the department and generally accepted methods of**  
27 **appraisal.**

28 **“(b) A system for issuance of vehicle appraiser certificates and master vehicle appraiser**  
29 **certificates to persons who qualify under the rules of the department.**

30 **“(c) Procedures and grounds for revocation or suspension of vehicle appraiser certificates and**  
31 **master vehicle appraiser certificates issued under this section if the department determines the**  
32 **person holding the certificate has violated the rules adopted by the department.**

33 **“(d) A procedure for renewal of vehicle appraiser certificates and master vehicle appraiser**  
34 **certificates issued under this section.**

35 **“(3) The department may establish rules to adopt educational requirements for issuance**

1 **or renewal of vehicle appraiser certificates and master vehicle appraiser certificates.**

2 “[3] **(4) Vehicle appraiser certificates and master vehicle** appraiser certificates issued un-  
3 der this section are subject to the following:

4 “(a) A certificate shall expire [*two*] **three** years from the date of issuance unless renewed ac-  
5 cording to the rules of the department.

6 “(b) The department shall not issue [*an*] **a vehicle appraiser certificate or a master vehicle**  
7 appraiser certificate to a person until the person has paid the fee for issuance of [*an*] **a vehicle**  
8 **appraiser certificate or a master vehicle** appraiser certificate under ORS 822.700.

9 “(c) The department shall not renew [*an*] **a vehicle appraiser certificate or a master vehicle**  
10 appraiser certificate issued under this section until the holder has paid the fee for renewal of [*an*]  
11 **a vehicle appraiser certificate or a master vehicle** appraiser certificate under ORS 822.700.

12 “**SECTION 4.** ORS 822.700 is amended to read:

13 “822.700. (1) Fee for issuance of dismantler certificates:

14 “(a) \$450, for an original dismantler certificate covering a single place of business issued under  
15 ORS 822.110;

16 “(b) \$90, for a supplemental certificate for each additional place of business to be covered by  
17 that certificate and operated under the same name; and

18 “(c) \$30, for each duplicate dismantler certificate issued under ORS 822.110.

19 “(2) Fee for renewal of dismantler certificate under ORS 822.125, \$450.

20 “(3) Fee for original issuance of vehicle dealer certificate under ORS 822.020:

21 “(a) \$958, for a certificate covering a single place of business;

22 “(b) \$230, for each additional place of business to be covered by the certificate and operated  
23 under the same name; and

24 “(c) \$30, for each corrected vehicle dealer certificate issued under ORS 822.040.

25 “(4) Fee for renewal of vehicle dealer certificate under ORS 822.040:

26 “(a) \$958, for renewal of a vehicle dealer certificate covering a single place of business; and

27 “(b) \$230, for each additional place of business to be covered by the certificate and operated  
28 under the same name.

29 “(5) Fee for issuance of towing business certificate under ORS 822.205, \$17 for each vehicle used  
30 for towing or recovery purposes.

31 “(6) Fee for renewal of towing business certificate under ORS 822.210, \$17 for each vehicle used  
32 for towing or recovery purposes.

33 “(7) Fee for issuance of vehicle transporter certificate under ORS 822.310, \$150.

34 “(8) Fee for renewal of vehicle transporter certificate under ORS 822.310, \$150.

35 “(9) Fee for issuance of driver training instructor certificate under ORS 822.530, \$100.

36 “(10) Fee for renewal of driver training certificate under ORS 822.530, \$100.

37 “(11) Fee for issuance of commercial driver training school certificate under ORS 822.515, \$200.

38 “(12) Fee for renewal of commercial driver training school certificate under ORS 822.515, \$200.

39 “(13) Fee for issuance of **vehicle** appraiser certificate under ORS 819.230, [*\$50*] **\$75.**

40 “(14) Fee for renewal of [*an*] **vehicle** appraiser certificate under ORS 819.230, [*\$50*] **\$75.**

41 “**(15) Fee for issuance of master vehicle appraiser certificate under ORS 819.230, \$150.**

42 “**(16) Fee for renewal of master vehicle appraiser certificate under ORS 819.230, \$150.”.**
