

SENATE AMENDMENTS TO A-ENGROSSED HOUSE BILL 2435

By COMMITTEE ON BUSINESS, TRANSPORTATION AND WORKFORCE DEVELOPMENT

1 On page 1 of the printed A-engrossed bill, delete lines 5 through 19 and insert:

2 **“SECTION 1. Sections 2 and 3 of this 2007 Act are added to and made a part of the**
3 **Oregon Vehicle Code.**

4 **“SECTION 2. (1) A person commits the offense of acting as a vehicle appraiser without**
5 **a certificate if the person does not hold a vehicle appraiser certificate issued under ORS**
6 **819.230 and the person, for consideration, issues an opinion as to the value of a vehicle.**

7 **“(2) This section does not apply to:**

8 **“(a) A person who holds a vehicle dealer certificate issued or renewed under ORS 822.020**
9 **or 822.040 and who appraises vehicles in the operation of the vehicle dealer’s business;**

10 **“(b) A person from another jurisdiction who holds a vehicle appraiser certificate requir-**
11 **ing qualifications substantially similar to qualifications required for the certification of a**
12 **vehicle appraiser in this state;**

13 **“(c) An insurance adjuster authorized to do business under ORS 744.505 or 744.515; or**

14 **“(d) A person licensed or certified to appraise real estate under ORS 674.310 and who**
15 **appraises the value of manufactured structures.**

16 **“(3) The offense described in this section, acting as a vehicle appraiser without a certif-**
17 **icate, is a Class A violation.**

18 **“SECTION 3. ‘Vehicle appraiser’ means an individual who has been issued a vehicle ap-**
19 **praiser certificate under ORS 819.230 and who, for consideration, issues opinions as to the**
20 **value of vehicles.”.**

21 In line 20, delete “3” and insert “4”.

22 In line 21, after the first “vehicle” delete the rest of the line.

23 In line 24, delete “appraiser certif-”.

24 In line 25, delete “icates and master vehicle”.

25 On page 2, line 3, delete “appraiser certificates and master vehicle”.

26 In line 5, delete “appraiser certificates and”.

27 In line 6, delete “master vehicle”.

28 In line 8, delete “appraiser certificates and master vehicle”.

29 In line 11, delete “and master vehicle appraiser certificates”.

30 In line 12, delete “appraiser certificates and master vehicle”.

31 In line 16, after the first “vehicle” delete the rest of the line.

32 In line 18, delete “appraiser certificate or a master vehicle”.

33 In line 19, after the first “vehicle” delete the rest of the line.

34 In line 21, delete “appraiser certificate or a master vehicle”.

35 In line 22, delete “4” and insert “5”.
