

HOUSE AMENDMENTS TO HOUSE BILL 2438

1 On page 1 of the printed bill, line 2, delete “822.015, 822.030 and”.

2 Delete lines 4 through 26 and delete pages 2 through 5 and insert:

3 “**SECTION 1.** ORS 822.060 is amended to read:

4 “822.060. (1) A vehicle dealer issued a certificate under ORS 822.020 commits the offense of il-
5 legal consignment practices if the dealer does any of the following:

6 “(a) Takes a vehicle on consignment from a person who is not a certified dealer and does not
7 have proof that the consignor is the registered owner, a security interest holder or lessor of the
8 vehicle.

9 “(b) Takes a vehicle on consignment from a security interest holder without the security interest
10 holder first completing a repossession action prior to consigning the vehicle and providing the
11 dealer with proper documentary proof of the repossession action.

12 “(c) Takes a vehicle on consignment and does not have the terms of the consignment agreement
13 in writing and provide a copy of the agreement to the consignor. The agreement shall include a
14 provision stating that if the terms of the agreement are not met, the consignor may file a complaint
15 in writing with the Department of Transportation, Salem, Oregon.

16 “(d) Sells a vehicle that the dealer has on consignment and does not pay the consignor within
17 10 days of the sale.

18 “(e) Sells a vehicle that the dealer has on consignment and does not either provide the pur-
19 chaser with a certificate of title to the vehicle or with other primary ownership records in the form
20 of documents or apply to the department in the purchaser’s name for title to the vehicle within 30
21 days of the sale in a manner provided by the department by rule.

22 “(f) Does not allow the department or any duly authorized representative to inspect and audit
23 any records of any separate accounts into which the dealer deposits any funds received or handled
24 by the dealer or in the course of business as a dealer from consignment sale of vehicles at such
25 times as the department may direct.

26 “(g) Takes any part of any money paid to the dealer in connection with any consignment
27 transaction as part or all of the dealer’s commission or fee until the transaction has been completed
28 or terminated.

29 “(h) Does not make arrangement for the disposition of money from a consignment transaction
30 with the seller at the time of establishing a consignment agreement.

31 “(i) Sells a vehicle that the dealer has taken on consignment without first giving the purchaser
32 the following disclosure in writing:
