

B-Engrossed House Bill 2469

Ordered by the House June 25
Including House Amendments dated May 3 and June 25

Sponsored by Representative KOTEK; Representative DINGFELDER

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Expands temporary assistance for needy families to include new State Family Pre-SSI/SSDI program and new temporary assistance for needy families program for working families. Increases number of hours absent parent may visit child without loss of assistance.

Describes suitable activities for job opportunity and basic skills program. Requires screening, assessment and case planning. Creates special provisions for participants with disabilities. Extends program exemption to six months for parent of newborn with exception of parent under 20 years of age. Creates sanctions for failing to comply with case plan in program.

Changes time limit for receipt of temporary assistance for needy families to 60-month lifetime limit. Specifies exceptions.

Exempts specified participants in temporary assistance for needy families program and State Family Pre-SSI/SSDI program from requirement to assign child support. Requires Department of Justice to pass through to family receiving aid \$50 of monthly child support received for each child up to maximum of \$200. Requires Department of Human Services to disregard child support in determination of aid. Adds temporary assistance for needy families recipients to list of individuals rebuttably presumed to be unable to pay child support. Authorizes department to recover adult portion of temporary assistance for needy families from retroactive Supplemental Security Income payments.

Removes requirement to receive aid for three of six months to qualify for extended medical assistance after increase in number of hours worked or earnings.

Declares emergency, effective October 1, 2007.

7 **Be It Enacted by the People of the State of Oregon:**

8 **SECTION 1.** ORS 418.035 is amended to read:

9 418.035. As used in ORS 418.035 to 418.172, unless the context or a specially applicable statutory
10 definition requires otherwise:

11 (1) "Aid" means money payments with respect to, or on behalf of, a dependent child or children
12 and includes:

13 (a) Money payments to meet the needs of the relative with whom the child is living and[:]

14 [(A)] the spouse of the relative if the spouse lives with the relative, the relative is the child's
15 parent and the child is a dependent child by reason of the physical or mental incapacity, **or the**
16 **unemployment or underemployment**, of a parent; or

17 [(B) *The spouse of the relative if the spouse lives with the relative, the relative is the child's parent*

NOTE: Matter in **boldfaced** type in an amended section is new; matter [*italic and bracketed*] is existing law to be omitted. New sections are in **boldfaced** type.

1 and the child is a dependent child as defined in ORS 418.070 (2)(a) and is dependent by reason of the
2 unemployment of parents.]

3 (b) Payments made to a representative payee or guardian pursuant to ORS 418.050 or 418.054.

4 **(2) “Caretaker relative” means a dependent child’s father, mother, grandfather, grand-**
5 **mother, brother, sister, stepfather, stepmother, stepbrother, stepsister, uncle, aunt, first**
6 **cousin, nephew or niece who lives in a residence maintained by one or more of the relatives**
7 **as the child’s or the relative’s own home.**

8 [(2)(a)] **(3)(a)** “Dependent child” means a needy child:

9 (A) Who has been deprived of parental support or care by reason of the death, continued ab-
10 sence from the home or physical or mental incapacity, **or unemployment or underemployment,**
11 of a parent;

12 **(B) Whose caretaker relatives are not able to provide adequate care and support for the**
13 **child without public**

14 [(B) Whose relatives are not able to provide adequate care and support for the child without
15 public] assistance, as defined in ORS 411.010;

16 [(C) Who is living with the child’s father, mother, grandfather, grandmother, brother, sister,
17 stepfather, stepmother, stepbrother, stepsister, uncle, aunt, first cousin, nephew or niece in a place of
18 residence maintained by one or more of such relatives as the child’s or their own home; and]

19 **(C) Who lives with a caretaker relative; and**

20 (D) Who meets the requirements of paragraph (b) of this subsection.

21 (b)(A) Except as provided in subparagraphs (B) and (C) of this paragraph, a “dependent child”
22 must be under the age of 18 years.

23 (B) A child may qualify as a “dependent child,” subject to the availability of funds, if the child
24 is 18 or 19 or 20 years of age and a student regularly attending a school in grade 12 or below or
25 regularly attending a course of professional or technical training designed to fit the child for gainful
26 employment, other than a course provided by or through a college or university.

27 (C) Students under the age of 21 years and regularly attending a school, college or university
28 or regularly attending a course of professional or technical training designed to fit the child for
29 gainful employment may be included in the description in subparagraph (B) of this paragraph at the
30 option of the Department of Human Services.

31 **(4) “Federally required participation rates” means the participation rates as required by**
32 **section 407 of the Social Security Act.**

33 [(3)] **(5)** “Representative payee” means an individual designated by the department to receive
34 money payments of aid pursuant to ORS 418.050.

35 **SECTION 2.** ORS 418.040 is amended to read:

36 418.040. (1) Aid pursuant to the temporary assistance for needy families program shall be
37 granted under [ORS 418.035 to 418.125] **this section** to any dependent child who is living in a home
38 meeting the standards of care and health fixed by the rules [and regulations] of the Department of
39 Human Services and who is a resident of the State of Oregon, if [the] a parent or [other] **caretaker**
40 relative with whom the child is living is a resident of the State of Oregon.

41 [(2) No parent of a child receiving aid under ORS 418.035 to 418.125 shall be exempt from a re-
42 quirement to participate in programs to develop employment or self-sufficiency skills due to the age of
43 the child except:]

44 [(a) During the first two months of the third trimester of pregnancy, the parent shall not be re-
45 quired to participate more than 10 hours per week and shall be exempt from participation during the

1 *last month of pregnancy; and]*

2 *[(b) During the first 90 days after the birth of a child.]*

3 *[(3) No individual in a household receiving aid under ORS 418.035 to 418.125 shall be exempt, due*
4 *to the pregnancy of the individual, from a requirement to obtain a high school diploma or its equivalent*
5 *or to participate in programs to develop employment or self-sufficiency skills.]*

6 *[(4) No parent shall be eligible to receive aid under ORS 418.035 to 418.125 if the parent fails to*
7 *participate in programs to develop employment or self-sufficiency skills during the period of eligibility*
8 *determination.]*

9 *[(5) The provisions of subsection (3) of this section shall not apply to an individual experiencing*
10 *medical complications due to pregnancy, as determined by a person licensed by the Board of Medical*
11 *Examiners or the Oregon State Board of Nursing, that prohibit participation in the activities otherwise*

13 *[(6) Notwithstanding section 16, chapter 739, Oregon Laws 1993, and subsection (5) of this section,*
14 *no individual in a household receiving aid under ORS 418.035 to 418.125 shall be exempt from any*
15 *requirement to participate in programs to develop employment or self-sufficiency skills, as defined by*
16 *the department, unless the individual and the individual's department case manager agree in writing*
17 *that the exemption is appropriate under guidelines developed by the department.]*

18 **(2) Except as provided in subsections (7) and (8) of this section, a needy caretaker rela-**
19 **tive may be required to participate in the job opportunity and basic skills program that is**
20 **described in subsections (3) to (6) of this section.**

21 **(3) The department shall use a basic assessment tool to determine if a needy caretaker**
22 **relative applying for or receiving aid under this section has or may have a barrier to em-**
23 **ployment or to family stability. If the basic assessment tool indicates that there is or may**
24 **be a barrier, the needy caretaker relative shall be referred for an in-depth assessment by a**
25 **person with relevant expertise or specialized training.**

26 **(4) Based upon the assessment described in subsection (3) of this section, the depart-**
27 **ment, in cooperation with appropriate partner agencies or professionals, shall work with the**
28 **participant to create an effective individualized case plan that establishes goals and identifies**
29 **suitable activities that promote family stability and financial independence.**

30 **(5) Suitable activities may include:**

31 **(a) Job readiness activities or employment;**

32 **(b) Vocational rehabilitation or training;**

33 **(c) Remedial, secondary or post-secondary education;**

34 **(d) Community service; or**

35 **(e) Other activities that reduce or eliminate barriers to full participation in the program**
36 **or to employment.**

37 **(6) For individuals with disabilities, the goal of the individualized case plan must be to**
38 **promote greater independence and may include physical or mental health evaluation or**
39 **treatment.**

40 **(7) A needy caretaker relative receiving aid under ORS 418.035 to 418.125 may volunteer**
41 **for but may not be required to participate in the job opportunity and basic skills program:**

42 **(a) More than 10 hours per week during the first two months of the third trimester of**
43 **the parent's pregnancy;**

44 **(b) During the last month of the parent's pregnancy;**

45 **(c) If the needy caretaker relative is experiencing medical complications due to preg-**

1 **nancy that prohibit participation in activities in the program;**

2 **(d) For one parent per family, during the first six months after the birth of a child, up**
3 **to a total of 12 months per family except that:**

4 **(A) The department may require a parent to participate in suitable activities, with a**
5 **preference for educational activities, 16 weeks after the birth of a child if the parent is under**
6 **20 years of age; and**

7 **(B) The department may require a parent of a child under 12 months of age to participate**
8 **in evidence-based parenting classes or family stability activities; or**

9 **(e) If participation is likely to cause undue hardship or is contrary to the best interests**
10 **of the child or needy caretaker relative.**

11 [(7)] **(8) The department [by rule shall define programs to develop employment or self-sufficiency**
12 **skills for purposes of this section] shall adopt rules to carry out the provisions of this section.**

13 **SECTION 3.** ORS 418.045 is amended to read:

14 418.045. (1) The need for and amount of aid pursuant to the temporary assistance for needy
15 families to be granted for any dependent child or relative pursuant to ORS [418.035 to 418.172]
16 **418.040** shall be determined, in accordance with the rules [and regulations] of the Department of
17 Human Services, taking into account:

18 (a) The income, resources and maintenance available to such child and relative from whatever
19 source derived, allowable deductions and the statewide income and payment standards.

20 (b) The income and financial condition of the stepparent, if any, of the child for whom aid is
21 sought.

22 (2) Subsection (1)(b) of this section is not intended to relieve any [father] **parent** of any legal
23 obligation in respect of the support of the natural or adopted children of the [father] **parent**.

24 [(3) *In the determination of eligibility and the amount of need, and in any reconsideration thereof,*
25 *with respect to an applicant or recipient of aid pursuant to ORS 418.035 to 418.172, such amounts of*
26 *income and resources may be disregarded as the department may prescribe by rules and regulations*
27 *promulgated by it. The amounts to be disregarded shall be within the limits required or permitted by*
28 *federal laws and by federal rules and orders thereto applicable.*]

29 [(4)(a) *Notwithstanding section 16 (5)(d), chapter 739, Oregon Laws 1993, an individual who fails*
30 *to cooperate in such education, employment or job training programs as may be required by law shall*
31 *have aid payments reduced by the amount of \$50 for a period of two months.*]

32 [(b) *Continued failure of an adult aid recipient to cooperate in mandatory education, employment*
33 *or job training programs for more than two months as described in paragraph (a) of this subsection*
34 *shall result in the removal of the noncooperating adult from the eligibility determination for the corre-*
35 *sponding recipient family for a period of two months in addition to the period required under para-*
36 *graph (a) of this subsection.*]

37 [(c) *Subsequent and continued failure of an individual to cooperate in mandatory education, em-*
38 *ployment or job training programs beyond the period described in paragraph (b) of this subsection shall*
39 *result in termination of all aid.*]

40 [(d) *The department shall adopt rules defining standards for cooperation in programs for educa-*
41 *tion, employment or job training as provided in this subsection.*]

42 [(5) *Aid terminated under subsection (4) of this section shall be restored upon demonstrated coop-*
43 *eration, as defined by the department, in applicable education, employment or job training programs.*]

44 **(3) The department by rule shall adopt proven methods of encouraging participants' full**
45 **engagement in the job opportunity and basic skills program, including the development of**

1 **an individualized case plan in accordance with ORS 418.040.**

2 **(4)(a) The department may not reduce the family's aid payment as a method of encour-**
3 **aging full engagement in the job opportunity and basic skills program pursuant to subsection**
4 **(3) of this section until the department determines that the noncompliant needy caretaker**
5 **relative:**

6 **(A) Has no barriers or refuses to take appropriate steps to address identified barriers to**
7 **participation in the program;**

8 **(B) Has the ability to be fully engaged in the program as defined by the department by**
9 **rule; and**

10 **(C) Is willfully noncompliant with the requirements of the individualized case plan.**

11 **(b) The department may not reduce aid payments under this subsection to families:**

12 **(A) Receiving aid pursuant to ORS 418.155 or section 8 of this 2007 Act;**

13 **(B) In which the caretaker relative participates in suitable activities for the number of**
14 **hours required each month to satisfy federally required participation rates; or**

15 **(C) Until the department has screened for and, if appropriate, assessed barriers to par-**
16 **ticipation, including but not limited to physical or mental health needs, substance abuse,**
17 **domestic violence or learning needs.**

18 **(c) The department may not reduce aid payments under this subsection before assessing**
19 **the risk of harm posed to the children in the household by the reduction in aid payments and**
20 **taking steps to ameliorate the risk.**

21 **(5)(a) The department may reduce the aid payment to a family in accordance with sub-**
22 **section (4) of this section following notice and an opportunity for a hearing under ORS**
23 **chapter 183, as follows:**

24 **(A) The department may reduce the aid payment by the portion attributable to the needs**
25 **of the noncompliant individual for up to three months.**

26 **(B) After three months of noncompliance and subject to subsection (4)(c) of this section,**
27 **the department may terminate the aid payment to the family.**

38 **418.045. (1) The need for and amount of aid pursuant to the temporary assistance for needy**
39 **families to be granted for any dependent child or relative pursuant to ORS 418.040 shall be deter-**
40 **mined, in accordance with the rules of the Department of Human Services, taking into account:**

41 **(a) The income, resources and maintenance available to such child and relative from whatever**
42 **source derived, allowable deductions and the statewide income and payment standards.**

43 **(b) The income and financial condition of the stepparent, if any, of the child for whom aid is**
44 **sought.**

45 **(2) Subsection (1)(b) of this section is not intended to relieve any parent of any legal obligation**

1 in respect of the support of the natural or adopted children of the parent.

8 [(3)] (4) The department by rule shall adopt proven methods of encouraging participants' full
9 engagement in the job opportunity and basic skills program, including the development of an indi-
10 vidualized case plan in accordance with ORS 418.040.

11 [(4)(a)] (5)(a) The department may not reduce the family's aid payment as a method of encour-
12 aging full engagement in the job opportunity and basic skills program pursuant to subsection [(3)]
13 (4) of this section until the department determines that the noncompliant needy caretaker relative:

14 (A) Has no barriers or refuses to take appropriate steps to address identified barriers to par-
15 ticipation in the program;

16 (B) Has the ability to be fully engaged in the program as defined by the department by rule; and

17 (C) Is willfully noncompliant with the requirements of the individualized case plan.

18 (b) The department may not reduce aid payments under this subsection to families:

19 (A) Receiving aid pursuant to ORS 418.155 or section 8 of this 2007 Act;

20 (B) In which the caretaker relative participates in suitable activities for the number of hours
21 required each month to satisfy federally required participation rates; or

28 [(5)(a)] (6)(a) The department may reduce the aid payment to a family in accordance with sub-
29 section [(4)] (5) of this section following notice and an opportunity for a hearing under ORS chapter
30 183, as follows:

31 (A) The department may reduce the aid payment by the portion attributable to the needs of the
32 noncompliant individual for up to three months.

33 (B) After three months of noncompliance and subject to subsection [(4)(c)] (5)(c) of this section,
34 the department may terminate the aid payment to the family.

35 (b) Any reduction or termination in aid under this section may continue until the noncompliant
36 individual participates in suitable activities required by the case plan for two consecutive weeks.

37 (c) A caretaker relative may request a hearing to contest the basis for a reduction in or termi-
38 nation of an aid payment within 90 days of a reduction in or termination of aid.

39 [(6)] (7) Every six months, the department shall report to the Family Services Review Commis-
40 sion established under ORS 411.125 the status of and outcomes for families for whom aid has been
41 reduced or terminated under subsection [(5)] (6) of this section. The department shall work with the
42 commission to establish the details to be provided in the report.

43 **SECTION 4.** ORS 418.070 is amended to read:

44 418.070. (1) [For the purposes of ORS 418.035 to 418.185,] With respect to any period for which
45 federal funds are made available to this state in aid of a state-administered program of aid to any

1 child defined in and meeting the requirements of this section[.], **the Department of Human Ser-**
2 **vices may provide foster care payments**

3 [(1) "Aid" includes foster care] in behalf of a child [described in subsection (2)(b) of this section]
4 in the foster home of any individual or in a licensed nonprofit private child-caring agency[.] **who:**

5 [(2) "Dependent Child" includes:]

6 (a) **Is** a needy child meeting the requirements of ORS 418.035 [(2)(b)(A)] **(3)(b)(A)** or (B) who has
7 been deprived of parental support or care by reason of the **continued absence from the home, the**
8 **physical or mental incapacity or the unemployment or underemployment** of a parent or
9 parents; [and who is living with any of the relatives specified in ORS 418.035 (2) in a place of resi-
10 dence maintained by one or more of such relatives as the relative's or relatives' own home].

12 [(A)] **(b)** [Who] Would meet the requirements of ORS [418.035 (2) or of paragraph (a) of this

15 therein would be contrary to the welfare of such child;

27 [(3)] **(2)** "Foster home" means a foster home which is certified by this state or has been ap-
28 proved, by the agency of this state responsible for the certification of foster homes, as meeting the
29 standards established for such certification.

30 [(4) "Unemployment of parent" shall be defined by the department and such definition may take into
31 account definitions used to establish the availability of federal funds for the program of temporary as-
32 sistance for needy families.]

33 **SECTION 5.** ORS 418.131 is amended to read:

34 418.131. (1) **Except as provided in subsections (2) and (3) of this section, a needy caretaker**
35 **relative may** [a person shall] not receive aid **under ORS 418.040** for more than a total of [24 months
36 in any period of 84 consecutive] **60** months.

37 [(2) For purposes of determining the 24-month limitation described in subsection (1) of this section,
38 a month in which one parent of a family receiving aid under ORS 418.035 to 418.125 receives gross
39 earnings in an amount equal to 173 times the hourly minimum wage as provided in ORS 653.025 but
40 in an amount that does not exceed the eligibility requirements for aid under ORS 418.035 to 418.125
41 shall be counted as two-fifths of a month.]

42 [(3) The 24-month limitation described in subsection (1) of this section shall not apply to:]

43 [(a) A month in which a dependent child receiving aid resides with a person other than the child's
44 natural or adoptive parent;]

45 [(b) Up to three months within a two-year period for the care of any family members who suffer

1 *serious health conditions as defined in ORS 659A.150; or]*

2 *[(c) A household with only one parent in which the basis of eligibility is the incapacity of that*
3 *parent or, in a household with two parents, if both parents are incapacitated or one parent is required*

6 *receive aid, as determined by the Department of Human Services, in excess of 24 months if:]*

9 *[(b) The former recipient is a dependent child and the child resides with a person other than the*

13 *mines that the parent is making diligent efforts in good faith to obtain permanent employment. The*
14 *number of families receiving aid under this paragraph in any month may not exceed one percent of the*
15 *total number of families receiving aid in that month or 400 families, whichever is greater.]*

16 *[(5)(a) The time limitations described in subsection (1) of this section do not apply to any person*
17 *who is:]*

18 *[(A) Required to participate in the JOBS Program unless the person has been offered the oppor-*
19 *tunity to participate in an education, employment or job training program including teen parent pro-*
20 *grams as defined by the department.]*

21 *[(B) Participating in an employment and training program including any employment search ac-*
22 *tivities required by the program.]*

23 *[(C) Enrolled at an educational institution under section 1, chapter 212, Oregon Laws 2003.]*

24 *[(b) The department shall report to each session of the Legislative Assembly the number of families*
25 *whose period of time receiving aid has exceeded the time limitations of subsection (1) of this section*
26 *because of the exceptions provided under paragraph (a) of this subsection. The report shall include*
27 *information sufficient to permit the Legislative Assembly to determine if the exceptions make a signif-*
28 *icant contribution to increased self-sufficiency of persons granted an exemption.]*

29 **(2) The Department of Human Services may not count toward the 60-month limit on re-**
30 **ceipt of aid described in subsection (1) of this section any month in which a needy caretaker**
31 **relative:**

32 **(a) Receives a grant of temporary assistance to needy families under ORS 418.035 to**
33 **418.125, or assistance funded under Title IV-A of the Social Security Act in this or another**
34 **state, prior to July 1, 2003;**

35 **(b) Resides in an area described in 18 U.S.C. 1151, and 50 percent or more of the adult**
36 **residents in the area are unemployed;**

37 **(c) Is, in that month, a minor child and neither the head of the household nor married**
38 **to the head of the household;**

39 **(d) Receives aid under ORS 418.035 to 418.172 that is not funded with grants under Title**
40 **IV-A of the Social Security Act;**

41 **(e) Is enrolled at an educational institution under section 1, chapter 212, Oregon Laws**
42 **2003;**

43 **(f) Is exempt from time limits pursuant to rules adopted by the department in accordance**
44 **with section 408(a)(7)(C) of the Social Security Act; or**

45 **(g) Is unable to obtain or maintain employment for a sufficient number of hours in a**

1 **month to satisfy the federally required participation rates because the needy caretaker rel-**
2 **ative:**

3 **(A) Is a victim of domestic violence as defined in ORS 411.117;**

4 **(B) Has a certified learning disability;**

25 (2) Except as otherwise provided in this subsection, an applicant or recipient who receives aid
26 as defined in ORS 418.035 shall cooperate with the Department of Human Services and the Depart-
27 ment of Justice in establishing the paternity of the applicant's or recipient's child born out of
28 wedlock and in obtaining support or other payments or property due the applicant or child. An ap-
29 plicant or recipient is not required to cooperate if there is good cause or some other exception to
30 the cooperation requirement that takes into account the best interest of the child. The Department
31 of Human Services shall adopt rules defining good cause, other exceptions to cooperation and non-
32 cooperation by an applicant or recipient, and setting the sanction for noncooperation. The sanction
33 may include total ineligibility of the family for aid, but in no situation may the sanction be less than
34 a 25 percent reduction of the monthly grant amount. At the time an applicant applies for aid, the
35 Department of Human Services shall inform the applicant, in writing, of the requirement of and ex-
36 ceptions to cooperation and the sanctions for noncooperation, and shall inform recipients, in writing,
37 whenever eligibility for aid is redetermined.

38 **(3) This section shall apply to recipients of aid under ORS 418.035 to 418.125 and 418.155**
39 **only as long as the aid is funded in whole or in part with federal grants under Title IV-A of**

9 418.075. Aid[, *as defined in ORS 418.035,*] **under ORS 418.040** shall not be granted with respect
10 to, or on behalf of, a dependent child [*as defined in ORS 418.070 (2)(a)*] **living with an unemployed**
11 **parent** if, and for as long as, the unemployed parent of such child refuses without good cause to
12 accept employment in which the unemployed parent is able to engage and which is offered through
13 any employment office defined in ORS 657.010 or which is otherwise offered by any employer if such
14 offer is determined by the Department of Human Services after notification by such employer to be
15 a bona fide offer of such employment.

16 **SECTION 15.** ORS 418.085 is amended to read:

17 418.085. During any period in which aid may be granted **under ORS 418.040** with respect to,

33 (d) Temporary assistance for needy families and food stamp benefits shall be suspended at the
34 end of the calendar month in which an employer makes the first wage payment to a participant who
35 is a custodial parent in a family that receives temporary assistance for needy families or to any
36 adult member of a household receiving food stamp benefits. Failure of the participant to cooperate
37 with the requirements of the JOBS Plus Program may result in the participant's removal, in ac-
38 cordance with rules adopted by the Department of Human Services, from the JOBS Plus Program
39 and suspension of the participant's temporary assistance for needy families grant and food stamp
40 benefits. A temporary assistance for needy families and food stamp benefits recipient who has been
41 removed from the program for failing to cooperate shall be eligible to reapply to participate in the

44 (6)(a) Employers shall pay all participating individuals at least the hourly rate of the Oregon
45 minimum wage.

1 (b) Sick leave, holiday and vacation absences shall conform to the individual employer's rules
2 for temporary employees.

3 (c) Group health insurance benefits shall be provided by the employer to program participants
4 if, and to the extent that, state or federal law requires the employer to provide such benefits.

12 (h) Is a caretaker relative [*named*] **as defined** in ORS 418.035 [(2)(a)(C)] who cares for a de-
13 pendent child receiving [*temporary assistance for needy families*] **aid granted under ORS 418.035**
14 **to 418.125** or is the spouse of [*such*] **the** caretaker relative [*and fulfills the requirements of ORS*

16 (i) Is under the age of 21 years, is in a youth care center and is one for whom a public agency

30 (m) Is an adopted person under 21 years of age for whom a public agency is assuming financial

34 (o) Is an individual or member of a group who, subject to the rules of the department and within
35 available funds, may optionally be included in the state's medical assistance program under federal
36 law and regulations concerning the availability of federal funds for the expenses of that individual

38 (p) Is a pregnant woman who would be eligible for [*temporary assistance for needy families in-*
39 *cluding such aid based on the unemployment of a parent*] **aid granted under ORS 418.035 to**

41 [*(q) Would be eligible for temporary assistance for needy families pursuant to 42 U.S.C. 607 based*

43 [(r)] (q) Except as otherwise provided in this section and to the extent of available funds, is a
44 pregnant woman or child for whom federal financial participation is available under Title XIX of the
45 federal Social Security Act.

1 [(s)] (r) Is not otherwise categorically needy and is not eligible for care under Title XVIII of the
2 federal Social Security Act or is not a full-time student in a post-secondary education program as
3 defined by the Department of Human Services by rule, but whose family income is less than the
4 federal poverty level and whose family investments and savings equal less than the investments and
5 savings limit established by the department by rule.

6 (3) "Income" has the meaning given that term in ORS 411.704.

7 (4) "Investments and savings" means cash, securities as defined in ORS 59.015, negotiable in-

37 for the mentally retarded; or is under the age of 22 years and is in a psychiatric hospital.

38 (k) Is under the age of 21 years and is in an independent living situation with all or part of the
39 maintenance cost paid by the Department of Human Services.

40 (L) Is a member of a family that received aid **in the preceding month** under ORS 418.040 or
41 under section 8 of this 2007 Act [*in at least three of the six months immediately preceding the month*
42 *in which the family*] **and** became ineligible for aid due to increased hours of or increased income
43 from employment. As long as the member of the family is employed, such families will continue to
44 be eligible for medical assistance for a period of at least six calendar months beginning with the
45 month in which such family became ineligible for assistance due to increased hours of employment

1 or increased earnings.

2 (m) Is an adopted person under 21 years of age for whom a public agency is assuming financial
3 responsibility in whole or in part.

4 (n) Is an individual or is a member of a group who is required by federal law to be included in
5 the state's medical assistance program in order for that program to qualify for federal funds.

6 (o) Is an individual or member of a group who, subject to the rules of the department and within
7 available funds, may optionally be included in the state's medical assistance program under federal
8 law and regulations concerning the availability of federal funds for the expenses of that individual
9 or group.

10 (p) Is a pregnant woman who would be eligible for aid granted under ORS 418.035 to 418.125,
11 whether or not the woman is eligible for cash assistance.

12 (q) Except as otherwise provided in this section and to the extent of available funds, is a preg-
13 nant woman or child for whom federal financial participation is available under Title XIX of the
14 federal Social Security Act.

15 (r) Is not otherwise categorically needy and is not eligible for care under Title XVIII of the
16 federal Social Security Act or is not a full-time student in a post-secondary education program as
17 defined by the Department of Human Services by rule, but whose family income is less than the
18 federal poverty level and whose family investments and savings equal less than the investments and
19 savings limit established by the department by rule.

20 (3) "Income" has the meaning given that term in ORS 411.704.

21 (4) "Investments and savings" means cash, securities as defined in ORS 59.015, negotiable in-
22 struments as defined in ORS 73.0104 and such similar investments or savings as the Department of
23 Human Services may establish by rule that are available to the applicant or recipient to contribute
24 toward meeting the needs of the applicant or recipient.

25 (5) "Medical assistance" means so much of the following medical and remedial care and services
26 as may be prescribed by the Department of Human Services according to the standards established
27 pursuant to ORS 414.065, including payments made for services provided under an insurance or
28 other contractual arrangement and money paid directly to the recipient for the purchase of medical
29 care:

30 (a) Inpatient hospital services, other than services in an institution for mental diseases;

31 (b) Outpatient hospital services;

32 (c) Other laboratory and X-ray services;

33 (d) Skilled nursing facility services, other than services in an institution for mental diseases;

34 (e) Physicians' services, whether furnished in the office, the patient's home, a hospital, a skilled
35 nursing facility or elsewhere;

36 (f) Medical care, or any other type of remedial care recognized under state law, furnished by
37 licensed practitioners within the scope of their practice as defined by state law;

38 (g) Home health care services;

39 (h) Private duty nursing services;

40 (i) Clinic services;

41 (j) Dental services;

42 (k) Physical therapy and related services;

43 (L) Prescribed drugs, including those dispensed and administered as provided under ORS chapter
44 689;

45 (m) Dentures and prosthetic devices; and eyeglasses prescribed by a physician skilled in diseases

1 of the eye or by an optometrist, whichever the individual may select;

2 (n) Other diagnostic, screening, preventive and rehabilitative services;

3 (o) Inpatient hospital services, skilled nursing facility services and intermediate care facility
4 services for individuals 65 years of age or over in an institution for mental diseases;

5 (p) Any other medical care, and any other type of remedial care recognized under state law;

6 (q) Periodic screening and diagnosis of individuals under the age of 21 years to ascertain their
7 physical or mental impairments, and such health care, treatment and other measures to correct or
8 ameliorate impairments and chronic conditions discovered thereby;

9 (r) Inpatient hospital services for individuals under 22 years of age in an institution for mental
10 diseases; and

11 (s) Hospice services.

12 (6) "Medical assistance" includes any care or services for any individual who is a patient in a
13 medical institution or any care or services for any individual who has attained 65 years of age or
14 is under 22 years of age, and who is a patient in a private or public institution for mental diseases.
15 "Medical assistance" includes "health services" as defined in ORS 414.705. "Medical assistance"
16 does not include care or services for an inmate in a nonmedical public institution.

17 (7) "Medically needy" means a person who is a resident of this state and who is considered el-
18 igible under federal law for medically needy assistance.

19 (8) "Resources" has the meaning given that term in ORS 411.704. For eligibility purposes, "re-
20 sources" does not include charitable contributions raised by a community to assist with medical
21 expenses.

22 **SECTION 19.** ORS 418.160 is amended to read:

23 418.160. The Department of Human Services shall have the responsibility and authority to pro-
24 vide such services as are necessary to maintain the intent of and compliance with federal require-
25 ments for the [*programs defined*] **program described** in ORS 418.155.

26 **SECTION 20.** ORS 418.163 is amended to read:

27 418.163. The Department of Human Services shall have the responsibility and authority to pro-
28 vide such services and engage in such cooperative and coordinated efforts with the Employment
29 Department and other appropriate agencies as are necessary to maintain the intent of and compli-
30 ance with federal requirements for the [*programs defined*] **program described** in ORS 418.155.

31 **SECTION 21.** ORS 414.042 is amended to read:

32 414.042. (1) The need for and the amount of medical assistance to be made available for each
33 eligible group of recipients of medical assistance shall be determined, in accordance with the rules
34 of the Department of Human Services, taking into account:

35 (a) The requirements and needs of the person, the spouse and other dependents;

36 (b) The income, resources and maintenance available to the person but, except as provided in
37 ORS 414.025 [(2)(s)] **(2)(r)**, resources shall be disregarded for those eligible by reason of having in-
38 come below the federal poverty level and who are eligible for medical assistance only because of the
39 enactment of chapter 836, Oregon Laws 1989;

40 (c) The responsibility of the spouse and, with respect to a person who is blind or is permanently
41 and totally disabled or is under 21 years of age, the responsibility of the parents; and

42 (d) The report of the Health Services Commission as funded by the Legislative Assembly and
43 such other programs as the Legislative Assembly may authorize. However, medical assistance, in-
44 cluding health services, shall not be provided to persons described in ORS 414.025 [(2)(s)] **(2)(r)** un-
45 less the Legislative Assembly specifically appropriates funds to provide such assistance.

1 (2) Such amounts of income and resources may be disregarded as the department may prescribe
2 by rules, except that the department may not require any needy person over 65 years of age, as a
3 condition of entering or remaining in a hospital, nursing home or other congregate care facility, to
4 sell any real property normally used as such person's home. Any rule of the department inconsistent
5 with this section is to that extent invalid. The amounts to be disregarded shall be within the limits
6 required or permitted by federal law, rules or orders applicable thereto.

7 (3) In the determination of the amount of medical assistance available to a medically needy
8 person, all income and resources available to the person in excess of the amounts prescribed in ORS
9 414.038, within limits prescribed by the department, shall be applied first to costs of needed medical

11 costs of benefits under the medical assistance program.

15 benefit package of health care services described in ORS 414.835 if:

16 (a) The Department of Human Services receives 100 percent federal medical assistance per-
17 centage for payments made by the department for the health care services provided as part of the
18 benefit package described in ORS 414.835 that are not included in the benefit package described in
19 ORS 414.834; or

20 (b) The department receives funding from the Indian tribes for which federal financial partic-
21 ipation is available.

22 (2) As used in this section, "American Indian and Alaskan Native beneficiary" means:

23 (a) A member of a federally recognized Indian tribe, band or group;

24 (b) An Eskimo or Aleut or other Alaskan native enrolled by the United States Secretary of the
25 Interior pursuant to the Alaska Native Claims Settlement Act, 43 U.S.C. 1601; or

26 (c) A person who is considered by the United States Secretary of the Interior to be an Indian
27 for any purpose.

28 **SECTION 23.** ORS 418.095 and 418.185 are repealed.

29 **SECTION 24.** Section 4, chapter 212, Oregon Laws 2003, is repealed.

30 **SECTION 25.** The amendments to ORS 25.020, 414.025, 418.045 and 418.134 by sections 3a,
31 5b, 10 and 18a of this 2007 Act and the repeal of section 4, chapter 212, Oregon Laws 2003,
32 by section 24 of this 2007 Act become operative on October 1, 2008.

33 **SECTION 26.** This 2007 Act being necessary for the immediate preservation of the public
34 peace, health and safety, an emergency is declared to exist, and this 2007 Act takes effect
35 October 1, 2007.
