**SUMMARY**

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Revises provisions governing condominiums and planned communities.

**A BILL FOR AN ACT**

2 Relating to properties governed by declarations; creating new provisions; and amending ORS 94.572,  
3 94.580, 94.595, 94.616, 94.645, 94.647, 94.650, 94.655, 94.658, 94.660, 94.675, 94.680, 94.685, 94.719,  
4 100.175, 100.210, 100.407, 100.408, 100.410, 100.412, 100.415, 100.425, 100.427, 100.435, 100.470,  
5 100.525, 100.640 and 100.655.

6 **Be It Enacted by the People of the State of Oregon:**

7 **SECTION 1. Sections 2, 3, 4, 5 and 6 of this 2007 Act are added to and made a part of**  
8 **ORS 94.550 to 94.783.**

9 **SECTION 2. (1) Subject to subsection (2) of this section, if a homeowners association fails**  
10 **to fill vacancies on the board of directors sufficient to constitute a quorum in accordance**  
11 **with the bylaws, an owner or a first mortgagee may request the circuit court of the county**  
12 **in which the planned community is located to appoint a receiver under ORCP 80 to manage**  
13 **the affairs of the association.**

14 **(2) At least 45 days before an owner or first mortgagee requests the circuit court to ap-**  
15 **point a receiver under subsection (1) of this section, the owner or first mortgagee shall mail,**  
16 **by certified or registered mail, a notice to the association and shall post a copy of the notice**  
17 **at a conspicuous place or places on the property or provide notice by a method otherwise**  
18 **reasonably calculated to inform owners of the proposed action.**

19 **(3) The notice shall be signed by the owner or first mortgagee and include:**

20 **(a) A description of the intended action.**

21 **(b) A statement that the intended action is pursuant to this section.**

22 **(c) The date, not less than 30 days after mailing of the notice, by which the association**  
23 **must fill vacancies on the board sufficient to constitute a quorum.**

24 **(d) A statement that if the association fails to fill vacancies on the board by the specified**  
25 **date, the owner or first mortgagee may file a petition with the court under subsection (1)**  
26 **of this section.**

27 **(e) A statement that if a receiver is appointed, all expenses of the receivership will be**  
28 **common expenses of the association as provided in subsection (4) of this section.**

**NOTE:** Matter in **boldfaced** type in an amended section is new; matter *[italic and bracketed]* is existing law to be omitted.  
New sections are in **boldfaced** type.

1 (4) If a receiver is appointed, the salary of the receiver, court costs, attorney fees and  
2 all other expenses of the receivership shall be common expenses of the association.

3 (5) A receiver appointed under this section has all of the powers and duties of a duly  
4 constituted board of directors and shall serve until a sufficient number of vacancies on the  
5 board are filled to constitute a quorum.

6 (6) If at a turnover meeting held in accordance with ORS 94.616 the owners fail to elect  
7 the number of directors sufficient to constitute a quorum of the board of directors, in addi-  
8 tion to the notice requirements specified in subsections (2) and (3) of this section, an owner  
9 shall give the notice to all other owners as provided in the bylaws.

10 (7) Notwithstanding subsections (2) and (3) of this section, in the case of an emergency,  
11 the court may waive the notice requirements of subsections (2) and (3) of this section.

12 **SECTION 3.** (1) If the declaration or bylaws of a planned community created under ORS  
13 94.550 to 94.783 before the effective date of this 2007 Act or a planned community subject to  
14 ORS 94.572 do not assign the responsibility for payment of the amount of the deductible in  
15 an association insurance policy, the board of directors of the homeowners association may  
16 adopt a resolution that assigns the responsibility for payment of the amount of the deduct-  
17 ible. The resolution must include, but need not be limited to:

18 (a) The circumstances under which the deductible will be charged against:

19 (A) An owner or the owners affected by a loss; or

20 (B) All owners;

21 (b) The allocation of the deductible charged under paragraph (a) of this subsection; and

22 (c) If an owner and the association have duplicate insurance coverage, the insurance  
23 policy that is primary, unless otherwise provided in the declaration or bylaws.

24 (2) If the board of directors adopts a resolution as described in subsection (1) of this  
25 section, the resolution may require that an owner, in addition to any other insurance re-  
26 quired by the declaration or bylaws, obtain and maintain:

27 (a) An insurance policy that insures the owner's lot for not less than the amount of the  
28 deductible in the association's insurance policy for which the owner may be responsible and  
29 that insures the owner's personal property for any loss or damage; and

30 (b) Comprehensive liability insurance that includes, but is not limited to, coverage for  
31 negligent acts of owners and tenants, guests of owners and tenants and occupants of other  
32 lots for damage to the common property, to other lots and to the personal property of other  
33 persons that is located on other lots or the common property.

34 (3) Unless otherwise provided in the declaration or bylaws, the board of directors may  
35 adopt a resolution that:

36 (a) Prescribes a procedure for processing insurance claims. The procedure may require  
37 that all claims against the association's insurance policy be processed through and coordi-  
38 nated by the board of directors or the managing agent, if authorized by the board.

39 (b) Assigns the responsibility for payment of charges for handling claims, including any  
40 charges by a managing agent.

41 (4) Not later than 10 days after adoption of a resolution under subsection (1) or (3) of this  
42 section, the board of directors shall ensure that a copy of the resolution and a notice de-  
43 scribed in subsection (5) of this section are:

44 (a) Delivered to each lot; or

45 (b) Mailed to the mailing address of each owner or to the mailing address designated in

1 writing by the owner.

2 (5) The notice required under subsection (4) of this section shall:

3 (a) Advise each owner to contact an insurance agent to determine the effect of the re-  
4 solution on the owner's individual insurance coverage; and

5 (b) Be in a form and style reasonably calculated to inform the owner of the importance  
6 of the notice.

7 (6) Failure to provide a copy of a resolution or a notice required under this section does  
8 not affect the responsibility of an owner to comply with a resolution adopted under this  
9 section.

10 **SECTION 4.** (1) Subject to subsection (2) of this section and notwithstanding any re-  
11 quirement under the declaration or bylaws or ORS 94.550 to 94.783, in the discretion of the  
12 board of directors of the homeowners association, any notice, information or other written  
13 material required to be given to an owner or director under the declaration or bylaws or ORS  
14 94.550 to 94.783, may be given by electronic mail, facsimile or other form of electronic com-  
15 munication.

16 (2) Notwithstanding subsection (1) of this section, electronic mail, facsimile or other form  
17 of electronic communication may not be used to give notice of:

18 (a) Failure to pay an assessment;

19 (b) Foreclosure of an association lien under ORS 94.709; or

20 (c) An action the association may take against an owner.

21 (3) An owner or director may decline to receive notice by electronic mail, facsimile or  
22 other form of electronic communication and may direct the board of directors to provide  
23 notice in the manner required under the declaration or bylaws or ORS 94.550 to 94.783.

24 **SECTION 5.** (1) As used in this section, "electronic ballot" means a ballot given by:

25 (a) Electronic mail;

26 (b) Facsimile transmission;

27 (c) Posting on a website; or

28 (d) Other means of electronic communication acceptable to the board of directors.

29 (2) Unless the declaration or bylaws prohibit or provide for other methods of electronic  
30 ballots, the board of directors of a homeowners association, in its discretion, may provide  
31 that a vote, approval or consent of an owner may be given by electronic ballot.

32 (3) An electronic ballot shall comply with the requirements of this section and the dec-  
33 laration or bylaws or ORS 94.550 to 94.783.

34 (4) An electronic ballot may be accompanied by or contained in an electronic notice in  
35 accordance with section 4 of this 2007 Act.

36 (5) If an electronic ballot is posted on a website, a notice of the posting shall be sent to  
37 each owner and shall contain instructions on obtaining access to the posting on the website.

38 (6) A vote made by electronic ballot is effective when it is electronically transmitted to  
39 an address, location or system designated by the board of directors for that purpose.

40 (7) Unless otherwise provided in the declaration or bylaws or rules adopted by the board  
41 of directors, a vote by electronic ballot may not be revoked.

42 (8) The board of directors may not elect to use electronic ballots unless there are pro-  
43 cedures to ensure:

44 (a) Compliance with ORS 94.647 if the vote conducted by written ballot under ORS 94.647  
45 uses the procedures specified in ORS 94.647 (2)(b); and

1       **(b) That the electronic ballot is secret, if the declaration or bylaws or rules adopted by**  
2 **the board require that electronic ballots be secret.**

3       **SECTION 6.** (1) **A director of a homeowners association who is present at a meeting of**  
4 **the board of directors at which action is taken on any association matter is presumed to**  
5 **have assented to the action unless the director votes against the action or abstains from**  
6 **voting on the action because the director claims a conflict of interest.**

7       **(2) When action is taken on any matter at a meeting of the board of directors, the vote**  
8 **or abstention of each director present must be recorded in the minutes of the meeting.**

9       **(3) Directors may not vote by proxy or by secret ballot at meetings of the board of di-**  
10 **rectors.**

11       **(4) Notwithstanding subsection (3) of this section, officers may be elected by secret bal-**  
12 **lot.**

13       **SECTION 6a.** ORS 94.580 is amended to read:

14       94.580. (1) A declarant shall record, in accordance with ORS 94.565, the declaration for a  
15 planned community in the office of the recording officer of each county in which the planned com-  
16 munity is located.

17       (2) The declaration shall include:

18       (a) The name and classification of the planned community;

19       (b) The name of the association and the type of entity formed in accordance with ORS 94.625;

20       (c) A statement that the planned community is subject to ORS 94.550 to 94.783;

21       (d) A statement that the bylaws adopted under ORS 94.625 must be recorded;

22       (e) A legal description, as required under ORS 93.600, of the real property included in the  
23 planned community;

24       (f) A legal description, as required under ORS 93.600, of any real property included in the  
25 planned community which is or must become a common property;

26       (g) A description of any special declarant rights other than the rights described under sub-  
27 sections (3) and (4) of this section;

28       (h) A statement of the number of votes allocated to each lot in accordance with ORS 94.658;

29       (i) A method of determining the liability of each lot for common expenses and the right of each  
30 lot to any common profits of the association;

31       (j) A statement of when the lots, including lots owned by the declarant, become subject to as-  
32 sessment;

33       (k) If a Class I planned community, provisions for establishing a reserve account and for the  
34 preparation, review and update of the reserve study **and the maintenance plan** as required by ORS  
35 94.595;

36       (L) Any restrictions on the alienation of lots. Any such restriction created by any document  
37 other than the declaration may be incorporated by reference to the official records of the county  
38 where the property is located;

39       (m) A statement of the use, residential or otherwise, for which each lot is intended;

40       (n) A statement as to whether or not the association pursuant to ORS 94.665 may sell, convey  
41 or subject to a security interest any portion of the common property and any limitation on such  
42 authority;

43       (o) A statement of any restriction on the use, maintenance or occupancy of lots or units;

44       (p) The method of amending the declaration and a statement of the percentage of votes required  
45 to approve an amendment of the declaration in accordance with ORS 94.590;

1 (q) A description of any contemplated improvements which the declarant agrees to build, or a  
2 statement that the declarant does not agree to build any improvement or does not choose to limit  
3 declarant's rights to add improvements not described in the declaration;

4 (r) A statement of any period of declarant control or other special declarant rights reserved by  
5 the declarant under ORS 94.600;

6 (s) A statement of the time at which the deed to the common property is to be delivered,  
7 whether by date or upon the occurrence of a stipulated event; and

8 (t) Any provisions restricting a right of the association with respect to the common property,  
9 or an individual lot owner with respect to the lot or improvements on the lot, including but not  
10 limited to:

11 (A) A right to divide the lot or to combine it with other lots;

12 (B) A right to repair or restore improvements on the lot at the owner's discretion in the event  
13 of damage or destruction;

14 (C) The requirement for architectural controls, including but not limited to fencing, landscaping  
15 or choice of exterior colors and materials of structures to be placed on the common property or on  
16 a lot; and

17 (D) The requirement of review of any plans of any structure to be placed on the common prop-  
18 erty or a lot.

19 (3) If the declarant reserves the right to expand the planned community by annexing lots or  
20 common property or by creating additional lots or common property by developing existing property  
21 in the planned community, the declaration shall contain, in addition to the provisions required under  
22 subsections (1) and (2) of this section, a general description of the plan of development including:

23 (a) The procedure by which the planned community will be expanded;

24 (b) The maximum number of lots and units to be included in the planned community or a state-  
25 ment that there is no limitation on the number of lots or units which the declarant may create or  
26 annex to the planned community;

27 (c) A general description of the nature and proposed use of any common property which the  
28 declarant agrees to create or annex to the planned community or a statement that there is no lim-  
29 itation on the right of the declarant to create or annex common property;

30 (d) The method of allocation of votes if additional lots are to be created or annexed to the  
31 planned community; and

32 (e) The formula to be used for reallocating the common expenses if additional lots are to be  
33 created or annexed to the planned community, and the manner of reapportioning the common ex-  
34 penses if lots are created or annexed during the fiscal year.

35 (4) If the declarant may withdraw property from the planned community, the declaration shall  
36 include in addition to the provisions required under subsections (1), (2) and (3) of this section:

37 (a) The procedure by which property will be withdrawn;

38 (b) A general description of the property which may be withdrawn from the planned community;

39 (c) The method of allocation of votes if lots are withdrawn from the planned community;

40 (d) The formula to be used for reallocating the common expenses if the property to be withdrawn  
41 has been assessed for common expenses prior to withdrawal; and

42 (e) The date after which the right to withdraw property from the planned community shall ex-  
43 pire or a statement that such a right shall not expire.

44 **SECTION 7.** ORS 94.595 is amended to read:

45 94.595. (1) The declarant, **on behalf of a homeowners association**, shall:

- 1 (a) Conduct a reserve study **as** described in subsection (3) of this section; *[and]*
- 2 **(b) Prepare a maintenance plan as described in subsection (4) of this section; and**
- 3 **(c) Establish a reserve account as provided in subsection (2) of this section.**

4 *[(b)]* **(2)(a)** *[Establish]* A reserve account *[for]* **shall be established to fund major maintenance, repair or** replacement of all items of common property which will normally require **major**  
5 **maintenance, repair or** replacement, in whole or in part, in more than *[three]* **one** and less than  
6 30 years, for exterior painting if the common property includes exterior painted surfaces, for other  
7 items, whether or not involving common property, if the association has responsibility to maintain  
8 the items and for other items required by the declaration or bylaws. The reserve account need not  
9 include reserves for those items:

10 (A) That *[could]* **can** reasonably be funded from *[operating assessments]* **the general budget or**  
11 **other funds or accounts of the association;** or

12 (B) For which one or more, **but less than all**, owners are responsible for maintenance and re-  
13 placement under the provisions of the declaration or bylaws.

14 *[(2)(a)]* A reserve account established under this section must be funded by assessments against the  
15 individual lots for which the reserves are established.]

16 *[(b)]* Unless the declaration provides otherwise, the assessments under this subsection begin accru-  
17 ing for all lots from the date the first lot is conveyed.]

18 *[(3)(a)]* **(b)** The reserve account shall be established in the name of the homeowners association.  
19 The association is responsible for administering the account and for making periodic payments into  
20 the account.

21 *[(b)]* **(c)** The reserve portion of the initial assessment determined by the declarant shall be based  
22 on:

23 (A) The reserve study described in *[paragraph (c) of this subsection]* **subsection (3) of this**  
24 **section;** or

25 (B) Other *[sources of]* reliable information.

26 **(d) A reserve account established under this section must be funded by assessments**  
27 **against the individual lots for which the reserves are established.**

28 **(e) Unless the declaration provides otherwise, the assessments under this subsection be-**  
29 **gin accruing for all lots from the date the first lot is conveyed.**

30 *[(c)]* **(3)(a)** The board of directors of the association annually shall conduct a reserve study or  
31 review and update an existing study to determine the reserve account requirements and may:

32 (A) Adjust the amount of payments as indicated by the study or update; and

33 (B) Provide for other reserve items that the board of directors, in its discretion, may deem ap-  
34 propriate.

35 *[(d)]* **(b)** The reserve study shall *[include]*:

36 (A) *[Identification of]* **Identify** all items for which reserves are *[required to]* **or will** be estab-  
37 lished;

38 (B) **Include** the estimated remaining useful life of each item as of the date of the reserve study;  
39 **and**

40 (C) *[The]* **Include for each item, as applicable, an** estimated cost of maintenance[,] **and** repair  
41 *[or]* **and** replacement *[of each item]* at the end of *[its]* **the item's** useful life; *[and]*.

42 *[(D)]* **(4)(a)** *[A 30-year]* **The board of directors shall prepare a maintenance** plan for the  
43 maintenance, repair and replacement of *[common property with regular and adequate contributions,*  
44 *adjusted by estimated inflation and interest earned on reserves, to meet the maintenance, repair and*  
45

1 *replacement schedule.*] **all property for which the association has maintenance, repair or re-**  
2 **placement responsibility under the declaration or bylaws or ORS 94.550 to 94.783. The main-**  
3 **tenance plan shall:**

4 **(A) Describe the maintenance, repair and replacement to be conducted;**

5 **(B) Include a schedule for the maintenance, repair and replacement;**

6 *[(4) The 30-year plan under subsection (3) of this section shall:]*

7 *[(a)]* **(C) Be appropriate for the size and complexity of the [common property] maintenance,**  
8 **repair and replacement responsibility of the association; and**

9 *[(b)]* **(D) Address issues that include but are not limited to warranties and the useful life of the**  
10 **[common property] items for which the association has maintenance, repair and replacement**  
11 **responsibility.**

12 **(b) The board of directors shall review and update the maintenance plan described under**  
13 **this subsection as necessary.**

14 *[(5) The board of directors and the declarant shall, within 30 days after conducting the reserve*  
15 *study, provide to every owner a written summary of the reserve study and of any revisions to the*  
16 *30-year plan adopted by the board of directors or the declarant as a result of the reserve study.]*

17 *[(6)(a)]* **(5)(a) If the declaration or bylaws require a reserve account, the reserve study require-**  
18 **ments of subsection (3) of this section and the maintenance plan requirements of subsection (4)**  
19 **of this section first apply to the association of a subdivision that meets the definition of a planned**  
20 **community under ORS 94.550 and is recorded prior to October 23, 1999, when:**

21 **(A) The board of directors adopts a resolution in compliance with the bylaws that applies the**  
22 **requirements of [subsection (3)] subsections (3) and (4) of this section to the association; or**

23 **(B) A petition signed by a majority of owners is submitted to the board of directors mandating**  
24 **that the requirements of [subsection (3)] subsections (3) and (4) of this section apply to the asso-**  
25 **ciation.**

26 **(b) A reserve study and maintenance plan shall be completed within one year of adoption of**  
27 **the resolution or submission of the petition to the board of directors.**

28 *[(7)(a)]* **(6)(a) Except as provided in paragraph (b) of this subsection, the reserve account may**  
29 **be used only for the purposes for which reserves have been established and is to be kept separate**  
30 **from other funds.**

31 **(b) After the individual lot owners have assumed responsibility for administration of the planned**  
32 **community under ORS 94.616, if the board of directors has adopted a resolution, which may be an**  
33 **annual continuing resolution, authorizing the borrowing of funds:**

34 **(A) The board of directors may borrow funds from the reserve account to meet high seasonal**  
35 **demands on the regular operating funds or to meet unexpected increases in expenses.**

36 **(B) Not later than the adoption of the budget for the following year, the board of directors shall**  
37 **adopt by resolution a written payment plan providing for repayment of the borrowed funds within**  
38 **a reasonable period.**

39 *[(8)]* **(7) Nothing in this section prohibits prudent investment of reserve account funds subject**  
40 **to any constraints imposed by the declaration, bylaws or rules of the association.**

41 *[(9)]* **(8) In addition to the authority of the board of directors under subsection [(3)(c)] (3)(a) of**  
42 **this section, following the second year after the association has assumed administrative responsi-**  
43 **bility for the planned community under ORS 94.616:**

44 **(a) By an affirmative vote of at least 75 percent of the owners of the planned community, the**  
45 **association may elect to reduce or increase future assessments for the reserve account; and**

1 (b) The association may, on an annual basis by a unanimous vote, elect not to fund the reserve  
2 account.

3 [(10)] (9) Assessments paid into the reserve account are the property of the association and are  
4 not refundable to sellers or owners of lots.

5 **SECTION 8.** ORS 94.616 is amended to read:

6 94.616. (1) At the meeting called under ORS 94.609, the declarant shall turn over to the home-  
7 owners association the responsibility for the administration of the planned community, and the as-  
8 sociation shall accept the administrative responsibility from the declarant.

9 (2) **If a quorum of the owners is present**, the owners shall elect **not fewer than the number**  
10 **of directors sufficient to constitute a quorum of the** [a] board of directors in accordance with  
11 the **declaration or** bylaws of the association.

12 (3) At the meeting[,] called under ORS 94.609, the declarant shall deliver to the association:

13 (a) The original or a photocopy of the recorded declaration and copies of the bylaws and the  
14 articles of incorporation, if any, of the planned community and any supplements and amendments to  
15 the articles or bylaws;

16 (b) A deed to the common property in the planned community, unless otherwise provided in the  
17 declaration;

18 (c) The minute books, including all minutes, and other books and records of the association and  
19 the board of directors;

20 (d) All rules and regulations adopted by the declarant;

21 (e) Resignations of officers and members of the board of directors who are required to resign  
22 because of the expiration of any period of declarant control reserved pursuant to ORS 94.600;

23 (f) A financial statement. The financial statement:

24 (A) Must consist of a balance sheet and an income and expense statement for the preceding  
25 12-month period or the period following the recording of the declaration, whichever period is  
26 shorter; and

27 (B) Must be reviewed, in accordance with the Statements on Standards for Accounting and Re-  
28 view Services issued by the American Institute of Certified Public Accountants, by an independent  
29 certified public accountant licensed in the State of Oregon if the annual assessments of an associ-  
30 ation exceed \$75,000;

31 (g) All funds of the association and control of the funds, including all bank records;

32 (h) All tangible personal property that is property of the association, and an inventory of the  
33 property;

34 (i) Records of all property tax payments for the common property to be administered by the as-  
35 sociation;

36 (j) Copies of any income tax returns filed by the declarant in the name of the association, and  
37 supporting records for the returns;

38 (k) All bank signature cards;

39 (L) The reserve account established in the name of the association under ORS 94.595;

40 (m) The reserve study [*described in*] **and the maintenance plan required under** ORS 94.595,  
41 including all updates and other sources of information that serve as a basis for calculating reserves  
42 in accordance with ORS 94.595;

43 (n) An operating budget for the portion of the planned community turned over to association  
44 administration and a budget for replacement and maintenance of the common property;

45 (o) A copy of the following, if available:



- 1 (A) The as-built architectural, structural, engineering, mechanical, electrical and plumbing plans;  
2 (B) The original specifications, indicating all subsequent material changes;  
3 (C) The plans for underground site service, site grading, drainage and landscaping together with  
4 cable television drawings;  
5 (D) Any other plans and information relevant to future repair or maintenance of the property;  
6 and  
7 (E) A list of the general contractor and the electrical, heating and plumbing subcontractors re-  
8 sponsible for construction or installation of common property;  
9 (p) Insurance policies;  
10 (q) Copies of any occupancy permits issued for the planned community;  
11 (r) Any other permits issued by governmental bodies applicable to the planned community in  
12 force or issued within one year before the date on which the owners assume administrative respon-  
13 sibility;  
14 (s) A list of any written warranties on the common property that are in effect and the names  
15 of the contractor, subcontractor or supplier who made the installation for which the warranty is in  
16 effect;  
17 (t) A roster of owners and their addresses and telephone numbers, if known, as shown on the  
18 records of the declarant;  
19 (u) Leases of the common property and any other leases to which the association is a party;  
20 (v) Employment or service contracts in which the association is one of the contracting parties  
21 or service contracts in which the association or the owners have an obligation or responsibility,  
22 directly or indirectly, to pay some or all of the fee or charge of the person performing the service;  
23 and  
24 (w) Any other contracts to which the homeowners association is a party.  
25 (4) In order to facilitate an orderly transition, during the three-month period following the  
26 turnover meeting, the declarant or an informed representative shall be available to meet with the  
27 board of directors on at least three mutually acceptable dates to review the documents delivered  
28 under subsection (3) of this section.  
29 (5) If the declarant has complied with this section and unless the declarant has sufficient voting

37 purposes for which the reserve account is being established.]

38 *[(b)]* The assessment under this subsection will accrue from the time of the conveyance of the first  
39 individual unit assessed as provided in ORS 100.530.]

40 *[(3)(a)]* (b) The reserve account shall be established in the name of the association of unit own-  
41 ers. *[that will be]* The association is responsible for administering the account and for making pe-  
42 riodic payments into the account.

43 *[(b)]* (c) The reserve portion of the initial assessment determined by the declarant shall be based  
44 on *[the following]*:

45 (A) The reserve study described in *[paragraph (c) of this]* subsection (3) of this section;

1 (B) In the case of a conversion condominium, the statement described in ORS 100.655 (1)(g); or

2 (C) Other reliable information.

3 **(d) The reserve account must be funded by assessments against the individual units for**  
4 **the purposes for which the reserve account is established.**

5 **(e) The assessment under this subsection accrues from the time of the conveyance of the**  
6 **first individual unit assessed as provided in ORS 100.530.**

7 [(c)] **(3)(a)** The board of directors of the association annually shall conduct a reserve study or  
8 review and update an existing study to determine the reserve account requirements and may:

9 (A) Adjust the amount of payments in accordance with the study or review; and

10 (B) Provide for other reserve items that the board of directors, in its discretion, may deem ap-  
11 propriate.

12 [(d)] **(b)** The reserve study shall [include]:

13 (A) [Identification of] **Identify** all items for which reserves are [to] **or will** be established;

14 (B) **Include** the estimated remaining useful life of each item as of the date of the reserve study;

19 maintenance, repair and replacement of [common elements and association property with regular and

21 maintenance, repair and replacement schedule.] **all property for which the association has main-**

25 [(12)] **(L)** Insurance coverage in accordance with ORS 100.435 **and the responsibility for pay-**

29 [(14)] **(n)** The reserve account and the preparation, review and update of the reserve study **and**

33 (8) Notwithstanding a provision in the bylaws, including bylaws adopted prior to July 14, 2003,  
34 that requires an amendment to be executed, or executed and acknowledged, by all owners approving  
35 the amendment, amendments to the bylaws under this section become effective after approval by the  
36 owners if executed and certified on behalf of the association by the chairperson and secretary in  
37 accordance with subsection (3)(b) of this section.

38 (9) An amendment to the bylaws must be conclusively presumed to have been regularly adopted  
39 in compliance with all applicable procedures relating to the amendment unless an action is brought  
40 within one year after the effective date of the amendment or the face of the amendment indicates  
41 that the amendment received the approval of fewer votes than required for the approval. Nothing  
42 in this subsection prevents the further amendment of an amended bylaw.

43 (10)(a) The board of directors, by resolution and without the further approval of unit owners,  
44 may cause restated bylaws to be prepared and recorded to codify individual amendments that have  
45 been adopted in accordance with this section.

1 (b) Bylaws restated under this subsection must:

2 (A) Include all previously adopted amendments that are in effect, state that the amendments  
3 were approved by the commissioner as required under this section and state that no other changes  
4 were made except, if applicable, to correct scriveners' errors or to conform format and style;

5 (B) Include a statement that the board of directors has adopted a resolution in accordance with  
6 paragraph (a) of this subsection and is causing the bylaws to be restated and recorded under this  
7 subsection;

8 (C) Include a reference to the recording index numbers and date of recording of the initial by-  
9 laws and all previously recorded amendments that are in effect and are being codified;

10 (D) Include a certification by the chairperson and secretary of the association that the restated  
11 bylaws include all previously adopted amendments that are in effect, that amendments were ap-  
12 proved by the commissioner if required under this section and that no other changes were made  
13 except, if applicable, to correct scriveners' errors or to conform format and style;

14 (E) Be executed and acknowledged by the chairperson and secretary of the association and re-  
15 corded in the deed records of each county in which the condominium is located; and

16 (F) If required under subsection (6) of this section, be approved by the commissioner.

17 (c) The board of directors shall cause a copy of the recorded restated bylaws, including the re-  
18 cording information, to be filed with the commissioner.

24 where the condominium was created;

25 (2) A copy of the proposed or recorded bylaws drawn in conformance with ORS 100.415 or the  
26 law applicable in the state where the condominium was created;

27 (3) A copy of the full size plat prepared in conformance with ORS 100.115 (2) or the law appli-  
28 cable in the state where the condominium was created, or a copy of the site plan;

29 (4) A statement from the county assessor or county surveyor that the name for the condominium  
30 is acceptable under ORS 100.105 (6);

31 (5) A copy of a preliminary title report, title insurance policy or condominium guarantee that  
32 has been issued within the preceding 30 days, including a map showing the location of property de-  
33 scribed in the report, policy or guarantee or other evidence of title satisfactory to the commissioner;

34 (6) A copy of all restrictive covenants, reservations or other documents that may create an  
35 encumbrance on or limit the use of the property other than those restrictions contained in the  
36 declaration or bylaws;

37 (7) A copy of the reserve study required by ORS 100.175 and other sources of information that  
38 serve as a basis for calculating reserves in accordance with ORS 100.175 [(3)], unless the information  
39 is contained in the disclosure statement;

41 (a) Unit sales agreement, including the notice to purchaser of cancellation rights in accordance  
42 with ORS 100.730 and 100.740, the statement required by ORS 93.040 (1) and any warranty required  
43 under ORS 100.185; and

44 (b) A receipt for documents required under ORS 100.725;

45 (9) If required by ORS 100.680:

1 (a) A copy of the escrow agreement drawn in conformance with ORS 100.680 and executed by  
2 both the declarant and the escrow agent. If individual escrow agreements or instructions are to be  
3 executed by the purchaser, other than the standard escrow instruction required by the escrow agent,  
4 submit sample form and a letter from the escrow agent, agreeing to the establishment of the escrows  
5 and the procedure set forth in the sample form; and

6 (b) A unit sales agreement drawn in conformance with ORS 100.680;

7 (10) If any of the sales will be by means of an installment contract of sale:

8 (a) A copy of the escrow agreement or escrow instructions executed by the developer and the

20 (a) The name and address of the condominium, and the name, address and telephone number of

22 (b) A general narrative description of the condominium stating the total number of units, a de-  
23 scription of the types of units, the total number of units that may be included in the condominium  
24 pursuant to ORS 100.105 (2), and a precise statement of the nature of the interest which is being  
25 offered;

26 (c) If at the time of filing:

27 (A) The construction of the project is not completed, general disclosure of the status of con-  
28 struction and the actual or scheduled dates of completion of buildings, recreational facilities and  
29 other common elements, including a statement describing any recreational facilities or improvements  
30 to the common elements that the developer reserves the right to develop or promises to develop, or  
31 a statement that there are no such facilities or improvements; or

32 (B) The construction of the project is completed, the actual dates of completion of buildings,  
33 recreational facilities and other common elements if known by the developer;

34 (d) The nature and significant terms of any financing offered by the developer to purchasers of  
35 the condominium units;

36 (e) Copies of any warranties for structural elements and mechanical and other systems or a brief  
37 description of such warranties;

38 (f)(A) A current or projected budget of the association of unit owners for the operation and  
39 maintenance and any other common expenses of the condominium, including an amount for a subsidy  
40 of the association by the declarant, if any, by a contribution of funds, goods or services;

41 (B) A brief statement of the method of determining liability for common expenses and the right  
42 to common profits; and

43 (C) The following notice in at least 12-point type that is either all capitals or boldface:

5 missioner may accept a disclosure report issued or approved by another state or governmental  
6 agency.

7 (3) No disclosure statement is required for condominiums described in ORS 100.660.

8 (4) The declarant is not liable to the association or the owners with respect to a statement of  
9 condition or estimate of useful life contained in the disclosure statement if:

10 (a) The declarant did not have actual knowledge of any inaccuracies in the statement at the  
11 time of delivery of the disclosure statement to the purchaser; and

12 (b) The declarant relied upon reports prepared by licensed engineers or architects in making the  
13 statement or, if the condominium has four or fewer units, reports prepared by licensed engineers,  
14 architects or home inspectors.
