

House Bill 2728

Sponsored by Representative ROBLAN (at the request of Bruce Herbert)

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Establishes Oregon Center for Business and Economic Education.
Appropriates moneys from General Fund to center for administration.
Sunsets January 1, 2013.
Declares emergency, effective July 1, 2007.

A BILL FOR AN ACT

2 Relating to Oregon Center for Business and Economic Education; appropriating money; and declar-
3 ing an emergency.

4 **Be It Enacted by the People of the State of Oregon:**

5 **SECTION 1. (1) The Oregon Center for Business and Economic Education is established**
6 **in Florence, Oregon.**

7 **(2) The Governor shall appoint a director for the center.**

8 **(3) The center may:**

9 **(a) Adopt rules necessary for operation of the center;**

10 **(b) Hire staff for the center; and**

11 **(c) Perform other duties as necessary for the operation of the center.**

12 **(4) The center shall:**

13 **(a) Work with school districts that offer education programs in kindergarten through**
14 **grade 12, community colleges and state institutions of higher education to increase student**
15 **education in business and economics; and**

16 **(b) Report annually to the Department of Education and the Department of Higher Edu-**
17 **cation.**

18 **(5)(a) The center may accept contributions of moneys or properties that are donated for**
19 **the use or benefit of the center and use the moneys or properties for the purposes for which**
20 **they were donated.**

21 **(b) All moneys received by the center under paragraph (a) of this subsection shall be paid**
22 **into the State Treasury and deposited in the General Fund to the credit of the center. The**
23 **moneys are continuously appropriated to the center for the purposes of carrying out its du-**
24 **ties under this section.**

25 **SECTION 2. In addition to and not in lieu of any other appropriation, there is appropri-**
26 **ated to the Oregon Center for Business and Economic Education, for the biennium beginning**
27 **July 1, 2007, out of the General Fund, the amount of \$900,000, which may be expended for**
28 **carrying out the purposes of the center.**

29 **SECTION 3. Section 1 of this 2007 Act is repealed on January 1, 2013.**

30 **SECTION 4. This 2007 Act being necessary for the immediate preservation of the public**
