SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Creates crime of aggravated vehicular homicide. Punishes by mandatory minimum sentence of imprisonment of 20 years, maximum fine of \$375,000, or both.

Expands crime of assault in first degree to include serious physical injury caused by person driving under influence of intoxicants if person has specified record.

5 **Be It Enacted by the People of the State of Oregon:**

6 **SECTION 1. (1) Criminal homicide constitutes aggravated vehicular homicide when it is**
7 **committed with criminal negligence, recklessly or recklessly under circumstances manifest-**
8 **ing extreme indifference to the value of human life by a person operating a motor vehicle**
9 **while under the influence of intoxicants in violation of ORS 813.010 and:**

10 (a) **The person has at least three previous convictions for driving while under the influ-**
11 **ence of intoxicants under ORS 813.010, or its statutory counterpart in any jurisdiction, in the**
12 **10 years prior to the date of the current offense; or**

13 (b)(A) **The person has a previous conviction for any of the crimes described in subsection**
14 **(2) of this section, or their statutory counterparts in any jurisdiction; and**

15 (B) **The victim's death or serious physical injury in the previous conviction was caused**
16 **by the person driving a motor vehicle.**

17 (2) **The previous convictions to which subsection (1)(b) of this section applies are:**

18 (a) **Manslaughter in the first degree under ORS 163.118;**

19 (b) **Manslaughter in the second degree under ORS 163.125;**

20 (c) **Criminally negligent homicide under ORS 163.145;**

21 (d) **Assault in the first degree under ORS 163.185;**

22 (e) **Assault in the second degree under ORS 163.175; or**

23 (f) **Assault in the third degree under ORS 163.165.**

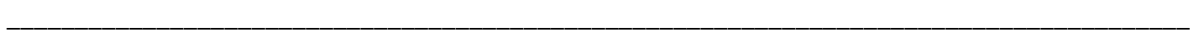
3 (2) "Criminal homicide" is murder, manslaughter, [or] criminally negligent homicide **or aggra-**
4 **vated vehicular homicide.**

5 (3) "Human being" means a person who has been born and was alive at the time of the criminal
6 act.

28 137.707. (1)(a) Notwithstanding any other provision of law, when a person charged with aggra-
29 vated murder, as defined in ORS 163.095, or an offense listed in subsection (4)(a) of this section is
30 15, 16 or 17 years of age at the time the offense is committed, and the offense is committed on or
31 after April 1, 1995, or when a person charged with an offense listed in subsection (4)(b) of this sec-
32 tion is 15, 16 or 17 years of age at the time the offense is committed, and the offense is committed
33 on or after October 4, 1997, **or when a person charged with the offense described in subsection**

40 offense and the lesser included offense is:

22 (a) Store blood and buccal samples received under authority of this section, ORS 137.076, 161.325
23 and 419C.473 (1) and section 2, chapter 852, Oregon Laws 2001, and other physical evidence obtained
24 from analysis of such samples;

25 (b) Analyze such samples for the purpose of establishing the genetic profile of the donor or
26 otherwise determining the identity of persons or contract with other qualified public or private
27 laboratories to conduct that analysis;

28 (c) Maintain a criminal identification database containing information derived from blood and
29 buccal analyses;

30 (d) Utilize such samples to create statistical population frequency databases, provided that ge-
31 netic profiles or other such information in a population frequency database shall not be identified
32 with specific individuals; and

33 (e) Adopt rules establishing procedures for obtaining, transmitting and analyzing blood and
34 buccal samples and for storing and destroying blood and buccal samples and other physical evidence
35 and criminal identification information obtained from such analysis. Procedures for blood and buccal
36 analyses may include all techniques which the department determines are accurate and reliable in
37 establishing identity, including but not limited to, analysis of DNA (deoxyribonucleic acid), antigen
38 antibodies, polymorphic enzymes or polymorphic proteins.

41 (a) The department shall first analyze samples from persons convicted of:

21 (4) The department may not transfer or disclose any sample, physical evidence or criminal

24 (a) To a law enforcement agency as defined in ORS 181.010, a district attorney or the Criminal
25 Justice Division of the Department of Justice for the purpose of establishing the identity of a person

28 discovery or disclosure is required by a separate statutory or constitutional provision; or

32 identification information under subsection (4) of this section unless the public agency or person
33 receiving the sample, physical evidence or criminal identification information agrees to destroy the
34 sample, physical evidence or criminal identification information if notified by the department that
35 a court has reversed the conviction, judgment or order that created the obligation to provide the
36 blood or buccal sample.
37 (6) Any public agency that receives a sample, physical evidence or criminal identification in-
38 formation under authority of subsection (4) of this section may not disclose it except as provided in
39 subsection (4) of this section.
40 (7) Notwithstanding subsections (4) and (6) of this section, any person who is the subject of a
41 record within a criminal identification database maintained under the authority of this section may,
42 upon request, inspect that information at a time and location designated by the department. The
43 department may deny inspection if it determines that there is a reasonable likelihood that such in-
44 spection would prejudice a pending criminal investigation. In any case, the department is not re-
45 quired to allow the person or anyone acting on the person's behalf to test any blood or buccal

1 sample or other physical evidence. The department shall adopt procedures governing the inspection
2 of records and samples and challenges to the accuracy of records. The procedures shall accommo-
3 date the need to preserve the materials from contamination and destruction.

4 (8)(a) Whenever a court reverses the conviction, judgment or order that created an obligation
5 to provide a blood or buccal sample under ORS 137.076 (2), 161.325 or 419C.473 (1), the person who
6 provided the sample may request destruction of the sample and any criminal identification record
7 created in connection with that sample.

8 (b) Upon receipt of a written request for destruction pursuant to this section and a certified
9 copy of the court order reversing the conviction, judgment or order, the department shall destroy
10 any sample received from the person, any physical evidence obtained from that sample and any
11 criminal identification records pertaining to the person, unless the department determines that the
12 person has otherwise become obligated to submit a blood or buccal sample as a result of a separate
13 conviction, juvenile adjudication or finding of guilty except for insanity for an offense listed in ORS
14 137.076 (1). When the department destroys a sample, physical evidence or criminal identification
15 record under this paragraph, the department shall notify any public agency or person to whom the
16 sample, physical evidence or criminal identification information was transferred or disclosed under
17 subsection (4) of this section of the reversal of the conviction, judgment or order.

18 (c) The department is not required to destroy an item of physical evidence obtained from a blood
19 or buccal sample if evidence relating to another person subject to the provisions of ORS 137.076,
20 161.325, 181.085, 419A.260 and 419C.473 (1) would thereby be destroyed. Notwithstanding this sub-
21 section, no sample, physical evidence or criminal identification record is affected by an order to set
22 aside a conviction under ORS 137.225.

26 419A.260. (1) As used in this section and ORS 419A.262:

27 (a) "Contact" means any instance in which a person's act or behavior, or alleged act or behav-
28 ior, which could result in a juvenile court's assumption of jurisdiction under ORS 419B.100 (1)(a) to
29 (c) and (f) or 419C.005 comes to the attention of an agency specified in paragraph (d) of this sub-
30 section.

31 (b) "Expunction" means:

32 (A) The removal and destruction or sealing of a judgment or order related to a contact and all
33 records and references; and

34 (B) Where a record is kept by the Department of Human Services or the Oregon Youth Au-
35 thority, either the sealing of such record by the department or the Oregon Youth Authority or, in
36 a multiperson file, the affixing to the front of the file, by the department or the youth authority, a
37 stamp or statement identifying the name of the individual, the date of expunction and instruction
38 that no further reference shall be made to the material that is subject to the expunction order ex-
39 cept upon an order of a court of competent jurisdiction.

40 (c) "Person" includes a person under 18 years of age.

41 (d) "Record" includes a fingerprint or photograph file, report, exhibit or other material which
42 contains information relating to a person's contact with any law enforcement agency or juvenile
43 court or juvenile department and is kept manually, through the use of electronic data processing
44 equipment, or by any other means by a law enforcement or public investigative agency, a juvenile
45 court or juvenile department or an agency of the State of Oregon. "Record" does not include:

1 (e) "Termination" means:

2 (A) For a person who is the subject of a record kept by a juvenile court or juvenile department,
3 the final disposition of a case by informal means, by a decision not to place the person on probation
4 or make the person a ward of the court after the person has been found to be within the court's
5 jurisdiction, or by a discontinuance of probation or of the court's wardship.

6 (B) For a person who is the subject of a record kept by a law enforcement or public investi-
7 gative agency, a juvenile court or juvenile department or an agency of the State of Oregon, the final
8 disposition of the person's most recent contact with a law enforcement agency.

25 (a) Any degree of murder, manslaughter, criminally negligent homicide or assault resulting from
26 the operation of a motor vehicle;

27 (b) Reckless driving, as defined in ORS 811.140;

28 (c) Driving while under the influence of intoxicants, as defined in ORS 813.010;

29 (d) Failure to perform the duties of a driver involved in an accident or collision, as described
30 in ORS 811.700 or 811.705;

31 (e) Criminal driving while suspended or revoked, as defined in ORS 811.182; [or]

32 (f) Fleeing or attempting to elude a police officer, as defined in ORS 811.540; **or**

33 **(g) Aggravated vehicular homicide, as defined in section 1 of this 2007 Act.**

34 (2) A conviction arising out of the same episode as the current suspension is not considered a
35 conviction for purposes of subsection (1) of this section.

36 (3) The department may not issue a hardship permit to a person whose driving privileges are
37 suspended for a conviction of assault in the second, third or fourth degree:

38 (a) For a period of four years from the date the department suspends driving privileges if the
39 person's driving privileges are suspended for conviction of assault in the second degree and the
40 person was not incarcerated for that conviction.

41 (b) For a period of four years from the date the person is released from incarceration for the

37 (f) Fleeing or attempting to elude a police officer under ORS 811.540.

38 **(g) Aggravated vehicular homicide under section 1 of this 2007 Act.**

39 (2) A person's driving privileges shall be revoked as a habitual offender if the person, within a
40 five-year period, has been convicted of 20 or more of any one or more of the following offenses as
41 evidenced by the records maintained by the department or by a similar agency of another state:

42 (a) Any offenses enumerated in subsection (1) of this section.

43 (b) Any offense specified in the rules of the department adopted under ORS 809.605.

44 (3) A person's driving privileges shall not be revoked under subsection (2) of this section until
45 the person's 21st conviction within a five-year period when the 20th conviction occurs after a lapse
