SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Requires health benefit plan to cover treatment of pervasive developmental disorder subject to

same conditions as treatment of physical illness. Directs Health Resources Commission to conduct review of available medical and behav-ioral health evidence on treatment of pervasive developmental disorders and to report findings and recommendations to Seventy-fifth Legislative Assembly.
