# House Bill 2918

Sponsored by Representative BUCKLEY; Representatives C EDWARDS, HOLVEY, SHIELDS, TOMEI

## SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure as introduced.

Requires health benefit plan to cover treatment of pervasive developmental disorder subject to same conditions as treatment of physical illness.

A BILL FOR AN ACT 1 2 Relating to health benefit plan coverage of pervasive developmental disorder; creating new pro-3

visions; and amending ORS 750.055 and 750.333.

Be It Enacted by the People of the State of Oregon: 4

SECTION 1. Section 2 of this 2007 Act is added to and made a part of the Insurance Code. 5

6 SECTION 2. (1) All health benefit plans, as defined in ORS 743.730, shall provide coverage

7 for treatment of a pervasive developmental disorder that is prescribed by the beneficiary's physician in accordance with a treatment plan. 8

(2) The coverage for treatment of a pervasive developmental disorder may be subject to 9 the same requirements in the plan that apply to physical illness generally, including 10 copayments, coinsurance or deductibles. 11

(3) As used in this section, "pervasive developmental disorder" means a neurological 12 13condition, including Asperger's syndrome and autism, as defined in the most recent edition of the Diagnostic and Statistical Manual of Mental Disorders of the American Psychiatric 14 Association. 15

(4) The provisions of ORS 743.700 do not apply to this section. 16
