House Bill 2953

Sponsored by Representative TOMEI; Representatives BEYER, BOONE, BUCKLEY, GILLIAM, GILMAN, HANNA, HOLVEY, JENSON, KOMP

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure as introduced.

Requires health benefit plans to cover bone mass measurements.

A BILL FOR AN ACT

- Relating to health benefit plan coverage for bone mass measurements; creating new provisions; and amending ORS 750.055 and 750.333.
- 4 Be It Enacted by the People of the State of Oregon:
 - SECTION 1. Section 2 of this 2007 Act is added to and made a part of the Insurance Code.
 - SECTION 2. (1) As used in this section, "bone mass measurement" means a radiologic, radioisotopic or other procedure approved by the United States Food and Drug Administration for the purpose of identifying bone mass, detecting bone loss or interpreting bone quality.
 - (2) A health benefit plan as defined in ORS 743.730 shall provide coverage for bone mass measurements as follows:
 - (a) For the purpose of diagnosis of osteoporosis in a symptomatic or at-risk individual, at any time upon referral of the individual's health care provider.
 - (b) Without a referral from the individual's health care provider, every two years for women who are at menopause, post-menopausal or have known risk factors, and every two years for men who are 75 years of age or older.
 - (3) The coverage required under subsection (2) of this section is subject to the same terms and conditions under the policy that apply to other benefits under the policy.
 - (4) The provisions of ORS 743.700 do not apply to this section.
