

House Bill 2971

Sponsored by COMMITTEE ON AGRICULTURE AND NATURAL RESOURCES

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Allows State Department of Fish and Wildlife to appoint person to act as agent for purpose of using one or more dogs to hunt or pursue black bear or cougar. Directs department to fix compensation and prescribe duties of agent. Limits authority of agent to act.

2 Relating to methods of taking wildlife; amending ORS 498.164.

3 **Be It Enacted by the People of the State of Oregon:**

4 **SECTION 1.** ORS 498.164 is amended to read:

5 498.164. (1) Except as provided in subsections (2) [*and (3)*] **to (4)** of this section, a person may
6 not use bait to attract or take black bears or use one or more dogs to hunt or pursue black bears
7 or cougars.

8 (2) Nothing in subsection (1) of this section prohibits the use of bait or one or more dogs by
9 employees or agents of county, state, or federal agencies while acting in their official capacities.

10 **(3)(a) Nothing in subsection (1) of this section prohibits the State Department of Fish and**
11 **Wildlife from appointing a person to act as an agent for the department for the purpose of**
12 **using one or more dogs to hunt or pursue a black bear or cougar.**

13 **(b) The department shall:**

14 **(A) Make the appointment in written form; and**

15 **(B) Ensure that the written appointment is available to the public for review at the main**
16 **office of the department in Salem.**

17 **(c) Upon appointment of an agent by the department, the department shall fix the com-**
18 **penensation of the agent and prescribe the duties of the agent. The authority of the agent to**
19 **act shall be limited to the terms set forth in the written appointment under paragraph (b)**
20 **of this subsection.**

21 [(3)] (4) Nothing in subsection (1) of this section prohibits the use of bait or dogs by persons for
22 the taking of black bears or cougars in accordance with the provisions of ORS 498.012 relating to
23 taking wildlife that is causing damage.

24 [(4)] (5) Any person who violates subsection (1) of this section commits a Class A misdemeanor
25 and, upon conviction, shall in addition to appropriate criminal penalties have his or her privilege
26 to apply for any hunting license suspended for a period of five years for a first offense and perma-
27 nently suspended for any subsequent offense.

28 [(5)] (6) For the purposes of this section, "bait" means any material placed for the purpose of
29 attracting or attempting to attract bears.
