

House Bill 3033

Sponsored by Representative WHISNANT; Representatives CAMERON, FLORES, GILLIAM, THATCHER, Senator MONNES ANDERSON (at the request of Coalition of County Children and Family Commissions)

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Directs Department of Transportation to issue group registration plate for State Commission on Children and Families. Imposes surcharge for registration plate. Directs that moneys from surcharge on registration plate be deposited in State Commission on Children and Families Account.

2 Relating to group registration plates; amending ORS 805.205 and 805.206.

3 **Be It Enacted by the People of the State of Oregon:**

4 **SECTION 1.** ORS 805.205 is amended to read:

5 805.205. (1) The Department of Transportation by rule shall provide for issuance of registration
6 plates described in subsection (3) of this section for nonprofit groups meeting the qualifications for
7 tax exempt status under section 501(c)(3) of the Internal Revenue Code, for institutions of higher
8 education, **for the State Commission on Children and Families** and for veterans' organizations.
9 The department shall also provide, upon request from a veterans' group or the Director of Veterans'
10 Affairs, for issuance of a veterans' recognition registration plate that may be issued only to veter-
11 ans. Plates issued under this section may be issued to owners of motor vehicles registered under the
12 provisions of ORS 803.420 (1). Plates issued under this section may not contain expressions of poli-
13 tical opinion or religious belief. Rules adopted under this section shall include, but need not be
14 limited to, rules that:

15 (a) Describe general qualifications to be met by any group in order to be eligible for plates is-
16 sued under this section.

17 (b) Specify circumstances under which the department may cease to issue plates for any partic-
18 ular group.

19 (c) Require each group for which plates are issued, other than a group or the Director of Vet-
20 erans' Affairs requesting a veterans' recognition plate **or the State Commission on Children and**
21 **Families**, to file an annual statement on a form designed by the department showing that the group
22 is a nonprofit group or **is** an institution of higher education and **that the group** otherwise meets
23 the qualifications imposed for eligibility for plates issued under this section. The statement shall
24 include names and addresses of current directors or officers of the group or of other persons au-
25 thorized to speak for the group or institution on matters affecting plates issued under this section.

26 (d) Require proof of veteran status for issuance of a veterans' recognition plate and specify what
27 constitutes proof.

28 (2)(a) Except as otherwise provided in [*paragraph*] **paragraphs (b) and (c)** of this subsection, in
29 addition to any other fee authorized by law, upon issuance of a plate under this section and upon
30 renewal of registration for a vehicle that has plates issued under this section, the department shall

1 collect a surcharge of \$2.50 per plate for each year of the registration period.

2 (b) In addition to any other fee authorized by law, upon issuance of a plate under this section
 3 that recognizes an institution of higher education in this state, and upon renewal of registration for
 4 a vehicle that has such plates, the department shall collect a surcharge of \$8 per plate for each year
 5 of the registration period.

6 **(c) In addition to any other fee authorized by law, upon issuance of a plate under this**
 7 **section that recognizes the State Commission on Children and Families, and upon renewal**
 8 **of registration for a vehicle that has such plates, the department shall collect a surcharge**
 9 **of \$5 per plate for each year of the registration period.**

10 (3) Plates issued under this section shall be from the current regular issue of plates except that:

11 (a) In consultation with the group or the Director of Veterans' Affairs requesting the plates[,]
 12 **or the State Commission on Children and Families**, the department shall add words to the plate
 13 that name or describe the group, **the [or] veterans recognized or the State Commission on Chil-**
 14 **dren and Families.**

15 (b) If the group or the Director of Veterans' Affairs requesting the plates represents persons
 16 who have been awarded the Purple Heart medal, the plates shall contain an image of the medal.

17 (c) If the group requesting the plates is an institution of higher education, the plates shall, upon
 18 request, contain words that indicate the plates are issued to recognize the institution or shall con-
 19 tain the institution's logo or an image of the institution's mascot.

20 (4) Except as otherwise required by the design chosen, the plates shall comply with the re-
 21 quirements of ORS 803.535. The department shall determine how many sets of plates shall be man-
 22 ufactured for each group approved under this section or for the Director of Veterans' Affairs. If the
 23 department does not sell or issue renewal for 500 sets of plates for a particular group or for the
 24 Director of Veterans' Affairs in any one year, the department shall cease production of those plates.

25 (5) Except as otherwise provided in subsection (6) of this section, each group that is found by
 26 the department to be eligible for plates issued under this section may designate an account into
 27 which the net proceeds of the surcharge collected by the department under subsection (2) of this
 28 section are to be deposited. The department shall keep accurate records of the number of plates is-
 29 sued for each group that qualifies. After payment of administrative expenses of the department,
 30 moneys collected under this section for each group shall be deposited by the department into an
 31 account specified by that group. If any group does not specify an account for the moneys collected
 32 from the sale of plates issued under this section, the department shall deposit moneys collected for
 33 those plates into the Environmental Quality Information Account established under ORS 802.100 to
 34 be used as other moneys in the account are used. Deposits under this subsection shall be made at
 35 least quarterly.

36 (6)(a) Each institution of higher education that requests a plate under this section shall desig-
 37 nate an account in the general fund of the institution, and the proceeds in the account shall be used
 38 for the purpose of academic enrichment at the institution.

39 (b) Net proceeds of the surcharge collected by the department for the veterans' recognition plate
 40 shall be deposited in the trust fund established under ORS 406.050 for paying the expenses of oper-
 41 ating the Oregon Veterans' Home. Deposits under this paragraph shall be made at least quarterly.

42 **(c) Net proceeds of the surcharge collected by the department for the State Commission**
 43 **on Children and Families shall be deposited in the State Commission on Children and Fami-**
 44 **lies Account established under ORS 417.733. Deposits under this paragraph shall be made at**
 45 **least quarterly.**

1 **SECTION 2.** ORS 805.206 is amended to read:

2 805.206. (1) A group, institution or organization [*that requests*] **or the State Commission on**
3 **Children and Families, upon requesting** issuance of a plate under ORS 805.205, shall pay to the
4 Department of Transportation an application fee of \$10,000 in addition to all of the department's
5 anticipated costs of adding the group to the program. The department may not begin creating or
6 issuing the plates until the application fee and anticipated costs are paid. If 1,000 sets of the plates
7 are purchased in the first 12 months that the plates are available, the department shall refund the
8 application fee. For purposes of this section, costs of adding a new group include, but are not limited
9 to, computer programming costs and vendor set-up fees.

10 (2) If the Director of Veterans' Affairs requests issuance of a plate under ORS 805.205, the di-
11 rector shall pay to the department the application fee and all of the department's anticipated costs
12 of issuance of the plate from grants, donations and gifts accepted by the Director of Veterans' Af-
13 fairs under ORS 406.050 that are expendable for the purpose of issuance of a veterans' recognition
14 registration plate.
