# House Bill 3092

Sponsored by COMMITTEE ON HEALTH CARE (at the request of Oregon Delegation of National Conference of Commissioners on Uniform State Laws)

#### SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Adopts provisions of Revised Uniform Anatomical Gift Act of 2006.

# A BILL FOR AN ACT

- 2 Relating to anatomical gifts; creating new provisions; amending ORS 97.130, 97.966, 114.305, 125.230,
- 3 125.315, 127.510 and 802.179; and repealing ORS 97.950, 97.952, 97.954, 97.956, 97.958, 97.960,
- 4 97.962 and 97.964.

5 Be It Enacted by the People of the State of Oregon:

6 <u>SECTION 1.</u> Sections 1 to 22 of this 2007 Act may be cited as the Revised Uniform Ana-7 tomical Gift Act.

8 SECTION 2. As used in sections 1 to 22 of this 2007 Act:

- 9 (1) "Adult" means an individual who is 18 years of age or older.
- 10 (2) "Agent" means an:
- 11 (a) Attorney-in-fact as that term is defined in ORS 127.505; or
- 12 (b) Individual expressly authorized to make an anatomical gift on the principal's behalf

13 by any record signed by the principal.

- (3) "Anatomical gift" means a donation of all or part of a human body to take effect after
   the donor's death for the purpose of transplantation, therapy, research or education.
- 16 (4) "Body part" means an organ, an eye or tissue of a human being. The term does not
   17 include the whole body.
- 18 (5) "Decedent" means a deceased individual whose body or body part is or may be the 19 source of an anatomical gift, and includes a stillborn infant or a fetus.
- 20 (6)(a) "Disinterested witness" means a witness other than:
- (A) A spouse, child, parent, sibling, grandchild, grandparent or guardian of the individual
   who makes, amends, revokes or refuses to make an anatomical gift; or
- 23

- (B) An adult who exhibited special care and concern for the individual.
- (b) "Disinterested witness" does not include a person to whom an anatomical gift could
   pass under section 10 of this 2007 Act.
- (7) "Document of gift" means a donor card or other record used to make an anatomical
   gift. The term includes a statement, symbol or designation on a driver license, identification
   card or donor registry.
- (8) "Donor" means an individual whose body or body part is the subject of an anatomical
   gift.
- 31
- (9) "Donor registry" means a centralized database that contains records of anatomical

1 gifts and amendments to or revocations of anatomical gifts.

2 (10) "Driver license" means a license or permit issued under ORS 807.040, 807.200 or 3 807.280, regardless of whether conditions are attached to the license or permit.

4 (11) "Eye bank" means an organization licensed, accredited or regulated under federal 5 or state law to engage in the recovery, screening, testing, processing, storage or distribution 6 of human eyes or portions of human eyes.

7 (12) "Guardian" means a person appointed by a court to make decisions regarding the 8 support, care, education, health or welfare of an individual. "Guardian" does not include a 9 guardian ad litem.

(13) "Hospital" means a facility licensed as a hospital under the law of any state or a
 facility operated as a hospital by the United States, a state or a subdivision of a state.

(14) "Identification card" means the card issued under ORS 807.400 or a comparable pro vision of the motor vehicle laws of another state.

14 (15) "Know" means to have actual knowledge.

15 (16) "Minor" means an individual who is under 18 years of age.

(17) "Organ procurement organization" means an organization designated by the Secre tary of the United States Department of Health and Human Services as an organ procure ment organization.

(18) "Parent" means a parent whose parental rights have not been terminated.

(19) "Physician" means an individual authorized to practice medicine or osteopathy under
 the law of any state.

(20) "Procurement organization" means an eye bank, organ procurement organization or
 tissue bank.

(21) "Prospective donor" means an individual who is dead or near death and has been determined by a procurement organization to have a body part that could be medically suitable for transplantation, therapy, research or education. The term does not include an individual who has made a refusal.

(22) "Reasonably available" means able to be contacted by a procurement organization
 without undue effort and willing and able to act in a timely manner consistent with existing
 medical criteria necessary for the making of an anatomical gift.

(23) "Recipient" means an individual into whose body a decedent's body part has been or
 is intended to be transplanted.

(24) "Record" means information that is inscribed on a tangible medium or that is stored
 in an electronic or other medium and is retrievable in perceivable form.

(25) "Refusal" means a record that expressly states an intent to prohibit other persons
 from making an anatomical gift of an individual's body or body part.

37 (26) "Sign" means, with the present intent to authenticate or adopt a record:

38 (a) To execute or adopt a tangible symbol; or

(b) To attach to or logically associate with the record an electronic symbol, sound or
 process.

(27) "State" means a state of the United States, the District of Columbia, Puerto Rico,
the United States Virgin Islands or any territory or insular possession subject to the jurisdiction of the United States.

44 (28) "Technician" means an individual determined to be qualified to remove or process
 45 body parts by an appropriate organization that is licensed, accredited or regulated under

federal or state law. The term includes an enucleator. 1 2 (29) "Tissue" means a portion of the human body other than an organ or an eye. The term does not include blood unless the blood is donated for the purpose of research or edu-3 4 cation. (30) "Tissue bank" means a person that is licensed, accredited or regulated under federal 5 or state law to engage in the recovery, screening, testing, processing, storage or distribution 6 of tissue. 7 (31) "Transplant hospital" means a hospital that furnishes organ transplants and other 8 9 medical and surgical specialty services required for the care of transplant patients. SECTION 3. (1) Subject to section 7 of this 2007 Act, a donor may make an anatomical 10 gift of a donor's body or body part during the life of the donor for the purpose of trans-11 12 plantation, therapy, research or education. 13 (2) An anatomical gift may be made in the manner provided in section 4 of this 2007 Act by: 14 15 (a) The donor, if the donor is an adult or if the donor is a minor and is: 16 (A) Emancipated; or (B) Authorized under ORS 807.280 to apply for an instruction driver permit because the 17donor is at least 15 years of age; 18 (b) An agent of the donor, unless the power of attorney for health care or other record 19 prohibits the agent from making an anatomical gift; 20(c) A parent of the donor, if the donor is an unemancipated minor; or 2122(d) The donor's guardian. SECTION 4. (1) A donor may make an anatomical gift: 23(a) By a designation on the donor's driver license or identification card; 24 (b) In a will; 25(c) During a terminal illness or injury of the donor, by any form of communication ad-2627dressed to at least two adults, at least one of whom is a disinterested witness; (d) By a donor card or other record signed by the donor or other person making the gift; 2829or 30 (e) By authorizing that a statement, symbol or designation indicating that the donor has 31 made an anatomical gift is to be included on a donor registry. (2) If the donor or other person authorized to make an anatomical gift under section 3 32of this 2007 Act is physically unable to sign a record, the record may be signed by another 33 34 individual at the direction of the donor or other person and must: 35 (a) Be witnessed by at least two adults, at least one of whom is a disinterested witness, 36 who have signed at the request of the donor or the other person; and 37 (b) State that it has been signed and witnessed as provided in paragraph (a) of this sub-38 section. (3) Revocation, suspension, expiration or cancellation of a driver license or identification 39 card upon which an anatomical gift is indicated does not invalidate the gift. 40 (4) An anatomical gift made by will takes effect upon the donor's death whether or not 41 the will is probated. Invalidation of the will after the donor's death does not invalidate the 42 gift. 43 SECTION 5. (1) Except as provided in section 7 of this 2007 Act, a donor or other person 44 authorized to make an anatomical gift under section 3 of this 2007 Act may amend or revoke 45

1 an anatomical gift by:

2 (a) A record signed by:

3 (A) The donor;

4 (B) The other person; or

5 (C) Subject to subsection (2) of this section, another individual acting at the direction of

6 the donor or the other person if the donor or other person is physically unable to sign; or

(b) A later-executed document of gift that amends or revokes a previous anatomical gift
 or portion of an anatomical gift, either expressly or by inconsistency.

(a) Be witnessed by at least two adults, at least one of whom is a disinterested witness,

9 (2) A record signed pursuant to subsection (1)(a)(C) of this section must:

11 who have signed at the request of the donor or the other person; and

12 (b) State that it has been signed and witnessed as required in this subsection.

(3) Except as provided in section 7 of this 2007 Act, a donor or other person authorized
to make an anatomical gift under section 3 of this 2007 Act may revoke an anatomical gift
by the destruction or cancellation of the document of gift, or the portion of the document
of gift used to make the gift, with the intent to revoke the gift.

(4) A donor may amend or revoke an anatomical gift that was not made in a will by any
form of communication during a terminal illness or injury addressed to at least two adults,
at least one of whom is a disinterested witness.

- (5) A donor who makes an anatomical gift in a will may amend or revoke the gift in the
   manner provided for amendment or revocation of wills or as provided in subsection (3) of this
   section.
- 23 <u>SECTION 6.</u> (1) An individual may refuse to make an anatomical gift of the individual's 24 body or body part by:

25 (a) A record signed by:

26 (A) The individual; or

(B) Subject to subsection (2) of this section, another individual acting at the direction
of the individual if the individual is physically unable to sign;

(b) The individual's will, whether or not the will is admitted to probate or invalidated
 after the individual's death; or

(c) Any form of communication made by the individual during the individual's terminal
 illness or injury addressed to at least two adults, at least one of whom is a disinterested
 witness.

34 (2) A record signed under subsection (1)(a)(B) of this section must:

(a) Be witnessed by at least two adults, at least one of whom is a disinterested witness,
 who have signed at the request of the individual; and

37 (b) State that it has been signed and witnessed as provided in this subsection.

38 (3) An individual who has made a refusal may amend or revoke the refusal:

39

(a) In the manner provided in subsection (1) of this section for making a refusal;

40 (b) By subsequently making an anatomical gift pursuant to section 4 of this 2007 Act that
41 is inconsistent with the refusal; or

42 (c) By destroying or canceling the record evidencing the refusal, or the portion of the 43 record used to make the refusal, provided that the destruction or cancellation is done with 44 the intent to revoke the refusal.

45

(4) Except as otherwise provided in section 7 (8) of this 2007 Act, in the absence of an

1 express, contrary indication by the individual set forth in the refusal, an individual's unre-

voked refusal to make an anatomical gift of the individual's body or body part prohibits all
other persons from making an anatomical gift of the individual's body or body part.

<u>SECTION 7.</u> (1) Except as otherwise provided in subsection (7) of this section and subject to subsection (6) of this section, in the absence of an express, contrary indication by the donor, a person other than the donor is prohibited from making, amending or revoking an anatomical gift of a donor's body or body part if the donor made an anatomical gift of the donor's body or body part under section 4 of this 2007 Act or an amendment to an anatomical gift of the donor's body or body part under section 5 of this 2007 Act.

(2) A donor's revocation of an anatomical gift of the donor's body or body part under
section 5 of this 2007 Act is not a refusal and does not prohibit another person specified in
section 3 or 8 of this 2007 Act from making an anatomical gift of the donor's body or body
part under section 4 or 9 of this 2007 Act.

(3) If a person other than the donor makes an unrevoked anatomical gift of the donor's
body or body part under section 4 of this 2007 Act or an amendment to an anatomical gift
of the donor's body or body part under section 5 of this 2007 Act, another person may not
make, amend or revoke the gift of the donor's body or body part under section 9 of this 2007
Act.

(4) A revocation of an anatomical gift of a donor's body or body part under section 5 of
this 2007 Act by a person other than the donor does not prohibit another person from making
an anatomical gift of the body or body part under section 4 or 9 of this 2007 Act.

(5) In the absence of an express, contrary indication by the donor or other person authorized to make an anatomical gift under section 3 of this 2007 Act, an anatomical gift of a body part is neither a refusal to give another body part nor a limitation on the making of an anatomical gift of another body part at a later time by the donor or other person.

(6) In the absence of an express, contrary indication by the donor or other person authorized to make an anatomical gift under section 3 of this 2007 Act, an anatomical gift of
a body part for one or more of the purposes set forth in section 3 of this 2007 Act is not a
limitation on the making of an anatomical gift of the body part for any of the other purposes
by the donor or other person under section 4 or 9 of this 2007 Act.

(7) If a donor who is an unemancipated minor dies, a parent of the donor who is reasonably available may revoke or amend an anatomical gift of the donor's body or body part.
(8) If an unemancipated minor who signed a refusal dies, a parent of the minor who is reasonably available may revoke the minor's refusal.

<u>SECTION 8.</u> (1) Subject to subsections (2) and (3) of this section and unless prohibited by section 6 or 7 of this 2007 Act, an anatomical gift of a decedent's body or body part for purpose of transplantation, therapy, research or education may be made by any member of the following classes of persons who is reasonably available, in the following order:

(a) An agent of the decedent at the time of death who could have made an anatomical
gift under section 3 (2)(b) of this 2007 Act immediately before the decedent's death;

41 (b) The spouse of the decedent;

42 (c) An adult child of the decedent;

43 (d) A parent of the decedent;

44 (e) An adult sibling of the decedent;

45 (f) An adult grandchild of the decedent;

(g) A grandparent of the decedent; 1 (h) An adult who exhibited special care and concern for the decedent; 2 (i) A guardian of the decedent at the time of death; or 3 (j) Any other person having the authority to dispose of the decedent's body. 4 5 (2) If there is more than one member of a class listed in subsection (1) of this section entitled to make an anatomical gift, an anatomical gift may be made by a member of the 6 class unless that member or a person to which the gift may pass under section 10 of this 2007 7 Act knows of an objection by another member of the class. If an objection is known, the gift 8 9 may be made only by a majority of the members of the class who are reasonably available. (3) A person may not make an anatomical gift if, at the time of the decedent's death, a 10 person in a prior class under subsection (1) of this section is reasonably available to make 11 12 or to object to the making of an anatomical gift. 13 SECTION 9. (1) A person authorized to make an anatomical gift under section 8 of this 2007 Act may make an anatomical gift by a document of gift signed by the person making 14 15 the gift or by that person's oral communication that is electronically recorded or is 16 contemporaneously reduced to a record and signed by the individual receiving the oral com-17 munication. 18 (2) Subject to subsection (3) of this section, an anatomical gift by a person authorized under section 8 of this 2007 Act may be amended or revoked orally or in a record by any 19 20member of a prior class who is reasonably available. If more than one member of the prior class is reasonably available, the gift made by a person authorized under section 8 of this 21222007 Act may be: 23(a) Amended only if a majority of the reasonably available members agree to amendment of the gift; or 24(b) Revoked only if a majority of the reasonably available members agree to the revoca-25

tion of the gift or if they are equally divided as to whether to revoke the gift.

(3) A revocation under subsection (2) of this section is effective only if, before an incision
has been made to remove a body part from the donor's body or before invasive procedures
have begun to prepare the recipient, the procurement organization, transplant hospital,
physician or technician knows of the revocation.

31 <u>SECTION 10.</u> (1) An anatomical gift may be made to the following persons named in the 32 document of gift:

(a) A hospital, accredited medical school, dental school, college, university, organ pro curement organization or other appropriate person, for research or education;

(b) Subject to subsection (2) of this section, an individual designated by the person mak ing the anatomical gift if the individual is the recipient of the body part; or

37 (c) An eye bank or tissue bank.

(2) If an anatomical gift to an individual under subsection (1)(b) of this section cannot
be transplanted into the individual, the body part passes in accordance with subsection (7)
of this section in the absence of an express, contrary indication by the person making the
anatomical gift.

(3) If an anatomical gift of one or more specific body parts or of all body parts is made
in a document of gift that does not name a person described in subsection (1) of this section
but identifies the purpose for which an anatomical gift may be used, the following rules apply:

(a) If the body part is an eye and the gift is for the purpose of transplantation or therapy,
 the gift passes to the appropriate eye bank.

3 (b) If the body part is tissue and the gift is for the purpose of transplantation or therapy,
4 the gift passes to the appropriate tissue bank.

5 (c) If the body part is an organ and the gift is for the purpose of transplantation or 6 therapy, the gift passes to the appropriate organ procurement organization as custodian of 7 the organ.

8 (d) If the body part is an organ, an eye or tissue and the gift is for the purpose of re-9 search or education, the gift passes to the appropriate procurement organization.

(4) For the purposes of subsection (3) of this section, if there is more than one purpose of an anatomical gift set forth in the document of gift but the purposes are not set forth in any priority, the gift must be used for transplantation or therapy, if suitable. If the gift cannot be used for transplantation or therapy, the gift may be used for research or education.

(5) If an anatomical gift of one or more specific body parts is made in a document of gift that does not name a person described in subsection (1) of this section and does not identify the purpose of the gift, the gift may be used only for transplantation or therapy, and the gift passes in accordance with subsection (7) of this section.

(6) If a document of gift specifies only a general intent to make an anatomical gift by words such as "donor," "organ donor" or "body donor" or by a symbol or statement of similar import, the gift may be used only for transplantation or therapy, and the gift passes in accordance with subsection (7) of this section.

(7) For purposes of subsections (2), (5) and (6) of this section, the following rules apply:(a) If the body part is an eye, the gift passes to the appropriate eye bank.

(b) If the body part is tissue, the gift passes to the appropriate tissue bank.

(c) If the body part is an organ, the gift passes to the appropriate organ procurement
 organization as custodian of the organ.

(8) An anatomical gift of an organ for transplantation or therapy, other than an ana tomical gift under subsection (1)(b) of this section, passes to the organ procurement organ ization as custodian of the organ.

(9) If an anatomical gift does not pass pursuant to subsections (1) to (8) of this section
or the decedent's body or body part is not used for transplantation, therapy, research or
education, custody of the body or body part passes to the person under obligation to dispose
of the body or body part.

(10) A person may not accept an anatomical gift if the person knows that the gift was not effectively made under section 4 or 9 of this 2007 Act or if the person knows that the decedent made a refusal under section 6 of this 2007 Act that was not revoked. For purposes of this subsection, if a person knows that an anatomical gift was made on a document of gift, the person is deemed to know of any amendment or revocation of the gift or any refusal to make an anatomical gift on the same document of gift.

(11) Except as otherwise provided in subsection (1)(b) of this section, sections 1 to 22 of
this 2007 Act do not affect the allocation of organs for transplantation or therapy.

43 <u>SECTION 11.</u> (1) The following persons shall make a reasonable search of an individual 44 who the persons reasonably believe is dead or near death for a document of gift or other 45 information identifying the individual as a donor or as an individual who made a refusal:

1 (a) A law enforcement officer, firefighter, paramedic or other emergency rescuer finding 2 the individual; and

3 (b) If no other source of the information is immediately available, a hospital, as soon as
4 practicable after the individual's arrival at the hospital.

5 (2) If a document of gift or a refusal to make an anatomical gift is located by the search 6 required by subsection (1)(a) of this section and the individual or deceased individual to whom 7 it relates is taken to a hospital, the person responsible for conducting the search shall send 8 the document of gift or the refusal to the hospital.

9 (3) A person is not subject to criminal or civil liability for failing to discharge the duties
 10 imposed by this section but may be subject to administrative sanctions.

11 <u>SECTION 12.</u> (1) A document of gift need not be delivered during the donor's lifetime to
 12 be effective.

(2) Upon or after an individual's death, a person in possession of a document of gift or
a refusal to make an anatomical gift with respect to the individual shall allow examination
and copying of the document of gift or the refusal by a person authorized to make or object
to the making of an anatomical gift with respect to the individual or by a person to whom
the gift could pass under section 10 of this 2007 Act.

<u>SECTION 13.</u> (1) When a hospital refers an individual at or near death to a procurement organization, the organization shall make a reasonable search of the records of the Department of Transportation and any donor registry that it knows exists for the geographical area in which the individual resides to ascertain whether the individual has made an anatomical gift.

(2) A procurement organization must be allowed reasonable access to information in the
 records of the Department of Transportation to ascertain whether an individual at or near
 death is a donor.

(3) When a hospital refers an individual at or near death to a procurement organization,
the organization may conduct any reasonable examination necessary to ensure the medical
suitability of a body part that is or could be the subject of an anatomical gift for transplantation, therapy, research or education from a donor or a prospective donor. During the examination period, measures necessary to ensure the medical suitability of the body part may
not be withdrawn unless the hospital or procurement organization knows that the individual
expressed a contrary intent.

(4) Unless otherwise prohibited by law, at any time after a donor's death, the person to
 whom a body part passes under section 10 of this 2007 Act may conduct any reasonable ex amination necessary to ensure the medical suitability of the body or body part for its in tended purpose.

(5) Unless otherwise prohibited by law, an examination under subsection (3) or (4) of this
 section may include an examination of all medical and dental records of the donor or pro spective donor.

(6) Upon the death of a minor who was a donor or had signed a refusal, unless a procurement organization knows the minor is emancipated, the procurement organization shall
conduct a reasonable search for the parents of the minor and provide the parents with an
opportunity to revoke or amend the anatomical gift or revoke the refusal.

44 (7) Upon referral by a hospital under subsection (1) of this section, a procurement or-45 ganization shall make a reasonable search for any person listed in section 8 of this 2007 Act

having priority to make an anatomical gift on behalf of a prospective donor. If a procurement
 organization receives information that an anatomical gift to any other person was made,
 amended or revoked, it shall promptly advise the other person of all relevant information.

(8) Subject to sections 10 (9) and 20 of this 2007 Act, the rights of the person to whom a 4 body part passes under section 10 of this 2007 Act are superior to the rights of all others 5 with respect to the body part. The person may accept or reject an anatomical gift in whole 6 or in part. Subject to the terms of the document of gift and sections 1 to 22 of this 2007 Act, 7 a person who accepts an anatomical gift of an entire body may allow embalming, burial or 8 9 cremation and use of remains in a funeral service. If the gift is of a body part, the person to whom the body part passes under section 10 of this 2007 Act, upon the death of the donor 10 and before embalming, burial or cremation, shall cause the body part to be removed without 11 12unnecessary mutilation.

(9) Neither the physician who attends the decedent at death nor the physician who de termines the time of the decedent's death may participate in the procedures for removing
 or transplanting a body part from the decedent.

(10) A physician or technician may remove from the body of a donor a donated body part
 that the physician or technician is qualified to remove.

18 <u>SECTION 14.</u> Each hospital in this state shall enter into agreements or affiliations with 19 procurement organizations for coordination of procurement and use of anatomical gifts.

20 <u>SECTION 15.</u> (1) A person who acts in accordance with sections 1 to 22 of this 2007 Act 21 or with the applicable anatomical gift law of another state, or attempts in good faith to do 22 so, is not liable for the act in a civil action, criminal prosecution or administrative proceed-23 ing.

(2) Neither the person making an anatomical gift nor the donor's estate is liable for any
 injury or damage that results from the making or use of the gift.

(3) In determining whether an anatomical gift has been made, amended or revoked under
sections 1 to 22 of this 2007 Act, a person may rely upon representations of an individual
listed in section 8 (1)(b), (c), (d), (e), (f), (g) or (h) of this 2007 Act relating to the individual's
relationship to the donor or prospective donor unless the person knows that the representation is untrue.

31 SECTION 16. (1) A document of gift is valid if executed in accordance with:

32 (a) Sections 1 to 22 of this 2007 Act;

33 (b) The laws of the state or country where it was executed; or

(c) The laws of the state or country where the person making the anatomical gift was
 domiciled, had a place of residence or was a national at the time the document of gift was
 executed.

(2) If a document of gift is valid under this section, the law of this state governs the in terpretation of the document of gift.

(3) A person may presume that a document of gift or amendment of an anatomical gift
 is valid unless that person knows that it was not validly executed or was revoked.

41 <u>SECTION 17.</u> (1) The Department of Human Services may establish or contract for the 42 establishment of a donor registry.

(2) The Department of Transportation shall cooperate with a person who administers any
 donor registry that this state establishes, contracts for or recognizes for the purpose of
 transferring to the donor registry all relevant information regarding a donor's making,

1 amending or revoking an anatomical gift.

2 (3) A donor registry must:

(a) Allow a donor or other person authorized under section 3 of this 2007 Act to include
on the donor registry a statement or symbol that the donor has made, amended or revoked
an anatomical gift;

6 (b) Be accessible to a procurement organization to allow the procurement organization 7 to obtain relevant information on the donor registry to determine, at or near death of the 8 donor or a prospective donor, whether the donor or prospective donor has made, amended 9 or revoked an anatomical gift; and

10

(c) Be accessible for purposes of this subsection seven days a week on a 24-hour basis.

(4) Personally identifiable information on a donor registry about a donor or prospective donor may not be used or disclosed without the express consent of the donor, prospective donor or person who made the anatomical gift for any purpose other than to determine, at or near death of the donor or prospective donor, whether the donor or prospective donor has made, amended or revoked an anatomical gift.

(5) This section does not prohibit any person from creating or maintaining a donor reg istry that is not established by or under contract with the state. Any such registry must
 comply with subsections (3) and (4) of this section.

19 **SECTION 18.** (1) As used in this section:

20 (a) "Advance directive" has the meaning given that term in ORS 127.505.

(b) "Declaration" means a record signed by a prospective donor specifying the circumstances under which a life support system may be withheld or withdrawn from the prospective donor.

(2) If a prospective donor has a declaration or advance directive, measures necessary to
 ensure the medical suitability of an organ for transplantation or therapy may not be withheld
 or withdrawn from the prospective donor, unless the declaration or advance directive ex pressly provides to the contrary.

28 <u>SECTION 19.</u> (1) A medical examiner shall cooperate with procurement organizations to 29 maximize the opportunity to recover anatomical gifts for the purpose of transplantation, 30 therapy, research or education.

(2) If a medical examiner receives notice from a procurement organization that an anatomical gift might be available or was made with respect to a decedent whose body is under the jurisdiction of the medical examiner and a post-mortem examination is going to be performed, unless the medical examiner denies recovery in accordance with section 20 of this 2007 Act, the medical examiner or designee shall conduct a post-mortem examination of the body or the body part in a manner and within a period compatible with its preservation for the purposes of the gift.

(5) If an anatomical gift of a body part from the decedent under the jurisdiction of the medical examiner has been or might be made, but the medical examiner initially believes that the recovery of the body part could interfere with the post-mortem investigation into the decedent's cause or manner of death, the medical examiner shall consult with the procurement organization, or physician or technician designated by the procurement organization, about the proposed recovery. After consultation, the medical examiner may allow the recovery.

16 (C) That the disseminator will have a method of ensuring that the disseminator can delay for a 17 period of up to two days the giving of personal information to a requester who is not a subscriber.

(14) The department shall disclose personal information to representatives of the news media for
the gathering or dissemination of information related to the operation of a motor vehicle or to public
safety.

(15) The department shall disclose personal information as provided in ORS 802.220 (5).

(16) The department shall adopt rules providing for the release of personal information from motor vehicle records to a person who has a financial interest in the vehicle. Rules adopted under this subsection may include, but need not be limited to, rules establishing procedures for the department to verify the financial interest of the person making the request for personal information.

(17) The department shall adopt rules providing for the release of personal information from
 motor vehicle records to a person who is injured by the unsafe operation of a vehicle or who owns
 property that is damaged because of the unsafe operation of a vehicle.

(18) The department shall disclose personal information to a private investigator licensed by any licensing authority within the State of Oregon, to be used for any purpose permitted any person under this section. A licensed private investigator requesting information must prove to the department that the person has a corporate surety bond, an irrevocable letter of credit issued by an insured institution as defined in ORS 706.008 or such other security as the Department of Public Safety Standards and Training may prescribe by rule in the minimum amount of \$5,000 or errors and omissions insurance in the minimum amount of \$5,000.

(19) The department shall disclose personal information to a procurement organization as de fined in [ORS 97.950] section 2 of this 2007 Act for the purpose of facilitating the making of ana tomical gifts under the provisions of [97.952] section 3 of this 2007 Act.

A person named executor who carries out [*the*] **an anatomical** gift of the testator made 41 under the provisions of [*ORS 97.950 to 97.964*] **section 4 of this 2007 Act** before issuance of letters 42 testamentary or under a will which is not admitted to probate shall not be liable to the surviving 43 spouse or next of kin for performing acts necessary to carry out the gift of the testator.

(1) Sections 1 to 23 of this 2007 Act and the amendments to statutes by sections 24 to 30 of this 2007 Act apply to documents of gifts and amendments to, revocations of and refusals of documents of gifts made on or after the effective date of this 2007 Act. (2) Sections 1 to 23 of this 2007 Act and the amendments to statutes by sections 24 to 30 of this 2007 Act do not apply to or affect any action or document relating to an anatomical gift made before the effective date of this 2007 Act.
