SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Creates subtraction from federal taxable income for income from TRICARE paid to health care provider in first two years of provider's participation in TRICARE system.

Allows employee of Oregon Military Department to subtract from federal taxable income specified amount for performing duties for Oregon National Guard Youth Challenge Program.

Creates personal income tax credit for physicians who provide medical care to residents of Oregon Veterans' Home. Requires physician claiming credit to submit letter with tax return confirming physician missed no more than five percent of scheduled visits with residents.

Establishes one-time tax credit for health care provider participating in TRICARE system. Directs Office of Rural Health to establish criteria to certify eligibility for tax credit.

Increases amount that certain taxpayers may subtract from federal taxable income for contributions to college savings network.

Increases annual cap on amount of business energy tax credit that may be claimed for certified facilities using renewable energy resources or renewable energy resource equipment manufacturing facilities. Eliminates required reduction in value of credit when taxpayer also claims federal income tax credit for same facility.

Expands business energy tax credit to include credit for homebuilder-installed renewable energy systems, high-performance homes, renewable energy resource equipment manufacturing facilities and energy facilities that manufacture or distribute alternative fuels. Modifies period over which credit may be claimed if facility upon which credit is based uses or produces renewable energy resources. Defines terms and authorizes State Department of Energy to adopt performance, efficiency and other criteria for certain types of facilities that qualify for credit.

Expands residential alternative energy device tax credit to permit increased capacity wind electric systems and fuel cell systems to qualify for credit. Allows credit for each alternative energy device. Makes conforming changes.

Creates income tax credit for certain costs of repowering or retrofitting diesel engines in service. Extends existing tax credit for purchasing new diesel engines meeting clean diesel emissions standards to permit purchase of new diesel engines before 2012 to qualify for credit.

Increases maximum tax credits for certified film production development contributions to Oregon Production Investment Fund.

Adds loans made to finance construction, development or acquisition of manufactured dwelling parks to loans eligible for affordable housing tax credit. Adds loans made to finance acquisition of affordable housing to loans eligible for affordable housing tax credit. Increases monetary cap on allowable tax credit certifications.

Modifies threshold amounts of federal adjusted gross income for purposes of calculating allowed personal exemption credit.

Excludes natural resource property and property used in commercial fishing operations from value of gross estate of decedent for Oregon inheritance tax purposes. Limits amount of exclusion. Directs Department of Revenue, for each calendar year beginning on or after January 1, 2009, to recompute maximum excluded value.

Exempts qualified egg processing machinery and equipment from property tax for specified period of time.

Permits Economic and Community Development Department to approve second or subsequent applications for annual certification for property tax exemptions when business retains reasonably similar characteristics to prior certification years.

Allows tax credit to individual who owns and occupies manufactured dwelling as primary residence and ends tenancy as result of manufactured dwelling park or portion of park closing.

NOTE: Matter in **boldfaced** type in an amended section is new; matter *[italic and bracketed]* is existing law to be omitted. New sections are in **boldfaced** type.

Takes effect on 91st day following adjournment sine die.

A BILL FOR AN ACT

Relating to taxation; creating new provisions; amending ORS 90.635, 285C.506, 315.354, 315.356, 315.514, 316.085, 316.116, 316.502, 316.680, 316.699, 317.097, 348.841, 469.160, 469.165, 469.170, 469.172, 469.176, 469.180, 469.185, 469.200, 469.205, 469.206 and 469.215 and section 2, chapter 649, Oregon Laws 1975, section 2, chapter 422, Oregon Laws 1979, sections 28, 29, 31 and 32, chapter 618, Oregon Laws 2003, section 3, chapter 595, Oregon Laws 2005, and section 5a, chapter 832, Oregon Laws 2005; repealing ORS 316.153; and prescribing an effective date.

Be It Enacted by the People of the State of Oregon:

SECTION 1. ORS 316.680 is amended to read:

316.680. (1) There shall be subtracted from federal taxable income:

(a) The interest or dividends on obligations of the United States and its territories and possessions or of any authority, commission or instrumentality of the United States to the extent includable in gross income for federal income tax purposes but exempt from state income taxes under the laws of the United States. However, the amount subtracted under this paragraph shall be reduced by any interest on indebtedness incurred to carry the obligations or securities described in this paragraph, and by any expenses incurred in the production of interest or dividend income described in this paragraph to the extent that such expenses, including amortizable bond premiums, are deductible in determining federal taxable income.

(b) The amount of any federal income taxes accrued by the taxpayer during the taxable year as described in ORS 316.685, less the amount of any refunds of federal taxes previously accrued for which a tax benefit was received.

(c)(A) If the taxpayer does not qualify for the subtraction under subparagraph (B) of this paragraph, compensation (other than pension or retirement pay) received for active service performed by a member of the Armed Forces of the United States in an amount not to exceed [~~\$3,000~~] **\$6,000** per annum.

(B) For the tax year of initial draft or enlistment into the Armed Forces of the United States or for the tax year of discharge from or termination of full-time active duty for the Armed Forces of the United States, compensation (other than pension or retirement pay or pay for service when on military reserve duty) paid by the Armed Forces of the United States for services performed outside this state, if the taxpayer is on active duty as a full-time officer, enlistee or draftee, with the Armed Forces of the United States.

(d) Amounts allowable under sections 2621(a)(2) and 2622(b) of the Internal Revenue Code to the extent that the taxpayer does not elect under section 642(g) of the Internal Revenue Code to reduce federal taxable income by those amounts.

(e) Any supplemental payments made to JOBS Plus Program participants under ORS 411.892.

(f)(A) Federal pension income that is attributable to federal employment occurring before October 1, 1991. Federal pension income that is attributable to federal employment occurring before October 1, 1991, shall be determined by multiplying the total amount of federal pension income for the tax year by the ratio of the number of months of federal creditable service occurring before October 1, 1991, over the total number of months of federal creditable service.

(B) The subtraction allowed under this paragraph applies only to federal pension income received at a time when:

(i) Benefit increases provided under chapter 569, Oregon Laws 1995, are in effect; or

(ii) Public Employees Retirement System benefits received for service prior to October 1, 1991,

1 Internal Revenue Code as if the obligations, although issued by a foreign state or a political subdivi-
2 sion of a foreign state, were not tax exempt under the Internal Revenue Code.

3 **SECTION 3.** (1) A resident or nonresident individual physician licensed under ORS chap-
4 ter 677 who is engaged in the practice of medicine qualifies for an annual credit against the
5 taxes that are otherwise due under ORS chapter 316 if the physician provides medical care
6 to residents of an Oregon Veterans' Home.

7 (2) The amount of the credit allowed under this section shall be equal to the lesser of:

8 (a) \$1,000 for every eight residents to whom the physician provides care at an Oregon
9 Veterans' Home; or

10 (b) \$5,000.

11 (3) The credit allowed under this section may not exceed the tax liability of the taxpayer
12 for the tax year, and a credit allowed under this section that is unused may not be carried
13 forward to a succeeding tax year.

14 (4) A nonresident shall be allowed the credit described in this section in the proportion
15 provided in ORS 316.117. If a change in the status of a taxpayer from resident to nonresident
16 or from nonresident to resident occurs, the credit allowed by this section shall be determined
17 in a manner consistent with ORS 316.117.

18 (5) In order to qualify for the tax credit allowed under this section, the physician claim-
19 ing the credit must submit with the physician's tax return a letter from the Oregon Veter-
20 ans' Home at which the physician provided care to residents, confirming that the physician
21 missed no more than five percent of the physician's scheduled visits with residents of the
22 home during the tax year.

23 (6) In the case of a shareholder of a corporation or a member of a partnership, only the
24 care provided by the individual shareholder or partner shall be considered, and the full
25 amount of the credit shall be allowed to each shareholder or partner who qualifies in an in-
26 dividual capacity.

27 (7) The Director of Veterans' Affairs shall assist the Department of Revenue in deter-
28 mining if a taxpayer claiming a credit under this section qualifies for the credit.

29 **SECTION 4.** Sections 3 and 5 of this 2007 Act are added to and made a part of ORS

31 **SECTION 5.** (1) A health care provider who enters into a contract for the first time on
32 or after January 1, 2007, to provide health care services permitted under a TRICARE con-
33 tract to patients enrolled in the TRICARE military health care system shall be allowed a
34 one-time credit against taxes otherwise due under ORS chapter 316 in the amount of \$2,500.

35 (2) A health care provider who has a contract to provide health care services permitted
36 under a TRICARE contract to patients enrolled in the TRICARE military health care system
37 shall be allowed a credit each tax year against taxes otherwise due under ORS chapter 316
38 in the amount of \$1,000 if the health care provider actively participates in the TRICARE
39 military health care system and each tax year provides health care services to at least 10
40 patients enrolled in the TRICARE military health care system. A health care provider who
41 serves patients in a rural community, as defined by the Office of Rural Health, may provide
42 health care services to fewer than 10 patients in a tax year and qualify for the credit.

43 (3) A health care provider may not receive a credit under subsections (1) and (2) of this
44 section in the same tax year.

45 (4) A nonresident shall be allowed a credit under this section in the proportion provided

1 in ORS 316.117. If a change in the status of a taxpayer from resident to nonresident or from
2 nonresident to resident occurs, the credit allowed by this section shall be determined in a
3 manner consistent with ORS 316.117.

4 **SECTION 6.** (1) The Office of Rural Health shall establish criteria for certifying health
5 care providers as eligible for a tax credit authorized by section 5 of this 2007 Act or a de-
6 duction from federal taxable income under ORS 316.680. Upon finding that a health care
7 provider meets the eligibility criteria established by the office, the office shall certify the
8 provider for a tax credit under section 5 of this 2007 Act or the tax deduction under ORS
9 316.680. The office may not issue more than 500 certifications under this section in any cal-
10 endar year and may not certify more than 1,000 providers before December 31, 2009.

11 (2) Prior to October 1 of each year, the office shall report to the legislative interim
12 committees on revenue regarding the number of health care providers who qualify for the
13 tax credit under section 5 (2) of this 2007 Act.

14 (3) Prior to December 31 of each year, the administrator of the TRICARE contracts with
15 health care providers who provide health care services to patients in Oregon shall make a
16 report to the office regarding the number of patients that each health care provider has
17 contracted to provide health care services.

22 **SECTION 9.** Section 3 of this 2007 Act and the amendments to ORS 316.680 by section 2
23 of this 2007 Act apply to tax years beginning on or after January 1, 2008, and before January
24 1, 2012.

25 **SECTION 10.** The amendments to ORS 316.680 by section 2a of this 2007 Act apply to tax
26 years beginning on or after January 1, 2012.

27 **SECTION 11.** ORS 316.699 is amended to read:

28 316.699. (1) There shall be subtracted from federal taxable income the amount contributed to a
29 college savings network account established under ORS 348.841 to 348.873.

30 (2) Notwithstanding subsection (1) of this section, a subtraction under this section may not ex-
31 ceed the lesser of:

32 *[(a) \$2,000 for the tax year or, in the case of a married individual filing separately, \$1,000 for the*
33 *tax year; and]*

34 **(a) \$4,000 for the tax year if the taxpayer files a joint return, or \$2,000 for the tax year**
35 **if the taxpayer files a return other than a joint return; and**

36 (b) If an amount is carried forward to a succeeding tax year under subsection (3) of this section,

4 [(3)] (4) Any amounts contributed to a college savings network account that are not subtracted
5 from federal taxable income because of the monetary limitations imposed by subsection (2) of this
6 section may be carried forward for four succeeding tax years and subtracted from federal taxable
7 income in any of those succeeding tax years in an amount that does not exceed the monetary limi-
8 tations imposed by subsection (2) of this section.

9 [(4)] (5) The amount contributed to a college savings network account may be subtracted from
10 a preceding tax year if the contribution is made before the taxpayer files a return or before the 15th
11 day of the fourth month following the closing of the taxpayer’s tax year, whichever is earlier.

32 (9) “Network” means the Oregon 529 College Savings Network established under ORS 348.841
33 to 348.873.

34 (10) “Nonqualified withdrawal” means a withdrawal from an account that is not a qualified
35 withdrawal.

36 (11) “Qualified higher education expenses” means tuition and other permitted expenses as set
37 forth in section 529(e) of the Internal Revenue Code for the enrollment or attendance of a designated
38 beneficiary at a higher education institution.

39 (12) “Qualified withdrawal” means a withdrawal made as prescribed under ORS 348.870 and
40 made:

41 (a) From an account to pay the qualified higher education expenses of the designated benefi-
42 cary;

43 (b) As the result of the death or disability of the designated beneficiary;

44 (c) As the result of a scholarship, allowance or payment described in section 135(d)(1)(A), (B)
45 or (C) of the Internal Revenue Code that is received by the designated beneficiary, but only to the

2 (d) As a rollover or change in the designated beneficiary described in ORS 348.867.

4 [(4)(a)] **(5)(a)** Upon any sale, termination of the lease or contract, exchange or other disposition
5 of the facility, notice thereof shall be given to the Director of the State Department of Energy who
6 shall revoke the certificate covering the facility as of the date of such disposition. The new owner,
7 or upon re-leasing of the facility, the new lessor, may apply for a new certificate under ORS 469.215,
8 but the tax credit available to the new owner shall be limited to the amount of credit not claimed
9 by the former owner or, for a new lessor, the amount of credit not claimed by the lessor under all
10 previous leases.

40 (C) Generate electricity to replace an existing source of electricity or to provide a new source
41 of electricity for sale by or use in the trade or business; [*or*]

42 (D) Perform a process that obtains energy resources from material that would otherwise be solid
43 waste as defined in ORS 459.005; **or**

44 **(E) Manufacture or distribute alternative fuels, including but not limited to electricity,**
45 **ethanol, methanol, gasohol or biodiesel.**

1 (b) Any acquisition of, addition to, reconstruction of or improvement of land or an existing
2 structure, building, installation, excavation, machinery, equipment or device necessarily acquired,
3 erected, constructed or installed by any person in connection with the conduct of a trade or business
4 in order to substantially reduce the consumption of purchased energy.

5 (c) A necessary feature of a new commercial building or multiple unit dwelling, as dwelling is
6 defined by ORS 469.160, that causes that building or dwelling to exceed an energy performance
7 standard in the state building code.

8 (d) The replacement of an electric motor with another electric motor that substantially reduces
9 the consumption of electricity.

10 (6) "Facility" means an energy facility, recycling facility, transportation facility, car sharing
11 facility, sustainable building practices facility, alternative fuel vehicle or facilities necessary to op-
12 erate alternative fuel vehicles, including but not limited to an alternative fuel vehicle refueling
13 station, **a high-efficiency combined heat and power facility, a high-performance home, a**
14 **homebuilder-installed renewable energy system, or a renewable energy resource equipment**
15 **manufacturing facility.**

16 (7) "**High-efficiency combined heat and power facility**" means a device or equipment that
17 **simultaneously produces heat and electricity from a single source of fuel and that meets the**
18 **criteria established for a high-efficiency combined heat and power facility under section 22**
19 **of this 2007 Act.**

20 (8) "**High-performance home**" means a new single-family dwelling that:

21 (a) **Is designed and constructed to reduce net purchased energy through use of both en-**
22 **ergy efficiency and on-site renewable energy resources; and**

23 (b) **Meets the criteria established for a high-performance home under section 22 of this**
24 **2007 Act.**

25 (9) "**Homebuilder-installed renewable energy system**" means a renewable energy resource
26 **system that:**

27 (a) **Meets the criteria established for a renewable energy resource system under section**
28 **22 of this 2007 Act; and**

29 (b) **Is installed in a new single-family dwelling by, or at the direction of, the homebuilder**
30 **constructing the dwelling.**

31 [(7)] (10) "Qualified transit pass contract" means a purchase agreement entered into between a
32 transportation provider and a person, the terms of which obligate the person to purchase transit
33 passes on behalf or for the benefit of employees, students, patients or other individuals over a
34 specified period of time.

35 [(8)] (11) "Recycling facility" means equipment used by a trade or business solely for recycling:

36 (a) Including:

37 (A) Equipment used solely for hauling and refining used oil;

38 (B) New vehicles or modifications to existing vehicles used solely to transport used recyclable
39 materials that cannot be used further in their present form or location such as glass, metal, paper,
40 aluminum, rubber and plastic;

41 (C) Trailers, racks or bins that are used for hauling used recyclable materials and are added to
42 or attached to existing waste collection vehicles; and

43 (D) Any equipment used solely for processing recyclable materials such as bailers, flatteners,
44 crushers, separators and scales.

2 [(9)(a)] (12)(a) “Renewable energy resource” includes, but is not limited to[,]:

3 (A) Straw, forest slash, wood waste or other wastes from farm or forest land, [*industrial waste*]
4 **nonpetroleum plant or animal based biomass**, solar energy, wind power, water power or
5 geothermal energy; or

6 (B) **A hydroelectric generating facility that obtains all applicable permits and complies
7 with all state and federal statutory requirements for the protection of fish and wildlife and:**

8 (i) **That does not exceed 10 megawatts of installed capacity; or**

9 (ii) **Qualifies as a research, development or demonstration facility.**

10 (b) “Renewable energy resource” does not include a hydroelectric generating facility [*larger
11 than one megawatt of installed capacity unless the facility qualifies as a research, development or
12 demonstration facility*] **that is not described in paragraph (a) of this subsection.**

13 (13) **“Renewable energy resource equipment manufacturing facility” means any struc-
14 ture, building, installation, excavation, machinery, equipment or device, or an addition, re-
15 construction or improvement to land or an existing structure, building, installation,
16 excavation, machinery, equipment or device, that is necessarily acquired, constructed or in-
17 stalled by a person in connection with the conduct of a trade or business, that is used pri-
18 marily to manufacture equipment, machinery or other products designed to use a renewable

20 [(10)] (14) “Sustainable building practices facility” means a commercial building in which build-
21 ing practices that reduce the amount of energy, water or other resources needed for construction

24 practice baselines in energy, water or other resource usage for comparative purposes for use in
25 determining whether a facility is a sustainable building practices facility.

26 [(11)] (15) “Transportation facility” means a transportation project that reduces energy use
27 during commuting to and from work or school, during work-related travel, or during travel to obtain
28 medical or other services, and may be further defined by the department by rule. “Transportation
29 facility” includes, but is not limited to, a qualified transit pass contract or a transportation services
30 contract.

31 [(12)] (16) “Transportation provider” means a public, private or nonprofit entity that provides
32 transportation services to members of the public.

33 [(13)] (17) “Transportation services contract” means a contract that is related to a transporta-
34 tion facility, and may be further defined by the department by rule.

45 the status of a facility as a research, development or demonstration facility of new renewable re-

1 source generating and conservation technologies or a qualified transit pass contract in the deter-
2 mination.

3 **SECTION 18.** ORS 469.205 is amended to read:

4 469.205. (1) Prior to erection, construction, installation or acquisition of a proposed facility, any
5 person may apply to the State Department of Energy for preliminary certification under ORS 469.210
6 if:

7 (a) The erection, construction, installation or acquisition of the facility is to be commenced on
8 or after October 3, 1979;

9 (b) The facility complies with the standards or rules adopted by the Director of the State De-
10 partment of Energy; and

11 (c) The applicant meets one of the following criteria:

12 (A) The applicant is a person to whom a tax credit has been transferred; or

13 (B) The applicant will be the owner or contract purchaser of the facility at the time of erection,

21 (a) A statement that the applicant or the lessee of the applicant's facility:

22 (A) Intends to convert from a purchased energy source to a renewable energy resource;

23 (B) Plans to acquire, construct or install a facility that will use a renewable energy resource
24 or solid waste instead of electricity, petroleum or natural gas;

25 (C) Plans to use a renewable energy resource in the generation of electricity for sale or to re-
26 place an existing or proposed use of an existing source of electricity;

27 (D) Plans to acquire, construct or install a facility that substantially reduces the consumption
28 of purchased energy;

29 (E) Plans to acquire, construct or install equipment for recycling as defined in ORS 469.185
30 [(8)] (11);

31 (F) Plans to acquire an alternative fuel vehicle or to convert an existing vehicle to an alterna-
32 tive fuel vehicle;

33 (G) Plans to acquire, construct or install a facility necessary to operate alternative fuel vehicles;

34 (H) Plans to acquire transit passes for use by individuals specified by the applicant;

35 (I) Plans to acquire, construct or install a transportation facility;

36 (J) Plans to acquire a sustainable building practices facility; [or]

37 (K) Plans to acquire a car sharing facility and operate a car sharing program;

38 **(L) Plans to construct a high-efficiency combined heat and power facility;**

39 **(M) Is a homebuilder and plans to construct a homebuilder-installed renewable energy**
40 **system;**

41 **(N) Is a homebuilder and plans to construct a high-performance home; or**

42 **(O) Plans to acquire, construct or install a renewable energy resource equipment manu-**
43 **facturing facility.**

44 (b) A detailed description of the proposed facility and its operation and information showing that
45 the facility will operate as represented in the application.

1 (c) Information on the amount by which consumption of electricity, petroleum or natural gas by
2 the applicant or the lessee of the applicant's facility will be reduced, and on the amount of energy
3 that will be produced for sale, as the result of using the facility or, if applicable, information about
4 the expected level of sustainable building practices facility performance.

5 (d) The projected cost of the facility.

6 (e) If applicable, a copy of the proposed qualified transit pass contract, transportation services
7 contract or contract for lease of parking spaces for a car sharing facility.

8 (f) Any other information the director considers necessary to determine whether the proposed
9 facility is in accordance with the provisions of ORS 469.185 to 469.225, and any applicable rules or
10 standards adopted by the director.

11 (3) An application for preliminary certification shall be accompanied by a fee established under
12 ORS 469.217. The director may refund the fee if the application for certification is rejected.

39 (4) **For a renewable energy resource equipment manufacturing facility, standards relating**
40 **to the type of equipment, machinery or other products being manufactured and related per-**
41 **formance and efficiency standards applicable to the manufactured products.**

42 **SECTION 23. Section 24 of this 2007 Act is added to and made a part of ORS chapter 315.**

43 **SECTION 24. A taxpayer may not be allowed a credit under ORS 315.354 if the first tax**

11 [(1) "Alternative energy device" means:]

12 [(a) Any system, mechanism or series of mechanisms, including photovoltaic systems, that uses so-
13 lar radiation or wind for space heating, cooling or electrical energy for one or more dwellings;]

14 [(b) Any system that uses solar radiation for:]

15 [(A) Domestic water heating; or]

16 [(B) Swimming pool, spa or hot tub heating and that meets the requirements set forth in ORS

18 [(c) A ground water heat pump and ground loop system;]

19 [(d) A wind powered turbine that generates electricity;]

23 [(g) A generator powered by alternative fuels and used to produce electricity;]

27 **(1) "Alternative energy device" means a category one alternative energy device or a**

32 (c) A fueling station necessary to operate an alternative fuel vehicle.

33 (3) "Alternative fuel vehicle" means a motor vehicle as defined in ORS 801.360 that is:

12 (5) **“Category two alternative energy device” means a fuel cell system, solar electric**
13 **system or wind electric system.**

14 [(4)] (6) **“Coefficient of performance” means the ratio calculated by dividing the usable output**
15 **energy by the electrical input energy. Both energy values must be expressed in equivalent units.**

16 [(5)] (7) **“Contractor” means a person whose trade or business consists of offering for sale an**
17 **alternative energy device, construction service, installation service or design service.**

18 [(6)(a)] (8)(a) **“Cost” means the actual cost of the acquisition, construction and installation of**
19 **the alternative energy device [or solar electric system] paid by the taxpayer for the alternative en-**
20 **ergy device [or solar electric system].**

21 (b) For an alternative fuel vehicle, “cost” means the difference between the cost of the alter-
22 native fuel vehicle and the same vehicle or functionally similar vehicle manufactured to use con-

7 alternative fuel vehicle ready and available for use.

8 (B) In the case of modification, the date that the modification is completed and the vehicle is
9 ready and available for use as an alternative fuel vehicle.

10 (c) For a fueling station necessary to operate an alternative fuel vehicle, the date that the fu-
11 eling station is first operational.

12 (d) For related equipment, the date that the equipment is first operational.

13 [(13)] (16) "Related equipment" means equipment necessary to convert a vehicle to use an al-
14 ternative fuel.

15 [(14)] (17) "Solar electric system" means any system, mechanism or series of mechanisms, in-
16 cluding photovoltaic systems, that uses solar radiation to generate electrical energy for a dwelling.

17 (18) "Wind electric system" means any system, mechanism or series of mechanisms that
18 uses wind to generate electrical energy for a dwelling.

20 316.116. (1)(a) A resident individual shall be allowed a credit against the taxes otherwise due

2 (c) For *[an]* **each category one** alternative energy device used for swimming pool, spa or hot
3 tub heating, the credit allowed under this section shall be based upon 50 percent of the cost of the
4 device or the first year's energy yield in kilowatt hours per year multiplied by 15 cents, whichever
5 is lower, up to:

6 (A) \$1,500 for tax years beginning on or after January 1, 1990, and before January 1, 1996.

7 (B) \$1,200 for tax years beginning on or after January 1, 1996, and before January 1, 1998.

8 (C) \$1,500 for tax years beginning on or after January 1, 1998.

9 (d) For *[an]* **each** alternative fuel device, the credit allowed under this section is 25 percent of

20 *[credit]* **credits** allowed in any one tax year may not exceed the tax liability of the taxpayer or

9 tax purposes [shall] **may** not exceed the cost to the taxpayer for the acquisition, construction and
10 installation of the alternative energy device [or solar electric system].

37 compared with the baseline emissions for the relevant engine year and application; **and**

38 (b) A list of technologies approved as qualifying repowers or retrofits that have been verified
39 by the United States Environmental Protection Agency or the California Air Resources Board[;
40 *and*].

41 [*(c) A requirement that a qualifying repower or retrofit does not include the repower or retrofit of*
42 *a vehicle or engine for which a tax credit under section 47 of this 2007 Act has been allowed, unless*
43 *the repower or retrofit will reduce emissions further than the repower or retrofit funded by the tax*
44 *credit.*]

45 **SECTION 46.** The amendments to section 44 of this 2007 Act by section 45 of this 2007

1 Act become operative on January 2, 2018.

2 **SECTION 47. (1) A personal income or corporate income or excise taxpayer is allowed a**
3 **credit against the taxes that are otherwise due under ORS chapter 316, 317 or 318 for the**
4 **certified costs of a repower of a nonroad Oregon diesel engine or retrofit of an Oregon diesel**
5 **engine that occurs after the effective date of this 2007 Act if:**

6 (a) The repower or retrofit has been identified as qualifying for the credit under rules
7 adopted by the Environmental Quality Commission under section 44 of this 2007 Act;

8 (b) The engine will constitute an Oregon diesel engine; and

9 (c) The taxpayer has obtained a tax credit cost certification from the Department of
10 Environmental Quality under section 51 of this 2007 Act for the cost of the repower or
11 retrofit.

12 (2) The maximum amount of the tax credit allowed under this section is limited to:

13 (a) 25 percent of the certified cost of each qualifying repower; and

14 (b) 50 percent of the certified cost of each qualifying retrofit.

15 (3) The amount of the tax credit allowed to the taxpayer under this section in any one
16 tax year may not exceed the tax liability of the taxpayer for the tax year.

17 (4) Any tax credit that is allowed under this section, but limited by subsection (3) of this
18 section, and that is not used by the taxpayer in a particular tax year may be carried forward
19 and offset against the taxpayer's tax liability as prescribed in subsection (3) of this section
20 for the next succeeding tax year. Any credit remaining unused in the next succeeding tax
21 year may be carried forward and offset against the taxpayer's tax liability as prescribed in
22 subsection (3) of this section for the second succeeding tax year. Any credit remaining un-
23 used in the second succeeding tax year may be carried forward and offset against the tax-
24 payer's tax liability as prescribed in subsection (3) of this section for the third succeeding
25 tax year, but may not be carried forward for any tax year thereafter.

26 (5) The credit allowed under this section is not in lieu of any depreciation or amortization
27 deduction for the engine to which the taxpayer otherwise may be entitled for purposes of
28 ORS chapter 316, 317 or 318. The taxpayer's adjusted basis for determining gain or loss may
29 not be decreased by any tax credits allowed under this section.

30 (6)(a) The Department of Revenue may disallow the credit allowed under this section if
31 the department finds that the credit was obtained by fraud or misrepresentation, or if the
32 department learns that the engine that was the subject of the qualifying repower or retrofit
33 was destroyed by arson committed by the taxpayer, or if the engine no longer meets the
34 requirements for obtaining the tax credit.

35 (b) If the tax credit is disallowed pursuant to this subsection, notwithstanding ORS
36 314.410 or other law, all prior tax relief provided to the taxpayer shall be forfeited, the de-
37 partment shall proceed to collect those taxes not paid by the taxpayer as a result of the prior
38 granting of the credit and the taxpayer shall be denied any further credit provided under this
39 section.

40 (c) The department may perform activities necessary to ensure that recipients of the tax
41 credit comply with applicable requirements.

42 (7)(a) A nonresident individual shall be allowed the credit computed in the same manner
43 and subject to the same limitations as the credit allowed a resident by this section. However,
44 the credit shall be prorated using the proportion provided in ORS 316.117.

45 (b) If a change in the taxable year of a taxpayer occurs as described in ORS 314.085, or

1 if the Department of Revenue terminates the taxpayer's taxable year under ORS 314.440, the
2 credit allowed by this section shall be prorated or computed in a manner consistent with ORS
3 314.085.

4 (c) If a change in the status of a taxpayer from resident to nonresident or from nonres-
5 ident to resident occurs, the credit allowed by this section shall be determined in a manner
6 consistent with ORS 316.117.

7 (8) The taxpayer shall claim the credit on a form prescribed by the Department of Re-
8 venue containing the information required by the Department of Revenue. The taxpayer shall
9 maintain the tax credit cost certification issued by the Department of Environmental Quality
10 under section 51 of this 2007 Act in the records of the taxpayer for the length of time pre-
11 scribed by the Department of Revenue and shall provide a copy of the cost certification to
12 the Department of Revenue if requested.

13 (9) A taxpayer may not claim a credit under this section and ORS 315.304 with respect
14 to the same diesel engine or group of diesel engines. A taxpayer may claim a credit under

16 (3) The taxpayer shall file the application within one year following the date of the invoice
17 for the qualifying repower or retrofit. The application may not be accepted unless the appli-
18 cation includes payment of the nonrefundable fees imposed under rules adopted under section
19 50 of this 2007 Act.

20 (4) The department shall consider completed applications and determine if the application
21 describes a repower or retrofit that qualifies for a tax credit under section 47 of this 2007
22 Act and, if qualified, the certified cost of the repower or retrofit. In determining the amount
23 of a tax credit under this section, the department shall reduce the incremental cost of a
24 qualifying repower or retrofit by the value of any existing financial incentive that directly

33 (8)(a) Pursuant to the procedures for a contested case under ORS [*183.310 to 183.550*] **chapter**
34 **183**, the Department of Revenue may order the disallowance of the credit allowed under this section
35 if it finds, by order, that the credit was obtained by fraud or misrepresentation.

36 (b) If the tax credit is disallowed pursuant to this subsection, notwithstanding ORS 314.410 or

28 (B) **Used to finance construction, development, acquisition, or acquisition and rehabili-**
29 **tation of housing consisting of a manufactured dwelling park; and**

30 (C) **Accompanied by a written certification by the Housing and Community Services De-**
31 **partment that the housing will continue to be operated as a manufactured dwelling park**
32 **during the period for which the tax credit is allowed; or**

33 (d)(A) **Made to a qualified borrower;**

34 (B) **Used to finance acquisition, or acquisition and rehabilitation, of housing consisting**
35 **of a preservation project; and**

36 (C) **Accompanied by a written certification by the Housing and Community Services De-**
37 **partment that the housing preserved by the loan:**

38 (i) **Is or will be occupied by households earning less than 80 percent of the area median**
39 **income; and**

40 (ii) **Has a rent assistance contract with the United States Department of Housing and**
41 **Urban Development or the United States Department of Agriculture that will be maintained**

30 (d) **"Manufactured dwelling park" has the meaning given that term in ORS 446.003.**

31 (e) **"Nonprofit corporation" means a corporation that is exempt from income taxes under**
32 **section 501(c)(3) or (4) of the Internal Revenue Code as amended and in effect on December**
33 **31, 2006.**

34 (f) **"Preservation project" means housing that was previously developed as affordable**
35 **housing with a contract for rent assistance from the United States Department of Housing**
36 **and Urban Development or the United States Department of Agriculture and that is being**
37 **acquired by a sponsoring entity.**

38 [(d)] (g) "Qualified assignee" means any investor participating in the secondary market for real
39 estate loans.

40 [(e)] (h) "Qualified borrower" means any borrower that is a sponsoring entity that has a con-
41 trolling interest in the real property that is financed by the loan described in subsection (4) of this
42 section. Such a controlling interest includes, but is not limited to, a controlling interest in the gen-
43 eral partner of a limited partnership that owns the real property.

44 [(f)] (i) "Sponsoring entity" means a nonprofit corporation, **nonprofit cooperative**, state gov-
45 ernmental entity, local unit of government as defined in ORS 466.706, housing authority or any other

1 person, provided that the person has agreed to restrictive covenants imposed by a nonprofit corpo-
2 ration, **nonprofit cooperative**, state governmental entity, local unit of government or housing au-
3 thority.

4 (11) Notwithstanding any other provision of law, a lending institution that is a community de-
5 velopment corporation organized under the Oregon Nonprofit Corporation Law may transfer any

31 main, by order of a federal, state or local agency or by the landlord; and

32 (b) Ends tenancy at the manufactured dwelling park site in response to the delivered
33 notice described in paragraph (a) of this subsection.

34 (3) For purposes of subsection (2) of this section:

35 (a) Tenancy by the individual at the manufactured dwelling park site ends on the last day
36 that a member of the individual's household occupies the manufactured dwelling at the
37 manufactured dwelling park site; and

38 (b) Tenancy by the individual at the manufactured dwelling park site does not end if the
39 manufactured dwelling park is converted to a subdivision under ORS 92.830 to 92.845 and the
40 individual buys a space or lot in the subdivision or sells the manufactured dwelling to a

12 tax credit, the qualifying individuals may each claim a share of the available credit that is
13 in proportion to their respective gross incomes for the tax year.
