

# House Bill 3209

Sponsored by Representative NELSON

## SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Requires health insurance to cover services of chiropractor subject to same conditions as coverage of physician services.

## A BILL FOR AN ACT

1  
2 Relating to health insurance coverage of chiropractor services; creating new provisions; and  
3 amending ORS 750.055 and 750.333.

4 **Be It Enacted by the People of the State of Oregon:**

5 **SECTION 1. Section 2 of this 2007 Act is added to and made a part of the Insurance Code.**

6 **SECTION 2. (1) An individual or group health insurance policy or contract that provides**  
7 **coverage for physician services shall provide for payment or reimbursement for any service**  
8 **that is within the lawful scope of a chiropractor licensed under ORS chapter 684.**

9 **(2) The insured under the health insurance policy or contract shall be entitled to have**  
10 **payment or reimbursement made to the insured or on the insured's behalf for the services**  
11 **performed.**

12 **(3) Payment or reimbursement under the plan for chiropractor services may be subject**  
13 **to the requirements under the plan for physician services, including the payment of**  
14 **copayments, coinsurance or deductibles.**
