

C-Engrossed House Bill 3242

Ordered by the Senate June 27

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure.

Creates categories and levels of endorsement for construction contractors. Creates new experience, continuing education, bonding and insurance provisions for categories and levels of construction contractor. Requires contractor to have current license with proper endorsement before undertaking or offering or bidding to undertake construction work. Prohibits contracting agency from excluding commercial contractor from competing for public contract based on license endorsement level. Requires commercial contractor to have key employees meeting experience requirements. Exempts city and county inspectors from construction contractor licensing requirement.

Modifies claim and recovery provisions. Imposes workers' compensation insurance requirement on certain contractors otherwise qualifying as exempt.

Revises definitions of small commercial structure and residential structure. Requires general contractor for new large commercial structure to provide warranty of building envelope and penetration components. Changes required composition of Construction Contractors Board.

Makes bond, insurance and application procedure changes applicable to licenses issued or renewed on or after July 1, 2008. Makes claim resolution, satisfaction and lien recording changes applicable to claims against persons issued or renewing licenses on or after July 1, 2008. Makes endorsement requirement, key employee and workers compensation changes effective July 1, 2010. Makes Construction Contractors Board composition changes effective for appointments to terms beginning on or after July 1, 2009.

Increases biennial limitation of expenditures from fees, moneys or other revenues, including Miscellaneous Receipts, but excluding lottery funds and federal funds, collected or received by Construction Contractors Board for certain purposes.

Declares emergency, effective July 1, 2007.

9 **SECTION 1. Sections 2 to 12 of this 2007 Act are added to and made a part of ORS**
10 **chapter 701.**

11 **SECTION 2. (1) Except as provided in ORS 701.010, a person or joint venture that**
12 **undertakes, offers to undertake or submits a bid to do work as a contractor must have a**
13 **current license issued by the Construction Contractors Board and possess an appropriate**
14 **endorsement as provided in this section.**

35 **(b) Obtain general liability insurance under ORS 701.105 in an amount not less than**
36 **\$300,000; and**

37 **(c) Have a responsible managing individual who meets the requirements of ORS 701.078.**

38 **(3) A residential limited contractor shall:**

16 (d) Have one or more key employees with a combined total of at least four years of ex-

20 (b) Obtain general liability insurance under ORS 701.105 in an amount of not less than

24 (d) Have one or more key employees with a combined total of at least eight years of ex-
25 perience described in section 8 of this 2007 Act.

26 (4) A commercial specialty contractor level 2 shall:

27 (a) Obtain a surety bond under ORS 701.085 in the amount of \$20,000;

28 (b) Obtain general liability insurance under ORS 701.105 in an amount not less than
29 \$500,000;

30 (c) Have a responsible managing individual who meets the requirements of ORS 701.078;
31 and

32 (d) Have one or more key employees with a combined total of at least four years of ex-
33 perience described in section 8 of this 2007 Act.

34 (5) A commercial developer shall:

35 (a) Obtain a surety bond under ORS 701.085 in the amount of \$20,000; and

36 (b) Obtain general liability insurance under ORS 701.105 in an amount not less than
37 \$500,000.

38 **SECTION 5. A residential limited contractor may not:**

39 (1) Perform work as a contractor exceeding \$40,000 in gross annual volume; or

40 (2) Enter into contracts to perform work as a contractor in excess of \$5,000.

41 **SECTION 6. A licensed developer or a residential or commercial developer:**

42 (1) Shall act only in association with licensed general contractors, one or a combination
43 of whom must have sole responsibility for overseeing all phases of construction activity on
44 a property; and

45 (2) May not perform any construction work on a property.

1 **SECTION 7.** Section 6 of this 2007 Act is amended to read:

2 **Sec. 6.** A [*licensed developer or a*] residential or commercial developer:

3 (1) Shall act only in association with licensed general contractors, one or a combination of
4 whom must have sole responsibility for overseeing all phases of construction activity on a property;
5 and

6 (2) May not perform any construction work on a property.

7 **SECTION 8.** (1) **A commercial general contractor or commercial specialty contractor**
8 **shall certify upon license application or renewal that the contractor has one or more key**
9 **employees with the combined total amount of experience required under section 4 of this 2007**
10 **Act.**

11 (2) **Except as provided in subsection (3) of this section, the experience certified under**
12 **subsection (1) of this section must be as a licensed contractor, journeyman, foreperson or**
13 **supervisor or as any other employee engaged in construction work for a licensed contractor.**

14 (3) **The following experience or education may substitute for construction experience**
15 **described in subsection (2) of this section:**

16 (a) **Completion of an apprenticeship program may substitute for up to three years of ex-**
17 **perience;**

18 (b) **A bachelor's degree in a construction-related field may substitute for up to three**
19 **years of experience;**

20 (c) **A bachelor's degree or master's degree in business, finance or economics may sub-**
21 **stitute for up to two years of experience; and**

22 (d) **An associate's degree in construction or building management may substitute for up**
23 **to one year of experience.**

24 **SECTION 9.** (1) **A commercial general contractor level 1 or commercial specialty con-**
25 **tractor level 1 shall have a key employee, or combination of key employees, who completes**
26 **at least 40 hours of continuing education per year.**

27 (2) **A commercial general contractor level 2 or commercial specialty contractor level 2**
28 **shall have a key employee, or combination of key employees, who completes the equivalent**
29 **of at least 16 hours of continuing education per year.**

30 (3) **Notwithstanding subsection (1) of this section, if a commercial general contractor**
31 **level 1 or commercial specialty contractor level 1 has no more than four key employees, the**
32 **contractor shall have a key employee, or combination of key employees, that completes**
33 **continuing education each year equivalent to the number of key employees multiplied by**
34 **eight hours.**

35 (4) **Continuing education may be provided by post-secondary institutions, trade schools,**
36 **trade associations, professional societies, private companies, public agencies, business asso-**
37 **ciations and contractor-provided in-house training programs. Continuing education topics**
38 **may include, but need not be limited to, construction means, methods and business practices.**

39 (5) **A contractor applying for renewal shall certify the number of continuing education**
40 **hours completed during the preceding licensing period.**

41 (6) **A contractor subject to this section shall maintain records of the continuing educa-**
42 **tion completed by key employees.**

43 (7) **This section does not apply to a commercial contractor:**

44 (a) **That is subject to regulation under ORS 479.510 to 479.945 or 480.510 to 480.670 or ORS**
45 **chapter 693; or**

1 (b) As provided by rule by the Construction Contractors Board.

2 **SECTION 10.** (1) If an order of the Construction Contractors Board that determines a
3 claim under ORS 701.145 becomes final by operation of law or on appeal and remains unpaid
4 10 days after the date the order becomes final, the claimant may file the order with the
5 county clerk in any county of this state.

6 (2) Upon receipt, the clerk shall record the order in the County Clerk Lien Record. In
7 addition to any other remedy provided by law, recording an order in the County Clerk Lien
8 Record pursuant to the provisions of this section has the effect provided for in ORS 205.125
9 and 205.126, and the order may be enforced as provided in ORS 205.125 and 205.126.

10 (3)(a) Payments from the surety bond of a residential contractor pursuant to board order
11 and notice are satisfied in the following priority in any 90-day period:

12 (A) Board orders as a result of claims against a residential contractor by the owner of
13 a residential or small commercial structure have payment priority to the full extent of the
14 bond over all other types of claims.

15 (B) If the claims described in subparagraph (A) of this paragraph do not exhaust the
16 bond, then amounts due as a result of all other types of residential or small commercial
17 structure claims filed within that 90-day period may be satisfied from the bond, except that
18 the total amount paid from any one bond to nonowner claimants may not exceed \$3,000.

19 (b) A 90-day period begins on the date the first claim is filed with the board. Subsequent
20 90-day periods begin on the date the first claim is filed with the board after the close of the
21 preceding 90-day period.

22 (4) If the total claims filed with the board against a residential contractor within 90 days
23 after the board receives notice of the first claim against the contractor exceed the amount
24 of the bond available for those claims, the bond shall be apportioned as the board determines,
25 subject to the priorities established under this section.

26 (5) If the total amounts due as a result of claims filed with the board within 90 days after
27 the first claim is filed do not exceed the amount of the bond available for those claims, all
28 amounts due as a result of claims filed within the 90-day period shall have priority over all
29 claims subsequently filed until the amount of the bond available for the payment of claims
30 is exhausted.

31 (6) The total amount paid from a residential contractor bond for costs, interest and at-
32 torney fees may not exceed \$3,000.

33 **SECTION 11.** (1)(a) Payments from the surety bond of a commercial contractor pursuant
34 to Construction Contractors Board order and notice are satisfied in the following priority in
35 any 90-day period:

36 (A) Board orders as a result of claims against a commercial contractor by a person fur-
37 nishing labor to a contractor or owed employee benefits by a contractor have payment pri-
38 ority to the full extent of the bond over all other types of claims.

39 (B) If the claims described in subparagraph (A) of this paragraph do not exhaust the
40 bond, then amounts due as a result of all other types of small commercial or large com-
41 mercial structure claims may be satisfied from the bond, except claims for costs, interest
42 and attorney fees.

43 (C) If claims described in subparagraphs (A) and (B) of this paragraph do not exhaust the
44 bond, then claims for costs, interest and attorney fees resulting from small commercial or
45 large commercial structure claims may be satisfied from the bond.

1 (b) A 90-day period begins on the date the first claim is filed with the board. Subsequent
2 90-day periods begin on the date the first claim is filed with the board after the close of the
3 preceding 90-day period.

4 (2) If the total claims filed with the board against a commercial contractor within 90 days
5 after the board receives notice of the first claim against the contractor exceed the amount
6 of the bond available for those claims, the bond shall be apportioned as the board determines,
7 subject to the priorities established under this section.

8 (3) If the total amounts due as a result of claims filed with the board within 90 days after
9 the first claim is filed do not exceed the amount of the bond available for those claims, all
10 amounts due as a result of claims filed within the 90-day period shall have priority over all
11 claims subsequently filed until the amount of the bond available for the payment of claims
12 is exhausted.

13 **SECTION 12.** A commercial general contractor level 1 or level 2 that constructs a new
14 large commercial structure shall provide the owner with a two-year warranty of the building
15 envelope and penetration components against defects in materials and workmanship. The
16 warranty shall provide for the contractor to annually inspect the building envelope and pen-
17 etration components during the warranty period. The warranty need not cover conditions
18 resulting from improper maintenance by the owner.

19 **SECTION 13.** ORS 701.005 is amended to read:

20 701.005. As used in this chapter:

21 (1) "Board" means the Construction Contractors Board.

22 (2) "Commercial contractor" means a licensed contractor that holds an endorsement as
23 a:

24 (a) Commercial general contractor level 1;

25 (b) Commercial specialty contractor level 1;

26 (c) Commercial general contractor level 2;

27 (d) Commercial specialty contractor level 2; or

28 (e) Commercial developer.

29 (3) "Commercial developer" means a developer of property that is zoned for or intended
30 for use compatible with a small commercial or large commercial structure.

31 [(2)] (4) "Construction debt" means an amount owed under:

32 (a) A final order or arbitration award issued by the board; or

33 (b) A judgment or civil penalty arising from construction activities within the United States.

34 [(3)] (5) "Contractor" means **any of the following:**

35 (a) A person who, for compensation or with the intent to sell, arranges or undertakes or offers
36 to undertake or submits a bid to construct, alter, repair, add to, subtract from, improve, inspect,
37 move, wreck or demolish, for another, any building, highway, road, railroad, excavation or other
38 structure, project, development or improvement attached to real estate or to do any part thereof.
39 ["Contractor" includes general contractors, residential-only contractors and specialty contractors as
40 defined in this section.]

41 (b) A person that purchases or owns property and constructs or for compensation ar-
42 ranges for the construction of one or more residential structures or small commercial
43 structures with the intent of selling the structures.

44 (c) A school district, as defined in ORS 332.002, that permits students to construct a
45 residential structure or small commercial structure as an educational experience to learn

1 **building techniques and sells the completed structure.**

2 (d) **A community college district, as defined in ORS 341.005, that permits students to**
3 **construct a residential structure or small commercial structure as an educational experience**
4 **to learn building techniques and sells the completed structure.**

5 (e) **Any person except a landscape contractor, nurseryman, gardener or person engaged**
6 **in the commercial harvest of forest products, that is engaged as an independent contractor**
7 **to remove trees, prune trees, remove tree limbs or stumps or to engage in tree or limb**
8 **guying.**

9 (f) **A business that supplies the services of a home inspector certified under ORS 701.350,**
10 **a lead-based paint inspector licensed under ORS 701.515 or a cross connection inspector and**
11 **backflow assembly tester certified under ORS 448.279.**

12 (6) **“Developer” means a contractor that owns property or an interest in property and**
13 **engages in the business of arranging for construction work or performing other activities**
14 **associated with the improvement of real property, with the intent to sell the property.**

15 [(4)] (7) **“General contractor”:**

16 (a) **Means a contractor whose business operations require the use of more than two unrelated**
17 **building trades or crafts that the contractor supervises or performs in whole or part, whenever the**
18 **sum of all contracts on any single property, including materials and labor, exceeds an amount es-**
19 **tablished by rule by the board. [*“General contractor” does not include specialty contractors or limited***
20 ***contractors, as described in ORS 701.085.*]**

21 (b) **Does not mean a specialty contractor or a residential limited contractor.**

22 [(5)] (8) **“Home inspector” means a person who, for a fee, inspects and provides written reports**
23 **on the overall physical condition of a residential structure and the appurtenances thereto. “Home**
24 **inspector” does not include persons certified under ORS chapter 455 to inspect new, repaired or**
25 **altered structures for compliance with the state building code.**

26 [(6)] **“Inspector” means a contractor registered with the board who inspects or otherwise provides**
27 **services to a property owner or other contractor but does not substantively add to or subtract from a**
28 **structure. “Inspector” includes but is not limited to a home inspector certified under ORS 701.350, a**
29 **lead-based paint inspector licensed under ORS 701.515 and a cross connection inspector and backflow**
30 **assembly tester certified under ORS 448.279. “Inspector” does not include city or county inspectors**
31 **acting under ORS 701.225 or an inspector as defined in ORS 455.715.]**

32 (9) **“Key employee” means an employee or owner of a contractor who is a corporate of-**
33 **ficer, manager, superintendent, foreperson or lead person or any other employee identified**
34 **by the board by rule.**

35 [(7)] (10) **“Large commercial structure” means a structure that is not a residential structure or**
36 **small commercial structure.**

37 [(8)] **“Licensed developer” means a contractor who owns property or an interest in property and**
38 **arranges for construction work, if the contractor:]**

39 [(a)] **Engages in the business of arranging for construction work and performing other activities**
40 **associated with the improvement of real property, with the intent to sell the property;]**

41 [(b)] **Acts in association with one or more licensed general contractors and the general contractor**
42 **or combination of general contractors have sole responsibility for overseeing all phases of construction**
43 **activity on the property; and]**

44 [(c)] **Does not perform any construction work on the property.]**

45 [(9)] (11) **“Officer” means any of the following persons:**

1 (a) A president, vice president, secretary, treasurer or director of a corporation.

2 (b) A general partner in a limited partnership.

3 (c) A manager in a manager-managed limited liability company.

4 (d) A member of a member-managed limited liability company.

5 (e) A trustee.

6 (f) A person defined as an officer under board rules. The definition of officer adopted by board
7 rule may include persons not listed in this subsection who may exercise substantial control over a
8 business.

9 [(10) “Residential-only contractor” means a general contractor or specialty contractor who performs
10 work exclusively in connection with residential structures and small commercial structures, and the
11 appurtenances thereto. “Residential-only contractor” includes, but is not limited to:]

12 [(a) A person who purchases or owns property and constructs or for compensation arranges for the
13 construction of one or more residential structures or small commercial structures with the intent of
14 selling the structures;]

15 [(b) A school district, as defined in ORS 332.002, that permits students to construct a residential
16 structure or small commercial structure as an educational experience to learn building techniques and
17 sells the completed structure;]

18 [(c) A community college district, as defined in ORS 341.005, that permits students to construct a
19 residential structure or small commercial structure as an educational experience to learn building
20 techniques and sells the completed structure; or]

21 [(d) Any person except a landscape contractor, nurseryman, gardener or person engaged in the
22 commercial harvest of forest products who is engaged as an independent contractor to remove trees,
23 prune trees, remove tree limbs or stumps or to engage in tree or limb guying.]

24 **(12) “Residential contractor” means a licensed contractor that holds an endorsement as**
25 **a:**

26 **(a) Residential general contractor;**

27 **(b) Residential specialty contractor;**

28 **(c) Residential limited contractor; or**

29 **(d) Residential developer.**

30 **(13) “Residential developer” means a developer of property that is zoned for or intended**
31 **for use compatible with a residential or small commercial structure.**

32 [(11) “Residential structure” means a residence, including a site-built home, modular home con-
33 structed off-site, floating home as defined in ORS 830.700, condominium unit, manufactured dwelling
34 or duplex, or a multiunit residential building consisting of four units or less that is not part of a
35 multistructure complex of buildings.]

36 [(12) “Small commercial structure” means a nonresidential structure that has a ground area of
37 4,000 square feet or less, including exterior walls, and a height of not more than 20 feet from the top
38 surface of the lowest flooring to the highest interior overhead finish of the structure.]

39 **(14) “Residential structure”:**

40 **(a) Means:**

41 **(A) A residence that is a site-built home;**

42 **(B) A structure that contains one or more dwelling units and is four stories or less above**
43 **grade;**

44 **(C) A condominium, rental residential unit or other residential dwelling unit that is part**
45 **of a larger structure, if the property interest in the unit is separate from the property in-**

1 **terest in the larger structure;**

2 **(D) A modular home constructed off-site;**

3 **(E) A manufactured dwelling; or**

4 **(F) A floating home as defined in ORS 830.700.**

5 **(b) Does not mean:**

6 **(A) Subject to paragraph (a)(C) of this subsection, a structure that contains both resi-**
7 **dential and nonresidential units;**

8 **(B) Transient lodging;**

9 **(C) A residential school or residence hall;**

10 **(D) A state or local correctional facility other than a local facility for persons enrolled**
11 **in work release programs maintained under ORS 144.460;**

12 **(E) A youth correction facility as defined in ORS 420.005;**

13 **(F) A youth care center operated by a county juvenile department under administrative**
14 **control of a juvenile court pursuant to ORS 420.855 to 420.885;**

15 **(G) A detention facility as defined in ORS 419A.004;**

16 **(H) A nursing home;**

17 **(I) A hospital; or**

18 **(J) A place constructed primarily for recreational activities.**

19 **(15) "Small commercial structure" means:**

20 **(a) A nonresidential structure that has a ground area of 10,000 square feet or less, in-**
21 **cluding exterior walls, and a height of not more than 20 feet from the top surface of the**
22 **lowest flooring to the highest interior overhead finish of the structure;**

23 **(b) A nonresidential leasehold, rental unit or other unit that is part of a larger structure,**
24 **if the unit has a ground area of 12,000 square feet or less, excluding exterior walls, and a**
25 **height of not more than 20 feet from the top surface of the lowest flooring to the highest**
26 **interior overhead finish of the unit; or**

27 **(c) A nonresidential structure of any size for which the contract price of all construction**
28 **contractor work to be performed on the structure as part of a construction project does not**
29 **total more than \$250,000.**

30 **[(13)] (16) "Specialty contractor" means a contractor who performs work on a structure, project,**
31 **development or improvement and whose operations as such do not fall within the definition of**
32 **"general contractor." "Specialty contractor" includes a person who performs work regulated under**
33 **ORS [chapter 446] 446.395.**

34 **SECTION 14. ORS 701.010 is amended to read:**

35 **701.010. The Construction Contractors Board may adopt rules to make licensure optional for**
36 **persons who offer, bid or undertake to perform work peripheral to construction, as defined by ad-**
37 **ministrative rule of the board. The following persons are exempt from licensure under this chapter:**

39 **(2) A person who is constructing, altering, improving or repairing a structure located within the**
40 **boundaries of any site or reservation under the jurisdiction of the federal government.**

41 **(3) A person who furnishes materials, supplies, equipment or finished product and does not fab-**
42 **ricate them into, or consume them, in the performance of the work of a contractor.**

43 **(4) A person working on one structure or project, under one or more contracts, when the ag-**
44 **gregate price of all of that person's contracts for labor, materials and all other items is less than**
45 **\$500 and such work is of a casual, minor or inconsequential nature. This subsection does not apply**

1 to a person who advertises or puts out any sign or card or other device that might indicate to the
2 public that the person is a contractor.

3 (5) An owner who contracts for work to be performed by a licensed contractor. This subsection
4 does not apply to a person who, in the pursuit of an independent business, constructs, remodels,
5 repairs or for compensation and with the intent to sell the structure, arranges to have constructed,
6 remodeled or repaired a structure with the intent of offering the structure for sale before, upon or
7 after completion. It is prima facie evidence that there was an intent of offering the structure for sale
8 if the person who constructed, remodeled or repaired the structure or arranged to have the struc-
9 ture constructed, remodeled or repaired does not occupy the structure after its completion.

10 (6) A person performing work on a property that person owns or performing work as the owner's
11 employee, whether the property is occupied by the owner or not, or a person performing work on
12 that person's residence, whether or not that person owns the residence. This subsection does not
13 apply to a person performing work on a structure owned by that person or the owner's employee if
14 the work is performed, in the pursuit of an independent business, with the intent of offering the
15 structure for sale before, upon or after completion.

16 (7) A person licensed in one of the following trades or professions when operating within the
17 scope of that license:

18 (a) An architect licensed by the State Board of Architect Examiners.

19 (b) A registered professional engineer licensed by the State Board of Examiners for Engineering

30 (8) A person who performs work subject to this chapter as an employee of a contractor.

31 (9) A manufacturer of a manufactured home constructed under standards established by the
32 federal government.

33 (10) A person involved in the movement of:

34 (a) Modular buildings or structures other than manufactured structures not in excess of 14 feet
35 in width.

36 (b) Structures not in excess of 16 feet in width when the structures are being moved by their
37 owner if the owner is not a contractor required to be licensed under this chapter.

38 (11) A commercial lending institution or surety company that arranges for the completion, repair
39 or remodeling of a structure. As used in this subsection, "commercial lending institution" means
40 any bank, mortgage banking company, trust company, savings bank, savings and loan association,
41 credit union, national banking association, federal savings and loan association, insurance company
42 or federal credit union maintaining an office in this state.

43 (12) A real estate licensee as defined in ORS 696.010 or the employee of that licensee when
44 performing work on a structure that the real estate licensee manages under a contract.

45 (13) Units of government other than those specified in ORS 701.005 [(10)(b) and (c)] **(5)(c) and**

1 (d).

2 (14) A qualified intermediary in a property exchange that qualifies under section 1031 of the
3 Internal Revenue Code as amended and in effect on January 1, 2004, if the qualified intermediary
4 is not performing construction activities.

5 (15) A business that supplies personnel to a licensed contractor for the performance of work
6 under the direction and supervision of the contractor.

7 **(16) City or county inspectors acting under ORS 701.225 or inspectors described in ORS**
8 **455.715.**

9 **SECTION 15.** ORS 701.035 is amended to read:

10 701.035. (1) An applicant must qualify as an independent contractor under ORS 670.600 to be
11 eligible for a license with the Construction Contractors Board.

12 (2) The board shall establish two classes of independent contractor [*licenses*]:

13 (a) The nonexempt class is composed of the following entities:

14 (A) Sole proprietorships, partnerships, corporations, limited liability companies with one or more
15 employees; and

16 (B) Partnerships, corporations and limited liability companies with more than two partners,
17 corporate officers or members, if any of the partners, corporate officers or members are not part of

41 (3) The Construction Contractors Board shall adopt by rule a form titled “Information Notice
42 to Property Owners About Construction Responsibilities” that clearly describes in everyday lan-
43 guage the responsibilities property owners are undertaking by acting as their own *[general]* con-
44 tractor and the problems that could develop. The responsibilities described in the form shall include,
45 but not be limited to:

1 (a) Compliance with state and federal laws regarding Social Security tax, income tax and un-

8 (b) **A person that purchases or owns property and constructs or for compensation ar-**
9 **ranges for the construction of one or more residential structures or small commercial**
10 **structures with the intent of selling the structures.**

11 (c) **A school district, as defined in ORS 332.002, that permits students to construct a**
12 **residential structure or small commercial structure as an educational experience to learn**
13 **building techniques and sells the completed structure.**

14 (d) **A community college district, as defined in ORS 341.005, that permits students to**
15 **construct a residential structure or small commercial structure as an educational experience**
16 **to learn building techniques and sells the completed structure.**

17 (e) **Any person except a landscape contracting business, nurseryman, gardener or person**
18 **engaged in the commercial harvest of forest products, that is engaged as an independent**
19 **contractor to remove trees, prune trees, remove tree limbs or stumps or to engage in tree**
20 **or limb guying.**

21 (f) **A business that supplies the services of a home inspector certified under ORS 701.350,**
22 **a lead-based paint inspector licensed under ORS 701.515 or a cross connection inspector and**
23 **backflow assembly tester certified under ORS 448.279.**

24 (6) **“Developer” means a contractor that owns property or an interest in property and**
25 **engages in the business of arranging for construction work or performing other activities**
26 **associated with the improvement of real property, with the intent to sell the property.**

27 [(4)] (7) “General contractor”:

28 (a) Means a contractor whose business operations require the use of more than two unrelated
29 building trades or crafts that the contractor supervises or performs in whole or part, whenever the
30 sum of all contracts on any single property, including materials and labor, exceeds an amount es-
31 tablished by rule by the board. [*“General contractor” does not include specialty contractors or limited*
32 *contractors, as described in ORS 701.085.*]

33 (b) **Does not mean a specialty contractor or a residential limited contractor.**

34 [(5)] (8) “Home inspector” means a person who, for a fee, inspects and provides written reports
35 on the overall physical condition of a residential structure and the appurtenances thereto. “Home
36 inspector” does not include persons certified under ORS chapter 455 to inspect new, repaired or
37 altered structures for compliance with the state building code.

38 [(6)] “Inspector” means a contractor registered with the board who inspects or otherwise provides
39 services to a property owner or other contractor but does not substantively add to or subtract from a
40 structure. “Inspector” includes but is not limited to a home inspector certified under ORS 701.350, a
41 lead-based paint inspector licensed under ORS 701.515 and a cross connection inspector and backflow
42 assembly tester certified under ORS 448.279. “Inspector” does not include city or county inspectors
43 acting under ORS 701.225 or an inspector as defined in ORS 455.715.]

44 (9) **“Key employee” means an employee or owner of a contractor who is a corporate of-**
45 **ficer, manager, superintendent, foreperson or lead person or any other employee identified**

1 **by the board by rule.**

2 [(7)] (10) “Large commercial structure” means a structure that is not a residential structure or
3 small commercial structure.

4 [(8) “Licensed developer” means a contractor who owns property or an interest in property and
5 arranges for construction work, if the contractor:]

6 [(a) Engages in the business of arranging for construction work and performing other activities
7 associated with the improvement of real property, with the intent to sell the property;]

8 [(b) Acts in association with one or more licensed general contractors and the general contractor
9 or combination of general contractors have sole responsibility for overseeing all phases of construction
10 activity on the property; and]

11 [(c) Does not perform any construction work on the property.]

12 [(9)] (11) “Officer” means any of the following persons:

13 (a) A president, vice president, secretary, treasurer or director of a corporation.

14 (b) A general partner in a limited partnership.

15 (c) A manager in a manager-managed limited liability company.

16 (d) A member of a member-managed limited liability company.

17 (e) A trustee.

18 (f) A person defined as an officer under board rules. The definition of officer adopted by board
19 rule may include persons not listed in this subsection who may exercise substantial control over a
20 business.

21 [(10) “Residential-only contractor” means a general contractor or specialty contractor who performs
22 work exclusively in connection with residential structures and small commercial structures, and the
23 appurtenances thereto. “Residential-only contractor” includes, but is not limited to:]

24 [(a) A person who purchases or owns property and constructs or for compensation arranges for the
25 construction of one or more residential structures or small commercial structures with the intent of
26 selling the structures;]

27 [(b) A school district, as defined in ORS 332.002, that permits students to construct a residential
28 structure or small commercial structure as an educational experience to learn building techniques and
29 sells the completed structure;]

30 [(c) A community college district, as defined in ORS 341.005, that permits students to construct a
31 residential structure or small commercial structure as an educational experience to learn building
32 techniques and sells the completed structure; or]

33 [(d) Any person except a landscape contracting business, nurseryman, gardener or person engaged
34 in the commercial harvest of forest products who is engaged as an independent contractor to remove
35 trees, prune trees, remove tree limbs or stumps or to engage in tree or limb guying.]

36 (12) “Residential contractor” means a licensed contractor that holds an endorsement as
37 a:

38 (a) Residential general contractor;

39 (b) Residential specialty contractor;

40 (c) Residential limited contractor; or

41 (d) Residential developer.

42 (13) “Residential developer” means a developer of property that is zoned for or intended
43 for use compatible with a residential or small commercial structure.

44 [(11) “Residential structure” means a residence, including a site-built home, modular home con-
45 structed off-site, floating home as defined in ORS 830.700, condominium unit, manufactured dwelling

1 or duplex, or a multiunit residential building consisting of four units or less that is not part of a
2 multistructure complex of buildings.]

3 [(12) “Small commercial structure” means a nonresidential structure that has a ground area of
4 4,000 square feet or less, including exterior walls, and a height of not more than 20 feet from the top
5 surface of the lowest flooring to the highest interior overhead finish of the structure.]

6 **(14) “Residential structure”:**

7 **(a) Means:**

8 **(A) A residence that is a site-built home;**

9 **(B) A structure that contains one or more dwelling units and is four stories or less above
10 grade;**

11 **(C) A condominium, rental residential unit or other residential dwelling unit that is part
12 of a larger structure, if the property interest in the unit is separate from the property in-
13 terest in the larger structure;**

14 **(D) A modular home constructed off-site;**

15 **(E) A manufactured dwelling; or**

16 **(F) A floating home as defined in ORS 830.700.**

17 **(b) Does not mean:**

18 **(A) Subject to paragraph (a)(C) of this subsection, a structure that contains both resi-
19 dential and nonresidential units;**

20 **(B) Transient lodging;**

21 **(C) A residential school or residence hall;**

22 **(D) A state or local correctional facility other than a local facility for persons enrolled
23 in work release programs maintained under ORS 144.460;**

24 **(E) A youth correction facility as defined in ORS 420.005;**

25 **(F) A youth care center operated by a county juvenile department under administrative
26 control of a juvenile court pursuant to ORS 420.855 to 420.885;**

27 **(G) A detention facility as defined in ORS 419A.004;**

28 **(H) A nursing home;**

29 **(I) A hospital; or**

30 **(J) A place constructed primarily for recreational activities.**

31 **(15) “Small commercial structure” means:**

32 **(a) A nonresidential structure that has a ground area of 10,000 square feet or less, in-
33 cluding exterior walls, and a height of not more than 20 feet from the top surface of the
34 lowest flooring to the highest interior overhead finish of the structure;**

35 **(b) A nonresidential leasehold, rental unit or other unit that is part of a larger structure,
36 if the unit has a ground area of 12,000 square feet or less, excluding exterior walls, and a
37 height of not more than 20 feet from the top surface of the lowest flooring to the highest
38 interior overhead finish of the unit; or**

39 **(c) A nonresidential structure of any size for which the contract price of all construction
40 contractor work to be performed on the structure as part of a construction project does not
41 total more than \$250,000.**

42 [(13)] **(16) “Specialty contractor” means a contractor who performs work on a structure, project,
43 development or improvement and whose operations as such do not fall within the definition of
44 “general contractor.” “Specialty contractor” includes a person who performs work regulated under
45 ORS [chapter 446] 446.395.**

1 **SECTION 57. If House Bill 2498 becomes law, section 14 of this 2007 Act (amending ORS**
2 **701.010) is repealed and ORS 701.010, as amended by section 1, chapter __, Oregon Laws 2007**
3 **(Enrolled House Bill 2498), is amended to read:**

4 701.010. The Construction Contractors Board may adopt rules to make licensure optional for
5 persons who offer, bid or undertake to perform work peripheral to construction, as defined by ad-
6 ministrative rule of the board. The following persons are exempt from licensure under this chapter:

7 (1) A person who is constructing, altering, improving or repairing personal property.

8 (2) A person who is constructing, altering, improving or repairing a structure located within the
9 boundaries of any site or reservation under the jurisdiction of the federal government.

10 (3) A person who furnishes materials, supplies, equipment or finished product and does not fab-
11 ricate them into, or consume them, in the performance of the work of a contractor.

12 (4) A person working on one structure or project, under one or more contracts, when the ag-
13 gregate price of all of that person's contracts for labor, materials and all other items is less than
14 \$500 and such work is of a casual, minor or inconsequential nature. This subsection does not apply
15 to a person who advertises or puts out any sign or card or other device that might indicate to the
16 public that the person is a contractor.

17 (5) An owner who contracts for work to be performed by a licensed contractor. This subsection
18 does not apply to a person who, in the pursuit of an independent business, constructs, remodels,
19 repairs or for compensation and with the intent to sell the structure, arranges to have constructed,
20 remodeled or repaired a structure with the intent of offering the structure for sale before, upon or
21 after completion. It is prima facie evidence that there was an intent of offering the structure for sale
22 if the person who constructed, remodeled or repaired the structure or arranged to have the struc-
23 ture constructed, remodeled or repaired does not occupy the structure after its completion.

24 (6) An owner who contracts for one or more licensed contractors to perform work wholly or
25 partially within the same calendar year on not more than three existing residential structures of the
26 owner. This subsection does not apply to an owner contracting for work that requires a building
27 permit unless the work that requires a permit is performed by, or under the direction of, a **resi-**
28 **dential** general contractor.

29 (7) A person performing work on a property that person owns or performing work as the owner's
30 employee, whether the property is occupied by the owner or not, or a person performing work on
31 that person's residence, whether or not that person owns the residence. This subsection does not
32 apply to a person performing work on a structure owned by that person or the owner's employee,
33 if the work is performed in the pursuit of an independent business with the intent of offering the
34 structure for sale before, upon or after completion.

35 (8) A person licensed in one of the following trades or professions when operating within the
36 scope of that license:

37 (a) An architect licensed by the State Board of Architect Examiners.

38 (b) A registered professional engineer licensed by the State Board of Examiners for Engineering
39 and Land Surveying.

40 (c) A water well contractor licensed by the Water Resources Department.

41 (d) A sewage disposal system installer licensed by the Department of Environmental Quality.

42 (e) A landscaping business licensed under ORS 671.510 to 671.710 that constructs fences, decks,
43 arbors, patios, landscape edging, driveways, walkways or retaining walls and that meets the appli-
44 cable bonding requirements under ORS 671.690.

45 (f) A pesticide operator licensed under ORS 634.116 who does not conduct inspections for wood

1 destroying organisms for the transfer of real estate.

2 (g) An appraiser certified or licensed under ORS chapter 674 or an appraiser assistant registered
3 under ORS chapter 674 by the Appraiser Certification and Licensure Board.

4 (9) A person who performs work subject to this chapter as an employee of a contractor.

5 (10) A manufacturer of a manufactured home constructed under standards established by the
6 federal government.

7 (11) A person involved in the movement of:

8 (a) Modular buildings or structures other than manufactured structures not in excess of 14 feet
9 in width.

10 (b) Structures not in excess of 16 feet in width when the structures are being moved by their
11 owner if the owner is not a contractor required to be licensed under this chapter.

12 (12) A commercial lending institution or surety company that arranges for the completion, repair
13 or remodeling of a structure. As used in this subsection, "commercial lending institution" means
14 any bank, mortgage banking company, trust company, savings bank, savings and loan association,
15 credit union, national banking association, federal savings and loan association, insurance company
16 or federal credit union maintaining an office in this state.

17 (13) A real estate licensee as defined in ORS 696.010 or the employee of that licensee when
18 performing work on a structure that the real estate licensee manages under a contract.

19 (14) Units of government other than those specified in ORS 701.005 [(10)(b) and (c)] **(5)(c) and**
20 **(d)**.

21 (15) A qualified intermediary in a property exchange that qualifies under section 1031 of the
22 Internal Revenue Code as amended and in effect on January 1, 2004, if the qualified intermediary
23 is not performing construction activities.

24 (16) A business that supplies personnel to a licensed contractor for the performance of work
25 under the direction and supervision of the contractor.

26 **(17) City or county inspectors acting under ORS 701.225 or inspectors described in ORS**
27 **455.715.**

28 **SECTION 58. If Senate Bill 94 becomes law, section 18 of this 2007 Act (amending ORS**
29 **701.065) is repealed and ORS 701.065, as amended by section 6, chapter __, Oregon Laws 2007**
30 **(Enrolled Senate Bill 94), is amended to read:**

31 701.065. (1) Except as provided in subsection (2) of this section, a contractor may not perfect a
32 construction lien, file a complaint with the Construction Contractors Board or commence an arbi-
33 tration or a court action for compensation for the performance of any work or for the breach of any
34 contract for work that is subject to this chapter, unless the contractor had a valid license issued
35 by the board **and properly endorsed for the work performed:**

36 (a) At the time the contractor bid or entered into the contract for performance of the work; and

37 (b) Continuously while performing the work for which compensation is sought.

38 (2) The board, arbitrator or court may not apply the provisions of subsection (1) of this section
39 to a contractor if the board, arbitrator or court determines that:

5 injustice to the contractor;

6 (b) The contractor was licensed by the board for some but not all of the times required under
7 subsection (1) of this section and had a lapse in the license and:

8 (A) The contractor was not aware of the lapse in the license for more than a number of days
9 established by the board, but not to exceed 90 days, before submitting a completed application for
10 license renewal with the board;

11 (B) Except for perfection of a construction lien and a court action to foreclose the lien, at the
12 time the contractor commenced any proceeding subject to the provisions of subsection (1) of this
13 section the contractor's license was renewed under ORS 701.115 to include the entire time period
14 for which a license was required under subsection (1) of this section; and

15 (C) For perfection of a construction lien and a court action to foreclose the lien, the contractor's
16 license was renewed under ORS 701.115 for the entire time period for which a license was required
17 under subsection (1) of this section, but not later than 90 days following perfection of the lien; **or**

18 *[(c)(A) The contractor is a licensed developer and did not have a valid license during all or part*
19 *of the period described in subsection (1) of this section;]*

20 *[(B) The licensed developer was unaware of the license requirement and obtained a license within*
21 *a time established by the board, not to exceed 90 days after the licensed developer learned of the re-*
22 *quirement;]*

23 *[(C) The licensed developer was licensed at the time the licensed developer perfected the lien or*
24 *commenced the proceeding; and]*

25 *[(D) Enforcement of subsection (1) of this section would result in substantial injustice to the li-*
26 *icensed developer; or]*

27 *[(d)] (c) The proceeding:*

28 (A) Is directed against a person or entity that:

29 (i) Is subject to this chapter or ORS chapter 671 or 672;

30 (ii) Provides construction or design labor or services of any kind; or

31 (iii) Manufactures, distributes, rents or otherwise provides materials, supplies, equipment, sys-
32 tems or products; and

33 (B) Arises out of defects, deficiencies or inadequate performance in the construction, design,
34 labor, services, materials, supplies, equipment, systems or products provided.

35 (3) If a contractor falsely swears to information provided under ORS 701.075 or knowingly vio-

30 nership that is a partner, joint venturer or member of the applicant.

- 33 (C) Each joint venturer in a joint venture that is a partner, joint venturer or member of the

17 (2) The application described in subsection (1) of this section must be accompanied by proof
18 satisfactory to the board that the applicant:

20 (b) Has the legal capacity to enter into contracts.

21 (3) Subsection (2)(a) of this section does not apply to [*a licensed*] **an applicant for licensing**
22 **with endorsement solely as a residential or commercial** developer.

23 (4) An applicant shall conform to the information provided by the applicant on the application
24 and to the terms of the application.

25 **SECTION 59. If Senate Bill 94 becomes law and House Bill 2654 does not become law,**
26 **section 22 of this 2007 Act (amending ORS 701.085) is repealed and ORS 701.085, as amended**
27 **by section 7, chapter __, Oregon Laws 2007 (Enrolled Senate Bill 94), is amended to read:**

28 701.085. (1) An applicant for issuance or renewal of a contractor license shall file with the
29 Construction Contractors Board a surety bond with one or more corporate sureties authorized to
30 do business in this state in the amount set forth in [*subsections (2) to (5) of this section*] **section 3**
31 **or 4 of this 2007 Act.**

32 **(2) If an applicant for issuance, renewal or an additional endorsement of a license will**
33 **hold endorsements as both a residential contractor and a commercial contractor, the appli-**

11 work on a large commercial structure or an appurtenance to a large commercial structure must be
12 resolved as provided in ORS 701.146.

13 [(4) *A complaint by an owner that involves work on a large commercial structure or an*
14 *appurtenance to a large commercial structure when the total contract involved in the complaint is*
15 *\$25,000 or less may be resolved as provided in ORS 701.145 or 701.146.].*

16 [(5) (4) Notwithstanding subsections (1) to [(4)] (3) of this section **and except as provided in**
17 **ORS 701.148**, with prior agreement of the complainant and the licensed contractor, a complaint may
18 be resolved by the board through binding arbitration under ORS 701.148.

19 **SECTION 65. If Senate Bill 94 becomes law, section 29 of this 2007 Act (amending ORS**
20 **701.140) is repealed and ORS 701.140, as amended by section 12, chapter __, Oregon Laws 2007**

22 701.140. A complaint [*made against a licensed contractor's bond required by ORS 701.085*] **under**
23 **ORS 701.139** must arise from the performance, or a contract for the performance, of work that [*is*

40 tion toward completion of the improvement; **and**
- 41 (c) **The complaint is described in ORS 701.139 (1) or (3)(a) or (b).**

42 (3) A complaint against a licensed subcontractor by a licensed contractor for the following:

- 43 (a) Negligent work;
- 44 (b) Improper work; or
- 45 (c) Breach of contract.

1 (4) A complaint by a person furnishing labor to a contractor **or owed employee benefits by a**
2 **contractor.**

3 (5) A complaint, as limited by rule of the board, by a person furnishing material or renting or
4 supplying equipment to a contractor. The minimum limit set by the board may not exceed \$150.

5 (6) A complaint by a subcontractor against a contractor for unpaid labor or materials arising
6 out of a contract.

21 competent jurisdiction for determination or have been submitted to any other entity authorized by
22 law or the parties to effect a resolution or settlement; or
