7 **“SECTION 1. Sections 2 to 12 of this 2007 Act are added to and made a part of ORS**
8 **chapter 701.**

9 **“SECTION 2. (1) Except as provided in ORS 701.010, a person that undertakes, offers to**
10 **undertake or submits a bid to do work as a contractor must have a current license issued**
11 **by the Construction Contractors Board and possess an appropriate endorsement as provided**
12 **in this section.**

13 **“(2) A person that undertakes, offers to undertake or submits a bid to do work as a**
14 **contractor in preparation for or in connection with a residential structure must have one**
15 **of the following endorsements:**

16 **“(a) Residential general contractor.**

17 **“(b) Residential specialty contractor.**

18 **“(c) Residential limited contractor.**

19 **“(d) Residential developer.**

20 **“(3) A person that undertakes, offers to undertake or submits a bid to do work as a**
21 **contractor in preparation for or in connection with a small commercial structure must have**
22 **one of the following endorsements:**

23 **“(a) Residential general contractor.**

24 **“(b) Residential specialty contractor.**

25 **“(c) Residential limited contractor.**

26 **“(d) Residential developer.**

27 **“(e) Commercial general contractor level 1.**

28 **“(f) Commercial specialty contractor level 1.**

29 **“(g) Commercial general contractor level 2.**

30 **“(h) Commercial specialty contractor level 2.**

31 **“(i) Commercial developer.**

32 **“(4) A person that undertakes, offers to undertake or submits a bid to do work as a**
33 **contractor in preparation for or in connection with a large commercial structure must have**
34 **one of the following endorsements:**

35 **“(a) Commercial general contractor level 1.**

1 “(b) Commercial specialty contractor level 1.
2 “(c) Commercial general contractor level 2.
3 “(d) Commercial specialty contractor level 2.
4 “(e) Commercial developer.
5 “SECTION 3. (1) A residential general contractor shall:
6 “(a) Obtain a surety bond under ORS 701.085 in the amount of \$15,000;
7 “(b) Obtain general liability insurance under ORS 701.105 in an amount of not less than
8 \$500,000; and
9 “(c) Have a responsible managing individual who meets the requirements of ORS 701.078.
10 “(2) A residential specialty contractor shall:
11 “(a) Obtain a surety bond under ORS 701.085 in the amount of \$10,000;
12 “(b) Obtain general liability insurance under ORS 701.105 in an amount not less than
13 \$300,000; and
14 “(c) Have a responsible managing individual who meets the requirements of ORS 701.078.
15 “(3) A residential limited contractor shall:
16 “(a) Obtain a surety bond under ORS 701.085 in the amount of \$5,000;
17 “(b) Obtain general liability insurance under ORS 701.105 in an amount not less than
18 \$100,000; and
19 “(c) Have a responsible managing individual who meets the requirements of ORS 701.078.
20 “(4) A residential developer shall:
21 “(a) Obtain a surety bond under ORS 701.085 in the amount of \$15,000; and
22 “(b) Obtain general liability insurance under ORS 701.105 in an amount not less than
23 \$500,000.
24 “SECTION 4. (1) A commercial general contractor level 1 shall:
25 “(a) Obtain a surety bond under ORS 701.085 in the amount of \$75,000;
26 “(b) Obtain general liability insurance under ORS 701.105 in an amount of not less than
27 \$2 million;
28 “(c) Have a responsible managing individual who meets the requirements of ORS 701.078;
29 and
30 “(d) Have one or more key employees with a combined total of at least eight years of
31 experience described in section 8 of this 2007 Act.
32 “(2) A commercial specialty contractor level 1 shall:
33 “(a) Obtain a surety bond under ORS 701.085 in the amount of \$50,000;
34 “(b) Obtain general liability insurance under ORS 701.105 in an amount not less than \$1
35 million;
36 “(c) Have a responsible managing individual who meets the requirements of ORS 701.078;
37 and
38 “(d) Have one or more key employees with a combined total of at least four years of ex-
39 perience described in section 8 of this 2007 Act.
40 “(3) A commercial general contractor level 2 shall:
41 “(a) Obtain a surety bond under ORS 701.085 in the amount of \$20,000;
42 “(b) Obtain general liability insurance under ORS 701.105 in an amount of not less than
43 \$1 million;
44 “(c) Have a responsible managing individual who meets the requirements of ORS 701.078;
45 and

1 “(d) Have one or more key employees with a combined total of at least eight years of
2 experience described in section 8 of this 2007 Act.

3 “(4) A commercial specialty contractor level 2 shall:

4 “(a) Obtain a surety bond under ORS 701.085 in the amount of \$20,000;

5 “(b) Obtain general liability insurance under ORS 701.105 in an amount not less than
6 \$500,000;

7 “(c) Have a responsible managing individual who meets the requirements of ORS 701.078;
8 and

9 “(d) Have one or more key employees with a combined total of at least four years of ex-
10 perience described in section 8 of this 2007 Act.

11 “(5) A commercial developer shall:

12 “(a) Obtain a surety bond under ORS 701.085 in the amount of \$15,000; and

13 “(b) Obtain general liability insurance under ORS 701.105 in an amount not less than
14 \$500,000.

15 “SECTION 5. A residential limited contractor may not:

16 “(1) Perform work as a contractor exceeding \$40,000 in gross annual volume; or

17 “(2) Enter into contracts to perform work as a contractor in excess of \$5,000.

18 “SECTION 6. A licensed developer or a residential or commercial developer:

19 “(1) Shall act only in association with licensed general contractors, one or a combination
20 of whom must have sole responsibility for overseeing all phases of construction activity on
21 a property; and

22 “(2) May not perform any construction work on a property.

23 “SECTION 7. Section 6 of this 2007 Act is amended to read:

24 “Sec. 6. A [*licensed developer or a*] residential or commercial developer:

25 “(1) Shall act only in association with licensed general contractors, one or a combination of
26 whom must have sole responsibility for overseeing all phases of construction activity on a property;
27 and

28 “(2) May not perform any construction work on a property.

29 “SECTION 8. (1) A commercial general contractor or commercial specialty contractor
30 shall certify upon license application or renewal that the contractor has one or more key
31 employees with the combined total amount of experience required under section 4 of this 2007
32 Act.

33 “(2) Except as provided in subsection (3) of this section, the experience certified under
34 subsection (1) of this section must be as a licensed contractor, journeyman, foreperson or
35 supervisor or as any other employee engaged in construction work for a licensed contractor.

36 “(3) The following experience or education may substitute for construction experience
37 described in subsection (2) of this section:

38 “(a) Completion of an apprenticeship program may substitute for up to three years of
39 experience;

40 “(b) A bachelor’s degree in a construction-related field may substitute for up to three
41 years of experience;

42 “(c) A bachelor’s degree or master’s degree in business, finance or economics may sub-
43 stitute for up to two years of experience; and

44 “(d) An associate’s degree in construction or building management may substitute for
45 up to one year of experience.

1 **“SECTION 9. (1) A commercial general contractor level 1 or commercial specialty con-**
2 **tractor level 1 shall have a key employee, or combination of key employees, who completes**
3 **at least 40 hours of continuing education per year.**

4 **“(2) A commercial general contractor level 2 or commercial specialty contractor level 2**
5 **shall have a key employee, or combination of key employees, who completes the equivalent**
6 **of at least 16 hours of continuing education per year.**

7 **“(3) Notwithstanding subsection (1) of this section, if a commercial general contractor**
8 **level 1 or commercial specialty contractor level 1 has no more than four key employees, the**
9 **contractor shall have a key employee, or combination of key employees, that completes**
10 **continuing education each year equivalent to the number of key employees multiplied by**
11 **eight hours.**

12 **“(4) Continuing education may be provided by post-secondary institutions, trade schools,**
13 **trade associations, professional societies, private companies, public agencies, business asso-**
14 **ciations and contractor-provided in-house training programs. Continuing education topics**
15 **may include, but need not be limited to, construction means, methods and business practices.**

16 **“(5) A contractor applying for renewal shall certify the number of continuing education**
17 **hours completed during the preceding licensing period.**

18 **“(6) A contractor subject to this section shall maintain records of the continuing educa-**
19 **tion completed by key employees.**

20 **“(7) This section does not apply to a commercial contractor:**

21 **“(a) That is subject to regulation under ORS 479.510 to 479.945 or 480.510 to 480.670 or**
22 **ORS chapter 693; or**

23 **“(b) As provided by rule by the Construction Contractors Board.**

24 **“SECTION 10. (1) If an order of the Construction Contractors Board that determines a**
25 **claim under ORS 701.145 becomes final by operation of law or on appeal and remains unpaid**
26 **10 days after the date the order becomes final, the claimant may file the order with the**
27 **county clerk in any county of this state.**

28 **“(2) Upon receipt, the clerk shall record the order in the County Clerk Lien Record. In**
29 **addition to any other remedy provided by law, recording an order in the County Clerk Lien**
30 **Record pursuant to the provisions of this section has the effect provided for in ORS 205.125**
31 **and 205.126, and the order may be enforced as provided in ORS 205.125 and 205.126.**

32 **“(3)(a) Payments from the surety bond of a residential contractor pursuant to board or-**
33 **der and notice are satisfied in the following priority in any 90-day period:**

34 **“(A) Board orders as a result of claims against a residential contractor by the owner of**
35 **a residential or small commercial structure have payment priority to the full extent of the**
36 **bond over all other types of claims.**

37 **“(B) If the claims described in subparagraph (A) of this paragraph do not exhaust the**
38 **bond, then amounts due as a result of all other types of residential or small commercial**
39 **structure claims filed within that 90-day period may be satisfied from the bond, except that**
40 **the total amount paid from any one bond to nonowner claimants may not exceed \$3,000.**

41 **“(b) A 90-day period begins on the date the first claim is filed with the board. Subsequent**
42 **90-day periods begin on the date the first claim is filed with the board after the close of the**
43 **preceding 90-day period.**

44 **“(4) If the total claims filed with the board against a residential contractor within 90 days**
45 **after the board receives notice of the first claim against the contractor exceed the amount**

1 of the bond available for those claims, the bond shall be apportioned as the board determines,
2 subject to the priorities established under this section.

3 “(5) If the total amounts due as a result of claims filed with the board within 90 days
4 after the first claim is filed do not exceed the amount of the bond available for those claims,
5 all amounts due as a result of claims filed within the 90-day period shall have priority over
6 all claims subsequently filed until the amount of the bond available for the payment of claims
7 is exhausted.

8 “(6) The total amount paid from a residential contractor bond for costs, interest and at-
9 torney fees may not exceed \$3,000.

10 “**SECTION 11.** (1)(a) Payments from the surety bond of a commercial contractor pursu-
11 ant to Construction Contractors Board order and notice are satisfied in the following priority
12 in any 90-day period:

13 “(A) Board orders as a result of claims against a commercial contractor by a person
14 furnishing labor to a contractor or owed employee benefits by a contractor have payment
15 priority to the full extent of the bond over all other types of claims.

16 “(B) If the claims described in subparagraph (A) of this paragraph do not exhaust the
17 bond, then amounts due as a result of all other types of small commercial or large com-
18 mercial structure claims may be satisfied from the bond, except claims for costs, interest
19 and attorney fees.

20 “(C) If claims described in subparagraphs (A) and (B) of this paragraph do not exhaust
21 the bond, then claims for costs, interest and attorney fees resulting from small commercial
22 or large commercial structure claims may be satisfied from the bond.

23 “(b) A 90-day period begins on the date the first claim is filed with the board. Subsequent
24 90-day periods begin on the date the first claim is filed with the board after the close of the
25 preceding 90-day period.

26 “(2) If the total claims filed with the board against a commercial contractor within 90
27 days after the board receives notice of the first claim against the contractor exceed the
28 amount of the bond available for those claims, the bond shall be apportioned as the board
29 determines, subject to the priorities established under this section.

30 “(3) If the total amounts due as a result of claims filed with the board within 90 days
31 after the first claim is filed do not exceed the amount of the bond available for those claims,
32 all amounts due as a result of claims filed within the 90-day period shall have priority over
33 all claims subsequently filed until the amount of the bond available for the payment of claims
34 is exhausted.

35 “**SECTION 12.** A commercial general contractor level 1 or level 2 that constructs a new
36 large commercial structure shall provide the owner with a two-year warranty of the building
37 envelope and penetration components against defects in materials and workmanship. The
38 warranty shall provide for the contractor to annually inspect the building envelope and pen-
39 etration components during the warranty period. The warranty need not cover conditions
40 resulting from improper maintenance by the owner.

41 “**SECTION 13.** ORS 701.005 is amended to read:

42 “701.005. As used in this chapter:

43 “(1) ‘Board’ means the Construction Contractors Board.

44 “(2) ‘Commercial contractor’ means a licensed contractor that holds an endorsement as
45 a:

1 “(a) **Commercial general contractor level 1;**
2 “(b) **Commercial specialty contractor level 1;**
3 “(c) **Commercial general contractor level 2;**
4 “(d) **Commercial specialty contractor level 2; or**
5 “(e) **Commercial developer.**
6 **“(3) ‘Commercial developer’ means a developer of property that is zoned for or intended**
7 **for use compatible with a small commercial or large commercial structure.**
8 “[(2)] (4) ‘Construction debt’ means an amount owed under:
9 “(a) A final order or arbitration award issued by the board; or
10 “(b) A judgment or civil penalty arising from construction activities within the United States.
11 “[(3)] (5) ‘Contractor’ means **any of the following:**
12 “(a) A person who, for compensation or with the intent to sell, arranges or undertakes or offers
13 to undertake or submits a bid to construct, alter, repair, add to, subtract from, improve, inspect,
14 move, wreck or demolish, for another, any building, highway, road, railroad, excavation or other
15 structure, project, development or improvement attached to real estate or to do any part thereof.
16 [*‘Contractor’ includes general contractors, residential-only contractors and specialty contractors as de-*
17 *defined in this section.*]
18 “(b) **A person that purchases or owns property and constructs or for compensation ar-**
19 **ranges for the construction of one or more residential structures or small commercial**
20 **structures with the intent of selling the structures.**
21 “(c) **A school district, as defined in ORS 332.002, that permits students to construct a**
22 **residential structure or small commercial structure as an educational experience to learn**
23 **building techniques and sells the completed structure.**
24 “(d) **A community college district, as defined in ORS 341.005, that permits students to**
25 **construct a residential structure or small commercial structure as an educational experience**
26 **to learn building techniques and sells the completed structure.**
27 “(e) **Any person except a landscape contractor, nurseryman, gardener or person engaged**
28 **in the commercial harvest of forest products, that is engaged as an independent contractor**
29 **to remove trees, prune trees, remove tree limbs or stumps or to engage in tree or limb**
30 **guying.**
31 “(f) **A business that supplies the services of a home inspector certified under ORS 701.350,**
32 **a lead-based paint inspector licensed under ORS 701.515 or a cross connection inspector and**
33 **backflow assembly tester certified under ORS 448.279.**
34 **“(6) ‘Developer’ means a contractor that owns property or an interest in property and**
35 **engages in the business of arranging for construction work or performing other activities**
36 **associated with the improvement of real property, with the intent to sell the property.**
37 “[(4)] (7) ‘General contractor’:
38 “(a) Means a contractor whose business operations require the use of more than two unrelated
39 building trades or crafts that the contractor supervises or performs in whole or part, whenever the
40 sum of all contracts on any single property, including materials and labor, exceeds an amount es-
41 tablished by rule by the board. [*‘General contractor’ does not include specialty contractors or limited*
42 *contractors, as described in ORS 701.085.*]
43 **“(b) Does not mean a specialty contractor or a residential limited contractor.**
44 “[(5)] (8) ‘Home inspector’ means a person who, for a fee, inspects and provides written reports
45 on the overall physical condition of a residential structure and the appurtenances thereto. ‘Home

1 inspector' does not include persons certified under ORS chapter 455 to inspect new, repaired or al-
2 tered structures for compliance with the state building code.

3 “[6] *‘Inspector’ means a contractor registered with the board who inspects or otherwise provides*
4 *services to a property owner or other contractor but does not substantively add to or subtract from a*
5 *structure. ‘Inspector’ includes but is not limited to a home inspector certified under ORS 701.350, a*
6 *lead-based paint inspector licensed under ORS 701.515 and a cross connection inspector and backflow*
7 *assembly tester certified under ORS 448.279. ‘Inspector’ does not include city or county inspectors act-*
8 *ing under ORS 701.225 or an inspector as defined in ORS 455.715.]*

9 **“(9) ‘Key employee’ means an employee or owner of a contractor who is a corporate of-**
10 **ficer, manager, superintendent, foreperson or lead person or any other employee identified**
11 **by the board by rule.**

12 “[7] (10) *‘Large commercial structure’ means a structure that is not a residential structure or*
13 *small commercial structure.*

14 “[8] *‘Licensed developer’ means a contractor who owns property or an interest in property and*
15 *arranges for construction work, if the contractor:]*

16 “[a] *Engages in the business of arranging for construction work and performing other activities*
17 *associated with the improvement of real property, with the intent to sell the property;]*

18 “[b] *Acts in association with one or more licensed general contractors and the general contractor*
19 *or combination of general contractors have sole responsibility for overseeing all phases of construction*
20 *activity on the property; and]*

21 “[c] *Does not perform any construction work on the property.]*

22 “[9] (11) *‘Officer’ means any of the following persons:*

23 *“(a) A president, vice president, secretary, treasurer or director of a corporation.*

24 *“(b) A general partner in a limited partnership.*

25 *“(c) A manager in a manager-managed limited liability company.*

26 *“(d) A member of a member-managed limited liability company.*

27 *“(e) A trustee.*

28 *“(f) A person defined as an officer under board rules. The definition of officer adopted by board*
29 *rule may include persons not listed in this subsection who may exercise substantial control over a*
30 *business.*

31 “[10] *‘Residential-only contractor’ means a general contractor or specialty contractor who performs*
32 *work exclusively in connection with residential structures and small commercial structures, and the*
33 *appurtenances thereto. ‘Residential-only contractor’ includes, but is not limited to:]*

34 “[a] *A person who purchases or owns property and constructs or for compensation arranges for*
35 *the construction of one or more residential structures or small commercial structures with the intent*
36 *of selling the structures;]*

37 “[b] *A school district, as defined in ORS 332.002, that permits students to construct a residential*
38 *structure or small commercial structure as an educational experience to learn building techniques and*
39 *sells the completed structure;]*

40 “[c] *A community college district, as defined in ORS 341.005, that permits students to construct*
41 *a residential structure or small commercial structure as an educational experience to learn building*
42 *techniques and sells the completed structure; or]*

43 “[d] *Any person except a landscape contractor, nurseryman, gardener or person engaged in the*
44 *commercial harvest of forest products who is engaged as an independent contractor to remove trees,*
45 *prune trees, remove tree limbs or stumps or to engage in tree or limb guying.]*

1 **“(12) ‘Residential contractor’ means a licensed contractor that holds an endorsement as**
2 **a:**
3 **“(a) Residential general contractor;**
4 **“(b) Residential specialty contractor;**
5 **“(c) Residential limited contractor; or**
6 **“(d) Residential developer.**
7 **“(13) ‘Residential developer’ means a developer of property that is zoned for or intended**
8 **for use compatible with a residential or small commercial structure.**
9 *“(11) ‘Residential structure’ means a residence, including a site-built home, modular home con-*
10 *structed off-site, floating home as defined in ORS 830.700, condominium unit, manufactured dwelling*
11 *or duplex, or a multiunit residential building consisting of four units or less that is not part of a*
12 *multistructure complex of buildings.]*
13 *“(12) ‘Small commercial structure’ means a nonresidential structure that has a ground area of*
14 *4,000 square feet or less, including exterior walls, and a height of not more than 20 feet from the top*
15 *surface of the lowest flooring to the highest interior overhead finish of the structure.]*
16 **“(14) ‘Residential structure’:**
17 **“(a) Means:**
18 **“(A) A residence that is a site-built home;**
19 **“(B) A structure that contains one or more dwelling units and is four stories or less**
20 **above grade;**
21 **“(C) A condominium, rental residential unit or other residential dwelling unit that is part**
22 **of a larger structure, if the property interest in the unit is separate from the property in-**
23 **terest in the larger structure;**
24 **“(D) A modular home constructed off-site;**
25 **“(E) A manufactured dwelling; or**
26 **“(F) A floating home as defined in ORS 830.700.**
27 **“(b) Does not mean:**
28 **“(A) Subject to paragraph (a)(C) of this subsection, a structure that contains both resi-**
29 **dential and nonresidential units;**
30 **“(B) Transient lodging;**
31 **“(C) A residential school or residence hall;**
32 **“(D) A state or local correctional facility other than a local facility for persons enrolled**
33 **in work release programs maintained under ORS 144.460;**
34 **“(E) A youth correction facility as defined in ORS 420.005;**
35 **“(F) A youth care center operated by a county juvenile department under administrative**
36 **control of a juvenile court pursuant to ORS 420.855 to 420.885;**
37 **“(G) A detention facility as defined in ORS 419A.004;**
38 **“(H) A nursing home;**
39 **“(I) A hospital; or**
40 **“(J) A place constructed primarily for recreational activities.**
41 **“(15) ‘Small commercial structure’ means:**
42 **“(a) A nonresidential structure that has a ground area of 10,000 square feet or less, in-**
43 **cluding exterior walls, and a height of not more than 20 feet from the top surface of the**
44 **lowest flooring to the highest interior overhead finish of the structure; or**
45 **“(b) A nonresidential leasehold, rental unit or other unit that is part of a larger struc-**

1 **ture, if the unit has a ground area of 12,000 square feet or less, excluding exterior walls, and**
2 **a height of not more than 20 feet from the top surface of the lowest flooring to the highest**
3 **interior overhead finish of the unit.**

4 “[13] (16) ‘Specialty contractor’ means a contractor who performs work on a structure, project,
5 development or improvement and whose operations as such do not fall within the definition of
6 ‘general contractor.’ ‘Specialty contractor’ includes a person who performs work regulated under
7 ORS [chapter 446] 446.395.

8 “**SECTION 14.** ORS 701.010 is amended to read:

9 “701.010. The Construction Contractors Board may adopt rules to make licensure optional for
10 persons who offer, bid or undertake to perform work peripheral to construction, as defined by ad-
11 ministrative rule of the board. The following persons are exempt from licensure under this chapter:

12 “(1) A person who is constructing, altering, improving or repairing personal property.

13 “(2) A person who is constructing, altering, improving or repairing a structure located within
14 the boundaries of any site or reservation under the jurisdiction of the federal government.

15 “(3) A person who furnishes materials, supplies, equipment or finished product and does not
16 fabricate them into, or consume them, in the performance of the work of a contractor.

17 “(4) A person working on one structure or project, under one or more contracts, when the ag-
18 gregate price of all of that person’s contracts for labor, materials and all other items is less than
19 \$500 and such work is of a casual, minor or inconsequential nature. This subsection does not apply
20 to a person who advertises or puts out any sign or card or other device that might indicate to the
21 public that the person is a contractor.

22 “(5) An owner who contracts for work to be performed by a licensed contractor. This subsection
23 does not apply to a person who, in the pursuit of an independent business, constructs, remodels,
24 repairs or for compensation and with the intent to sell the structure, arranges to have constructed,
25 remodeled or repaired a structure with the intent of offering the structure for sale before, upon or
26 after completion. It is prima facie evidence that there was an intent of offering the structure for sale
27 if the person who constructed, remodeled or repaired the structure or arranged to have the struc-
28 ture constructed, remodeled or repaired does not occupy the structure after its completion.

29 “(6) A person performing work on a property that person owns or performing work as the
30 owner’s employee, whether the property is occupied by the owner or not, or a person performing
31 work on that person’s residence, whether or not that person owns the residence. This subsection
32 does not apply to a person performing work on a structure owned by that person or the owner’s
33 employee if the work is performed, in the pursuit of an independent business, with the intent of of-
34 fering the structure for sale before, upon or after completion.

35 “(7) A person licensed in one of the following trades or professions when operating within the
36 scope of that license:

37 “(a) An architect licensed by the State Board of Architect Examiners.

38 “(b) A registered professional engineer licensed by the State Board of Examiners for Engineer-
39 ing and Land Surveying.

40 “(c) A water well contractor licensed by the Water Resources Department.

14 “(1) The person seeking to file the claim must:

15 “(a) Bring an action on the claim against the licensed contractor in a court of competent juris-
16 diction; or

17 “(b) Initiate a proceeding to resolve the claim through binding arbitration substantially in con-
18 formance with ORS 36.600 to 36.740.

19 “(2) The claimant must file the claim with the Construction Contractors Board by delivering to
20 the board a copy of the complaint or the demand for arbitration or other document necessary to
21 initiate arbitration. The complaint, demand or other document must be accompanied by a statement
22 of claim in a form prescribed by board rule. The claimant must also give notice to the surety on the
23 bond by delivering to the surety a copy of the complaint, demand for arbitration or other document
24 necessary to initiate arbitration and a copy of the statement of claim. Delivery to the board and
25 the surety must be accomplished by certified mail, return receipt requested, no later than the earlier
26 of:

27 “(a) The 90th day after the complaint, demand or other document was filed or made;

28 “(b) The 14th day before the first day of trial or arbitration; or

29 “(c) The 30th day before:

30 “(A) The court issues a judgment on the complaint; or

31 “(B) The arbitrator issues an award on the arbitration.

32 “(3) Filing the claim with the board under subsection (2) of this section constitutes filing the
33 claim for purposes of establishing timeliness of the claim under ORS 701.143 and priority of the
34 claim under [ORS 701.150] **section 11 of this 2007 Act.**

35 “(4) Except as provided in this subsection and subsection (7) of this section, if the claimant
36 properly gives notice to the surety under subsection (2) of this section, a judgment or award against
37 the contractor entered in the action or arbitration is binding on the surety. If the claimant delivers
38 the notice required under subsection (2) of this section to the wrong surety, the surety receiving the
39 notice may avoid being bound by a judgment or award by delivering notice of the mistake to the
40 claimant or the claimant’s attorney of record, and to the board, on or before the 30th day after the
41 surety receives notice under subsection (2) of this section. Delivery of the notice of mistake must
42 be by certified mail, return receipt requested, or by facsimile machine or other form of transmission
43 with an acknowledgment of receipt.

44 “(5) A surety under subsection (2) of this section has an absolute right to intervene in an action
45 or arbitration brought or initiated under subsection (1) of this section. A claimant may not join a

1 surety as a party to an action or arbitration unless the claimant disputes the validity or timeliness
2 of the surety's notice of mistake or the surety disputes the validity or timeliness of the delivery to
3 the surety of the notice required by subsection (2) of this section. If the surety elects to intervene
4 or is joined as a party, the surety is bound by all issues of fact and law determined by the court
5 or arbitrator and may not seek board review of those determinations.

6 “(6) If a court issues a judgment on an action, or reduces an arbitration award to judgment,
7 against a contractor on a claim described in subsection (1) of this section, the claimant must deliver
8 a certified copy of the judgment to the board and to the surety no later than the 30th day after entry
9 of the judgment in order to retain a claim against the bond. The entry of a final judgment against
10 the contractor concludes the contractor's involvement in any proceedings to determine whether the
11 bond is subject to payment of the claim. The claimant and the surety are the only parties to the
12 administrative process set forth in subsection (7) of this section.

13 “(7) Upon receipt of a timely delivered certified copy of the judgment as described in subsection
14 (6) of this section, the board shall issue a proposed order in the amount of the judgment together
15 with any costs, interest and attorney fees awarded under the judgment, to the extent that the
16 judgment, costs, interest and fees are within the jurisdiction of the board. The board's determination
17 of the claim is limited to whether the claim comes within the jurisdiction of the board and is subject
18 to payment by the surety. The board shall issue the proposed order in a form that indicates the
19 surety's maximum liability to the claimant. If a hearing is not requested within the time set forth
20 in the proposed order, the proposed order becomes final without any further action by the board.
21 If a hearing is requested, unless review of an issue is precluded under subsection (5) of this section,
22 the board may determine:

23 “(a) Whether the claim was timely filed with the board as provided in ORS 701.143.

24 “(b) Whether the surety received timely notice as provided in subsections (2) and (6) of this
25 section.

26 “(c) Whether the claim is for work subject to this chapter.

27 “(d) The extent of the surety's liability to the claimant.

28 “**SECTION 32.** ORS 701.148 is amended to read:

29 “701.148. (1) Subject to subsection (4) of this section, if the resolution of a claim under ORS
30 701.145 requires a hearing, the Construction Contractors Board may require that the hearing be
31 conducted as a binding arbitration under rules adopted by the board under subsection (3) of this
32 section. This subsection does not authorize the board to require binding arbitration of a claim that
33 is subject to ORS 701.146.

34 “(2) The board may use mediation or arbitration to resolve a construction dispute between any
35 parties who agree to follow the rules of the board, *[including but not limited to parties to a claim that*
36 *is subject to ORS 701.146]* **other than a dispute involving work on a large commercial**
37 **structure.**

38 “(3) Except as provided in this subsection, rules adopted by the board to regulate arbitration
39 under subsections (1) and (2) of this section must substantially conform with the provisions of ORS

45 “(c) Require that a request that an arbitrator modify or correct an award under ORS 36.690 be

30 integrity of a bidder if the contracting agency finds the bidder not to be responsible under this

34 If a bidder fails to promptly supply information requested by the contracting agency concerning re-

38 “(a) A person selling a security as defined in ORS 59.015, or securities which are exempt under

5 “(g) A person primarily soliciting the sale of a magazine or periodical, or contractual plans, in-
6 cluding book or record clubs:

8 instruct the seller not to ship the offered merchandise, and which is regulated by the Federal Trade
9 Commission trade regulation concerning ‘Use of Negative Option Plans by Sellers in Commerce’; or

7 about the private home of the person employing the worker.

9 “(A) The employment is not in the course of the trade, business or profession of the employer;
10 or

11 “(B) The employment is in the course of the trade, business or profession of a nonsubject em-
12 ployer.

13 “(b) For the purpose of this subsection, ‘casual’ refers only to employments where the work in
14 any 30-day period, without regard to the number of workers employed, involves a total labor cost
15 of less than \$500.

16 “(4) A person for whom a rule of liability for injury or death arising out of and in the course
17 of employment is provided by the laws of the United States.

18 “(5) A worker engaged in the transportation in interstate commerce of goods, persons or prop-
19 erty for hire by rail, water, aircraft or motor vehicle, and whose employer has no fixed place of
20 business in this state.

21 “(6) Firefighter and police employees of any city having a population of more than 200,000 that
22 provides a disability and retirement system by ordinance or charter.

23 “(7)(a) Sole proprietors, except those described in paragraph (b) of this subsection. When labor
24 or services are performed under contract, the sole proprietor must qualify as an independent con-
25 tractor.

26 “(b) Sole proprietors actively registered under ORS 671.525 or licensed under [ORS 701.035]
27 **section 2 of this 2007 Act**. When labor or services are performed under contract for remuneration,
28 notwithstanding ORS 656.005 (30), the sole proprietor must qualify as an independent contractor.
29 Any sole proprietor registered under ORS 671.525 or licensed under [ORS 701.035] **section 2 of this**
30 **2007 Act** and involved in activities subject thereto is conclusively presumed to be an independent
31 contractor.

32 “(8) Except as provided in subsection (23) of this section, partners who are not engaged in work
33 performed in direct connection with the construction, alteration, repair, improvement, moving or
34 demolition of an improvement on real property or appurtenances thereto. When labor or services
35 are performed under contract, the partnership must qualify as an independent contractor.

36 “(9) Except as provided in subsection (25) of this section, members, including members who are
37 managers, of limited liability companies, regardless of the nature of the work performed. However,
38 members, including members who are managers, of limited liability companies with more than one
39 member, while engaged in work performed in direct connection with the construction, alteration,
40 repair, improvement, moving or demolition of an improvement on real property or appurtenances
41 thereto, are subject workers. When labor or services are performed under contract, the limited li-
42 ability company must qualify as an independent contractor.

43 “(10) Except as provided in subsection (24) of this section, corporate officers who are directors
44 of the corporation and who have a substantial ownership interest in the corporation, regardless of
45 the nature of the work performed by such officers, subject to the following limitations:

1 “(a) If the activities of the corporation are conducted on land that receives farm use tax as-
2 assessment pursuant to ORS chapter 308A, corporate officer includes all individuals identified as di-
3 rectors in the corporate bylaws, regardless of ownership interest, and who are members of the same
4 family, whether related by blood, marriage or adoption.

5 “(b) If the activities of the corporation involve the commercial harvest of timber and all officers
6 of the corporation are members of the same family and are parents, daughters or sons, daughters-
7 in-law or sons-in-law or grandchildren, then all such officers may elect to be nonsubject workers.
8 For all other corporations involving the commercial harvest of timber, the maximum number of ex-
9 empt corporate officers for the corporation shall be whichever is the greater of the following:

10 “(A) Two corporate officers; or

11 “(B) One corporate officer for each 10 corporate employees.

12 “(c) When labor or services are performed under contract, the corporation must qualify as an
13 independent contractor.

14 “(11) A person performing services primarily for board and lodging received from any religious,
15 charitable or relief organization.

16 “(12) A newspaper carrier utilized in compliance with the provisions of ORS 656.070 and 656.075.

17 “(13) A person who has been declared an amateur athlete under the rules of the United States
18 Olympic Committee or the Canadian Olympic Committee and who receives no remuneration for
19 performance of services as an athlete other than board, room, rent, housing, lodging or other rea-
20 sonable incidental subsistence allowance, or any amateur sports official who is certified by a re-
21 cognized Oregon or national certifying authority, which requires or provides liability and accident
22 insurance for such officials. A roster of recognized Oregon and national certifying authorities will
23 be maintained by the Department of Consumer and Business Services, from lists of certifying or-
24 ganizations submitted by the Oregon School Activities Association and the Oregon Park and Re-
25 creation Society.

26 “(14) Volunteer personnel participating in the ACTION programs, organized under the Domestic
27 Volunteer Service Act of 1973, P.L. 93-113, known as the Foster Grandparent Program and the
28 Senior Companion Program, whether or not the volunteers receive a stipend or nominal reimburse-
29 ment for time and travel expenses.

30 “(15) A person who has an ownership or leasehold interest in equipment and who furnishes,
31 maintains and operates the equipment. As used in this subsection ‘equipment’ means:

32 “(a) A motor vehicle used in the transportation of logs, poles or piling.

33 “(b) A motor vehicle used in the transportation of rocks, gravel, sand, dirt or asphalt concrete.

34 “(c) A motor vehicle operated as a taxicab as defined in ORS 825.017.

35 “(d) A motor vehicle used in the transportation of property by a for-hire motor carrier that is
36 required under ORS 825.100 or 825.104 to possess a certificate or permit.

37 “(16) A person engaged in the transportation of the public for recreational down-river boating
38 activities on the waters of this state pursuant to a federal permit when the person furnishes the
39 equipment necessary for the activity. As used in this subsection, ‘recreational down-river boating
40 activities’ means those boating activities for the purpose of recreational fishing, swimming or
41 sightseeing utilizing a float craft with oars or paddles as the primary source of power.

42 “(17) A person who performs volunteer ski patrol activities who receives no wage other than
43 noncash remuneration.

44 “(18) A person 19 years of age or older who contracts with a newspaper publishing company or
45 independent newspaper dealer or contractor to distribute newspapers to the general public and

1 perform or undertake any necessary or attendant functions related thereto.

2 “(19) A person performing foster parent or adult foster care duties pursuant to ORS chapter 411,
3 418, 430 or 443.

4 “(20) A person performing services on a volunteer basis for a nonprofit, religious, charitable or
5 relief organization, whether or not such person receives meals or lodging or nominal reimbursements
6 or vouchers for meals, lodging or expenses.

7 “(21) A person performing services under a property tax work-off program established under
8 ORS 310.800.

9 “(22) A person who performs service as a caddy at a golf course in an established program for
10 the training and supervision of caddies under the direction of a person who is an employee of the
11 golf course.

12 “(23)(a) Partners who are actively registered under ORS 671.525 or licensed under [ORS
13 701.035] **section 2 of this 2007 Act** and who have a substantial ownership interest in a partnership.
14 If all partners are members of the same family and are parents, spouses, sisters, brothers, daughters
15 or sons, daughters-in-law or sons-in-law or grandchildren, all such partners may elect to be nonsub-
16 ject workers. For all other partnerships registered under ORS 671.510 to 671.710 or licensed under
17 [ORS chapter 701] **section 2 of this 2007 Act**, the maximum number of exempt partners shall be
18 whichever is the greater of the following:

19 “(A) Two partners; or

20 “(B) One partner for each 10 partnership employees.

21 “(b) When labor or services are performed under contract for remuneration, notwithstanding
22 ORS 656.005 (30), the partnership qualifies as an independent contractor. Any partnership registered
23 under ORS 671.525 or licensed under [ORS 701.035] **section 2 of this 2007 Act** and involved in ac-
24 tivities subject thereto is conclusively presumed to be an independent contractor.

25 “(24)(a) Corporate officers who are directors of a corporation actively registered under ORS
26 671.525 or licensed under [ORS 701.035] **section 2 of this 2007 Act** and who have a substantial
27 ownership interest in the corporation, regardless of the nature of the work performed. If all officers
28 of the corporation are members of the same family and are parents, spouses, sisters, brothers,
29 daughters or sons, daughters-in-law or sons-in-law or grandchildren, all such officers may elect to
30 be nonsubject workers. For all other corporations registered under ORS 671.510 to 671.710 or li-
31 censed under [ORS chapter 701] **section 2 of this 2007 Act**, the maximum number of exempt cor-
32 porate officers shall be whichever is the greater of the following:

33 “(A) Two corporate officers; or

34 “(B) One corporate officer for each 10 corporate employees.

35 “(b) When labor or services are performed under contract for remuneration, notwithstanding
36 ORS 656.005 (30), the corporation qualifies as an independent contractor. Any corporation registered
37 under ORS 671.525 or licensed under [ORS 701.035] **section 2 of this 2007 Act** and involved in ac-
38 tivities subject thereto is conclusively presumed to be an independent contractor.

39 “(25)(a) Limited liability company members who are members of a company actively registered
40 under ORS 671.525 or licensed under [ORS 701.035] **section 2 of this 2007 Act** and who have a
41 substantial ownership interest in the company, regardless of the nature of the work performed. If
42 all members of the company are members of the same family and are parents, spouses, sisters,
43 brothers, daughters or sons, daughters-in-law or sons-in-law or grandchildren, all such members may
44 elect to be nonsubject workers. For all other companies registered under ORS 671.510 to 671.710 or
45 licensed under [ORS chapter 701] **section 2 of this 2007 Act**, the maximum number of exempt

1 company members shall be whichever is the greater of the following:

2 “(A) Two company members; or

3 “(B) One company member for each 10 company employees.

4 “(b) When labor or services are performed under contract for remuneration, notwithstanding
5 ORS 656.005 (30), the company qualifies as an independent contractor. Any company registered un-
6 der ORS 671.525 or licensed under [ORS 701.035] **section 2 of this 2007 Act** and involved in activ-
7 ities subject thereto is conclusively presumed to be an independent contractor.

8 “(26) A person serving as a referee or assistant referee in a youth or adult recreational soccer
9 match whose services are retained on a match-by-match basis.

10 “(27) A person performing language translator or interpreter services that are provided for
11 others through an agent or broker.

12 “**SECTION 50.** ORS 671.540 is amended to read:

13 “671.540. ORS 671.510 to 671.710 and 671.990 (2) do not apply to:

14 “(1) Any federal or state agency or any political subdivision performing landscaping work on
15 public property.

16 “(2) Any landscape architect registered under ORS 671.310 to 671.459 and practicing as provided
17 under ORS 671.310 to 671.459.

18 “(3) Landscaping work performed by a landscape maintenance business if:

19 “(a) The landscaping work is performed for a customer that in a calendar year receives prima-
20 rily landscape maintenance services from the business;

21 “(b) The value of all labor, materials or other items supplied for landscaping work at a job site
22 does not exceed \$500 in a calendar year; and

23 “(c) The landscaping work is of a casual, minor or inconsequential nature, as those terms are
24 defined by the State Landscape Contractors Board by rule.

25 “(4) Installation of fences, decks, arbors, driveways, walkways or retaining walls if performed
26 by a person or business licensed with the Construction Contractors Board.

27 “(5) Rough grading of plots and areas of land performed in conjunction with new or remodeling
28 construction if performed by a person or business licensed with the Construction Contractors Board.

29 “(6) Any owner of property who contracts for landscaping work to be performed by a person
30 licensed under ORS 671.560. The exception provided by this subsection does not apply to a person
31 who, in pursuit of an independent business, performs or contracts for the performance of landscaping
32 work with the intent of offering for sale before, upon or after completion of the landscaping work
33 the property upon which the landscaping work is performed.

34 “(7) Any landscaping work performed by a person on property that the person owns or in which
35 the person has a legal interest. The exception provided by this subsection does not apply to a
36 person who, in pursuit of an independent business, performs or contracts for the performance of
37 landscaping work with the intent of offering for sale before, upon or after completion of the land-
38 scaping work the property on which the landscaping work is performed.

39 “(8) A **residential** general contractor licensed under ORS chapter 701 who performs landscaping
40 work if the total value of the landscaping is less than \$2,500 per residential dwelling and the land-
41 scaping work is performed on residential property for which the contractor is under contract for the
42 construction of a new dwelling. The exception provided by this subsection does not apply to the
43 performance of irrigation work by a **residential** general contractor. The State Landscape Contrac-
44 tors Board shall revise the amount specified in this subsection every five years, beginning in 2003,
45 based on changes in the Portland-Salem, OR-WA Consumer Price Index for All Urban Consumers for

2 “(9) A **residential** general contractor licensed under ORS chapter 701 who performs landscaping
3 work on residential property that is directly related to local building code requirements or occu-
4 pancy ordinances including, but not limited to, the placement of street trees. The exception provided
5 by this subsection does not apply to the performance of irrigation work by a general contractor.

6 “(10) A person engaged in making plans or drawings for the selection, placement or use of plants
7 or other site features, unless the plans or drawings are for the purpose of providing construction
8 details and specifications.

9 “(11) Use by a person other than a landscape contractor of the title ‘landscape designer’ when
10 engaged in making plans or drawings described in subsection (10) of this section.

11 “(12) A person providing recommendations or written specifications for soil amendments or
12 planting media if the recommendations or specifications are solely for the purpose of plant installa-
13 tion.

14 “(13) A person registered under ORS 447.010 to 447.156 when performing repair and maintenance
15 on piping for irrigation systems.

16 “(14) An employee, as defined in ORS 657.015, of a **residential** general contractor licensed under
17 ORS chapter 701 when performing work that the contractor may perform under subsection (8) or (9)
18 of this section.

19 “(15) An employee of a licensed landscaping business when performing work for the business
20 under the direct supervision of a licensed landscape contractor.

21 “(16) An employee of a worker leasing company or temporary service provider, both as defined
22 in ORS 656.850, when performing work for a licensed landscaping business under the direct super-
23 vision of a licensed landscape contractor.
