SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Requires Department of Human Services to publish and submit to Legislative Assembly annual report containing list of employers with employees receiving public assistance, including food stamp benefits.

2 Relating to reports published by Department of Human Services.

3 **Be It Enacted by the People of the State of Oregon:**

4 **SECTION 1. (1) The Department of Human Services shall publish annually a report con-**
5 **taining a list of employers with employees who:**

6 (a) **Receive medical assistance under ORS 414.705 to 414.750;**

7 (b) **Are enrolled in the Family Health Insurance Assistance Program established in ORS**
8 **735.720 to 735.740;**

9 (c) **Are subsidized members, as defined in ORS 735.750, of the Family Health Insurance**
10 **Assistance Program;**

11 (d) **Receive temporary assistance for needy families under ORS 418.035 to 418.172;**

12 (e) **Receive food stamp benefits under ORS 411.806 to 411.845; or**

13 (f) **Receive any other public assistance as defined by ORS 411.010.**

14 (2) **The report shall contain the following information:**

15 (a) **The name and address of the employer;**

16 (b) **The number of employees described in subsection (1) of this section who are employed**
17 **by the employer;**

18 (c) **The number of dependents of employees who are receiving a type of public assistance**
19 **described in subsection (1) of this section; and**

20 (d) **The costs to the department and to the Office of Private Health Partnerships of pro-**
21 **viding public assistance benefits to the employees described in subsection (1) of this section**
22 **and the dependents of those employees.**

23 (3) **The report may not contain any individually identifiable health information as defined**
24 **in ORS 192.519.**

25 (4) **The department, in consultation with the Office of Private Health Partnerships, shall**
26 **adopt all rules necessary to implement subsections (1) and (2) of this section, including but**
27 **not limited to obtaining information on employers of applicants for public assistance, in-**
28 **cluding food stamps.**

29 (5) **By March 1 of each year, the department shall submit the report to the Legislative**
30 **Assembly in the manner described in ORS 192.245 and post the report on the department's**

2 **(6) The Employment Department shall provide all information to the Department of Hu-**
3 **man Services that is necessary to produce the report required by this section.**
