## **SUMMARY**

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure as introduced.

Requires health benefit plans to provide coverage of human papillomavirus vaccine for female beneficiaries who are 11 years of age and older.

## A BILL FOR AN ACT

- of the human papillomavirus vaccine for female beneficiaries under the health benefit plan 7 8 who are 11 years of age and older.
