## SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure **as introduced**.

Requires health benefit plans to provide coverage of human papillomavirus vaccine for female beneficiaries who are 11 years of age and older.

## A BILL FOR AN ACT

2 Relating to health benefit plan coverage of human papillomavirus vaccine; creating new provisions;

4 **Be It Enacted by the People of the State of Oregon:**

5 **SECTION 1. Section 2 of this 2007 Act is added to and made a part of the Insurance Code.**

6 **SECTION 2. (1) All health benefit plans, as defined in ORS 743.730, shall include coverage**  
7 **of the human papillomavirus vaccine for female beneficiaries under the health benefit plan**  
8 **who are 11 years of age and older.**
